
INVITATION TO APPEAR

TO: Hon. Mike Mbuvi Sonko, the Governor of Nairobi City County

WHEREAS, pursuant to Article 181 of the Constitution and section 33 of the County Governments Act, 2012, on 3rd December, 2020 the Nairobi City County Assembly approved a Motion for the removal from office, by impeachment, of the Governor of Nairobi City County;

AND FURTHER, WHEREAS, by a letter, Reference: NCCA/SPK/12/2020(1), dated 4th December, 2020, received in the Office of the Speaker of the Senate on 4th December, 2020, the Speaker of the Nairobi City County Assembly informed the Speaker of the Senate of the approval of the Motion by the Nairobi City County Assembly and further forwarded to the Speaker of the Senate documents in evidence of the proceedings of the Assembly;

AND WHEREAS, pursuant to standing order 75(1)(b)(ii) of the Senate Standing Orders, the Senate shall investigate the matter in Plenary;




AND FURTHER WHEREAS, pursuant to standing order 75(3) of the Senate Standing Orders you have the right to appear and be represented before the Senate during its investigations;

NOW THEREFORE, the Senate invites you to appear and be represented before the Senate during its investigations. The first meeting of the Senate shall be held on Wednesday, 16th December, 2020 at 10:00 a.m. at the Senate Chamber, Main Parliament Buildings, Nairobi. If you choose to appear before the Senate, the Senate requires that you file, with the Office of the Clerk of the Senate, 1st Floor, Main Parliament Buildings, Nairobi, by 4:00 p.m. on Tuesday, 15th December, 2020, soft copies and EIGHTY (80) hard copies of your answer to the Particulars of the Allegations, which are annexed hereto, setting out -

- (a) your response to the Particulars of the Allegations;
- (b) how you propose to appear before the Senate; whether in person, by Advocate, or in person and by Advocate;
- (c) the names and addresses of the persons to be called as witnesses, if any, and witness statements containing a summary of the evidence to be presented by such witnesses before the Senate; and
- (d) any other evidence to be relied on.

TAKE NOTE that the Rules of Procedure for the Hearing and Determination of the Proposed Removal from Office by Impeachment of a Governor are contained in the Fifth Schedule to the Senate Standing Orders and shall apply to the proceedings of the Senate and are hereby attached for your information. Also attached is the letter from the Speaker of the Nairobi City County Assembly to the Speaker of the Senate, Reference:



NCCA/SPK/12/2020(1), dated 4th December, 2020 and the attached documents. The tentative Hearing Programme is also attached for your reference;

TAKE FURTHER NOTE that should you choose not to attend before the Senate on the date and time specified in this Invitation, the Senate shall proceed with this matter in accordance with the Constitution and the law, without further reference to you.
