INVITATION TO APPEAR

TO: Hon. Benson Mutura, MCA, Speaker, Nairobi City County Assembly

WHEREAS, pursuant to Article 181 of the Constitution and section 33 of the County Governments Act, 2012, on 3rd December, 2020 the Nairobi City County Assembly approved a Motion for the removal from office, by impeachment, of the Governor of Nairobi City County;

AND FURTHER, WHEREAS, by a letter, Reference: NCCA/SPK/12/2020(1), dated 4th December, 2020, received in the Office of the Speaker of the Senate on 4th December, 2020, the Speaker of the Nairobi City County Assembly informed the Speaker of the Senate of the approval of the Motion by the Nairobi City County Assembly and further forwarded to the Speaker of the Senate documents in evidence of the proceedings of the Assembly;

AND WHEREAS, pursuant to standing order 75(1)(b)(ii) of the Senate Standing Orders, the Senate shall investigate the matter in Plenary;

AND FURTHER WHEREAS, pursuant to standing order 75(8) of the Senate Standing Orders and Rule 4(b) of Part 1 to the Fifth Schedule of the Senate Standing Orders, the County Assembly has the right to appear before the Senate during the investigations;

NOW THEREFORE, the Senate invites the Nairobi City County Assembly to appear and be represented before the Senate during its investigations. The first meeting of the Senate shall be held on Wednesday, 16th December, 2020 at 10:00 a.m. at the Senate Chamber, Main Parliament Buildings, Nairobi. If the Assembly chooses to appear before the Senate, the Senate requires that you file, with the Office of the Clerk of the Senate, 1st Floor, Main Parliament Building, Parliament Road, Nairobi, by 4:00 p.m. on Tuesday, 15th December, 2020, soft copies and EIGHTY (80) hard copies of documentation-

- (a) designating the Members, if any, who shall attend and represent the Assembly in the proceedings before the Special Committee;
- (b) indicating the mode of appearance before the Special Committee: whether in person, by Advocate, or in person and by Advocate;
- (c) indicating the names and addresses of the persons to be called as witnesses, if any, and witness statements containing a summary of the evidence to be presented by such witnesses before the Committee; and
- (d) specifying any other evidence to be relied on.

TAKE NOTE that the Rules of Procedure for the Hearing and Determination of the Proposed Removal from Office by Impeachment of a Governor are contained in the Fifth Schedule to the Senate Standing Orders and shall apply to the proceedings of the Senate and are hereby annexed for your information. The tentative Hearing Programme is also attached for your reference;



TAKE FURTHER NOTE that should the County Assembly choose not to attend before the Senate on the date and time specified in this Invitation, the Senate shall proceed with this matter in accordance with the Constitution and the law, without further reference to you.
