REQUEST FOR STATEMENT

ON THE DISMISSAL FROM SERVICE OF PRIVATE ABDIRAHAMAN  
OMAR MADEY FROM THE KENYA ARMY

Mr. Speaker Sir,

Pursuant to Standing Order 45 (2) (b), I rise to seek a Statement from the Chairperson of the Standing Committee on National Security and Foreign Relations regarding the dismissal from service of Private Abdirahaman Omar Madey, an Infantryman at the 3<sup>rd</sup> Battalion of the Kenya Rifles (Kenya Army), Service No. 55662.

In the Statement, the Chairperson should:-

1. State whether he is aware that Private Omar was discharged from the Service of the Kenya Army, for completion of Colour Service, vide a discharge authority dated 24<sup>th</sup> September, 2008;
2. Explain the circumstances that led to the dismissal of the said officer, vide authority for dismissal dated 14<sup>th</sup> April, 2009;
3. Explain the circumstances under which the officer, who had a distinguished service for 25 years could be dismissed even after he had been honourably discharged from service and given 90 days terminal leave; and
4. State when the terminal dues for the said officer will be paid to him for the 25 years service that he rendered to this country.


