THE text of the Treaty for East African Co-operation (Modification) Agreement 1969 signed at Nairobi on 10th May 1969 by the President of the United Republic of Tanzania, the President of the Republic of Uganda and the President of the Republic of Kenya on behalf of the Governments of the United Republic of Tanzania, the Republic of Uganda and the Republic of Kenya is hereby published for general information.

AN AGREEMENT BETWEEN THE GOVERNMENT OF THE UNITED REPUBLIC OF TANZANIA THE GOVERNMENT OF THE REPUBLIC OF UGANDA AND THE GOVERNMENT OF THE REPUBLIC OF KENYA

WHEREAS by the Treaty for East African Co-operation provision is made for the establishment of an East African Community:

AND WHEREAS Article 94 of that Treaty makes provision for the modification of the Treaty at any time by agreement of all the Partner States:

AND WHEREAS it is considered desirable by the Partner States to modify Article 66 of and Annex VIII to the Treaty by the amendment of Articles 8 and 10 thereof:

NOW THEREFORE the Partner States, that is to say, the Government of the United Republic of Tanzania, the Government of the Republic of Uganda and the Government of the Republic of Kenya HEREBY AGREE as follows:-

Article 1

This Agreement may be cited as the Treaty for East African Co-operation (Modification) Agreement 1969.

Article 2

This Agreement shall enter into force on the date it is signed on behalf of all the Partner States.

Article 3

The Treaty for East African Co-operation shall be modified in the manner specified in the Schedule to this Agreement.

SCHEDULE

- 1. Article 66 of the Treaty for East African Co-operation is amended by inserting immediately after paragraph 8 thereof the following paragraph:—
- 9. The Authority may, on the recommendation of the Finance Council, authorize the payment out of the General Fund of any money for the purpose of making a loan (upon such terms and conditions as the Authority may approve) to the East African Development Bank or to any institution of the Community; and any such authorization shall, notwithstanding paragraph 4 of this Article, be sufficient authority for the payment out of the General Fund of the money.
- Annex VIII to Treaty for East African Co-operation is amended:—
 (a) In Article 8 thereof, by substituting for paragraph 1 thereof the following paragraph—
 - 1. Subject to any direction which may be given by the Authority, the dates and length of sessions of the Tribunal shall be determined by the Chairman having due regard for the Tribunal's obligations;
- (b) In Articoe 10 thereof, by substituting for the words "hold themselves permanently at the disposal of the Tribunal" the words "attend all sessions of the Tribunal".

THE EAST AFRICAN AIR NAVIGATION REGULATIONS, 1965 LEGAL NOTICE NO. 46 OF 1965 NOTICE OF EXEMPTION UNDER REGULATION 79 KENYA NOTICE NO. 6 OF 1969

IN EXERCISE of the powers conferred by Regulation 79 of the East African Air Navigation Regulations, 1965, the Director General of Civil Aviation hereby exempts the aircraft specified in the Schedule to this Notice from the provisions of paragraph (1) (a) of Rule 5 of Section II of the Eleventh Schedule subject to the following conditions:—

- (a) that the aircraft shall not fly closer than 500 feet to any person, vehicle or structure;
- (b) that this exemption shall apply only over the area of Nairobi City;
- (c) that the flight shall be carried out in accordance with the Visual Flight Rules and subject to Air Traffic Control instructions.

The exemption granted under this notice shall have effect on 16th June, 1969 from 0600 GMT to 1500 GMT.
