CHAPTER 1

INTRODUCTION

1.0 Background

1. At the sitting of the Senate held on 14th October, 2021, Sen. (Dr.) Lelegwe Ltumbesi, MP, reported to the Senate that a Petition has been submitted through the Clerk, concerning Historical Land Injustices against the Samburu Community living in Kirimun, Laikipia North, Laikipia County. Pursuant to standing order 232(1) and the Second Schedule to the Standing Orders of the Senate, the Petition was committed to the Standing Committee on Land, Environment and Natural Resources.

1.1. Underlying Constitutional and Statutory Provisions

- 2. Petitions to the Senate are governed by the Constitution, the Petition to Parliament (Procedure) Act, No. 22 of 2012 and the Senate Standing Orders.
- 3. Article 1(1) and (2) of the constitution of Kenya, reposes all sovereign Power in the People of Kenya, exercised solely in accordance with the Constitution
- 4. Article 1(3) (a) and 1(4) of the Constitution of Kenya delegates sovereign power of the constitution to, *inter alia*, parliament and the legislative assemblies of the county governments and that the sovereign power of the people is exercised at the national and county level.
- 5. Article 37 of the Constitution provides that every person has the right, peaceably and unarmed, to assemble, to demonstrate, to picket, and to present petitions to public authorities while Article 119(1) of the Constitution provides that "every person has a right to petition Parliament to consider any matter within its authority, including to enact, amend or repeal any legislation."

- 6. Article 40 (3)(b)(i) of the Constitution provides that the state shall not deprive a person of property of any description, or of any interest in, or right over, property of any description, unless the deprivation- is for a public purpose or in the public interest and is carried out in accordance with this Constitution and any Act of Parliament thatrequires prompt payment in full, of just compensation to the person.
- 7. Article 60(1)(b) of the provides that land in Kenya shall be held, used and managed in a manner that is unequitable, efficient, productive and sustainable and according to the principle of security of land rights.
- 8. Under Article 62(2) of the Constitution, public land shall vest and be held by the county government in trust for the people resident in the county and shall be administered by the National Land Commission. Further, under Article 67(2) of the Constitution, the National Land Commission is mandated to manage public land on behalf of the national and county governments.
- 9. Article 119 of the constitution provides that any person has a right to petition Parliament to consider any matter within its authority.
- 10. Article 37 of the Constitution provides that every person has the right, peaceably and unarmed, to assemble, to demonstrate, to picket, and to present petitions to public authorities while Article 119(1) of the Constitution provides that "every person has a right to petition Parliament to consider any matter within its authority, including to enact, amend or repeal any legislation."
- 11. Section 5(2) of the Petition to Parliament (Procedure) Act, provides that a petition that is tabled in Parliament under this Act shall be considered in accordance with the Standing Orders of the relevant House. In this regard, standing order 232 of the Senate Standing Orders provides as follows-

232. Committal of Petitions

- (1) Every Petition presented or reported pursuant to this Part, shall stand committed to the relevant Standing Committee.
- (2) Whenever a Petition is committed to a Standing Committee, the Committee shall, in not more than sixty calendar days from the time of reading the prayer, respond to the petitioner by way of a report addressed to the petitioner or petitioners and laid on the Table of the Senate and no debate on or in relation to the report shall be allowed, but the Speaker may, allow comments or observations in relation to the Petition for not more than thirty Minutes.
- 12. Standing order 233 requires the Clerk to, within fifteen days of tabling of the report on a petition under Standing Order 232 (Committal of Petitions), submit a copy of the report to the petitioner or petitioners.
- 13. Section 12 of the Land Act, 2012 provides for the procedure for allocation of Public Land.

1.2. The Complaint

- 14. This complaint before the Senate concerns the alleged historical land injustices against the Samburu Community living in Kirimun, Laikipia North, Laikipia County, where it is alleged that land belonging to the community was alienated by the colonial government for the establishment of the African Livestock Marketing Organization (ALMO) which later transformed into Livestock Marketing Division (LMD) for livestock development and marketing.
- 15. The subsequent existence and expansion of the Livestock Marketing Division led to the displacement of the Samburu Community from their traditional land without fair compensation. Despite numerous efforts to resolve the matter, it remains unresolved to date.

1.2.1. Background Facts of the Complaint

- 16. The National Land Commission Act, 2012 was enacted to provide for the management and administration of land in accordance with the principles of land policy set out in Article 60 of the Constitution and the National Land Policy. The enunciated principles included the principle of equitable access to land, the security of land rights and as well the settlement of community land disputes using local initiatives.
- 17. The Samburu community have often been depicted in postcards, coffee table books, and popular media as generously adorned girls or as glamorous bachelor warriors roaming the countryside engaging in livestock theft against their neighbors, and illegal herders.
- 18. The British colonial government founded the African Livestock Marketing Organization (ALMO), later transformed into the Livestock Marketing Division to spearhead livestock development and marketing. This policy development became a nightmare for the Samburu community. To date, the Livestock Marketing Division was seen as the curse to Samburu Community land rights;
- 19. The establishment of the Isiolo Holding Group in 1952 by the colonial government as a quarantine and disease screening area for pastoralists' cattle prior to their travelling further south for sale, was originally only 16,000 hectares but over time expanded to an area of approximately 124,000 hectares. This expansion extended to southern Livestock Marketing Division territory to the current Laikipia County further displacing the Samburu from their traditional lands.
- 20. The changes in land tenure introduced by the colonial government and later, the independent government affected the Samburu Community negatively. The nomadic pastoralist Samburu remain largely landless.

- 21. In Kirimun, there were harrowing testimonies of harassment, torture and even death of nomadic herders and even women and children found in the Livestock Marketing Division controlled areas, all in the hands of their personnel,;
- 22. The Samburu Community has been depicted as illegal herders and troublemakers in the vast ranches of Laikipia County. The herders, as they were referred to, were seen as a source of insecurity for the private ranchers. On the basis of this depiction, the serious problem of unfair land alienation of traditional Samburu lands has been perpetrated.
- 23. The local community members had in the past engaged with the relevant authorities to lay down formal claims to the Samburu traditional land in Laikipia North Sub County, and particularly Kirimun sub-location. As early as the 1900s, local delegations met with several national leaders to resolve the matter (2003-2007). The same issue had been raised with Laikipia County Council for a long time. In particular, in 1996, this was petitioned to the County Council during the leadership of Mr. John Lokopien, with no success. Local leaders were part of the delegation of Maa speakers to former Vice President Moody Awori in 2003 on the Laikipia landlessness of Samburu people but once again, no action was taken;
- 24. In 2004, following the expiry of the 100 years' land lease of 1 million hectares of land in the hands of British settlers in the country, the Samburu community under the aegis of Maasai Civil Society Group presented a petition to the government on the return of traditional Maa speaking land alienated by the colonial government. This was before the promulgation of the Kenya Constitution 2010, which now recognizes discussions on historical land injustices in the country. Unfortunately, the government rubbished the community demands.
- 25. The petitioners have made the best effort to have these matters addressed by the relevant authorities all of which have failed to give a satisfactory response.

The Petitioners prayed to the Senate that:

- (a) The rights and interests of the Samburu community be protected by the National Land Commission through conferment of title of all land in Kirimun sub-location to the designated Samburu community residents under the Community Land Act, 2016.
- (b) The Samburu People living in Kirimun, Laikipia North Sub County be compensated commensurate with the value of any land taken from them.
- (c) The Samburu community be compensated for historical wrongs of torture, humiliation and suffering perpetrated by the successive governments and its agents such as the Livestock Marketing Division, National Youth Service, Kenya Wildlife Service, game wardens and the police on the members of the Samburu community.
- (d) There is establishment of schools, health facilities and other public service institutions for the benefit of the Samburu community.
- (e) The rights of the Samburu community to use their traditional land, natural resources and water points for grazing and maintenance of their traditional way of life is upheld.
- (f) The planned establishment of Kirimun Game reserve is degazetted and subsequent allocation of the land to community residents.

CHAPTER 2

CONSIDERATION OF THE PETITION

2.0 Approach taken by the Committee

- 26. In considering the Petition, the Committee observed that it would be important to verify the facts alleged by the Petition. The Committee therefore resolved to conduct an inquiry on the issues raised in the Petition.
- 27. In this regard the Committee received the Petition from the Petitioner through the House and further met with the Petitioners on several occasions as it met with stakeholders.
- 28. Thereafter the Committee invited the Cabinet Secretary Ministry of Lands and Physical Planning and the Chairperson National Land Commission, who virtually appeared before the Committee.

2.1. Petitioners Submissions

29. Vide a letter REF: SEN/DCS/LENR/2/2021/(66) dated 21st October, 2021, the Committee invited the Petitioners to virtually appear before the Committee on Wednesday, 17th October, 2021. The Petitioners appeared before the Committee as invited and defended their Petition.

2.2. <u>Responses by the Cabinet Secretary, Ministry of Lands and Physical Planning</u>

30. Vide a letter REF: SEN/DCS/LENR/2/2022/(5A) dated 26th January 2022, the Committee invited the Cabinet Secretary Ministry of Lands and Physical Planning to virtually appear before the Committee on Thursday, 17th February, 2022. The Principal Secretary, Ministry of Lands and Physical Planning appeared before the Committee on 17th February, 2022 and made the following submissions:-

- 31. The Ministry informed the Committee that the land subject of the petition was Kirimun Ranch located on L.R No. 8036 and measures 16,655 Hectares (41,276 Acres). *Annexure 1* of the Ministry's Submissions is a copy of Deed Plan No. 325695.
- 32. According to the records with the Ministry, vide a letter Ref. 36661/59 dated December 22, 1954 (Annexure 2 of the Ministry's Submissions), the ranch was reserved for the Veterinary Department as a Livestock Holding ground for a term of 5 years with effect from January 1, 1956.
- 33. In 1958, the Ministry of Agriculture and Livestock Development applied to the Commissioner of Lands for a permanent reservation of the Holding Ground. This request was considered and approved by the Land Board at its meeting on February 25, 1959. A copy of the consent is marked annexure 3.
- 34. By a letter Ref. OP/CA.1/34A dated April 23, 1982 (annexure 4), the then Minister for Regional Development, Science and Technology wrote to the Minister for Lands and settlement where he confirmed that the National Youth Service was taking over the farm.
- 35. While the National Youth Service was taking over and settling on the farm, a delegation of leaders from Laikipia District also visited the then President of the Republic of Kenya (H. E. Daniel Arap Moi) on July 16, 1984 where they petitioned the President to consider establishing a Game Reserve at Kirimun Holding Ground, a request which was assented to by the President. Annexure 5 is a copy of a letter from the then Laikipia County Council Ref. LCC/ADM/36/46 dated May 8, 1990 communicating the President's approval.
- 36. In 1991, the Laikipia National Reserve was established vide Legal Notice No. 526 of October 16, 1991 (annexure 6) to cover the area previously known as Kirimun Holding Ground. In 1999, the same land (L.R No. 8036) was formally allocated to

the National Youth Service despite the fact that it had, in 1991 been gazetted as a National Reserve. A copy of the Letter of Allotment Ref. 215338/8 dated July 9, 1999 is marked annexure 7.

- 37. Upon receipt of the Letter of Allotment, the NYS duly accepted the offer and made the requisite payments and an official receipt No. E.522453 dated March 15, 2000 was issued by the Commissioner of Lands (annexures 8a and 8b).
- 38. The decision to allocate the land to the NYS did not go down well with both the County Council of Laikipia and the Kenya Wildlife Service who protested against the allocation stating that land was not available for alienation owing to the fact that it had earlier in 1991 been gazetted as a conservation area. Annexures 9a and 9b are copies of the protest letters.
- 39. In an effort to resolve the issue of ownership of the land, the Ministry mediated several meetings between the parties (County Council of Laikipia, Kenya Wildlife Service and the NYS) without any success. On April 14, 2004, the Permanent Secretary, Secretary to the Cabinet and Head of Public Service held a meeting in his office, Harambee House, where all the parties to the dispute were invited/present. Present in the meeting were:

40. From the above meeting, it was resolved that:

(a) Laikipia County Council retains Kirimun ranch for the establishment of a Game Reserve.

- (b) National Youth Service retains the remainder of Marmar Ranch L.R No. 8052 (Now surveyed as L.R 25089) measuring 18,030.65 Hectares.
- (c) Cadastral Survey for both ranches be carried out immediately to facilitate the preparation and issuance of Title Deeds. Annexure 10 is a copy of minutes of the meeting.
- 40. On the basis of the above resolutions, a Letter of Allotment was formally issued to the County Council of Laikipia Ref. 36661/143 dated May 24, 2004 for L.R 8036 measuring 16,738 hectares (41,360 Acres). The letter superseded the Letter of Allotment Ref. 215338/8 dated July 9, 1999, which allocated the land to the NYS. The Letter of Allotment indicates that the land was allocated for Kirimun Game Reserve.
- 41. Upon receipt of the Letter of Allotment (annexure 11), Laikipia County Council accepted the offer and made the necessary payments and an official receipt No. F. 827364 dated June 25, 2004 was issued by the Commissioner of Lands. Annexures 12a and 12b are copies of the acceptance letter and payment receipt respectively.

- 42. The interest of the NYS on the land was extinguished by the issuance of a letter of allotment to the Laikipia County Council.
- 43. The Ministry stated that the issues raised in the petition were of the nature of historical land injustice as defined under Section 15 (2) of the National Land Commission Act, 2012. The National Land Commission was seized of the matter registered as Claim No. NLC/HLI/1641/2021. The prayers sought by the petitioners would be addressed by the outcome

2.3. Responses by the National Land Commission

- 44. Vide a letter REF: SEN/DCS/LENR/2/2021/(80) dated 1st December, 2021, the Committee invited the Chairperson National Land Commission to virtually appear before the Committee on Wednesday, 7th December, 2021 who thereafter appeared and made the following submission;
- 45. The Chairperson informed the Committee that attention had been brought to the Commission in late August 2021 of a Petition and Complaints of a similar nature on the subject land by members of the Samburu community. The Commission, on its own motion, considered the issues to be candidate for historical land injustice and, under its mandate as spelt out in Article 67(2)(e) of the Constitution and Section 15 of the National Land Commission Act, 2012 which mandates the Commission "to initiate investigations, on its own initiative or on a complaint, into present or historical land injustices, and recommend appropriate redress", took cognizance of the matter and took it up.
- 46. It was noted that the Commission proceeded to formally receive the petition as a historical land injustice claim on its own initiative and entered it into the register of claims as Claim Number NLC/HLI/1641/2021 and will proceed to consider its admissibility, carry out investigations and make appropriate recommendations.

- 47. The Committee was informed that adjudication of and conferment of title to community land was governed by the Community Land Act (sections 8 to 14) and the mandate thereunder was primarily that of the Cabinet Secretary Lands and Physical Planning and the respective County Government.
- 48. However, upon hearing the Historical Land Injustice (HLI) claim, the Chairperson stated that the Commission may recommend appropriate remedies, possibly including those set out in the prayers.

CHAPTER 3

COMMITTEE OBSERVATIONS

- 44. The Committee having considered the submissions of the Petitioners, the Cabinet Secretary, Ministry of Lands and Physical Planning and the National Land Commission made the following observations-
 - (1) Historical Land Injustices- The Committee observed that the complaints by the Petitioners was protracted in nature and dated back to the injustices by the colonial administration and subsequent inaction and denial of rights to community land by the government. The Committee observed that historical land injustices have been committed against the Samburu Community at large and the community living in Kirimun in particular.
 - (2) Recommendation by the Ministry of Land and Physical Planning- The Committee notes that the Ministry of Land and Physical Planning admitted that the Petition raised fundamental historical land injustices and stated that the National Land Commission was properly seized of the matter and had the constitutional authority to handle it.
 - (3) Mandate of the National Land Commission- The Committee observed from the submission by the National Land Commission that the subject matter of the petition had been brought the attention of the Commission in August 2021 in addition to similar complaints by the Samburu Community. The Community observed that that the mandate to investigate and make recommendations on historical land injustices is the mandate of the National Land Commission as enshrined under Article 67(2)(e) of the Constitution. The National Land Commission should therefore undertake an investigation into the issues and make and recommendation on the remedies available to the Petitioners.

(4) Investigation by the National Land Commission- The Committee resonated with the confirmation by the Chairperson of the National Land Commission; Mr. Gershom Otachi in his assertion that that it was properly seized of the historical land injustices issues raised in the Petition and advised that it was in the process of conducting investigations on the same. Mr. Gershom Otachi undertook that the Commission would expedite its investigations and make its recommendations within 3 months of 17th February, 2022.

CHAPTER 4

COMMITTEE RECOMMENDATIONS

45. The Committee having investigated the matter in accordance with its mandate under the standing order 223 of the Senate Standing Orders and recommends that the National Land Commission, which undertook investigation of the historical land injustices raised in the Petition in accordance with its mandate under Article 67(2)(e) of the Constitution, promptly investigates the same and makes its recommendations by 30th June, 2022.

MINUTE SEN/SCLENR/377/2021: <u>PETITION ON RESETTLEMENT STATUS</u> OF FORMER KIMONDI FOREST EVICTEES

The meeting noted the absence of the Ministry of Lands and Physical Planning, and the National Land Commission but resolved to proceed with the submissions of the present stakeholders.

Submissions from the Ministry of Environment and Forestry

- Ministry of Environment and Forestry submitted to the Committee that it would have been imperative to have submissions from the Ministry of Land and Physical Planning (MoLPP) as the findings of the Committee on historical land injustices by National Land Commission (NLC), which the petitioners had based their claims on did not apply to Kenya Forest Services (KFS).
- The Ministry observed that the NLC Committee on historical land injustices recommendations placed responsibility of resettling the petitioners on MoLPP and the County government of Nandi.
- They informed the meeting that KFS responsibility was management of forests and played no role on matters resettlement.

Submissions from the County Government of Nandi

• In their submission, the County Government stated that the land meant for resettlement of the evictees was forest land that belonged to the Ministry of Environment and Forestry, and not the county government. They therefore could not do resettlement on it.

Committee Observations and Interventions

- The Committee sought to know from the alternative resettlement plans put in place by the county government and was informed that there existed numerous squatters in Nandi County whose resettlement awaited degazettement of some forest land, a process that was yet to be authorized by KFS
- The Committee observed that Kenya had a small forest cover and that alienating parts of forests land for resettlement would hamper the country's effort to attain a minimum of 10% forest cover.
- The Committee sought to know if there existed plans to degazette forest land for resettlement purposes in Nandi County and was informed by the CS, Ministry of Environment and Forestry that findings by the NLC historical land injustices committee had not given any recommendation requiring resettlement of squatters on forest land.
- The Committee observed the need to conserve forest, noting that NLC findings required the MoLPP and the County Government of Nandi to find a suitable place to resettle the evictees that was not necessarily forest land.
- Consequently, the Committee requested the County Government of Nandi to clarify
 the plans to resettle the evictees in an alleged forest land and was informed that was
 known to NLC and was conversed during the NLC Committee on historical land
 injustices public hearings.

Following a series of deliberations, the Committee resolved to reschedule the meeting to a later date and invite the following stakeholders;

CS Ministry of Lands and Physical Planning, CS Ministry of Environment and Forestry, the Chairperson National Land Commission, and the County Government of Nandi.

The leases expired in 2004 and the community's attempt to have some of the land returned to the were unsuccessful despite renewal of some of the leases where the land was granted to new owners.
- Members also observed that nomadic pastoralist communities within Laikipia county
 were regarded as illegal herders and source of insecurity, and that there existed an
 order from the Ministry of Interior and Coordination of National Government that
 required them to vacate Laikipia County. It was further noted that the security
 operations in Laikipia have led to loss of lives of members of the community as well
 as loss of livestock
- It was noted that the population of the community has since grown and were unable to practice their tradition such as grazing on the lands and that the petitioner's prayer was to have the Kirimun area given back to them to allow their lives to return to normal.

- The meeting was informed of an apology from the Cabinet Secretary Ministry of Lands and Physical Planning as she was held in Cabinet meeting.
- Nonetheless, the meeting proceeded and heard the submissions from the Chairperson National Land Commission as follows:

Submissions from National Land Commission

The Chairperson, National Land Commission submitted as follows;

The Commission acknowledges receipt of an Historical Land Injustice Claim from Former Kimondi Forest Squatters and Kimondi Forest Squatters whichwere admitted and registered under Claim No. NLC/HLI/430/2018 and NLC/HLI/016/2017 respectively.

The Commission proceeded to hearing the claims between 10th to 11th July 2018 in Nandi County. Subsequently, the Commission made and signed a determination on the 7th February 2019 in which it recommended as follows;

The County Government in collaboration with the Ministry of Lands (Adjudication and Settlement Department) and other relevant authorities, should proceed with the resettlement of both the 1st and 2nd claimants.

As per the determination, the principal entities anticipated to implement the recommendations are the Ministry of Lands and Physical Planning and the County Government of Nandi. The Commission has no specific role unless called upon to assist in any other manner as per its mandate.

Observations and Interventions

- The Committee noted that that the County Government in conjunction with the Ministry of Lands and Physical Planning were required to resettle the petitioners as recommended by the National Land Commission.
- The Committee also sought to know from the County Government the plans it had to resettle the evictees and the Deputy Governor informed the meeting that from National Land Commission community engagement exercise, the findings established the existence of an alleged 1,541 hectors of land excised from the current Nandi North Forest land that was to be used for resettlement and that it was yet to be allocated to the county.
- The Committee sought clarification on the existence of the alleged degazettement of forest land for resettlement and the Ministry informed the meeting that there existed no such degazettement in their records.
- There being no record of degazetted forest land, noting the need to protect the national forest cover, the Committee observed that the petitioners needed to be resettled on alternative land other and asked the County Government to brief the Committee on the available options.
- The County Government informed the meeting that apart from the petitioners, there existed other numerous squatters within Nandi County who needed resettlement and that following engagements with the National Land Commission, it was recommended that some of the land under tea plantations be resurveyed to ascertain its actual size as there existed a mismatch between the actual and the documented size. Excess land from the exercise would be used for re-settlement..
- The County Government also informed members that the resurvey process was put on hold after a section of the tea landowners sought judicial intervention over the recommended resurvey where a stay order was issued.
- The Committee sought the National Land Commission to clarify the number of people who were to be resettled, the criteria used to arrive at the figure and whether it had a role in following up implementation of its recommendations.
- Chairperson National Land Commission informed the meeting that the there was no
 actual number captured in the findings by National Land Commission but could be
 obtained from the numerous correspondences over the matter between different
 stakeholders. The Commission further added that its role ended at issuing findings
 and recommendation to the implementation agencies for action.
- From the deliberations, the Committee resolved as follows;
- i. The Committee resolved to hold a stakeholder's meeting with the Cabinet Secretary Ministry of Lands and Physical Planning, the National Land Commission, the County Government of Nandi and the tea farms

multinationals with the aim of;

- a. Getting the tea farms resurveyed through alternative dispute resolution away from the court. The Committee felt that move would be better than excising forest land.
- b. Seeking the Ministry of Lands and Physical Planning to look for some funds to facilitate acquisition of land for resettling the evictees.
- ii. The Committee also resolved to conduct a county visit to Nandi on a fact-finding mission and meet with different stakeholders to resolve the matter.

Attention had been brought to the Commission in late August 2021 of a Petition and Complaints of a similar nature on the subject land by members of the Samburu community. The Commission, on its own motion, considered the issues to be candidate for historical land injustice and, under its mandate as spelt out in Article 67(2)(e) of the Constitution and Section 15 of the National Land Commission Act, 2012 which mandates the Commission "to initiate investigations, on its own initiative or on a complaint, into present or historical land injustices, and recommend appropriate redress", took cognizance of the matter and took it up.

The Commission proceeded to formally receive the petition as a historical land injustice claim on its own initiative and entered it into the register of claims as Claim Number NLC/HLI/1641/2021 and will proceed to consider its admissibility, carry out investigations and make appropriate recommendations.

The Commission specifically wishes to point out that adjudication of and conferment of title to community land is governed by the Community Land Act (sections 8 to 14) and the mandate thereunder is primarily that of the Cabinet Secretary Lands and Physical Planning and the respective County Government.

However, upon hearing the HLI claim, the Commission may recommend appropriate

remedies, possibly including those set out in the prayers.

Interventions

The Committee noted the need to have to have both the Ministry of Lands and Physical Planning and the National Land Commission present when the matter is being discussed and resolved to invite both to a meeting of the Committee for conclusive deliberations.

HON CHAIR

I make reference to the letter Ref. SEN/DCS/LENR/2/2021(67) dated 21^{st} October, 2021 from the Clerk of the Senate on the above petition.

This petition is premised on the grounds that residents of Kirimun Community lay claim to the Samburu traditional land, and in particular Kirimun Sub location. As early as 1990s, local delegations met with several national leaders to resolve the matter including Laikipia Council of Elders.

The petition further notes that in 2004, following the expiry of 100 years' land lease of some of the million hectares of land in the hands of the British settlers in the country, the Samburu Community presented a petition to the Government on the return of traditional Maa speaking land alienated by the colonial Government. They claim that the Government, unfortunately, rubbished the demands of the community.

The petitioners inform that none of the issues raised in this petition pending in any court of the law, constitutional or any other legal body.

The petitioners pray that the Senate intervenes with a view to ensure that:

- 1. The rights and interest of the Samburu Community are protected by the National Land Commission through conferment of the title of all land in Kirimun Sub-location to the designated Samburu Community residents under the Community Land Act 2016;
- 2. The Samburu people living in Kirimun, Laikipia North Sub-county are compensated commensurate with the value of any land taken from them;
- 3. The Samburu Community are compensated for historical wrongs of torture, humiliation and suffering perpetuated by the successive governments and its agents such as the Livestock Marketing Division, National Youth Service, Kenya Wildlife Service game wardens and the Police on the members of the Samburu in Kirimun Sub-location;

- 4. There is accelerated establishment of schools, health facilities and other public service institutions for the benefit of the Samburu Community;
- 5. The rights of the Samburu Community to use their traditional land, natural resources and water points for grazing and maintenance of their traditional way of life is upheld; and
- 6. The planned establishment of Kirimun Game reserve is degazzeted and subsequent allocation of the land to community residents.

RESPONSE

Hon. Chair, The Commission wishes to respond as follows:

Attention had been brought to the Commission in late August 2021 of a Petition and Complaints of a similar nature on the subject land by members of the Samburu community. The Commission, on its own motion, considered the issues to be candidate for historical land injustice and, under its mandate as spelt out in Article 67(2)(e) of the Constitution and Section 15 of the National Land Commission Act, 2012 which mandates the Commission "to initiate investigations, on its own initiative or on a complaint, into present or historical land injustices, and recommend appropriate redress", took cognizance of the matter and took it up.

The Commission proceeded to formally receive the petition as a historical land injustice claim on its own initiative and entered it into the register of claims as Claim Number NLC/HLI/1641/2021 and will proceed to consider its admissibility, carry out investigations and make appropriate recommendations.

The Commission specifically wishes to point out that adjudication of and conferment of title to community land is governed by the Community Land Act (sections 8 to 14) and the mandate thereunder is primarily that of the Cabinet Secretary Lands and Physical Planning and the respective County Government.

However, upon hearing the HLI claim, the Commission may recommend appropriate remedies, possibly including those set out in the prayers.

Citizens of the Republic of Kenya, and residents of Kirimun,

DRAW the attention of the Senate to the following:

THAT, The National Land Commission Act 2012 was enacted to provide for the management and administration of land in accordance with the principles of land policy set out in Article 60 of the Constitution and the national land policy. The enunciated principles include the principle of equitable access to land, the security of land rights and as well the settlement of community land disputes using local initiatives;

THAT, the Samburu community have often been depicted in postcards, coffeetable books, and the popular media as generously adorned girls or as glamorous bachelor warriors roaming the countryside engaging in livestock theft against their neighbors, and illegal herders;

THAT, the British Colonial government founded the African Livestock Marketing Organization (ALMO), later transformed into the Livestock Marketing Division (LMD) to spearhead livestock development and marketing.

This policy development became a nightmare for the Samburu community. To date, the LMD is seen as the curse to the Samburu community land rights;

THAT, the establishment of the Isiolo Holding Ground in 1952 by the colonial government as a quarantine and disease screening area for pastoralists' cattle prior to their travelling further south for sale, was originally only 16,000 hectares but overtime expanded to an area of approximately 124,000 hectares. This expansion extended the southern LMD territory to the current Laikipia County further displacing the Samburu from their traditional lands;

THAT, the changes in land tenure introduced by the colonial government and later, the independent government affected the Samburu negatively. The nomadic pastoralist Samburus remained largely landless;

THAT, in Kirimun, there are harrowing testimonies of harassments, torture and even death in the hands of the LMD personnel for the nomadic herders, and even women and children found in the LMD controlled areas;

THAT, the Samburu community have been depicted as illegal herders and trouble makers in the vast ranches of Laikipia County. The herders, as they are referred are seen as a source of insecurity for the private ranchers. On the basis of this depiction, the serious problem of unfair land alienation of the traditional Samburu lands has been perpetrated;

THAT, the local community members have in the past engaged with the relevant authorities to lay down formal claims to the Samburu traditional land in Laikipia North Sub County, and particularly Kirimun sub-location. As early as the 1990s, local delegations met with several national leaders to resolve the matter (2003-2007). The same issue has been raised with the Laikipia County Council for a long time. In particular, in 1996, this was petitioned to the County council during the leadership of Mr. John Lokopien, with no success. Local leaders were part of the delegation of Maa speakers to former Vice

President Moody Awori in 2003 on the Laikipia landlessness of Samburu people but once again, no action was taken;

THAT, in 2004, following the expiry of the 100 years' land lease of some 1 million hectares of land in the hands of British settlers in the country, the Samburu community under the aegis of Maasai Civil Society Group presented a petition to the government on the return of traditional Maa speaking land alread by the colonial government. This was before the promulgation of Kenyan Constitution 2010, which now recognized discussions on historical land injustices in the country. Unfortunately, the government rubbished the community demands;

THAT, the petitioners have made the best efforts to have these matters addressed by the relevant authorities all of which have failed to give a satisfactory response.

THAT, none of these issues raised in this Petition is pending in any court of Law, Constitutional or any other legal body.

WHEREFORE, your humble petitioners pray that the Senate intervenes with a view to ensure that-

- 1. the rights and interests of the Samburu community are protected by the National Land Commission though conferment of the title of all land in Kirimun sub location to the designated Samburu community residents under the Community Land Act, 2016;
- the Samburu People living in Kirimun, Laikipia North Sub County are compensated commensurate with the value of any land taken from them;
- 3. the Samburu community are compensated for historical wrongs of torture, humiliation and suffering perpetrated by the successive

- 6. the planned establishment of Kirimun Game reserve, and allocation of the land to community residents is degazetted.
