#### CHAIRPERSON'S FOREWORD

Standing Order 200(A) (1) and (2) of the National Assembly Standing Orders provides that "(1) A Committee which is unable to complete its work before the expiry of its term shall table an exit report to the Assembly detailing reasons for such inability and (2) the Report shall be available to the succeeding Committee which may consider at in preparing its work plan.

The exit report is an important tool of gauging the Committee performance in the 12<sup>th</sup> Parliament. It details the business transacted by the Committee, the status of consideration of each and any matter pending before the Committee as required by Standing Orders 200 (A).

During the period under review, the Committee considered 28 Bills, 17 Legislative Proposals, 27 Petitions, 3 inquiries, 263 Questions, 74 requests for statements and 7 approval hearings for appointment to various positions including Principal Secretaries and Chairpersons and Members of independent Commissions.

Among the highlights of the achievements of the Committee in the 12<sup>th</sup> Parliament are: The introduction of the Internship Programme with an allocation of an initial sum of Kshs. 1 billion. The Program has accorded thousands of youth an opportunity to gain hands on experience required in the job market. The Committee has also endeavored to enhance the strength of the National Police Service and the Prison Service both in terms of numbers and facilities aimed at modernization of infrastructure.

In particular, the completion of the National Forensic Laboratory has improved crime surveillance and boosted the capacity of the Directorate of Criminal Investigations in tackling crime. The decentralization of police counselling services is also an important milestone towards the provision of reliable and efficient psycho-social support to police officers across the country.

Through efforts by the Committee various new administrative units have been created in various constituencies across the country. This has had the net effect of bringing government services closer to the citizens. Through various Questions and Petitions introduced by Members, the Committee has addressed and made far reaching resolutions on issues that fall under its purview.

On behalf of the Departmental Committee on Administration and National Security, pursuant to provisions of Standing Order 200 A(1), it is my pleasant privilege and honour to present to this House the Committee's exit report.

  - iv. To study, access and analyze the relative success of the Ministries and departments as measured by the results obtained as compared with their stated objectives;
  - v. To investigate and inquire into all matters relating to the assigned Ministries and departments as they may deem necessary, and as may be referred to them by the House;
  - vi. To vet and report on all appointments where the Constitution or any law requires the National Assembly to approve, except those under Standing Order No. 204 (Committee on appointments);
  - vii. To examine treaties, agreements and conventions;
  - viii. To make reports and recommendations to the House as often as possible, including recommendation of proposed legislation;
  - ix. To consider reports of Commissions and Independent Offices submitted to the House pursuant to the provisions of Article 254 of the Constitution; and
  - x. To examine any questions raised by Members on a matter within its mandate.
- 2. In accordance with the Second Schedule of the Standing Orders, the Committee is mandated to oversee the following areas:
  - i. National Security
  - ii. Police Services
  - iii. Home Affairs
  - iv. Public Administration
  - v. Public Service
  - vi. Prisons
  - vii. Immigration





# **2.4 INQUIRIES**


18. The Committee undertook three inquiries during the Twelfth Parliament-

(Col) (Rtd) Geoffrey King'ang'i, MP and pursuant to the National Assembly Standing Orders No. 216 (5) (e) which gives the Committee the mandate to investigate and inquire into all matters on which the journalists, residents and him were harassed, beaten and arrested, and whether the government intends to pursue the false/trumped-up charges against them.
- b) The Committee through a Statement sought by Hon. Charles Kamuren, MP pursuant to the National Assembly Standing Orders No. 216 (5) (e) which gives the Committee the mandate to investigate and inquire into all matters on insecurity in Baringo South Constituency.
- c) Inspection tour of police stations in Nairobi and Kajiado Counties to access their preparedness in the management of Covid 19.

#### 2.5 QUESTIONS

19. A total of two hundred and thirty six (236) Questions were referred to the Committee for response during the Twelfth Parliament. Two hundred and twenty five were responded to through written

#### PART THREE

#### **3 IMPACT OF THE BUSINESS TRANSACTED BY THE COMMITTEE**

Some of the impact that the Committee's work had to the country include:

- 25. The Departmental Committee on Administration and National Security conceptualised and approved various sums of money towards the Public Service Internship programme in 2018. The programme is an initiative designed to offer the opportunity for graduates to acquire and develop valuable technical and professional skills as well as work experience in the Public Service. Through the Programme, the interns are exposed to gain life-skills and values such as integrity, transparency\_and accountability, which are essential for national transformation, patriotism, and citizen honesty. Over the last medium term, the programme has recruited 18,000 interns. It is expected that the graduates of the programme are prioritised for public service jobs whenever such vacancies occur. It is from this initiative that the Committee appropriates at least KSh. 1 billion towards this programme. Going forward, there will be need for the next 13<sup>th</sup> parliament to double the allocation to enable the Commission to improve on the number of interns being recruited based on the thousands of applications they receive every year. Averagely, the Commission receives 20,000 applications but only recruit 3,000 due to resource constraints.
- 26. Clearance of pending Bills: The Departmental Committee on Administration and National Security through the supplementary I of FY 2020/21 appropriated resources amounting to KSh. 6.2 billion towards clearing pending bills for the State Department for Correctional Services. The Department over the years had accumulated pending bills which could not be paid through the normal budgetary allocation of settling such bills. The appropriation of such bills in 2020 was therefore part of stimulus programme which saw several suppliers get paid at a time the economy was choking from the effects of COVID-19 pandemic. However there seems to have been fictitious payments which the 13<sup>th</sup> parliament needs to inquire on how the KSh. 6.2 billion was utilised.
- 27. Increasing the strength of Police and Prisons Service: Over the period under review, the National Police Service recruited over 20,000 police officers across the three services of Kenya Police, Administration Police and the Directorate of Criminal Investigation Services. This was made possible through the Committee's initiative of sourcing resources from other areas which were not initially provided by the National Treasury.
- 28. Decentralization of Counselling Services: Due to rising cases of mental illness within the National Police Service, the Committee through the examination of Annual Estimates of Expenditure cumulatively appropriated KSh. 200 million over the period under review and helped the National Police Service Commission decentralize the services from Nairobi to a further 8 regions within the country.
- 29. Completion of ultra -modern complex at KSG Mombasa: The Committee appropriated cumulatively KSh. 600 million towards the stalled KSG in Mombasa. The completion of such critical project has seen the school increase its revenue through enhanced AIA.

30. Enhanced operations of the Directorate of Criminal Investigations Department: - the Committee from time to time enhanced the operations of investigative agencies such as DCI through additional resource allocation to the Service. This period has seen the DCI be on the forefront in the war against economic crimes where several suspects have been prosecuted.

# 4 REASON WHY THE COMMITTEE HAD SOME PENDING BUSINESS AND THE END OF THE $12^{\mbox{\tiny TH}}$ PARLIAMENT

The Committee experienced the following challenges which made it difficult for it to optimally discharge its mandate:

- 1. Unavailability of Government officials when invited for meetings to consider business before the Committee. This made it difficult for the Committee to discharge its mandate effectively.
- 2. The COVID-19 pandemic affected the frequency of meetings and it made it difficult to meet stakeholders to prosecute matters before the Committee. This affected the Committee's efficiency in the execution of its mandate.
- 3. Inadequate committee meeting rooms and furniture occasionally led to delays in starting meetings and at times cancellation of meetings.
- 4. Difficulty in raising quorum because of the 2022 General Elections especially in Sixth Session slowed down activities of the Committee.
