#### Stakeholders

In examining the Bill, the Committee invited the Minister of State for Immigration and Registration of Persons to give his views on the proposals. The Minister, having initiated the drafting of the Bill was optimistic that issues touching on Kenyan Citizens, whether resident in the country or abroad, had been addressed and articulated properly in the proposed legislation.

#### The Constitution

Issues on rights of citizens were not adequately addressed in the former Constitution. The quest for dual citizenship was a subject matter to many Kenyans before the promulgation of the new Constitution. Chapter three of the Constitution deals with matters of Citizenship. The passage of this Bill shall bring into reality some inalienable rights which many Kenyans have yearned for in a long time.

#### Procedural motion

Though there was a procedural motion to reduce the number of days of publication of the Bill, from fourteen to two, pursuant to Standing Order 107, and again to waive the Bill from being referred to the

relevant Departmental Committee, the Committee on Administration and National Security resolved to examine the Bill and present a report to the House.

The Committee proposes the following amendments to the Kenya Citizenship and Immigration Bill, 2011.

#### PART III - CITIZENSHIP

#### 1. Clause 10

THAT Clause 10 of the Bill be amended in sub-clause (1) by deleting the words "before the effective date of the Constitution".

#### PART V – PASSPORTS AND OTHER TRAVEL DOCUMENTS

#### 2. Clause 31

THAT Clause 31 of the Bill be amended in sub-clause (5) by deleting the word "withdraw" and substituting therefor the words "suspend or confiscate".

#### PART VI – IMMIGRATION CONTROLS

#### 3. Clause 33

THAT Clause 33 of the Bill be amended in sub-clause (2) -

- (a) by renumbering paragraphs (g) and (h) as sub-clauses (3) and (4), respectively;
- (b) by renumbering sub-clauses (3), (4), (5) (6) as sub-clauses (5), (6), (7), and (8), respectively.

#### 4. Clause 40

THAT Clause 40 of the Bill be amended-

- (a) in sub-clause (3) by deleting the word "undesirable" and substituting therefor the word "inadmissible";
- (b) in sub-clause (6) by deleting the words "forty five days" and substituting therefor the words "fourteen days";

(c) in sub-clause (8) by deleting the words "ninety days" and substituting therefor the words "fourteen days";

#### 5. Clause 49

THAT Clause 49 of the Bill be amended in sub-clause (5) by deleting the opening statement and substituting therefor the following new statement-

(5) The Court shall not order the release of a permanent resident or a foreign national unless satisfied that the permanent resident or foreign national shall present himself on being required to do so by an immigration officer or a police officer and taking into account the following factors-

#### 6. Clause 53

THAT Clause 53 of the Bill be amended in sub-clause (1) by inserting the words "or inadmissible person" immediately after the words "prohibited immigrant" appearing in paragraph (c).

#### PRELIMINARY

The Chairman called the meeting to order. After prayers, brief introductions and opening remarks were made. The Chair informed the Minister and his team that the Kenya Citizenship

and Immigration Bill 2011, was already before the House awaiting First Reading. The Committee had resolved to make its input to the Bill despite the waiver of referral of the Bill. He then invited the Minister to make key highlights of areas he thought required amendments.

### MIN. NO. 274 /2011 - MEETING WITH THE MINISTER OF STATE FOR IMMIGRATION AND REGISTRATION OF PERSONS

The Minister proceeded with key highlights of the Kenya Citizenship and Immigration Bill, 2011. The Bill was meant to repeal the current Immigration Act with its genesis being article 12, Chapter 3 of the constitution which stipulates over the rights of citizens. Previously the right of citizens to identification cards and passports was not enshrined in the Constitution.

The Committee heard that the notable new features the Bill sought to introduce were;

- Confiscation of ID's and Passports be dealt with only by an Act of Parliament.
- Provision for widows and widowers (section 12).
- Dual citizenship as per article 16 of the Constitution.
- Permanent residency status (section 37).
- Provision for stateless persons and their descendants (section 15 17).
- Citizenship of children found in Kenya (section 9).

The Chairperson of the Taskforce on the Bill proposed the following amendments;

- Section 2 on interpretation, in defining "inadmissible person" as a person declared under section 33(2) and not 34(2).
- Section 10, the words "before the effective date of the Constitution" be deleted.
- Section 12, the last subsection (3) be renumbered (4).
- Section 31(3), should refer to subsection (2).
- Section 31(5), the word "withdraws" is replaced by "confiscate".
- Section 33(2) (g) and (h), are numbered as (3) and (4) respectively and the following subsections are renumbered accordingly.
- Section 40 (1) be deleted.
- Section 49 (5), the word "unless" replaced by "if".
- Section 53 (1) the words "or inadmissible person" added after the words "prohibited migrant".

The Chairman thanked the team for having done various consultations on the Bill, including foreign visits, public hearings, and video conferencing with Kenyans in the Diaspora. However the Chair noted that the Committee should have been invited to such forums.
