#### 1.1 Establishment and Mandate of the Committee

  - f) vet and report on all appointments where the Constitution or any law requires the National Assembly to approve, except those under Standing Order No.204 (Committee on appointments);
    - a. (fa) examine treaties, agreements and conventions;
  - g) make reports and recommendations to the House as often as possible, including recommendation of proposed legislation;
  - h) consider reports of Commissions and Independent Offices submitted to the House pursuant to the provisions of Article 254 of the Constitution; and
  - i) examine any questions raised by Members on a matter within its mandate.
- 2. In accordance with the Second Schedule of the National Assembly Standing Orders, the Departmental Committee on Sports, Culture and Tourism is mandated to consider the following subjects: Sports, culture, language, arts, national heritage, betting and lotteries, tourism promotion and management.







# 3.0 ACHIEVEMENTS

Some of the impacts that the Committee's work had to the country include:

- 33. The Committee considered the Sports (Amendment) Bill, 2018 which operationalized the Sports, Arts and Social Development Fund which has had the following impact:
  - a) Supports universal health care;
  - b) Funded Harambee Stars participation in the Africa Cup of Nations, Magical Kenya Golf Open in Karen, the World Safari Rally and other sporting activities;
  - c) Has been funding sports infrastructure development e.g. sports stadia which had stalled due to underfunding; and,
  - d) Development of cultural activities in the country and other arts related activities which will highly contribute to the growth of the economy.
- 34. The Committee considered the Anti-Doping (Amendment) Bill, 2020 (National Assembly Bill No. 51 of 2020) which harmonized the legislative framework with the 2021 World Anti-Doping Code and Regulations and aided in the achievement of compliance by Kenya to the internationally adopted Code and facilitated the continued participation of Kenyan athletes in local, regional, and international competitions like the 2020 Olympics in Tokyo, Japan, the World Under 20 Championship, and Continental Tour among other activities while appreciating the relevance of curbing doping in sports.

#### PART FOUR

# 4.0 REASONS WHY THE COMMITTEE HAD PENDING WORK AT THE END OF THE $12^{\text{TH}}$ PARLIAMENT

- 35. The Committee experienced the following challenges which made it difficult for it to optimally discharge its mandate:
  - i. The COVID-19 pandemic affected the frequency of meetings and it made it difficult to meet stakeholders to prosecute matters before the Committee. This affected the Committee's efficiency in the execution of its mandate.
  - ii. Unavailability of Government officials when invited for meetings to consider business before the Committee. This made it difficult for the Committee to discharge its mandate effectively.
  - iii. Unavailability of some Members whose business was referred to the Committee when invited for Committee meetings to consider their Questions or Statements.
  - iv. Difficulty in raising quorum especially during the sixth session because of the 2022 General Elections campaigns slowed down activities of the Committee.
  - v. Inadequate committee meeting rooms and other required facilities occasionally led to delays in starting meetings and at times cancellation of meetings.
