1. THAT National Youth Services (NYS) was registered as a legal entity in 1964 and has been engaging in training of youths in various fields.
2. THAT NYS engaged a number of contractors and suppliers who carried all their works diligently especially during the Presidential Directive on restructuring and rebranding of the National Youth Service and projects on slum upgrading and youth and women empowerment to the organization's satisfaction.
3. THAT, as from 2013 to June 2018, suppliers and contractors genuinely supplied goods and services to NYS of which majority have not been paid to date.
4. THAT, every end of financial year since 2013 to 30th June 2018, there is always a promise to pay contractors and suppliers but to their disappointments, they are never paid.
5. THAT, in the financial year ending 30th June 2019, the President gave a directive to pay all pending bills but during the last week of June, 2019 a list of payables was released by NYS only to realize that most of the genuine contractors and suppliers were not included, and no official communication or reason was granted to the suppliers and contractors not in the payable list despite the fact that NYS is undeniably in custody of goods and services rendered by the suppliers and contractors from the year 2013 to 2018.

6. THAT, NYS suppliers and contractors have experienced grievous economic distress as a result of loss hard earned wealth and properties to auctioneers because of loans, deaths, medical conditions associated with stress, family breakups and shattered irreparable livelihoods.
7. THAT, I/we have made the best efforts to have these matters addressed by the relevant authorities all of which have failed to give a satisfactory response.
8. THAT, none of these issues raised in this Petition is pending in any court of Law, Constitutional or any other legal body.

WHEREFORE, your humble petitioners pray that the Senate-

- (i) Cause for intervention on genuine pending bills and claims for verifiable works and services already rendered with a view of recommending that payment be made without further delay so as to ease the unbearable economic distress on the suppliers and contractors.
- (ii) Physical verification in addition to document audit of goods and services rendered to the institution be instituted to ascertain the genuineness of pending bills/claims for unpaid suppliers and contractors so as to have a closure on this matter once and for all.
- (iii) Ensure that the plight of the Petitioner is addressed, and
- (iv) Make any other order(s) deemed fit on the circumstances of the Petitioners.

4. THAT we have made the best efforts to have these matters addressed by the relevant authorities all of which have failed to give a satisfactory response.



