EXECUTIVE SUMMARY

Mr. Speaker,

Article 245 (1) & 245(2)(a) of the Constitution provides that there is established the Office of the Inspector General, which is an office in the National Police Service. The Inspector General shall be appointed by the President, with the approval of Parliament. The Inspector General shall exercise independent command over the National Police Service, and perform any other functions prescribed by national legislation.

Mr. Speaker, Sir,

After receiving the name of the nominee for the position of the Inspector General on February 1 , 2015 the Speakers of both Houses directed that the vetting of the nominee for appointment to the position of Inspector General of Police shall be conducted jointly by both Houses and in particular the Departmental Committee on Administration and National Security of the National Assembly and Standing Committee on National Security & Foreign Relations of the Senate.

The Joint Committee held two preliminary sittings on Wednesday 18th February 2015 and Wednesday 25th February, 2015 to prepare for the vetting and consider memoranda from the members of the public.

The Joint Committee complied with the Constitutional and legal requirements and established procedures for vetting. It ensured public participation and openness in carrying out the proceedings. Notifications inviting the public to submit memoranda were placed in the mainstream print media on 18th February 2015 in tandem with the law.

On 25th February 2015, the Committee considered two memorandums in which one was recommending the appointment of the nominee and the other one was contesting his appointment.

The Joint Committee conducted the vetting exercise on 26th February 2015 and in conducting the vetting exercise, the joint Committee relied on the provisions of the Constitution, the Public Appointments (Parliamentary Approval) Act No. 33 of 2011), the Standing Orders of the respective Houses and the National Police Service Act 2012.

Mr. Speaker, Sir,

The Committee made several observations during the vetting exercise, key among them being the fact that Article 245(2)(a)of the Constitution read together with section 12(1) and section 12(2) of the National Police Service Act, 2011 (as amended by the National Police Service (Amendment) Act, 2014 and the Security Laws (Amendment) Act, 2014), gave the President discretion in the exercise of nomination for appointment of a candidate to the post of the Inspector-General of the National Police Service.



The Joint Committee's recommendation was solely based on the evidence and information from the proceedings of the Committee during the vetting exercise. The Joint Committee recommended that, having considered the suitability, capacity and integrity of the nominee, and pursuant to Article 245(2)(a) of the Constitution and Section 8 (2) of the Public Appointments (Parliamentary Approval) Act No. 33 of 2011, the Committee recommends that Parliament approves the nomination and subsequent appointment of Mr. Joseph Kipchirchir Boinett to the position of the Inspector-General of the National Police Service.

Parliament:: Joint Report of the Departmental Committee on Administration and National Security of the National Assembly and the Standing Committee on National Security & Foreign Relations of the Senate on the vetting of Mr. Joseph Kipchirchir Boinett, nominee for the position of Inspector General- National Police Service February, 2015.

GHAPTER ONE: BACKGROUND

Article 243 (1) of the Constitution stipulates that there shall be established the National Police Service. The objects and functions of the National Police Service are set out in Article 244 of the Constitution.

Article 245(1) of the Constitution provides for the establishment of the Office of Inspector-General of the National Police Service. The appointment of the Inspector-General of Police is contained in Article 245(2)(a) of the Constitution. The said Article provides for the appointment of the Inspector-General with the approval of Parliament.

The office of the Inspector-General of the National Police Service fell vacant after the immediate former holder Mr. David Kimaiyo, resigned on 2nd December, 2014 and tendered his resignation to His Excellency the President.

On 11th February 2015, His Excellency the President pursuant to Article 245 (2) (a) of the Constitution as read with Section 12 (2) of the National Police Service Act 2011 as amended by the Security Laws (Amendment) Act, 2014 vide his letter Ref. OP.CAB.1/32/10A nominated Mr. Joseph Kipchirchir Boinett to the position of the Inspector- General of the National Police Service.

On 17th February, 2015, pursuant to Standing Orders 41 (1) & 42 (1) the Speakers of the Senate and the National Assembly respectively conveyed a message to both Houses from H.E. the President that Mr. Joseph Kipchichir Boinett had been nominated to serve in the position of the Inspector General National Police Service.

The procedure of engagement for the Joint Committee was set out in recognition of the Standing Orders of both Houses and the requirements of the Public Appointments (Parliamentary Approval) Act, 2011 and it was resolved that the approval hearing shall proceed as follows-

- (i) The vetting process will therefore, be conducted by the Standing Committee on National Security and Foreign Relations of the Senate and the Departmental Committee on Administration and National Security of the National Assembly;
- (ii) That, the Chairpersons of the two committees will Co-Chair the joint sittings and the Secretariat will comprise officers of the two Houses;
- (iii) That, the quorum of the joint sittings will be the respective quorums of each of the committees as stipulated by the respective Standing Orders;
- (iv) That, as contemplated under Rule 9(6) of the Joint Rules, unless a decision is reached by consensus, any vote to be taken in the joint sitting of the committees shall be by separate Houses. This will ensure that the numerical difference of the individual members representing the Houses in the joint sittings has no effect on the decisions of the joint sittings of the Committees; and
- (v) That, the Committees shall, having conducted the vetting hearings, submit a Joint Report to the respective Houses in the manner contemplated by paragraph (7) of Joint Rule 9.



CHAPTER TWO: LEGAL FRAMEWORK FOR APPOINTMENT TO THE OFFICE OF THE INSPECTOR- GENERAL OF THE NATIONAL POLICE SERVICE.

Articles 245(1) and 245(2)(a) of the Constitution of Kenya, 2010 provides for the establishment of the office of the Inspector-General of the National Police Service, who shall be appointed by the President with the approval of Parliament.

The National Police Service, Act No. 11 of 2011, as amended by the National Police Service (Amendment), Act No. 11 of 2014 and the Security Laws (Amendment), Act No. 19 of 2014 sets out the functions, powers and qualifications for appointment to the office of Inspector- General of the National Police Service, while the Public Appointments (Parliamentary Approval) Act provides for the procedures for parliamentary approval of Constitutional and statutory appointments.

2.1 Functions and Powers of the Inspector- General of the National Police Service

Sections 10(1) and 10(4) of the National Police Service Act sets out the functions and powers of the Inspector- General as follows:-

- 2.1.1 Section 10 (1): The functions of the Inspector-General shall be to-
- (a) implement policy decisions;
- (b) audit of police operations and functioning;
- (c) co-ordinate all police operations;
- (d) advise the Government on policing matters and services;
- (e) prepare budgetary estimates and develop a policing plan before the end of each financial year, setting out the priorities and objectives of the service and the justification thereof;
- (f) determine the establishment and maintenance of police stations, posts, outposts, units or unit bases in the county and determine the boundaries of the police stations, outposts or unit bases;
- (g) determine the distribution and deployment of officers in the Service and recommend to the Commission and the County Policing Authorities;
- (h) organize the Service at national level into various formations, units or components;
- (i) recommend the establishment of, manage and maintain training institutions, centers or places for the training of officers joining the service and other officers;
- (j) commission research and benchmark against best practices;
- (k) issue guidelines on community policing and ensure co-operation between the Service and the communities it serves in combating crime;
- (l) provide the command structure and system of the Service for the efficient administration of the Service nationally;
- (m) subject to the Constitution and this Act. or any written law, cooperate with and implement the decisions of the Independent Policing Oversight Authority;



- (n) designate any police station, post, outpost, unit or unit base as a place of custody;
- (o) promote co-operation with international police agencies;
- (p) establish and devolve the services of the Internal Affairs Units that are able and equipped to conduct investigations into police misconduct in a fair and effective manner and report directly to the Inspector-General;
- (q) monitor the implementation of policy, operations and directions of the Service;
- (r) issue and document Service Standing Orders;
- (s) cooperate with other public or private bodies to provide reliable police statistics on crime rates, detection rate, public confidence in the police, number of complaints against the police, as well as personnel statistics;
- (t) act on the recommendations of the Independent Policing Oversight Authority, including compensation to victims of police misconduct; and
- (u) perform any other lawful act on behalf of the Service.
- 2.1.2 Section 10 (4): The Powers of the Inspector General
- (a) have all the necessary powers for the performance of such functions; and
- (b) uphold the national values, principles and objects set out in Articles 10, 232 and 244 of the Constitution.
- 2.2 Qualifications for Appointment to the Office of the Inspector General Sections 11(1) and 11(3) of the National Police Service Act, 2011 sets out the qualifications of a person for appointment to the office of the Inspector-General of the National Police Service as follows:-

Section 11(1)

A person shall be qualified for appointment as Inspector-General if such person;-

- (a) is a citizen of Kenya;
- (b) holds a degree from a university recognized in Kenya;
- (c) has had a distinguished career in their respective fields;
- (d) meets the requirements of Chapter Six of the Constitution;
- (e) has served in a senior management position for at least fifteen years and has knowledge and experience in matters relating to any of the following discipline;-
 - (i) criminal justice;
 - (ii) policy development and implementation;
 - (iii) finance and public administration;
 - (iv) strategic management;
 - (v) security;
 - (vi) law;
 - (vii) sociology; or
 - (viii) Government.



Section 11(3)

No person shall be qualified for appointment as Inspector-General or Deputy Inspector-General if the person-

- (a) is a member of Parliament or a county assembly, a Governor or Deputy Governor;
- (b) has served as a member of Parliament, county assembly, trade union or an office in a political party in Kenya in the preceding five years;
- (c) has previously been convicted of any criminal offence;
- (d) has violated the Constitution; or
- (e) is an undischarged bankrupt.

2.3 Procedure for Appointment of the Inspector -General of the National Police Service Section 12 of the National Police Service, Act No. 11 of 2011 as amended by section 11 of the National Police Service (Amendment), Act No. 11 of 2014 and section 86 of the Security Laws (Amendment) Act No. 19 of 2014 provides for the procedure for the appointment of the Inspector-General of the National Police Service. The Security laws (Amendment) Act, 2014 amended section 12(2) of the National Police Service Act and deleted sections 12(3),12(4),12(5) and 12(6).

Section 12(1)

Pursuant to Article 245(2)(a) of the Constitution, the Inspector-General of the Service shall be appointed by the President with the approval of Parliament.

Section 12(2)

The President shall, within fourteen days after a vacancy occurs in the office of the Inspector-General, nominate a person for appointment as an Inspector-General and submit the name of the nominee to Parliament.

Section 12(7)

If Parliament approves the nominee, the President shall, within seven days after receiving the notification to that effect, by notice in the Gazette appoint the nominee as the Inspector-General of the National Police Service.

Section 12(8)

Where Parliament rejects the nominee submitted by the President, the Speaker of the National Assembly shall communicate its decision to the President and request for a fresh nominee.

2.4 Submission of the name of the Nominee by the President

After the President submits to Parliament the name of the nominee for the position of the Inspector-General of Police, Parliament is then guided by the Public Appointments (Parliamentary Approval) Act and the Standing Orders of both Houses. Sections 5, 7 and 8 of the Public Appointments (Parliamentary Approval) Act provides that-



Section 5

- (1) An appointing authority shall, upon nominating a person for an appointment to which this Act applies, notify the relevant House of Parliament accordingly.
- (2) A notification under subsection (1) shall be—
 - (a) in writing;
 - (b) be lodged with the Clerk of the relevant House of Parliament.
- (3) A notification of appointment shall be accompanied by information concerning the nominee, having regard to the issues mentioned in section 7.
- (4) For purposes of this Act, a notification of nomination shall be deemed to be duly given on the day on which it complies fully with subsections (2) and (3).

Section 7

The issues for consideration by the relevant House of Parliament in relation to any nomination shall be;-

- (a) the procedure used to arrive at the nominee;
- (b) any constitutional or statutory requirements relating to the office in question; and
- (c) the suitability of the nominee for the appointment proposed having regard to whether the nominee's abilities, experience and qualities meet the needs of the body to which nomination is being made.

Section 8

- (1) Unless otherwise provided in any law, a Committee shall consider a nomination and table its report in the relevant House for debate and decision made within fourteen days from the date on which the notification of nomination was given in accordance with section 5.
- (2) At the conclusion of an approval hearing, the Committee shall prepare its report on the suitability of the candidate to be appointed to the office to which the candidate has been nominated and shall include in the report, such recommendations as the Committee may consider necessary.



CHAPTER THREE: VETTING PROCESS

3.1 Message from His Excellency the President

On 17th February, 2015, pursuant to Standing Orders 41(1) and 42(2) the Speakers of the Senate and the National Assembly respectively conveyed a message to both Houses from H.E. the President that Mr. Joseph Kipchichir Boinett had been nominated to serve in the position of the Inspector General National Police Service. Article 245 (2) (a) confers upon the President the power to nominate and subject to approval by Parliament, appoint the Inspector General.

The name of the nominee and his curriculum vitae was thereafter forwarded to the Joint Committee on Administration and National Security of the National Assembly and the Standing Committee on National Security and Foreign Relations of the Senate to conduct approval hearings.

3.2 Clearance Requirements

Following the receipt of the communication from the Speakers of both the National Assembly and the Senate to the Joint Committees, the Clerks wrote several letters to relevant institution seeking information on the nominee as listed below;

The nominee was also required to present his certificates, letters of clearance and compliance from the above organizations.

3.3 Notification to the Nominee

On 18th February, 2015, the Clerks of the National Assembly and the Senate, pursuant to Section 6(3) of the Public Appointments (Parliamentary Approval) Act (No. 33 of 2011), notified the nominee of the time and place for holding the approval hearing.

3.4 Notification to the Public

On 18th February, 2015, the Committee, through the Clerks of both Houses, placed a notification in the print media informing the general public of the intention of Parliament to conduct an approval hearing, as provided for by Article 118 (1) and (2) of the Constitution, Standing order 198 (1) of the National Assembly, Standing order 202 (1) of the Senate and Section 6(4) of the Public Appointments



(Parliamentary Approval) Act, 2011, which allow public participation in Committee proceedings. The notification gave provision for the submission of memoranda, on the suitability or otherwise of the nominee, by Tuesday, 24 February, 2015, at 5.00pm.

Section 6(9) of the Public Appointments (Parliamentary Approval) Act No. 33 of 2011, provides that "any person may, prior to the approval hearing, and by written statement on oath, provide the Clerk with evidence contesting the suitability of a candidate to hold the office to which the candidate has been nominated".

3.5 Committee Meetings

In execution of its mandate, the Committee had 5 meetings i.e two pre vetting meetings to prepare for the vetting exercise on 18th and 25th February 2015, carried out the vetting exercise on Thursday 26th February, 2015 and two meetings to prepare the report on the vetting exercise and adoption o the report on Monday 2nd and Tuesday 3rd March 2015 respectively.



CHAPTER FOUR: SUBMISSIONS

At the close of business on Tuesday, 24th February, 2015, the Joint Committee through the Office of the Clerk of the National Assembly was in receipt of two submissions in respect of the nomination of Mr. Joseph Kipchirchir Boinett as the Inspector - General of the National Police Service. These were from;-

- (a) Mr. Wycliffe Nyakina Gisebe, National Identity Card No. 13569487, Tel. No: 0722 916 397; and
- (b) Mr. Jason Kamweru, P.O. Box 7805-00100, Nairobi. Tel. No: 0719 816 288

4.1 Memorandum from Mr. Nyakina Wycliffe Gisebe

The memorandum was a written statement on oath (affidavit) by Nyakina Wycliffe Gisebe (the Deponent) contesting the appointment of Mr. Joseph Kipchirchir Boinett as the nominee to the position of Inspector General-National Police Service.

The memorandum sought to draw the attention of the Joint Committee to the following issues:

- (a) That where Mr. Joseph Kipchirchir Boinett is appointed as the Inspector General of Police, he will be in command of his seniors, who possess more experience in terms of their experience: contrary to the values and principles of public service requiring fair competition and merit as the basis for appointment contained under Article 232(g)(h) & (i). (paragraph 8)
- (b) That the President's nomination of Mr.Joseph Kipchirchir Boinett is a violation of Article 246(3)(a) of the Constitution, which places the role of conducting recruitment and appointment of members of the National Police Service in the hands of the National Police Service Commission. (paragraph 17)

The memorandum recommended that:

- (a) the Joint Committee rejects the nomination of Mr. Joseph Kipchirchir Boinett and
- (b) the recruitment and appointment of the Inspector General of Police be conducted afresh under Articles 10, 27, 47, 73, 75, 232, 245 and 246 of the Constitution and section 14 (a) of the National Police Service Commission (Act).

4.2 Submission from Mr. Jason Kamweru

The letter was a written statement supporting the appointment of Mr. Joseph Kipchirchir Boinett as the Inspector General of Police.

The letter states that;-

- (a) the author knows the Nominee personally and worked with the Nominee for three (3) years between 2005 and 2008 in Zimbabwe where the nominee was stationed as an officer at the Kenyan High Commission;
- (b) the nominee is a person who possesses qualities of integrity and patriotism; and
- (c) the author recommends the nominee for appointment as the Inspector General of Police.



CHAPTER FIVE: VETTING OF MR. JOSEPH KIPCHIRCHIR BOINETT.

On Thursday 26th February 2015, Mr. Joseph Kipchirchir Boinett appeared before the Joint Committee on Administration and National Security of the National Assembly and the National Security and Foreign Relations of the Senate for the approval hearing for the position of Inspector-General of the National Police Service. In conducting the Approval hearing, the Joint Committee was guided by the Constitution, the National Police Service Act, 2011, the Public Appointments (Parliamentary Approval) Act No. 33 of 2011 and the Standing Orders of the respective Houses.

The Committee also considered the following in vetting the nominee:

- a. Academic qualifications
- b. Employment record and work experience
- c. Professional association
- d. Public office, political activities and affiliations
- e. Potential conflict of interest
- f. Suitability to the position
- g. Tax compliance
- h. Integrity

Personal Background

The nominee was born in Keiyo in 1962 and is married with four children.

Educational Background

He holds two Master of Arts degrees in Security Policy from Australian National University, Canberra and in Diplomatic Studies from University of Westminster United Kingdom; a Bachelor of Arts degree in International Studies and Diplomacy from Washington International University.

Professional Courses

The nominee attended the following Professional courses-

- 3. He was seconded by the External division of the National Intelligence Service to serve as the Deputy Chief of Protocol in Ministry of Foreign Affairs between 2009 and 2012.
- 4. He served as a Principal Analyst in the Analysis & Production Division of the National Intelligence Service between 2008 and 2009.
- 5. He also served at the Head Quarters of the External division of the National Intelligence Service between 2004 and 2008.
- 6. He served as a station officer in the External division of the National Intelligence Service between 2003 and 2004 based in Harare, Zimbabwe.
- 7. He also served in the Chief Liaison Office of the External division of the National Intelligence Service a between 2001 and 2003.
- 8. He served in the External division of the National Intelligence Service as a station officer based in Rome between 1996 and 2001.
- 9. He has also worked in the Directorate of Security Intelligence (DSI) between 1986 and 1996.
- 10. He served as a Cadet inspector in the Kenya Police between 1984 and 1986.



KEY ISSUES ARISING FROM THE VETTING PROCESS

The nominee informed the Committee of the following key issues which he would deal with, if appointed to the position of Inspector-General of the National Police Service –

1. Personal Plan and Vision

The nominee stated that his objective would be to provide collaborative leadership and engage in meaningful dialogue with National Security Agencies, create partnership with the Kenyan people and revamp the police reform processes, to enhance security. He further stated that he would also engage the relevant agencies to access necessary resources to acquire modern equipment, including aircrafts for the National Police Service.

2. Corruption

On corruption, he stated that he would revitalize the Internal Affairs Unit within the National Police Service to act as the police of the police in curbing corruption within the Service. He also promised to work closely with the Ethics and Anti –Corruption Commission and the Independent Police Oversight Authority in investigating and taking action on corrupt police officers. He further pointed out that he would use the experience he had acquired during the course of diplomatic service and extensive travel in many countries such as Singapore, Malaysia and China to tackle corruption in the National Police Service.

3. Measures to Improve Security

The nominee stated that he would enhance the capacity of police officers through the acquisition of equipment such as amoured personnel carriers, police aircrafts; relevant training for officers and ensuring that the digitalization process of the police command and control system was fast tracked to enhance communication. He further stated that he would improve the terms and conditions for police officers to avoid high turnover within the Service. The nominee also promised to firmly deal with the problem of re-emergence of outlawed criminal groups and use a people centred approach and alternative dispute resolution mechanisms to tackle the perennial problem of cattle rustling.

On the issue of police outposts in remote areas that have few police officers, the nominee promised to rationalize the posting of police officers and institute measures to ensure that police officers have the right training and equipment to effectively serve in all stations in the Country. He stated that he would get rid of the culture where postings to hardship areas are conducted as punishment to officers.

4. Coordination Among Security Organs and Agencies

The nominee acknowledged that there was ineffective sharing of intelligence between the National Intelligence Service and the National Police Service. He pointed out that having served in both agencies, he would serve as an interlinkage, to improve the working relationship of the two organs and streamline the sharing of intelligence and initiation of



 timely measures to thwart security threats. He emphasized on the need to inculcate intelligence led policing to avoid the police being a reactive Service.

On the police command structure in the Counties, the nominee stated that he would apply the law to create a command structure that efficiently serves the citizens.

5. Previous Experience in Security Sector

The nominee observed that having served in the Police service, the National Intelligence Service and the Diplomatic Service, he would seek to utilize the local, regional and international experience to improve service delivery in the National Police Service.

6. Command and Control

The nominee appreciated the existence of the problem between the Regular Police and Administration Police over their mandate and stated that he would ensure collaboration of the two, without encroaching on each other's mandate. He further stated that he would approach the Joint Committee in the event of any gap in legislation.

7. Police Brutality

The Nominee appreciated that the law was clear on demonstrations and confirmed that the Police are allowed to use force proportionate to a threat faced during demonstrations but this should not be equated as an authorization of the use of brutality by police. He stated that the law should be enforced against protestors who use violence against the police and vice versa.

8. Education

Upon inquiry, the nominee informed the Committee that he had obtained an online degree in International Studies and Diplomacy from Washington University. He opted for this mode of study as he was stationed in Italy.



CHAPTER SIX: COMMITTEE'S OBSERVATIONS

After conducting the vetting exercise, the Committee made the following observations-

- 1. On the Memorandum by Nyakina Wycliffe Gisebe ,the Committee observed that Article 245(2)(a) of the Constitution read with sections 12(1) and 12(2) (as amended), of the National Police Service Act, 2011, gave the president discretion in the exercise of nomination for appointment of a candidate to the post of the Inspector-General of the National Police Service.
- 2. There was no evidence to suggest that the President did not take into consideration, and observe the provisions of Article 232(g),(h) and (i) of the Constitution (providing for fair competition and merit as the basis for appointment in public service), in exercising his powers of discretion, before nominating the candidate to the position of Inspector General of the National Police Service.
- 3. The National Police Service Commission's role of recruitment preceding the appointment of the Inspector-General of the National Police Service was scrapped of by an amendment to
 - a) Section 12(1) of the National Police Service Act by section 11 of the National Police Service (Amendment) Act, 2014 and
 - b) Section 12(2) of the National Police Service Act by section 86 of the Security Laws (Amendment) Act, 2014.
- 4. The Nominee was cleared by the Credit Reference Bureau, the Higher Education Loans Board, Directorate of Criminal Investigations, Kenya Revenue Authority and the Ethics and Anti-Corruption Commission, therefore making him fit to hold public office as per the requirements of Chapter Six of the Constitution.
- 5. The Nominee had the necessary experience and qualifications to hold the office of th Inspector-General of the National Police Service as per the requirements of the National Police Service. Act No. 11 of 2011.
- 6. The Nominee demonstrated considerable knowledge of topical issues in the Security sector, having worked in the Police, Intelligence and Diplomatic sectors.
- 7. That Washington International University is recognized by UNESCO despite not being recognized in its country of origin. This observation was made upon clarification from the Chief Executive Officer of the Commission for University Education.



CHAPTER SEVEN: COMMITTEE'S RECOMMENDATION

The Committee made the following recommendation:

That, having considered the suitability, capacity and integrity of the nominee, and pursuant to Article 245(2) of the Constitution and Section 8 (2) of the Public Appointments (Parliamentary Approval) Act No. 33 of 2011, the Committee recommends that Parliament approves the nomination and subsequent appointment of Mr. Joseph Kipchirchir Boinett to the position of the Inspector-General of the -National Police Service.

i. That the President's nomination of Mr. Boinett is a violation of the Article 246(3)(a) of the Constitution, which places the role of conducting recruitment and appointment of members of the National Police Service in the hands of the national Police Service Commission. (paragraph 17)

The memorandum recommended that:

- i. the Joint Committee rejects the nomination of Joseph Kipchirchir Boinett and
- ii. the recruitment and appointment of the Inspector General of Police be conducted afresh under Articles 10, 27, 47, 73, 75, 232, 245 and 246 of the Constitution and section 14 (a) of the National Police Service Commission (Act).

Letter from Jason Kamweru

The letter was a written statement supporting the appointment of Joseph Kipchirchir Boinett as the Inspector General of Police.

MIN.NO.11 /NSFR/ANS/2015 - PRELIMINARIES

The meeting was called to order at ten o'clock with a prayer by Sen. Fatuma Dullo. The agenda of the meeting was adopted having been proposed by Hon. Mohamed Shidiye, MP and seconded by Sen. Godana Hargura.

An oath was administered to the nominee for the position of the Inspector General of the National Police Service by Mr. Boniface Lenairoshi before the vetting exercise began.

MIN.NO.12 /NSFR /ANS/2015 - VETTING OF THE NOMINEE FOR THE POSTION OF INSPECTOR GENERAL OF THE NATIONAL POLICE SERVICE

The Joint Committee was briefed on the nominee's background, academic qualifications, employment record, compliance with statutory requirements, integrity and suitability for the position as follows:

(a) Background

The nominee was born in Elgeyo Marakwet County in 1963. He attended Arap Moi Primary School and Kipkabus Secondary School.

(b) Professional Experience

The nominee joined the National Police Force in 1984 having been impressed by the standing of security officers in society. He was trained as a cadet for nine months before being posted to Muranga Police Station as the Officer In-Charge of petty crime.

(c) Clearance Certificates

Mr. Boinett is tax compliant and he had a certificate from the Kenya Revenue Authority to that effect. He also produced a clearance certificate from the Higher Education Loans Board and he had not been a beneficiary of the fund. He had requested for a clearance certificate from the Ethics and Anti-Corruption Commission which the Commission forwarded to Parliament.

(d) Nominee's service in National Police Service, National Intelligence Service and Diplomatic Community

The nominee emphasized that he was equal to the task of being the Inspector General if cleared by the Committee. He cited the fact that the nomination was made in consideration of his attributes, academic and professional training as well as his experience in the security sector. The nominee stated that he had served for fifteen years in the then Police Force and served for sixteen years in the Intelligence service. His postings in the Intelligence Service were served in both Kenya and abroad including stints in Harare and Rome. The nominee cited his service in diplomatic intelligence as having exposed him to working with and understanding people from different cultures and his experience in

different jurisdictions would serve him well if he was to be confirmed as the next Inspector General.

(e) Nominee's understanding of the mandate of the Inspector General

The nominee stated his understanding of the core duties of the Inspector General as being in command of the National Police Service, implementing policies set by the National Security Council and the Cabinet Secretary and auditing police operations to ensure compliance with law. He also mentioned organizing police into various formations, structures and units, cooperating with the National Police Service Commission with regards to human resource functions and implementation of community policing as some of the core duties of the Inspector General.

(f) Respect for Human rights

Mr. Boinett stressed his intention to ensure policing is done within the law if confirmed as the next Inspector General. He also confirmed that he intends to respect and coordinate with both levels of government and ensuring human rights are respected.

(g) Personal Plan and Vision

The nominee confirmed that the National Police Service was not delivering to the satisfaction of Kenyans. He attributed this to poor working conditions and some officers operating outside the provisions of law. Mr. Boinett stated his plans to revamp and reenergize the police reform process to provide people centered policing to Kenyans. He plans to do this by exercising collaborative leadership within the Service to incorporate ideas of police from all ranks on how to conduct better policing, engaging with the other organs of security in the country and partnering with the Kenyan people to safeguard the country. The nominee also stated his intentions to see to it that terms and conditions for police officers are improved.

(h) Plan to curb corruption

Mr. Boinett confirmed his intention to confront the entrenched culture of impunity, abuse and corruption among police regardless of the consequences. To address corruption, the nominee declared his intention to revamp the Internal Affairs Unit of the Police and the Independent Policing Oversight Authority and stamp out the vice.

(i) Utilization of resources

The efforts of the government to improve the working conditioned of the Police were acknowledged by the nominee. He stated his intention to ensure that resources provided are utilized in an efficient manner to avoid wastage.

(j) Police officers working in hardship areas

The nominee confirmed his intention to ensure officers working in hardship areas have the necessary training and tools to serve in such areas. He stated his plan to ensure officers serve in such areas for set durations and get rid of the culture where postings to hardship areas are conducted as punishment to officers.

(k) County Policing Authority

The nominee would fast-track the formation of County Policing Authorities if confirmed as the new Inspector General, to enable police undertake their mandate more effectively.

(l) Sharing of intelligence

The nominee stated his experience as a police officer and an intelligence officer would be useful in addressing the perceived breakdown in intelligence between the National Police Service and the National Intelligence Service. He attributed such breakdown to suspicion and lack of understanding of roles between the two institutions. He promised to inculcate intelligence-led policing to avoid police being reactive.

(m) Coordination among security organs

The nominee confirmed his intention to ensure compliance with the law to address command and control glitches within the Service. He acknowledged the existence of the problem but stated that the law was clear on the mandate of the Service and he would ensure collaboration between the Regular Police and the Administration Police without encroaching on each other's mandate. If confirmed, the nominee stated his intention to approach the Committee to address any gap in legislation with regards to command and control.

(n) Police brutality

Mr. Boinett emphasized that demonstrations are provided for in law. He confirmed that police are allowed to use force proportionate to any threat faced during demonstrations but this did not mean use of brutality by police. He stated that the law must be enforced against protestors who use violence against the police as well as police who use brutality against protestors.

(o) Police Reforms

The nominee stated his intention to have the Ransley recommendations on police reform implemented.

(p) Nominee's bachelors degree education

The nominee confirmed that he undertook his undergraduate degree online from the Washington International University while serving as an Intelligence Officer. He undertook his Masters degree fulltime at the Westminster University in London.

The Co-Chairpersons thanked the nominee for answering the vetting questions put to him in a candid manner. He stated the task ahead was herculean for the nominee if confirmed as the next Inspector General of Police. The Co-Chairman cited challenges such as lack of clear command, lethargy among police officers, corruption, acting on intelligence and the terror threat as some of the urgent matters that need addressing.

The Co-Chairpersons stated that the joint Committee would deliberate on the suitability of the nominee to serve as the next Inspector General before submitting reports to both houses of Parliament. The process would lead to the confirmation or rejection of the nominee to the position.

The Co-Chairpersons also confirmed that the Committee would confirm the validity of the nominee's academic certificates during deliberations on the nominee's suitability.

(i) The Committee observed that Article 245(2)(a)of the Constitution read with sections 12(1) and 12(2) (as amended), of the National Police Service Act, 2011, gave the president discretion in the exercise of nomination for appointment of a candidate to the post of the Inspector-General of the National Police Service.

- (ii) There was no evidence to suggest that the President did not take into consideration, and observe the provisions of Article 232(g),(h) and (i) of the Constitution (providing for fair competition and merit as the basis for appointment in public service), in exercising his powers of discretion, before nominating the candidate to the position of Inspector General of the National Police Service.
- (iii) The National Police Service Commission's role of recruitment preceding the appointment of the Inspector-General of the National Police Service was scrapped of by an amendment to
 - a) Section 12(1) of the National Police Service Act by section 11 of the National Police Service (Amendment) Act, 2014 and
 - b) Section 12(2) of the National Police Service Act by section 86 of the Security Laws (Amendment) Act, 2014.

The minutes of the third sitting were also confirmed as a true record of the proceedings having been proposed by Hon. Timothy Wanyonyi Wetangula, MP and seconded by Sen. Godana Hargura.

MIN.NO. 17/NSFR /ANS/2015 - CONSIDERATION OF FIRST DRAFT OF THE REPORT

The joint Committee was taken through the first draft of the report by Mr. Boniface Lenairoshi. The Committee raised the following matters regarding the draft report:

- (i) There was a clarification that the nominee did not indicate in his curriculum vitae that he attended St. Paul's University. A member of the joint Committee had raised the matter during the vetting exercise, noting that the nominee had attended the said university which was allegedly not accredited by the Commission for University Education.
- (ii) The procedure for the appointment of the Inspector General of the National Police Service provided was within the law with regards to the timelines to be considered when a vacancy occurs in the office of the Inspector General. Section 12 (1) of the National Police Service Act providing that the appointment be done within fourteen days after the vacancy occurs was enacted after the resignation of the previous Inspector General and the timelines did not apply in this case.
- (iii) The annexure should include the questions asked during the vetting exercise.
- (iv) The procedure used to set up the joint committee was in order as pronounced by the two Speakers of Parliament.
- (v) The Committee amended the title of Chapter 5 to read "vetting" instead of "approval hearing".

The Committee resolved to adjourn until 3.00 pm to seek consensus on whether to reject or approve the nominee.

MIN.NO.20/NSFR/ANS/2015 CONSIDERATION OF THE INSPECTOR GENERAL NOMINEE VETTING REPORT.

The Chairman led the members through chapter seven of the report on the recommendation of the nominee to the position of Inspector General of the National Police Service. He noted that certain concerns had been raised touching on the validity of the Bachelors degree certificate of the nominee and invited Members to share their views on the same. The following issues emerged from the discussion:

- The Commission on University Education had been contacted on 26th February, 2015 by the secretariat to verify the validity of the undergraduate degree certificate of the nominee. The committee was waiting for feedback from the Commission.
- It was imperative that the Bachelors degree be from an accredited university recognized in Kenya in order to qualify the recognition of the nominee's Masters degrees.

3. A member alluded that an undergraduate degree certificate was not very essential, as some professional cadres such as national administrators would be permitted to enroll for a masters degree, by having a diploma and the value of their professional experience converted under a recognized point system.

4. It was observed that some successful career persons were not degree holders, thus the degree emphasis was not a major determinant of performance.

5. It was noted by a Member that the integrity of the nominee would be put in doubt if the undergraduate certificate was found to be invalid. However another member felt that it was not an integrity issue.

6. The transcript of the nominee raised further doubt to the extent that the nominee had had exemptions from his high school. It was observed that some educational systems especially in Europe, permitted such exemptions.

7. The members were asked to consider the professional certification the nominee had acquired which could amount to an equivalent of a degree.

8. It was noted that the joint vetting had a mandate to work within the confines of the Constitution that only gave a minimum of a degree from recognized institution as part of the basic criteria for the nominee of the inspector General position.

Members agreed to take a thirty minutes break at thirty minutes past four in the evening. Thus resume at five o'clock.

• The letter to the Commission on University Education seeking to establish the validity of the nominee's Bachelors degree was written on 27th February, 2015 and not 26th February, 2015 under Minute number 20 (1).

- Minute number 20 (2) be expunged as the matter was a repetition of Minute number 20 (8)
- Minute number 20 (4) be expunged from the Minutes of the fifth sitting.
- Minute number 20 (7) be expunged from the Minutes of the fifth sitting.
- Minute number 20 (8) be amended to refer to The National Police Service Act and not the Constitution of Kenya.

MIN.NO. 25/NSFR /ANS/2015 – ADOPTION OF THE REPORT ON THE VETTING OF THE NOMINEE FOR THE POSITION OF INSPECTOR GENERAL OF THE NATIONAL POLICE SERVICE

The Chairperson confirmed that the Committee was in receipt of a letter from the Commission for University Education regarding the validity of the nominee's academic qualifications. The Committee had also invited the Chief Executive Officer of the Commission to expound on the nominee's academic qualifications.

The Committee was taken through the letter from the Commission for University Education regarding the validity of the nominee's academic qualifications. The letter noted that the Australian National University and the University of Westminster are recognized in their respective home countries of Australia and the United Kingdom respectively. The foreign qualifications are therefore recognized in Kenya by convention as they are recognized in their countries of operation.

The letter however noted that Washington International University is not recognized by the Council for Higher Education Accreditation (CHEA) which is the American equivalent of the Commission of University Education. The University is also not recognized by the Distance Education and Training Council (DTEC) in the USA which is the body responsible for accreditation of institutions in the country.

The CEO of the Commission for University Education was invited to clarify on matters raised in the letter. An oath was administered to the CEO by Mr. Boniface Lenairoshi. The CEO clarified that:

- Section 5 (1) (g) of the Universities Act provides for the function of the Commission to recognize and equate degrees. Recognition is done through a reciprocal protocol. If the University is recognized in the country of origin, Kenya recognizes it and vice versa. Equation is done by looking at the time and qualifications of the University and equating it to qualifications in Kenya. The letter from Parliament sought to find out about the recognition of Washington International University in Kenya.
- An indication that a university is not recognized is written in block letters (NOT) as per protocol.
- The network of international recognition is paperless and all the information is found on websites.
- Authentification of certificates of academic qualification can only be done by the issuing institution and not the Commission for University Education.
- Washington International University is recognized by UNESCO despite not being recognized in its country of origin. The Statutes Law Miscellaneous Amendment Act of

2014 made amendments to the Universities Act in November 2014 and provided for the following new sub-section as a function of the Commission for University Education:

(c) promote, advance, publicize and set standards relevant in the quality of university education including the promotion and support of internationally recognized standards

This new sub-section provides that the Commission can promote and support internationally recognized standards. Taking cognizance of this, the recognition of academic qualifications from Washington International University by UNESCO falls under internationally recognized standards and can therefore be recognized in Kenya.

- You can acquire a Masters degree without an undergraduate degree. A person with a CPA
 (K) can be admitted to undertake a Masters in Finance in Universities in the United
 Kingdom. The decision to admit a student based on qualifications is a reserve of the
 respective University's senate.
- Work experience can be converted to credit hours when considering qualifications for admittance to undertake a certain course.

The Committee resolved by consensus to approve the nomination and subsequent appointment of Mr. Joseph Kipchirchir Boinett to the position of the Inspector-General of the National Police Service.



Pursuant to the provisions of Standing Order 41(1) of the Senate, I wish to convey a Message from H.E the President asking Parliament to approve one, Joseph Kipchirchir Boinett for appointment as the Inspector-General of Police. In the Message, H.E. the President conveys that, in exercise of powers vested in him under Article 245(2)(a) of the Constitution and section 12(2) of the National Police Service Act (No. 11A of 2011) as amended by the Security Laws (Amendment) Act, 2014, he nominates Joseph Kipchirchir Boinett for appointment to the position of the Inspector General of Police.

Honourable Senators, Article 245(2)(a) of the Constitution states-

"The Inspector-General is appointed by the President with the Approval of Parliament."

Further, section 12 of the National Police Service Act (No. 11A of 2011) as amended by section 11 of the National Police Service (Amendment) Act 2014 and further amendment by section 86 of the Security Laws (Amendment) Act 2014 states, and I quote:

- "12(1) Pursuant to Article 245(2)(a) of the Constitution, the Inspector-General of the Service shall be appointed by the President with the approval of Parliament.
- (2) The President shall, within fourteen days after a vacancy occurs in the office of the Inspector-General, nominate a person for appointment

as an Inspector-General and submit the name of the nominee to Parliament"

Honourable Senators,

You may recall that the approval of appointment of the immediate former Inspector-General of Police was granted by the National Assembly acting as Parliament as contemplated under paragraph 11 of the sixth schedule to the Constitution.

I wish, therefore, to note that this is the first time that the two Houses of Parliament are required to approve the appointment of a candidate to a public office and therefore, as you can expect in such situation, there are grey areas or uncharted waters with respect to processes. However, as Senators are aware, the Houses of Parliament are not helpless as the Speakers are empowered to deal with such scenarios.

Consequently, in order for Parliament to effectively conduct the vetting process, the Speaker of the National Assembly and I have consulted on the best way of facilitating Parliament to discharge this important duty. In the interest of economy, efficiency and cognizant of the Standing Orders of both Houses and the requirements of the Public Appointments (Parliamentary Approval) Act, 2011 we have agreed to proceed as follows-

- (i) That, the vetting of the nominee for appointment as Inspector-General of Police shall be conducted jointly by the Committees of the two Houses mandated to deal with matters of national security. The vetting process will therefore, be conducted by the Standing Committee on National Security and Foreign Relations of the Senate and the Departmental Committee on Administration and National Security of the National Assembly;
- (ii) That, the Chairpersons of the two committees will Co-Chair the joint sittings and the Secretariat will comprise officers of the two Houses;
- (iii) That, the quorum of the joint sittings will be the respective quorums of each of the committees as stipulated by the respective Standing Orders;
- (iv) That, as contemplated under Rule 9(6) of the Joint Rules, unless a decision is reached by consensus, any vote to be taken in the joint sitting of the committees shall be by separate Houses. This will ensure that the numerical difference of the individual members representing the Houses in the joint sittings has no effect on the decisions of the joint sittings of the Committees; and
- (v) That, the Committees shall, having conducted the vetting hearings, submit a Joint Report to the respective Houses in the manner contemplated by paragraph (7) of Joint Rule 9.

Honourable Senators,

Section 8 (1) of the Public Appointments (Parliamentary Approval) Act, 2011 states-

"Unless otherwise provided in any law, a Committee shall consider a nomination and table its report in the relevant House for debate and decision within fourteen days from the date on which the notification of nomination was given in accordance with section 5."

Section 9 of the Act further states-

"If, after expiry of the period for consideration specified in section 8, Parliament has neither approved nor rejected a nomination of a candidate, the candidate shall be deemed to have been approved."

In this regard, the period on the matter that is now before Parliament starts running tomorrow, and in order to facilitate the commencement of deliberations, the first sitting will be held in the Main Committee Room in County Hall on Wednesday, February 18, 2015 at 9.30 a.m. They should Table the joint Report on or before Thursday, February 26, 2015 to enable the Houses of Parliament to dispose of the report in good time.

This Message therefore, together with the résumé of the nominee stands committed to the Standing Committee on National Security and Foreign Relations of the Senate sitting jointly with the Departmental Committee on Administration and National Security of the National Assembly.





Pursuant to the said Article of the Constitution and the provisions of the Act, Mr. Joseph Kipchirchir Boinett has been nominated for appointment to the position of Inspector-General of Police.

Following the receipt of the nomination from H.E the President, the following two committees of Parliament are mandated to jointly vet, consider his suitability for pointment and submit their Joint report to the respective Houses for approval.



Dear Clerk of Parliament

RE: Vetting of Inspector-General of Police

Further to your invitation to the public to present information that could help the relevant vetting committee of Parliament on the appointment of the Inspector General of Police (IG), I wish to submit the following:

- 1. My name is Jason Kamweru, currently working as a Public Debt Management expert with the African Development Bank
- 2. I have known Mr. Joseph Boinnet personally and professionally, having lived with him in Zimbabwe from 2005 to 2008, where he was working in the Kenya High Commission, and I with the Commonwealth Secretariat as a regional public debt management advise in charge of eight countries in Eastern and Southern Africa. We have remained good friends since.
- 3. Having known Mr. Boinnet over the last ten years, I can attest that he is a hardworking, honest, reliable and disciplined individual. During the time he was in charge of consular affairs at the Kenya High Commission in Zimbabwe, he assisted many Kenyans in need, including going out of his way to assist those who required visas to travel to other countries, such as South Africa. He was always ready to put in a good word to his counterparts in other embassies and high commissions, if he assessed and satisfied himself that the applicant had valid and genuine reasons to travel to these countries. I witnessed on many occasions Mr. Boinnet using his personal resources to assist stranded Kenyans who turned up at the Kenya High Commission.
- 4. Mr. Boinnet served all who needed assistance without prejudice and was always polite and civil. As a result, he was one of the most respected diplomats in the High Commission by the Kenyan community and citizens of other countries, especially those from East Africa.





- 5. I want to cite events that made me have exceptional respect for Mr. Boinnet. In 2007, after the PEV broke out, the Kenyan community in Zimbabwe became deeply divided along ethnic lines. Almost all embassy officials were supporting one side or the other depending on their ethnicity. It did not help matters that the then High Commissioner failed to show leadership and openly displayed his bias to one camp. Given the mood in the country, it was expected that Mr. Boinnet, being a Kalenjin, would be biased and stand in solidarity with his people and defend the events unfolding in the Rift Valley. Mr. Boinnet remained the voice of reason throughout the crisis and was deeply affected by the violence. He invited me, a Kikuyu, on many occasions, and we had lengthy discussions and I can attest he showed genuine concern and anger at the violence that was unfolding in the country. This made me have extraordinary respect for Mr. Boinnet.
- 6. In my view, the most important qualities that a candidate for the position of IG requires are integrity and patriotism. I can attest that Mr. Boinnet has clearly demonstrated that he has these qualities.
- 7. My plea to the committee is to recommend Mr. Joseph K. Boinnet for appointment as the Inspector General of Police.

AFFIDAVIT

I, <u>NYAKINA WYCLIFE GISEBE</u>, of National Identity Card Number 13569487; Mobile Phone Number 0722 916 397, a citizen of Kenya resident in Nairobi City County, do hereby solemnly make oath and state as follows:

1. THAT I am an adult male of sound mind, aware of the matters in issue and hence competent to swear this affidavit on my own

behalf as an interested member of the public of the public

- 2. THAT I am a Human Resource expert, and the Secretary General of the Association of Human Resource Practitioners of Kenya.
- 3. THAT I swear this Affidavit in good faith pursuant to the advertorial the Parliament of Kenya published on Page 44 of the Daily Nation newspaper, on Wednesday, February 18, 2015, inviting interested members of the public to submit, by 5.00 pm on Tuesday, 24th February, 2015, any representations by written statement on oath (affidavit) on the suitability or otherwise of the nominee for appointment to the position of the Inspector General of the National police Service (hereinafter, the IG).
- 4. THAT I swear this affidavit to oppose H. E. the President's irregular nomination of Mr Joseph Kipchirchir Boinett, for Parliament's approval for appointment as the IG.
- 5. THAT I recognise that the National Police Service is the centre pole of the nation as regards enforcing law and order to protect lives and property.
- 6. THAT I am concerned that the recruitment and appointment of the all-important Inspector General of the National Police Service is NOT being done strictly according to the law.
- 7. THAT I am disturbed that His Excellency the President has, in breach of the National Police Service Act 2012, and of the Constitution of Kenya, secretly and singlehandedly nominated

Mr. Joseph Kipchirchir Boinett to be vetted by Parliament for appointment, upon approval, as the Inspector General of Police.

- 8. THAT I have investigated and confirmed that H. E. the President's irregular nomination of the relatively junior Mr. Boinett for the Inspector General's position will catapult him to the apex of the National Police Service, where he will be in command of his seniors.
- 9. THAT I am alarmed that the security of the aforesaid Republic will be compromised under Mr. Boinett's command because, being a disciplined force where seniority is paramount, a revolt in the rank and file of the National Police Service will naturally ensue to reject the imposition at the apex of the service of a junior officer who, to make matters worse, had left the police many years ago and joined the National Intelligence Service;
- 10. THAT I am fearful that the irregular nomination of Mr. Boinett has taken away the independence and the security of tenure of the IG.
- 11. THAT I am disgusted that the constitutional obligation on the National Police Service Commission to recruit and appoint persons to hold or act in offices in the National Police Service has effectively been rubbished by the unconstitutional actions and/or omissions of H. E. the President.
- 12. THAT Kenya is a constitutional democracy, where the sovereign people have made the Constitution the supreme law.

- 13. THAT the Constitution prescribes the values and principles of governance and, frequently, the procedures in accordance with which power must be exercised.
- 14. THAT every person, including His Excellency the President, is bound to perform their functions in accordance with the Constitution.
- 15. THAT Article 4(2) of the Constitution declares that "The Republic of Kenya shall be a multi-party democratic State founded on the national values and principles of governance referred to in Article 10."
- 16. THAT Article 10 declares that the national values and principles of governance which bind all State organs, State officers, public officers and all persons, include patriotism, national unity, the rule of law, democracy and participation of the people, equity, social justice, inclusiveness, equality, human rights, non-discrimination, good governance, integrity, transparency and accountability.
- THAT whereas Article 145(2)(a) states that "The Inspector General is appointed by the President with the approval of Parliament;" Article 246(3)(a) qualifies it further by stating that "The [National Police Service] Commission shall recruit and appoint persons to hold or act in offices in the service, confirm appointments, and determine promotions and transfers within the National Police Service."

- 18. THAT whereas on the one hand "appointment" is a shared function between the President and the Commission, on the other hand, "recruitment" is the exclusive function of the Commission.
- 19. THAT recruitment involves identifying individuals who are suitable for appointment, usually through the advertising of vacancies for interested candidates to apply; conducting interviews with the participation of the people; and shortlisting eligible candidates who can then be nominated for appointment.
- 20. THAT as a Human Resource professional, I understand a nomination, under the National Police Service Act and the Constitution to be the action of suggesting or proposing a person by name, from a list of eligible candidates already recruited by the police Service Commission, as a candidate for an office in the service.
- 21. THAT the President's nomination of Mr. Boinett without his being recruited by the Commission is a gross violation of Article 246(3)(a).
- 22. THAT Article 245(2)(b) states that "The Inspector General shall exercise independent command over the National Police Service, and perform any other functions prescribed by national legislation."
- 23. THAT unless the appointment of the Inspector General is itself independent and seen to be independent, there is no way the

product on an illegal process can be independent under the law.

- 24. THAT Article 246(2)(b) lists the Inspector-General of the National Police Service as a member of the National Police Service Commission which is an Independent Commission.
- 25. THAT it will be a violation of Article 248(2)(j), which declares the Commission to be independent, for the Inspector General who is not recruited and appointed through a competitive process to serve as a commissioner.
- of Police is in violation of Article 232(g), which states that "The values and principles of public service include— fair competition and merit as the basis of appointments and promotions."
- THAT the nomination of Mr. Boinett to be the Inspector General, in a process where other qualified Kenyans were not given a chance to compete is contrary to Article 27, which declares: "(1) Every person is equal before the law and has the right to equal protection and equal benefit of the law.

 (2) Equality includes the full and equal enjoyment of all rights and fundamental freedoms."
- 28. THAT the handpicking of Mr. Boinett to be the Inspector General of police is inconsistent with Section 14(a) of the National Police Service Act 2011, which states that:

"In the entire recruitment and appointment process of the Inspector-General or Deputy Inspector-General, the Commission, Parliament and President, as the case may be, shall— (a) comply with the values and principles set out under the Constitution, and in particular, Article 10, 27 and 232 of the Constitution."

- 29. THAT I am reasonably apprehensive that His Excellency's hand is being forced in the matter herein by political leaders from the community of the former Inspector General, Mr. David Kimayo, who have been loud in demanding that his replacement must be their kinsman.
- 30. THAT in the circumstances the nomination of Mr. Boinett as the Inspector General of Police amount to replacing merit with patronage, and entrenching tribalism and political chauvinism in the appointment of the inspector general of the national police service which is contrary to the law.
- 31. THAT the evident tribal considerations in his appointment, following public demands by politicians from his home region that the outgoing Inspector General be replaced by his tribesman, are inconsistent with:

Article 246(4) of the Constitution, which states that:

"The composition of the National Police Service shall reflect the regional and ethnic diversity of the people of Kenya."

Article 232(1)(h & i) of the Constitution, which states that:

- "(h) representation of Kenya's diverse communities; and (i) affording adequate and equal opportunities for appointment, training and advancement, at all levels of the public service, of—
- (i) men and women; (ii) the members of all ethnic groups; and (iii) persons with disabilities."

Article 73(1) which states that:

"(1) Authority assigned to a State officer— (a) is a public trust to be exercised in a manner that— (i) is consistent with the purposes and objects of this Constitution; (ii) demonstrates respect for the people; (iii) brings honour to the nation and dignity to the office; and (iv) promotes public confidence in the integrity of the office; and (b) vests in the State officer the responsibility to serve the people, rather than the power to rule them.

Article 73(2) which states that:

"(2) The guiding principles of leadership and integrity include— (a) selection on the basis of personal integrity, competence and suitability, or election in free and fair elections; (b) objectivity and impartiality in decision making, and in ensuring that decisions are not influenced by nepotism, favouritism, other improper motives or corrupt practices; (c) selfless service based solely on the public interest,

demonstrated by— (i) honesty in the execution of public duties; and (ii) the declaration of any personal interest that may conflict with public duties; (d) accountability to the public for decisions and actions; and(e) discipline and commitment in service to the people.

- 32. THAT I am aware that there has not been full disclosure about Mr. Boinett's academic background to show his strong educational foundation, especially at Secondary School level, for appointment as the Inspector General of Police.
- 33. THAT the recruitment phase gives the Commission the chance to test all requirements of suitability which candidates for the office of Inspector General must have.
- 34. THAT in the circumstances of the nomination of Mr. Boinett, there is no evidence of due diligence having been conducted to gauge his suitability for the job.
- THAT the decision to handpick and nominate Mr. Boinett as the IG is not procedural, reasonable, lawful and/or fair within the meaning of Article 47(1) & (2) of the Constitution as it is devoid of due diligence. Hence, the nomination is contrary to the right to fair administrative action under article 47 of the Constitution. Similarly, the appointment of the 3rd Interested Partyas the Acting IG is contrary to Article 47.
- 36. THAT H. E. the President's decision to secretively and singlehandedly nominate Mr. Boinett as the Inspector General, without reference to the National Police Service Commission,

and without the participation of people, offends best practice and the express and clear provisions of the Constitution, and is irregular, unreasonable, irrational, unlawful and, therefore, unconstitutional, null and void, *ab initio*.

- 37. THAT the rules of natural justice require that the process of appointing the Inspector General of the National Police Service should be independent, competitive, and insulated from any possibility of compromise by the appointing authority.
- 38. THAT the time has come for the Parliament of Kenya to intervene and respect, uphold and defend the Constitution of the Republic of Kenya.
- 39. THAT I urgently demand that the recruitment and appointment of the Inspector General of the National Police Service should be done in strict adherence to the clear and elaborate recruitment and appointment procedure spelt out in the Constitution in Articles 10, 27, 47, 73, 75, 232, 245, and 246, and in Section 14(a) of the National Police Service Commission 2011 (Amended).
- 40. THAT in view of the above, and pursuant to Parliament's duty to promote and safeguard constitutionalism and the rule of law, I verily believe that it is now incumbent upon this Honourable Committee of the House to reject the nomination of Mr. Boinett, and protect both statute and the Constitution, and to leave no doubts in the minds of many that the law will henceforth be applied with certainty.

41. THAT what is deponed to herein is true to the best of my knowledge save what has been deponed to on information and belief the sources and grounds whereof have been respectively specified.
