#### CHAIRPERSON'S FOREWORD

) **1** 

On Tuesday 22<sup>nd</sup> August, 2023 the Committee noted and deliberated on the contents of a Communication from the Kenya Rural Roads Authority to Regional Directors regarding reduction of projected funding ceilings to the Constituency Roads from 22% to 15% and to the Critical Roads from 10% to 6.8%, in the Financial Years 2024/25 and 2025/26.

The Committee resolved to invite the Director General for the Kenya Rural Roads Authority and the Director General for the Kenya Roads Board to a meeting to deliberate on the matter.

In the afternoon sitting of the same day (Tuesday, 22<sup>nd</sup> August, 2023), while rising on a point of order, the Member for Nyando, Hon. Jared Okello, M.P raised the matter in House and sought the direction of the Honourable Speaker. The Honourable Speaker directed that the Leader of the Majority Party follows up on the matter and responds before the House.

The Leader of the Majority Party, Hon. Kimani Ichungwah, M.P subsequently issued a Statement to the House in the afternoon Sitting of Thursday, 24<sup>th</sup> August, 2023. In his statement, he read a submission by the Cabinet Secretary for Roads and Transport, Hon. Kipchumba Murkomen, which indicated that the lower ceiling issued to KeRRA was made under caution to safeguard the Authority from early procurement of works and the resulting pending bills that may arise if the county governments are funded.

The Leader of the Majority Party also informed the House that the matter was now before the Departmental Committee on Transport and Infrastructure and the Committee would consider the matter further and report back to the House.

The Committee via letter Ref. NA/DDC/TI/2023/072, dated 28<sup>th</sup> August, 2023, invited the Directors for KeRRA and KRB to a meeting on 6<sup>th</sup> September, 2023. However, Director General for KRB via a letter Ref. No. KRB/DG1/A VOL.II (214) dated 1<sup>st</sup> September, 2023 requested that the meeting be rescheduled to a later date. He however The Director General made a written submission. The Director General for KeRRA also via a letter Ref. KeRRA/ 05/1/VOL.II (673) dated 5<sup>th</sup> September, 2023 requested that the meeting be rescheduled that the meeting be rescheduled but concurred with submissions from KRB.

The Committee having considered the submissions received observed that the 9th National and County Governments Coordinating Summit held in February 2023 in Naivasha resolved that the RMLF allocation to the counties would be given consideration in the Financial Year 2024/2025 through a restructured process. Implementation of the resolution would entail amendment of the Kenya Roads Board Act, 1999 which has not been done. The Committee also observed that the Communication by the Kenya Roads Board on the lower ceilings was only cautionary to prevent resulting pending bills that may arise in the event that county governments are funded in the Financial Year 2024/25 and 2025/26. The allocations for the Financial Year 2023/24 have not and will not be affected by the Communication.

The Committee therefore recommends that Section 6 of the Kenya Roads Board Act, 1999 provides for the allocation from the Roads Maintenance Levy Fund as follows:

Kenya Rural Roads Authority (KeRRA) - 32% (22% for Constituency Roads & 10% for Critical link roads);

- (i) Kenya Urban Roads Authority (KuRA) 15%;
- (ii) Kenya National Highways Authority (KeNHA) 40%;
- (iii) Kenya Wildlife Service (KWS) 1%;
- (iv) Emergency interventions/Cabinet Secretary 10%; and
- (v) Kenya Roads Board (KRB) Administration 2%).

Further, the Committee recommends that the Director General for the Kenya Rural Roads Authority should with withdraw the Memo to Regional Managers report back to the House within seven (7) days of adoption of this Report.

Pursuant to Standing Order 199, it is my pleasant duty to present the **Report of the Departmental Committee on Transport and Infrastructure regarding the proposed reduction of projected ceilings for Kenya Rural Roads Authority for the Financial Years 2024/25 and 2025/26.**

#### **1.0 PREFACE**

#### **1.1** Introduction and Committee Mandate

- The Departmental Committee on Transport and Infrastructure is established under the National Assembly Standing Orders No. 216 (1). The functions and mandate of the Committee as per Standing Orders, No. 216(5) include:
  - a) To investigate, inquire into, and report on all matters relating to the mandate, management, activities, administration, operations and estimates of the assigned ministries and departments;
  - b) To study the programme and policy objectives of Ministries and departments and the effectiveness of their implementation;
  - c) To study and review all the legislation referred to it;
  - d) To study, access and analyze the relative success of the Ministries and departments as measured by the results obtained as compared with their stated objectives;
  - e) To investigate and inquire into all matters relating to the assigned Ministries and departments as they may deem necessary, and as may be referred to them by the House;
  - f) To vet and report on all appointments where the Constitution or any law requires the National Assembly to approve, except those under Standing Order No.204 (Committee on appointments);
  - g) To make reports and recommendations to the House as often as possible, including recommendation of proposed legislation;
  - h) To consider reports of Commissions and Independent Offices submitted to the House pursuant to the provisions of Article 254 of the Constitution; and
  - i) To examine any questions raised by Members on a matter within its mandate.
  - j) To examine treaties, agreements and conventions;

The subject matter of the Departmental Committee on Transport and Infrastructure are stated in the Second Schedule of the National Assembly Standing Orders as follows: Transport, including non- motorized transport and maintenance of Roads, rails, air and marine transport, seaports and national integrated infrastructure policies and programmes and transport safety.

#### CHAPTER TWO: BACKGROUND INFORMATION

2.0 Introduction

- 8. On Tuesday 22<sup>nd</sup> August, 2023 the Committee noted and deliberated on the contents of a Communication from the Kenya Rural Roads Authority to Regional Directors regarding reduction of projected funding ceilings to the Constituency Roads from 22% to 15% and to the Critical Roads from 10% to 6.8%, in the Financial Years 2024/25 and 2025/26.
- 9. The Committee resolved to invite the Director General for the Kenya Rural Roads Authority and the Director General for the Kenya Roads Board to a meeting to deliberate on the matter.
- 10. In the afternoon sitting of the same day (Tuesday, 22<sup>nd</sup> August, 2023), while rising on a point of order, the Member for Nyando, Hon. Jared Okello, M.P raised the matter in House and sought the direction of the Speaker. The Speaker directed that the Leader of Majority follows up on the matter and responds before the House.
- 11. The Leader of the Majority Party, Hon. Kimani Ichungwah, M.P subsequently issued a Statement to the House in the afternoon Sitting of Thursday, 24<sup>th</sup> August, 2023. He read a submission by the Cabinet Secretary for Roads and Transport, Hon. Kipchumba Murkomen which indicated that the lower ceiling issued to KeRRA was made under caution to safeguard the Authority from early procurement of works and the resulting pending bills that may arise if the county governments are funded.
- 12. The Leader of the Majority Party also informed the House that the matter was now before the Departmental Committee on Transport and Infrastructure and the Committee would consider the matter further and report back to the House.
- 13. The Committee via letter Ref. NA/DDC/TI/2023/ 072, dated 28<sup>th</sup> August, 2023, invited the Directors for KeRRA and KRB to a meeting on 6<sup>th</sup> September, 2023. However, Director General for KRB via a letter Ref. No. KRB/DG1/A VOL.II (214) dated 1<sup>st</sup> September, 2023 requested that the meeting be rescheduled to a later date. He however The Director General made a written submission. The Director General for KeRRA via a letter Ref. KeRRA/ 05/1/VOL.II (673) dated 5<sup>th</sup> September, 2023, also requested that the meeting be rescheduled but concurred with submissions from KRB.

#### 2.2 Legal Framework

- 15. The Constitution of Kenya 2010 in part I of the Fourth Schedule, paragraph 18, has assigned the National Government responsibility for the construction and maintenance of national trunk roads, while part II of the Fourth Schedule assigns county governments the responsibility for county roads. The county governments became beneficiaries of the Road Maintenance Levy Fund (RMLF) conditional grant from Financial Year 2015/2016 based on the County Allocation of Revenue Act, 2015. The Kenya Roads Board (KRB), therefore, allocated 15 per cent of RMLF as conditional grant to the county governments for six years from Financial Year 2020/21. Effective Financial Year 2021/22, the maintenance of county roads was incorporated into the equitable revenue share.
- 16. The 9th National and County Governments Coordinating Summit held in February 2023 in Naivasha resolved that the RMLF allocation to the counties would be given consideration in the Financial Year 2024/2025 through a restructured process. To effect the resolution of the Summit, the Intergovernmental Relations Technical Committee convened a meeting on 8th August 2023 at the Kenya School of Government (KSG), where the road sector was expected to restructure the Kenya Roads Board Act or the Road Maintenance Levy Fund Act to include allocations to the county governments and review the road classification to align it with the restructured Act.
- 17. However, the discussion of the meeting was not concluded and, therefore, the Intergovernmental Relations Technical Committee was advised to convene a stakeholders' meeting involving the Council of Governors, CRA and the Ministry of Roads, Transport and Infrastructure, and its affiliate agencies to discuss the above matter further.

#### CHAPTER THREE

#### 3.0 SUBMISSIONS FROM STAKEHOLDERS

18. The Committee received written submissions by the Kenya Roads Board dated 1<sup>st</sup> September, 2023. The Kenya Rural Roads Authority vide a letter dated 5<sup>th</sup> September, 2023 concurred with the submissions by the Kenya Roads Board. The details of the submissions are detailed below:

#### 3.1 SUBMISSION BY THE KENYA ROADS BOARD

- 19. According to the submissions by the Kenya Roads Board and the Statement by the Leader of the Majority Party tabled in the House on 24<sup>th</sup> August, 2023, the legal notice no. 2 of 2016 classified the Country's road network in to National Trunk roads (Class S, A, B & C) and County roads (class D, E, F & G). In this classification KeRRA was given responsibility class C roads.
- 20. As such Counties became beneficiaries from the fund effective 2015/16 financial year based on CARA act, 2015 and instructions from the National Treasury issued on 28<sup>th</sup> August 2015. In this regard KRB allocated 15% of the fund to the Counties as conditional grants for Six (6) years up to 2020/21 financial year. However, effective financial year 2021/22 maintenance of county roads was incorporated into the equitable share and hence KRB stopped the conditional grants from the RMLF to the Counties and reverted to the original formulae as provided for in the KRB Act 1999 (KeRRA 32% (22% & 10%), KuRA 15%, KeNHA 40%, KWS 1%, Emergency interventions/CS 10%, KRB Admin 2%).
- 21. The 9<sup>th</sup> National and County Governments Coordinating Summit held in February 2023 resolved that effective 2024/25 consideration be given to allocate a share of RMLF to Counties through structured process. In order to effect the resolutions of the summit, the Intergovernmental Relations Technical Committee proposed that the Ministry of Roads and Transport amends the KRB Act to provide for allocations to County Governments and review classification of roads to align with amendments. According to the Submission of the Board, **the discussion is still ongoing on this matter**.
- 22. Section 19 of the KRB Act, 1999 requires the Board to communicate to the road agencies at least a year in advance on the projected funding likely to be available for allocation which they are required to prepare their annual roads programme. In these regard the Board issued the projected funding ceiling to KeRRA in July, 2023 reducing the share of Constituency roads allocation to 15% from 22% and Critical link roads from 10% to 6.8%. (Annexure 5)

23. Therefore the lower ceilings issued to KeRRA were made under caution to safeguard the Authority from early procurement of works and the resulting pending bills that may arise in the event that the Counties are funded from the RMLF.

#### CHAPTER FOUR

#### 4.0 **OBSERVATIONS**

24. The Committee having considered the matter observed the following, THAT:

- (1) The 9th National and County Governments Coordinating Summit held in February 2023 in Naivasha resolved that the Roads Maintenance Levy Fund (RMLF) allocation to the counties would be given consideration in the Financial Year 2024/2025 through a restructured process. Implementation of the resolution would entail amendment of the Kenya Roads Board Act, 1999 which has not been done. Article 95 of the Constitution gives the National assembly mandate to enact legislation and determine the allocation of national revenue between levels of government;
- (2) The Communication by the Kenya Rural Roads Authority on the lower ceilings was only cautionary to prevent resulting pending bills that may arise in the event that county governments are funded from the RMLF in the Financial Year 2024/25 and 2025/26. The allocations for the Financial Year 2023/24 have not and will not be affected by the Communication; and
- (3) The Communication Kenya Rural Roads Authority on the lower ceilings is inconsistent with section 6 of the Kenya Roads Board Act, 1999;

#### **CHAPTER FIVE**

#### 5.0 RECOMMENDATIONS

- (1) Section 6 of the Kenya Roads Board Act, 1999 provides that the Board shall allocate funds from the Roads Maintenance Levy Fund as follows:
  - (i) Kenya Rural Roads Authority (KeRRA) 32% (22% for Constituency Roads & 10% for Critical link roads);
  - (ii) Kenya Urban Roads Authority (KuRA) 15%;
  - (iii) Kenya National Highways Authority (KeNHA) 40%;
  - (iv) Kenya Wildlife Service (KWS) 1%;
  - (v) Emergency interventions/Cabinet Secretary 10%; and
  - (vi) Kenya Roads Board (KRB) Administration 2%).

And as long as the Law has not been changed, the position of the Law must be maintained;

- (2) The Director General for the Kenya Rural Roads Authority should with withdraw the Memo to Regional Managers report back to the House within seven (7) days of adoption of this Report;
- (3) Public officers should refrain from issuing communications/ circulars that have legal implication before the approval of Parliament; and
- (4) The Kenya Roads Board expedites release of funds for the Financial Year 2023/24 to the Road Agencies.

## MIN./NO./TI/2023/171: BRIEF BY THE LEGAL COUNSEL ON THE PROPOSED KENYA ROADS BOARD (AMENDMENT) BILL, 2023

The Legal Counsel informed the Committee that the Kenya Roads Board (Amendment) Bill 2023 is sponsored by Hon Wanjiku Muhia, Member of Parliament for Kipipiri Constituency. The Legislative proposal aims to prioritize the allocation of funds based on the specific needs of constituencies, especially those experiencing heavy rainfall, and to establish a limit (in respect to distance) of road work projects awarded to a single contractor to 35 kilometers on the strength that this segmented awarding of road maintenance and development contracts will encourage wider participation from various contractors and thereby promote job creation.

The Legal Counsel informed the Committee that the Committee received a memorandum from the Kenya Law Reform Commission. The Commission raised concerns about the proposal to allocate funds based on rainfall patterns. They pointed out that determining which constituencies experience heavy rains is unclear and challenging. Rainfall is unpredictable and varies yearly, making legislative decisions based on it impractical.

The Commission also submitted that all constituencies need road maintenance, regardless of rainfall, as roads are crucial for economic infrastructure. Focusing solely on rainfall might neglect other road maintenance issues like heavy traffic or wear and tear. Consistently monitoring rainfall across constituencies could be administratively inefficient, delaying road work. Additionally, this approach could lead to misinformation, disputes, and misallocation of funds, with constituencies exaggerating rainfall or road degradation for more funding.

The Kenya Law Reform Commission notes that road maintenance and development require a comprehensive approach, taking into account traffic volume, the importance of the road in regional connectivity, the age of the road, and other external factors. Prioritizing rainfall alone, might be inadvertently ignore other multifaceted needs.

The commission also indicates that while the intent behind the proposal, to address the specific challenges roads in heavy rainfall areas face is understandable, a broader, more comprehensive, and flexible approach might better serve the diverse needs of all constituencies and ensure equitable development.

In respect to the second proposal to limit the award of roadworks contracts for a single contractor to 35 kilometers the Commission raised the following concerns: —

Efficiency: Larger projects benefit from economies of scale. Limiting contracts could increase costs, as larger contractors can streamline operations.

Administrative Burden: Using multiple contractors raises administrative tasks (vetting, oversight, etc.), potentially delaying projects.

**Expertise and Disputes**: Limited contracts might lack expertise; disputes among contractors could arise.

The Commission however proposes that these proposals can be achieved through policy directives administratively and implemented by the relevant government agencies through their procurement processes instead of imposing a limit through legislation which is more tedious to change or amend.

#### MIN./NO./TI/2023/172: COMMITTEE CONCERNS

The Committee raised the following concerns:

The criteria for identifying constituencies prone to heavy rains lack clarity and would be hard to establish, as there is uncertainty about the precise annual rainfall measurements or metrics to employ. Members also noted that rainfall trends are unpredictable and can differ annually and that relying on such variable criteria for legislative decisions might not be practical.

Members also noted that the changing climate patterns could render this legislative approach difficult to implement and it would requiring frequent updates.

Members further labeled the Legislative proposal as discriminatory because it aims to allocate funds according to maintenance needs caused by heavy rainfall in certain areas. Members believe this could introduce bias into resource distribution, which goes against the current practice of distributing funds equally to all constituencies.

As regards the second proposal to limit the award of roadworks contracts for a single contractor to 35 kilometers, the Committee noted that this could be managed administratively and was already being implemented and did not need to be legislated.

#### MIN./NO./TI/2023/173: ANY OTHER BUSINESS

The Committee noted with concern the contents of a Communication from the Kenya Rural Roads Authority to Regional Directors regarding reduction of projected funding ceilings to the Constituency Roads from 22% to 15% and to the Critical Roads from 10% to 6.8%, in the Financial Years 2024/25 and 2025/26.

The Committee has resolved to invite the Director General for the Kenya Rural roads Authority and the Director General for Kenya Roads Board Roads to clarify on the contents of the communication from the Kenya Rural Roads Authority to Regional Directors regarding reduction of projected funding ceilings to the Constituency Roads on 6<sup>th</sup> of September, 2023.


### 1.0 BACKGROUND



The Constitution of Kenya, 2010 assigns the national governmentoresponsibility for construction and maintenance of national trunk roads, while county governments are assigned the responsibility for county roads. Legal Notice No. 2 of 2016 classified the road network into national trunk roads (class S, A, B & C) and county roads (class D, E, F, & G) of which KeRRA is responsible for class C roads.

County Governments became beneficiaries of the Road Maintenance Levy Fund (RMLF) conditional grant with effect from FY 2015/16, based on the County Allocation of Revenue Act (CARA) 2015 and an instruction from the National Treasury issued on 28<sup>th</sup> August 2015. Kenya Roads Board therefore allocated 15% of RMLF as a conditional grant to the county governments for six (6) financial years, up to FY 2020/21. These allocations were based on the CARA Acts that were passed by Parliament annually in subsequent financial years.

The maintenance of county roads was incorporated into the equitable revenue share with effect from FY 2021/2022- bringing an end to the conditional grant under RMLF.



The 9<sup>th</sup> National and County Governments Coordinating Summit held in February 2023 in Naivasha resolved that the RMLF allocation to the counties would be given consideration in the FY 2024/2025 through a restructured process.

To effect the resolution of the summit, Inter-Governmental Relations Technical Committee (IGRTC) convened a meeting on 8<sup>th</sup> August, 2023 at the Kenya School of Government where the following proposals were made:

- i. Ministry of Roads & Transport to review and amend the KRB Act section 6(2)(d) to include allocations to the County Governments.
- ii. Ministry of Roads & Transport to review the classification of roads to align with the amendments proposed in (i).

The discussion of the meeting was not concluded, and it was agreed that IGRTC engages key stakeholders for further discussions.

# 2.0 PROJECTED FUNDING CEILINGS FOR KERRA FOR FY 2024/25 AND 2025/2026

Section 19 of the KRB Act, 1999 requires the Board to communicate to the Road Agencies *at least a year in advance* on the funding likely to be available for allocation in the coming year. Every road agency is then required to submit to the Board an annual roads programme. The Board is further required in accordance with section 35(2A) of the Act to submit a collated annual roads maintenance programme to the National Assembly for approval.

To ensure compliance with the tight budget requirements under the KRB Act, the Board issued projected funding ceilings to KeRRA in July, 2023 as shown in **Table 1** below:

The ceilings issued to KeRRA were based on the assumption that county governments shall receive 15% of the RMLF effective FY 2024/25 as proposed by the 9<sup>th</sup> Summit.

It was noted that in the six financial years (FY 2015/16 to FY 2020/21) that counties received 15% RMLF in accordance with the CARA Act, KeRRA and KURA were allocated 21.8% and 10.2% respectively on a prorated basis. Noting that the road network administered under these two road agencies are within counties, both KeRRA and KURA included county roads in their Annual Roads Work Programmes.

#### RMLF Allocation to KeRRA in FY 2024/25 (Option 2)

The Board shall be guided by the resolution of Parliament as to whether county governments shall receive RMLF funding in FY 2024/25 for maintenance of county roads. In the event otherwise, the ceilings to KeRRA shall be revised upwards as shown below:

If the ceilings were issued based on **Table 2**, then KeRRA and KURA may incur pending bills in the event that county governments become beneficiaries of RMLF, noting that procurement for works commences based on the issued ceilings.

#### 3.0 CONCLUSION

The lower ceilings issued to KeRRA were made under caution, to safeguard the Authority from early procurement of works and the resulting pending bills that may arise in the event that county governments are funded.

Kenya Roads Board shall be guided appropriately by the National Assembly on this matter.

The 9<sup>th</sup> National and County Governments Coordinating Summit held in February 2023 in Naivasha resolved that the RMLF allocation to the counties would be given consideration in the FY 2024/2025 through a restructured process.

To effect the resolution of the summit, Inter-Governmental Relations Technical Committee (IGRTC) convened a meeting on 8<sup>th</sup> August, 2023 at the Kenya School of Government where the following proposals were made:

- i. Ministry of Roads & Transport to review and amend the KRB Act section 6(2)(d) to include allocations to the County Governments.
- ii. Ministry of Roads & Transport to review the classification of roads to align with the amendments proposed in (i).

The discussion of the meeting was not concluded, and it was agreed that IGRTC engages key stakeholders for further discussions.

# 2.0 PROJECTED FUNDING CEILINGS FOR KERRA FOR FY 2024/25 AND 2025/2026

Section 19 of the KRB Act, 1999 requires the Board to communicate to the Road Agencies *at least a year in advance* on the funding likely to be available for allocation in the coming year. Every road agency is then required to submit to the Board an annual roads programme. The Board is further required in accordance with section 35(2A) of the Act to submit a collated annual roads maintenance programme to the National Assembly for approval.

To ensure compliance with the tight budget requirements under the KRB Act, the Board issued projected funding ceilings to KeRRA in July, 2023 as shown in **Table 1** below:

The ceilings issued to KeRRA were based on the assumption that county governments shall receive 15% of the RMLF effective FY 2024/25 as proposed by the 9<sup>th</sup> Summit.

It was noted that in the six financial years (FY 2015/16 to FY 2020/21) that counties received 15% RMLF in accordance with the CARA Act, KeRRA and KURA were allocated 21.8% and 10.2% respectively on a prorated basis. Noting that the road network administered under these two road agencies are within counties, both KeRRA and KURA included county roads in their Annual Roads Work Programmes.

#### RMLF Allocation to KeRRA in FY 2024/25 (Option 2)

The Board shall be guided by the resolution of Parliament as to whether county governments shall receive RMLF funding in FY 2024/25 for maintenance of county roads. In the event otherwise, the ceilings to KeRRA shall be revised upwards as shown below:

The Board issued conservative ceilings to KeRRA and KURA for FY 2024/2025 in light of the developments noted above. If the ceilings were issued based on **Table 2**, then KeRRA and KURA may incur pending bills in the event that county governments become beneficiaries of RMLF, noting that procurement for works commences based on the issued ceilings.

#### 3.0 CONCLUSION

The lower ceilings issued to KeRRA were made under caution, to safeguard the Authority from early procurement of works and the resulting pending bills that may arise in the event that county governments are funded.

Kenya Roads Board shall be guided appropriately by the National Assembly on this matter.
