This is to inform you that on Thursday, the 08th day of June, 2023, during the Afternoon Sitting of the County Assembly of Siaya, vide a resolution of the Assembly, and pursuant to the provisions of Article 181 of the Constitution of Kenya, 2010, Section 33 of the County Governments Act, 2012 as read together with the provisions of Standing Order No. 71 and 72 of the County Assembly of Siaya Standing Orders, approved the motion to remove from office the Deputy Governor of Siaya County, Mr. William Oduol, by way of impeachment.
