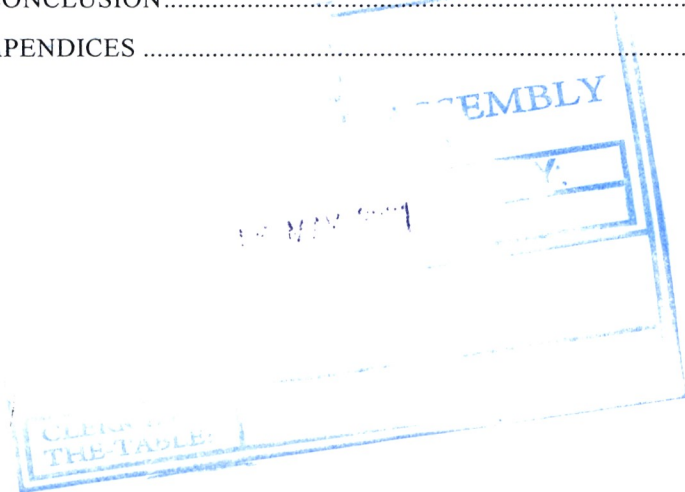

EXECUTIVE SUMMARY

The Constitution of Kenya, 2010 under Article 227 mandates Parliament to enact a legislation to provide for amongst others protection or advancement of persons or categories of persons or groups previously had been disadvantaged by unfair competition. To that end, the Public Procurement and Asset Disposal Act, 2015 (the Act) was enacted and came into force on 7th January, 2016. The Act under Part XII provides for promotion of different forms of preference and reservation in public procurement. Specifically, Section 157 focuses on disadvantaged (women, youth and persons living with disabilities); of which Section 157 (5) further instructs Accounting Officers to ensure they reserve not less than 30% of their procurement spend to the disadvantaged groups.

As consequence, Section 157(12) & (13) of the Act directs all public entities to report to the Authority every six months on the number and value of the contracts awarded to the target groups. In addition, to ensure uniform and consistent reporting, the Authority developed and disseminated templates for reporting by public entities vied PRRA Circular No. 01/2016 of 16th December, 2016.

To ensure compliance with Section 157(14) of the Act, the Authority has analysed and consolidated the reports received from the public entities and hereby submits the report to Parliament for consideration and necessary action. The report is generally organized into three parts: Part One presents with the background information; Part Two presents level of compliance with the requirement to reserve at least 30% and lastly Part Three details the number and value of contracts awarded to the disadvantaged groups.

1. Reporting Status of Procuring Entities

During the reporting period, only **193** procuring entities submitted reports on contracts awarded to enterprises owned by youth, women and PWDs; of which, **165** were from National Government and **28** from the County Governments. The National Government procuring entities comprised of **18** Ministries and State Departments; **101** State Corporations, **37** Universities, Colleges, Polytechnics and Technical Training Institutions and **9** Constitutional Commissions and Independent Offices. The **28** County Governments procuring entities comprised of **19** County Executives and **9** County Assemblies.

This reporting half recorded a **30.41%** increase in the number of procuring entities that submitted reports to the Authority on contracts awarded to the target groups; from **148** in the previous half-year. Majority of the procuring entities have persistently failed to submit reports to the Authority as required by the Act.

2. Reservation of Procurement Spend for the Disadvantaged Groups

During the reporting period, **193** procuring entities from National Government and County Governments that reported, cumulatively planned to spend Kes. **79,158,620,780.15** on procurement of goods, works and services. Of this amount, Kes. **19,473,288,069.16** was reserved for procurement of goods, works and services from firms owned by youth, women and PWDs. This represents an average reservation of **24.60%** of the cumulative planned annual

procurement spend. This implies that a majority of the procuring entities at both levels of Government reserved less than the required minimum of 30%.

Similarly, National Government and County Governments made average percentage reservation of 22.73% and 30.52% respectively. On average, none of the categories of procuring entities, reserved at least the required minimum of 30%. The figure below presents the average level of reservation and absorption of the procurement spend by different categories of procuring entities. The level of reservation and absorption by Ministries and State Departments was not estimated due to incomplete disclosure by the procuring entities.

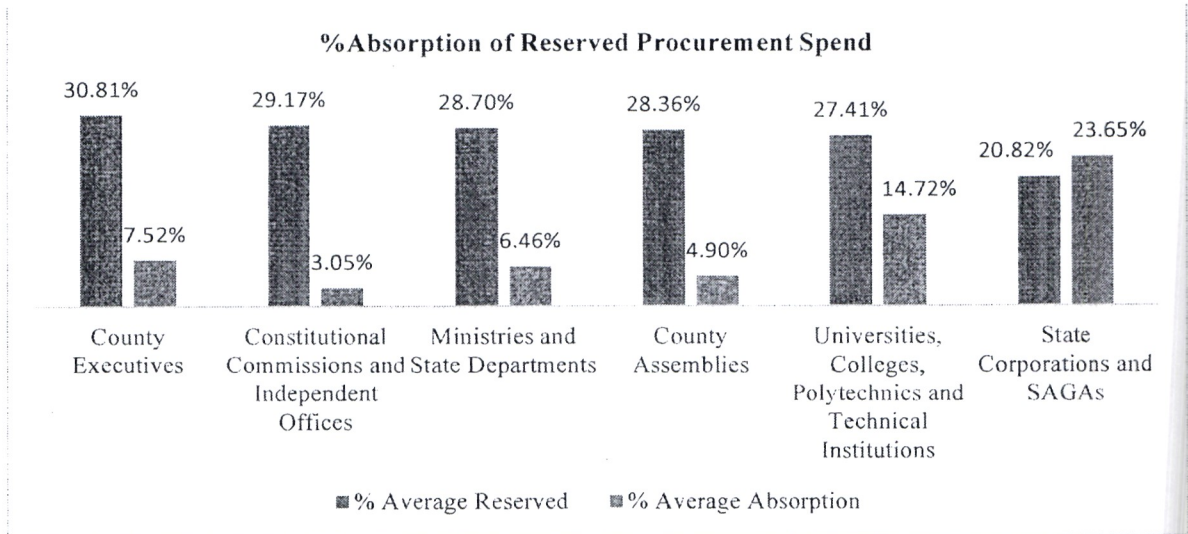


Figure E1: Level of Reservation and Absorption of Procurement Spend by Procuring Entities

The figure presents the average levels of reservation and absorption of procurement spend by category of procuring entities. The picture relayed here can be interpreted that the procuring entities are reserving procurements for uptake by the enterprises owned by youth, women and PWDs, but the uptake of the reserved procurement spend is still low amongst different categories of procuring entities.

3. Contracts Awarded to the Disadvantaged Groups (youth, women and PWDs)

In terms of number and value of contracts awarded to the disadvantaged groups, the procuring entities that reported awarded a total of 10,984 contracts worth Kes. 13,796,389,285.94. This is disaggregated into 9,966 contracts of Kes. 12,315,130,180.35 by National Government entities and 1,018 contracts of Kes. 1,481,259,105.59 by County Governments entities.

When disaggregated by category of disadvantaged groups, the women category was awarded the highest number and value of contracts at 6,098 (55.52%) and Kes. 7,139,407,103.82 (51.75%) whereas PWDs received the least at 833 (7.58%) and Kes. 1,294,241,164.45 (9.38%). The table below shows the percentage distribution of the number and value of contracts by target groups.

From the table above, majority of the contracts were awarded by State Corporations and SAGAs, followed by Universities, Colleges, Polytechnics and Technical Institutions, then by County Executives. Constitutional Commissions and Independent Offices and County Assemblies awarded the least number of contracts to the target groups.

In terms of value of the contracts awarded to the target groups, State Corporations reported the highest amount followed by County Executives, then by Ministries and State Departments. Constitutional Commissions and Independent Offices and County Assemblies reported the least amounts, synonymous with their low levels of reporting. The summary is presented in the table below.

In summary, we noted that PWDs were awarded the least number of contracts across all the categories of procuring entities that reported with some entities awarding nil contracts to this target group. We further noted that a number of public entities did not reserve at least the required minimum of **30%** of their procurement spends to the target groups. Additional observation was on low levels of absorption of the amounts reserved for the disadvantaged groups. Most procuring entities also reported that their levels of absorption of the reserved procurement spend were affected by prevailing COVID-19 pandemic.

1 PART ONE: BACKGROUND INFORMATION

1. The public procurement and asset disposal system is anchored in the Constitution of Kenya 2010 under article 227 (a)(b) which specifically states that public entities shall set aside categories of preference in the allocation of contracts and protection or advancement of persons or categories of persons or groups previously been disadvantaged by unfair competition.
2. The Public Procurement and Disposal Act, 2005 was repealed, on 7th January 2016 through a Kenya Gazette Supplement No.207. It was replaced with the Public Procurement and Asset Disposal Act 2015 (PPADA, 2015). This new Act aligned the procurement law with the Constitution of Kenya, 2010, Kenya Vision 2030, clarified the role of the National Treasury as the policy developer, Public Procurement Regulatory Authority as regulator, Public procurement Administrative Review Board as an adjudicator in tendering and asset disposal procedures. It also established the County Treasury to be responsible for monitoring public procurement and asset disposal procedures at the county level.
3. The Public Procurement and Disposal Act, 2005 had provided for preferences and reservations under Section 28 and which was operationalized through the Public Procurement and Disposal (Preference and Reservations) Regulations 2011 and Amended Regulations 2013.
4. In order to foster compliance with the Preference and Reservations Scheme, the Authority together with the National Treasury lobbied for the Preference and Reservations Scheme to be anchored in the PPADA, 2015.
5. One of the key features of the Act is that it underscores the need to promote local industry and provides procurement opportunities to the disadvantaged and marginalized groups. These provisions are covered under Part XII of the Act on Preferences and Reservation in Procurement. Specifically, the Act provides for Preferences and Reservations under Sec.155 through to 158 setting out the eligibility, target groups, application and monitoring of the scheme.
6. Section 157 (12) & (13) of the Act instructs procuring entities at the National and County levels to submit reports to the Authority every six (6) months demonstrating compliance with the legal provisions on implementation of the preferences and reservation scheme. The report should be disaggregated to indicate the number of youth, women and persons with disability from whom goods, works and services have been procured by the procuring entity as required under Section 157 (13) (b) of the Act. This is a mandatory report to be submitted to the Authority to enable preparation of a report to Parliament pursuant to Section 157 (14) of the Act. It is against this background that this report is submitted to the Parliament.

7. The performance report presented herein for the special groups under the 30% preference and reservation scheme during the second- half (January-June, 2020) of the 2019/2020 financial year is presented in two (2) parts. Part 1 presents the allocation/setting aside of the 30% procurement budget to the target groups; women, youth and people with Disabilities (PWDs) while Part 2 depicts the contract awards to the target groups in terms of number and value. Further each part is segregated into National Government and County Government Entities.
8. In order for procuring entities to prepare and submit this report in line with Section 157(12) and (13) of the Act, the Authority issued reporting guidelines vide PPRA Circular No. 1/2016 of 16thDecember, 2016 to all Accounting Officers. The Circular detailed the formats to be used by the procuring entities when preparing the reports as per the requirements set out in Section 157(13) of the Act. Further, the Circular requires the procuring entities to submit the reports to the Authority within 14 days after end of the half of the Financial Year (i.e., by January 14th and July 14threspectively).
9. As at the time of compilation of this report, only **193** procuring entities had reported; of which **165** were from National Government, comprising of **18** Ministries and State Departments; **101** State Corporations, **37** Universities, Polytechnics, Colleges & Technical Institutions and **9** Constitutional Commissions & Independent Offices. The remaining **28** were from County Governments, comprising of **19** County Executives and entities, and **9** from County Assemblies.
10. **Thus, there was a light improvement in reporting by procuring entities to the Authority during this half-year, compared to the previous period (January- June, 2020), where only 148 procuring entities reported; which was also a drop from 158 in the July – December, 2019 period.**

2 PART TWO: RESERVATION OF PROCUREMENT SPEND FOR THE TARGET GROUPS

11. Section 155 of the Public Procurement and Asset Disposal Act, 2015 (the Act) makes it mandatory for Public Entities to comply with the provisions of Part XII of the Act on Preference and Reservations in Procurement. Section 53(6), and 157(5) & (10) of the Act requires Accounting Officers of public entities to "... reserve a prescribed percentage of its procurement budget, which shall not be less than 30%, to the disadvantaged group and comply with the Act and the Regulations in respect of preference and reservations.

12. Table 2.0 below presents the level of reservation of procurement spend for the target groups by categories of procuring entities.

13. During the reporting period, 193 procuring entities from National Government and County Governments that reported, cumulatively planned to spend Kes. 79,158,620,780.15 on procurement of goods, works and services. Of this amount, Kes. 19,473,288,069.16 was reserved for procurement of goods, works and services from firms owned by youth, women and PWDs. This represents an average reservation of 24.60% of the cumulative planned annual procurement spend.

14. This implies that a majority of the procuring entities at both levels of Government reserved less than the required minimum of 30%. Similarly, National Government and County Governments made average percentage reservations of 22.53% and 30.52% respectively.

2.1 NATIONAL GOVERNMENT PROCURING ENTITIES

15. During the reporting period, some of the 165 National Government entities that reported planned to spend cumulatively Kes. **58,625,823,626.39** on procurement of goods, works and services; of which Kes. **13,207,199,993.26** for procurement of goods, works and services from firms owned by youth, women and PWDs. This represents an average percentage reservation of **22.53%**, which is below the prescribed minimum of 30%. Table 2.1 below presents the cumulative reserved procurement spends for the target groups by the different categories of National Government procuring entities.

2.1.1 Ministries and State Departments

16. During this half year, only 18 Ministries & State Departments submitted reports to the Authority on contracts awarded to youth, women and PWDs. Of the 18, only 10 disclosed the annual procurement budgets and amounts reserved for procurements of goods, works and services offered by the enterprises owned by youth, women and PWDs. The 10 procuring entities planned to spend a total of Kes **6,816,954,233.00** of which Kes **1,956,669,465.80** was reserved for procurement of goods, works and services from firms owned by youth, women and PWDs. This translated to an average reservation of 28.70%, which is less than the required minimum of 30%.

17. Table 2.1.1 presents the list of the Ministries and State Departments that reported and the level of reservation of their procurement spends for the target groups.

18. From a review of the requirement that procuring entities reserve at least 30% of their total procurement budgets for the target groups; all the 10 Ministries and State Departments that disclosed their planned procurement spend and the amounts reserved for the disadvantaged groups, reserved at least 30%, except State Department for Trade and Enterprise Development.

19. The remaining 8 Ministries and State Departments that reported did not disclose their total planned procurement budget and the amounts set aside for the disadvantaged groups contrary to the directives of the Authority, it was therefore not possible to determine their level of compliance with the Act.

2.1.2 Constitutional Commissions and Independent Offices

20. During the reporting period, nine (9) Constitutional Commissions & Independent Offices submitted reports on contracts awarded to the target groups (youth, women and PWDs).

21. During the financial year, the Constitutional Commissions and Independent Offices that reported had planned to spend of Kes. 3,080,139,309.00 for their procurements; of which Kes. 898,590,040.90 was set aside for procurement of goods, works and services from the firms owned by the youth, women and PWDs. This represented on average, a reservation of 29.17%.

22. Table 2.1.2 presents the list of the Constitutional Commissions and Independent Offices that reported and the level of reservation of their procurement spends for the target groups.

23. From a review of the requirement that procuring entities reserve at least 30% of their total procurement budgets for the target groups; only 7 out of 9 that reported their total procurement budgets and amounts reserved for the disadvantaged groups, reserved at least 30%.

24. The National Land Commission did not disclose the total planned procurement budget as well as the value of procurements reserved for the target groups for the financial year, contrary to the directives of the Authority, to enable us estimate the level of compliance with the Act.

2.1.3 State Corporations and Semi-Autonomous Government Agencies (SAGAs)

25. During this reporting period, only 101 State Corporations and SAGAs submitted reports to the Authority on contracts awarded to the youth, women and persons with disabilities (PWDs). Of this number (100), only 72 disclosed both annual procurement budget and the amount reserved for the targets for the 2020/2021 financial year.
26. The 72 State Corporations and SAGAs that disclosed both annual procurement budget and reserved procurement spend, planned to cumulatively spend Kes 43,979,889,619.76 on their procurements; of which they reserved Kes. 9,050,512,304.51 for procurement of goods, works and services from the firms owned by the target groups (Youth, Women and PWDs).
27. This represented an average reservation of 20.58% which is less than the required minimum of 30%. Table 2.1.3a presents the list of procuring entities under this category that reported and their level of reservation of the at least 30% of procurement budgets for the target groups.

28. From table 2.1.3a, only **52** of the **72** State Corporations and SAGAs reserved at least 30% of their total procurement budgets for the disadvantaged groups and the remaining **20** reserved less than the required minimum of 30%.

29. Further, **29** State Corporations and SAGAs did not disclose their total planned procurement budget as well as the amounts reserved for the target groups to enable us estimate their level of compliance with the Act. 2.1.4 Universities, Colleges, Polytechnics and Technical Institutions

30. During this reporting period, only **37** Universities, Colleges, Polytechnics and Technical Training Institutions submitted reports to the Authority on contracts awarded to the youth, women and persons with disabilities (PWDs).

31. During the period under review, the **37** Universities, Colleges and Technical Training Institutions planned to cumulatively spend Kes **4,748,840,464.63** on their procurements; of which they reserved Kes. **1,301,428,182.05** for procurement of goods, works and services from the firms owned by the target groups (Youth, Women and PWDs).

32. This represented on average, a reservation of **27.41%** which is below the required minimum of 30%. Table 2.1.4 presents the list of the Universities, Colleges and Technical Training Institutions that reported and the level of reservation of at least 30% of their procurement spends for the target groups.

33. From the requirement that every procurement entity reserves at least 30% of their procurement budget for the target group, only 22 of the 37 procuring entities under this category that reported, disclosed total and reserved procurement spends, of which only 17 (of the 22) reserved at least a minimum of 30% of their annual procurement budgets for the target groups (youth, women and persons with disabilities).
34. The remaining 15 procuring entities of the 37 failed to disclose, respectively the planned annual procurement spend as well as the amount reserved for the target groups; contrary to the directives of the Authority, it was therefore not possible to determine if they complied with the required threshold of at least 30%.

2.2 COUNTY GOVERNMENT PROCURING ENTITIES

35. During the period under review, only twenty-eight (28) County Government entities submitted reports to the Authority. The 28 entities planned to cumulatively spend Kes 20,532,797,153.76 on procurement of goods, works and services, of which Kes. 6,266,088,075.90 was reserved for procurement of goods, works and services from firms owned by the youth, women and PWDs.

36. This translated to an average reservation of 30.52% of the planned cumulative procurement budget, however some entities reserved less than the required 30%. The summary is presented in table 2.2 below.

2.2.1 County Executives

37. During the period under review, only 19 County Executives and its entities submitted reports to the Authority on contracts awarded to the youth, women and persons with disabilities (PWDs).

38. Of the 19, nine (9) procuring entities did not report on their planned annual procurement budgets as well as on the amounts reserved, contrary to the directives of the Authority. The remaining ten (10) reported a cumulative of Kes 18,106,853,993.76 of which Kes 5,578,182,308.90 was reserved for procurement of goods, works and services from the firms owned by the target groups (youth, women and PWDs).

39. This represented on average a reservation of 30.81% which is equivalent to the required minimum of 30%. Table 2.2.1 presents the list of the County Executives that reported and the level of reservation of at least 30% of their procurement spends for the target groups.

2.2.2 County Assemblies

40. During the period under consideration, only nine (9) County Assemblies submitted reports to the Authority on contracts awarded to the youth, women and persons with disabilities (PWDs). Out of the 9 County Assemblies only Mandera County Assembly did not disclose planned annual procurement budget as well as the amounts reserved for the target groups, contrary to the directives of the Authority.

41. The remaining 8 County Assemblies planned to cumulatively spend Kes 2,425,943,160.00 on their procurements for the 2020/2021 financial year of which Kes 687,905,767.00 was reserved for procurement of goods, works and services from enterprises owned by the target groups (youth, women and PWDs). This, on average, represents a level of reservation of 28.36% which is less than the required minimum of 30%. Table 2.2.2 presents the list of the County Assemblies that reported and the level of reservation of at least 30% of their procurement spends for the target groups.

This comprised of **9,966** contracts awarded by National Government entities and **1,018** awarded by County Government entities. 69. From the summary in table 3.3.5, the youth category was awarded the highest number of contracts at **50.63%**, followed by women at **45.62%** and PWDs were awarded the least at only **3.75%** contracts. In terms of value, youth category also got the highest share of the value of the contracts at **51.23%**, followed by women at **44.38%** while the PWDs were awarded the least amount represented by **4.39%**.

3.3.2 County Assemblies

70. During the reporting period, only **9** out of **47** County Assemblies reported to the Authority on contracts awarded to youth, women and PWDs. On the utilization of the reserved procurement spend, the **9** procuring entities awarded **139** contracts worth **Kes. 118,952,764.00** from a cumulative reserved procurement spend of **Kes. 687,905,767.00**. This represents an average absorption rate of **17.29%** of the procurement budget reserved for the target groups. Table 3.3.6 below presents the level of performance of the **6** County Assemblies in terms of absorption of the reserved procurement budget.

73. In terms of number of contracts awarded, the youth category received the highest share of **44.60%**, followed by women at **43.88%** contracts with PWDs awarded **11.51%**. In terms of value of the contracts, the youth category received the highest share of the value at **71.94%**, followed by women at **24.15%** while the PWDs were awarded the least at **3.91%**.

4 CONCLUSION

74. This report is prepared pursuant to Section 157 (14) of the Act in fulfillment of the statutory requirement to always report to Parliament every six months on the performance of the preference and reservation scheme targeting youth, women and persons living with disabilities (PWDs).

75. As presented above, the Authority noticed a slight improvement in mandatory reporting by the Procuring Entities (PEs) from 148 procuring entities that submitted the reports for the previous period (January– June, 2020) to 192 PEs during this current reporting period.

76. After reviewing the submitted reports; a number of issues were noted; which included:

- a) A number of procuring entities did not disclose all the information required, in terms of the annual procurement budgets and the amounts reserved for the target groups, thus we were not able to determine their level of compliance with Section 157(5) of the Act.
- b) A number of procuring entities reserved less than the required minimum of 30% of their annual procurement budget for the preference and reservation scheme, which is contrary to provisions of Section 157(5) & (13) of the Act.
- c) Some procuring entities have classified some of their procurements as complex and specialized or security based therefore cannot be reserved for the disadvantaged groups.
- d) Despite procuring entities reserving procurement budgets for the disadvantaged groups (youth, women and PWDs), absorption of the same has been very low across all categories of procuring entities. There is need to find out the factors the impede PEs from spending the reserved budgets.
- e) PWDs category was awarded the least contracts in terms of number and value by all the procuring entities that reported. Some procuring entities did not award contracts to this target group at all.
- f) Despite the circular on mandatory reporting issued by the Authority to all procuring entities (across all categories), and other reminder Circulars by the Cabinet Secretary of the National Treasury and Planning, most of the procuring entities are still not submitting mandatory reports as directed.

g) A number of procuring entities reported that their procurement activities during the half-year were greatly affected by the Corona Virus pandemic.

77. A number of milestones have been achieved under the preference and reservation scheme including: The National Treasury and the Authority have issued directives in form of circulars to Accounting Officers on implementation requirements as part of the operationalization of preferences and reservations. Further, the two institutions have continued to build the capacity of procuring entities and suppliers to enhance uptake the programme. Notwithstanding these major achievements, the uptake of the 30% procurement spend reserved for the target groups is still low.
