

MEETING ASSEMBLED ON 5TH SEPTEMBER 1907

Absent: The Treasurer.

Section 93

The Crown Advocate moved to insert " on Saturday afternoons, Sundays Public holidays and " after the word " open" in Section 93.

The Land Commissioner seconded and this was agreed to without dissent.

The Crown Advocate moved to insert after the word "be" in Section 93:

" such as the Governor in Council shall from time to time fix and notify in the Gazette and until so fixed shall be..."

The Land Commissioner seconded and this was agreed to without dissent.

Section 101

Mr Wilson moved to delete " grant receipts for such goods" in Section 101 and to substitute " forthwith grant receipts for cases, packages or parcels received".

Lord Delamere seconded and this was agreed to without dissent.

Section 104

Mr Wilson moved to delete " be proved to have" and insert " has " after " loss" in Section 104.

Lord Delamere seconded and this was agreed to without dissent.

Section 109

The Crown Advocate moved to delete " one per cent package" in Section 109 and to substitute " of such fee as may be fixed from time to time by the Chief of Customs with the consent of the Governor and published in the Gazette".

The General Manager Uganda Railway seconded.

Section 109

On the question being put, there voted for the motion the Senior Commissioner, the Land Commissioner, the Crown Advocate, the General Manager Uganda Railway and Mr Wilson. Lord Delamere voted against the motion.

The motion was carried.

Section 118

The Crown Advocate moved to insert the following at the end of Section 118:

" unless the Chief of Customs is satisfied that such information could have been given in the time allowed."

The General Manager, Uganda Railway seconded and this was agreed to without dissent.

The Crown Advocate moved to delete " owner" and ^{Substitute} substitute " exporter".

The Land Commissioner seconded and this was agreed to without dissent.

Section 104

The Crown Advocate moved to substitute " Government" for " Crown" in Section 104.

The Land Commissioner seconded and this was agreed to without dissent.

Section 140

Mr Wilson moved to delete "it be proved that" from Section 140.

Lord Delamere seconded.

On the question being put, there voted for the motion Mr Wilson and Lord Delamere. The Senior Commissioner, the Land Commissioner, the Crown Advocate and the General Manager Uganda Railway voted against the motion.

The motion was lost.

Proclamation No 7 of 1898

The Crown Advocate moved to insert in Schedule F, Proclamation No 7 of 1898.

The Land Commissioner seconded and this was agreed to without dissent.

ADJOURNMENT OF THE COMMITTEE SINE DIE

The Crown Advocate moved the adjournment of the Council in Committee on the Customs Bill 1907 sine die.

The Land Commissioner seconded and this was agreed to without dissent.

DISEASES OF ANIMALS BILL-- SECOND READING

The Crown Advocate in Council moved the Second Reading of a Bill to make further provision for preventing the spread of diseases among animals.

The Land Commissioner seconded and this was agreed to without dissent.

SPECIAL COMMITTEE

The Land Commissioner moved the formation of a Special Committee to consist ^{of} the Land Commissioner, the Treasurer, the Crown Advocate and Lord Delamere to consider this Bill.

The Crown Advocate seconded and this was agreed to without dissent.

SALE OF WINES AND SPIRITS BILL-- SECOND READING

The Crown ^{Advocate} Advocate moved the Second Reading of a Bill to regulate the sale of wines, spirits and malt liquors.

The Land Commissioner seconded and this was agreed to without dissent.

SPECIAL COMMITTEE

The Land Commissioner moved the formation of a Special Committee to consist of the Treasurer, the Crown Advocate, Lord Delamere and Mr Wilson to consider this Bill.

The Crown Advocate seconded and this was agreed to without dissent.

MASTER AND SERVANT BILL-- SECOND READING

The Crown Advocate moved the Second Reading of a Bill to amend the Master and Servant Ordinance 1906.

The Land Commissioner seconded and this was agreed to without dissent.

COUNCIL INTO COMMITTEE

The Crown Advocate moved that the Council go into Committee to consider this Bill.

The Land Commissioner seconded and this was agreed to without dissent.

The Bill ~~was~~ having been considered in committee and no amendments being made, the Crown Advocate moved to report progress to the Council.

The Land Commissioner seconded and this was agreed to without dissent.

The Crown Advocate gave notice that he proposed to move the Third Reading of this Bill on September 9th.

BRANDING BILL-- SECOND READING

The Crown Advocate moved the Second Reading of a Bill to make provision for the registration of brands for stock and for the compulsory branding of cattle and ostriches by owners.

The Land Commissioner seconded and this was agreed to without dissent.

SPECIAL COMMITTEE

The Land Commissioner moved the formation of a Special Committee to consist of the Land Commissioner, the Crown Advocate and Lord Delamere to consider this Bill.

The Crown Advocate seconded and this was agreed to without dissent.
