The Council is convinced that the rapid growth of export overseas trade of the group of territories served by Uganda Railway and the Port of Kilindini always calls for the early possession of a deep water wharfage or pier to enable cargo to be handled without the need for use of lighters between the ship and the shore, and that it is desirable that such deep water works be proceeded with immediately upon the completion of the preliminary works now in progress.

The Council therefore begs respectfully to request that His Excellency be pleased to exask the Right Honourable the Secretary of State into early consderation the question of such further works with the object aforesaid." <u>ADJOURNMENT</u>
