# **CHAIRPERSON'S FOREWORD**

On behalf of the Public Petitions Committee and pursuant to provisions of Standing Order 227, it is my pleasant privilege and honour to present to this House the Report of the Committee on the Public Petition Regarding Desiltation of Matinga Dam. The petition was presented to the House pursuant to Standing Order No. 225 (2) (a) by the Hon. Edith Nyenze, M.P., Member for Kitui West Constituency on behalf of the residents of Kitui West Constituency.

The Petitioner prayed that the House uses its authority to intervene to ensure that the desiltation of Matinga Dam in Kitui West Constituency is carried out by the Ministry of Water, Sanitation, and Irrigation to provide water to the residents around the dam and its environs. The Committee considered the Petition and made various observations regarding the issues arising from the Petition including the state of the dam and other colonial dams, the efforts to desilt the dam and the costs involved.

In response to the prayers sought in the Petition, the Committee made various recommendations including audit of all colonial dams and feasibility studies on those that can be rehabilitated and maintained to ensure access to water for all Kenyans. The Committee further recommends that Tanathi Water Works Development Agency submits to the Departmental Committee on Blue Economy and Irrigation the feasibility studies such as engineering studies & surveys and detailed technical designs, for the rehabilitation of Matinga Dam.

The Committee appreciates the Offices of the Speaker and Clerk of the National Assembly for providing guidance and necessary technical support without which its work would not have been possible. The Chairperson expresses gratitude to the Committee Members for their devotion and commitment to duty during the consideration of this Petition.

On behalf of the Committee and pursuant to the provisions of Standing Order 199, I now wish to lay the Report on the Table of the House.

# 2. PETITION NO. 12 OF 2023 REGARDING DESILTATION OF MATINGA DAM

#### **2.1 INTRODUCTION**

- Public Petition No. 12 of 2023 regarding Desiltation of Matinga Dam in Kitui West Constituency was presented to the House by the Member for Kitui West Constituency, Hon. Edith Nyenze, M.P., on behalf of the residents of Kitui West Constituency on Thursday, 16<sup>th</sup> March, 2023.
- 2. The Petitioners from Kauwi, Mutongoni, Matinyani, Kithimula/Kwa Muthonga Wards in Kitui West Constituency utilise the dam as a water supply for household use and watering their livestock.
- 3. Matinga Dam was a pre-colonial era constructed in 1954 and had been in operation until 1981. The Constituency is in an arid and semi-arid area and therefore experienced dry spells and lack of water and pastures throughout the year.
- 4. The Petitioners are of the view that de-siltation of the dam would renew the freshwater reservoir for the residents and allow for sand harvesting as an economic activity during the desiltation of the dam.

#### **2.2 PETITIONER'S PRAYERS**

The Petitioners prayed that the National Assembly through the Public Petitions Committee-

- i. Ensure that, the desiltation of Matinga Dam in Kitui West Constituency is carried out by the Ministry of Water, Sanitation, and Irrigation to provide water for the residents around the dam and its environs; and,
- ii. Makes any other necessary recommendations the Committee deems fit to address the issues raised in the Petition.

## PART THREE

#### 3. SUBMISSIONS BY STAKEHOLDERS ON THE PETITION

#### **3.1 THE PETITIONER**

The Hon. Edith Nyenze, MP, appeared before the Committee on Tuesday, 3<sup>rd</sup> May 2023 and submitted as follows—

- 5. The residents of Kitui West Constituency; Kauwi, Mutonguni, Matinyani, Kithumula/Kwa Muthonga Wards in Kitui Constituency had for a long time been facing difficulties in acquisition of water for their livestock and household.
- 6. For over 42 years, the residents have suffered lack of water for domestic use and watering of livestock due to siltation of Matinga Dam which is about 154 acres with a capacity of one billion cubic meters of water.
- 7. The community dam has a title deed with marker boundaries and is free from permanent human encroachment.
- 8. The dam is a potentially productive water catchment and ecosystem supporting a human population of excess of 180,000 people and livestock. Currently, residents obtained fresh water from Machakos County, which was far, resulting into them petitioning for desiltation of Matinga Dam in Kitui County for them to have a close water supply.
- 9. The residents through a group called Desiltation of Matinga Dam Lobby Group (DIMALG) had persistently sought assistance from government and NGOs for desiltation of the dam but had not succeeded.
- 10. Desiltation of the dam would realize greater benefits including utilization of sand by local community, afforestation around the dam, supply of water for irrigation, other income generating activities such as tourist attraction, water sports etc.
- 11. The desiltation process could be implemented through the Public Private Partnership (PPP) approach to ensure efficiency and sustainability.

#### 3.2 The National Water Harvesting and Storage Authority

The Chief Executive Officer of the National Water Harvesting and Storage Authority vide a letter Ref No. NWHSA/CEO/00/90/VOL.VII/ (11) date 24<sup>th</sup> June 2023 forwarded a written submission on the deliberations and recommendations following a joint site visit to the dam with the Committee. In the submission, the CEO indicated as follows:

#### 3.2.1 Background

- 12. Kitui County was categorised as an ASAL area thus water projects are considered crucial in the County Development Plan. Therefore, in a bid to address the water challenge in Kitui County, and specifically Kitui West Constituency, desiltation of Matinga Dam was crucial.
- 13. The dam was constructed during colonial times (1950's) and silted up in the 1980's. Several efforts have been made by Kitui County Government in partnership with World Bank, Africa Development Bank (ADB) and Tana and Athi River Development Authority (TARDA) on conservation of water catchment by planting of bamboo trees and educating farmers living next to the dam to carryout good farming practices, for instance, terracing on slopes. Desiltation of the dam has not been done, making the residents trek long distances in search of water for both domestic and livestock use.

#### 3.2.2 Preliminary studies on Matinga Dam

That from the previous studies done, National Water Harvesting and Storage Authority (NWSHA) submitted as follows—

- 14. The proposed project components required to rehabilitate the dam and water catchment area are proposed to include desilting of the earth dam to accommodate 3,108,000 cubic metres of water; construction of embankment draw off, scour culvert, spillway and treatment works; surveying and laying of water pipeline network; provision of 33,700 cubic metres per day of safe clean water to serve a population of 521,126 people and for small scale irrigation; and catchment, protection and conservation activities of approximately 302 km2 with a run-off dependability of 80%.
- 15. The preliminary proposed project cost includes the initial investment at Kshs. 1,134,639,513.86; dam rehabilitation (main embankment, draw-off, scour culvert and spillway) at Kshs. 701,154,886.86; water distribution infrastructure at Kshs. 173,214,627; catchment rehabilitation and conservation at Kshs. 185,750,000; supporting infrastructure at Kshs. 38,500,000; and administrative costs at Kshs. 20,000,000.

#### 3.2.3 Proposed Recommendations


After the joint site visit with the Public Petitions Committee to Matinga Dam and perusing through the available documentation provided, NWHSA recommended as follows:

- 16. In conjunction with other stakeholders, a through feasibility study should be undertaken to determine the target population to be served, the capacity of the dam and reservoir area, and viable project components.
- 17. A further investigation should be conducted to determine the tributaries and establish why there is no flow towards the dam and how to improve on the flow as well as a hydrological investigation of the water sources should be undertaken to determine the inflow into the dam.
- 18. There is need for a full report on catchment rehabilitation measures to be undertaken and a geological survey of the dam embankment are to determine downstream seepage/aquifer formation.
- 19. The Water Resource Authority (WRA) should be engaged on catchment conservation measures within the dam catchment and water catchment management plan with appropriate cost be prepared. Further, the County Government of Kitui should assist in lobbying for funds to carry out the studies.



#### 3.3 The County Government of Kitui

The County Government of Kitui through the County Executive Committee on Water and Irrigation submitted as follows:

- 25. The dam was allocated 154 acres and its design storage capacity was one million cubic metres and had the potential to serve a population of 200,000 people in Kivani, Nzawa, Nguutani, Mutonguni, Katheka, Katutu, and Kauwi Wards, with water for domestic and irrigation use.
- 26. The dam was the main source of water for both domestic and livestock up to the early 1980s when siltation reached to the levels that it could no longer hold water. It was first desilted in 1972 and has been accumulating silt since then. Currently, the dam reservoir is entirely silted, and all components of the dam are in a dilapidated state and therefore cannot be utilized by the beneficiary community.
- 27. Further, the dam site is unfenced and unprotected with encroachment activities especially farmers who use the wetland for agricultural activities.
- 28. The dam has an aquifer called, "*Kamelya andu*" which never dries up and currently acts as the only source of water for domestic use during the dry seasons.
- 29. Efforts to desilt the dam included resource mobilization by the local professionals who appealed to Water Sector Trust Fund (WSTF) through WRA.
- 30. The County Government of Kitui approached the World Bank to consider financing the rehabilitation of the dam through Public Private Partnership (PPP). TARDA was identified as a partner in the project but due to lack of resources to facilitate the technical consultative meetings, nothing much was realised.
- 31. TARDA had agreed to partner with the County Government in rehabilitation of the dam. An initial feasibility study was done, and a concept proposal submitted to the PPP Secretariat at the National Treasury.

#### 3.4 The Ministry of Water, Sanitation, and Irrigation

The Cabinet Secretary, Hon. Alice Wahome appeared before the Committee on Thursday, 6<sup>th</sup> July 2023 and submitted as follows—

32. Matinga Dam is in Kitui West Constituency in Kitui County and was constructed in 1955. The design storage capacity of the dam is one million cubic metres and serves a

population of 200,000 people in Nguutani, Mutonguni and Kauwi wards, with water for domestic and irrigation use.

- 33. The Dam was first desilted in 1972 and has been accumulating silt since then. Currently, the dam reservoir is entirely silted, and all components of the dam are in a dilapidated state and therefore cannot be utilized by the beneficiary community.
- 34. Tanathi Water Works Development Agency (TAWWDA) has been directed to undertake comprehensive engineering studies & surveys and prepare detailed technical designs for the rehabilitation of Matinga Dam.
- 35. The studies and survey conducted will be for the desilting of the dam, rehabilitation of the dam embankment, spillway and fencing of the dam reservoir area. The Agency will conclude these studies and submit them to the Ministry of Water, Sanitation, and Irrigation by 31<sup>st</sup> July 2023 for funding consideration.

#### 3.5 SITE VISIT

The Committee conducted a site visit to Matinga Dam on Monday, 29<sup>th</sup> May, 2023 to make observations and interact with community members. During the visit, the Committee engaged various stakeholders—

- 1. The County Government of Kitui represented by the Governor, H.E (Dr.) Julius Malombe, EGH.
- 2. The County Commissioner, Mr. Erastus Mbui;
- 3. The National Water Harvesting and Storage Authority represented by Eng. Rispah Achieng' and Mr. Joseph Gitonga;
- 4. The Water Resource Authority represented by Mr. Philip Munyua, the Principal Water Resource Safety Officer; and
- 5. Community Members (Petitioners).

The Committee made the following observations—

#### 3.5.1 The state of Matinga Dam

- 36. The County Commissioner stated that, despite Kitui County being an Arid and Semi-Arid Lands (ASAL) region, which is water-scarce, many economic activities, including crop cultivation and animal husbandry, significantly rely on water from dams.
- 37. There is a glaring evidence of the Matinga Dam's urgent need for desiltation. Lack of funding was the main obstacle to desilting the Matinga Dam. If provided it would allow for the restoration of the dam.

- 38. Matinga Dam was one of the many dams across the country established during colonial times that had neither been maintained nor properly utilised. The design of the dam was ideal, but it lacked allocation of funds to follow up on the maintenance and utilization of the colonial dams.
- 39. The silt in Matinga Dam had accumulated for over 42 years and could be used to fertilize farms if the dam was desilted.

#### 3.5.2 Funding challenges by the County Government of Kitui

- 40. The desiltation of Matinga dam had been prioritized during the public participation exercise for the budget but the project cost was too high for the county government to meet.
- 41. Matinga Dam was factored in the County Integrated Development Plan. The budget for water in the county government was too little for the amount required for the project. The County Government had canvassed the matter and made a request for assistance in the project with various donors such as the World Bank and Water Sector Trust Fund (WSTF).

#### 3.5.3 Efforts made towards the management of water resources

- 42. Kitui County Government had established a management committee to conduct follow ups and maintenance of water resources such as dams and boreholes. The county had invested in machinery to drill boreholes.
- 43. With regards to Matinga Dam, the county undertook to put structures in place to manage erosion which was the major cause of siltation including planting of trees in collaboration with community members.

#### 3.5.4 The cost of desiltation of Matinga Dam

- 44. The National Water Harvesting and Storage Authority (NWHSA) stated that it would be costlier to desilt the dam than constructing a new dam because the desiltation would require complex machinery as there could be a lot of water underneath.
- 45. NWHSA stated that desiltation of Matinga Dam was feasible but required further technical studies to establish the cost. Further, the public private partnership approach needed a comprehensive feasibility report, which could be conducted by NWHSA. The further feasibility analysis and research included establishing possibility of seepage and treatment works.

- 46. The previous survey conducted on the dam on treatment works was inadequate. Therefore, there was need for further study to establish the project components and detailed final design.
- 47. The County had also partnered with South Eastern Kenya University (SEKU) to map various sand dams. The exercise had revealed that about 154 ha area of the Matinga Dam had been encroached by the community who were utilising the area for farming, but they would be relocated.
- 48. Maintenance of environmental and catchment areas such as Matinga Dam was an expensive exercise that required continuous efforts on controlling erosion and siltation.
- 49. After the deliberations with different stakeholders, it was proposed that the NWHSA provides a comprehensive budget for feasibility study on the dam.





Figure 1. An aquifer at the Matinga Dam referred by the locals as "Kamelya andu"

#### **PART FOUR**

#### 4. COMMITTEE OBSERVATIONS

Following the submissions by the petitioners and various stakeholders, the Committee observed that—

- 50. Matinga Dam is silted and there is only one aquifer with water which rarely dries up. However, the dam is also unprotected, and residents have encroached the wetland areas to undertake farming activities.
- 51. Lack of rehabilitation of the dam has been primarily due to funding challenges and the lack of stakeholder collaboration between County and National Government on the project.
- 52. There are about four hundred and eight (408) colonial dams across the country that need to be desilted and rehabilitated to ensure access to water.
- 53. Maintenance of water sources such as dams is a costly endeavour requiring periodic budgetary allocation to ensure long-term and sustainable use of these water sources.
- 54. Desiltation of the dam would have several benefits for the residents of Kitui West Constituency including sand harvesting, afforestation of the area, supply of water for irrigation and other income generating activities.
- 55. Despite the encroachment into the dam's wetlands by farmers, they were aware of the land being a public land allocated for the dam and were only utilizing it temporarily; hence were ready to cease their activities upon commencement of the desiltation project.
- 56. The Ministry of Water, Sanitation and Irrigation was committed to rehabilitating Matinga Dam, but were awaiting results from various feasibility and technical review of the project to ascertain the funding required.

#### PART FIVE

#### 5. ISSUES FOR DETERMINATION AS PER THE PRAYERS IN THE PETITION

Upon hearing from the Petitioners and other witnesses, the Committee makes determination on prayers sought in the Petition as follows—

Prayer No. 1: Desiltation of Matinga Dam in Kitui West Constituency by the Ministry of Water, Sanitation, and Irrigation to provide water for the residents around the dam and its environs.

57. The Committee—

- i. Notes that the residents of Kitui West Constituency are dependent on the water from Matinga Dam, even though the dam is silted to the brim, the residents can still access the water through mudholes.
- ii. Notes that the rehabilitation of the dam will improve the economic and social welfare of the residents of Kitui West Constituency and the County.
- iii. Notes the rehabilitation will involve various water sector stakeholders and agencies of the National Government such as the National Water Harvesting Authority, the Water Resources Authority, and the Tanathi Water Works Development Agency.
- iv. Notes that the National Government and County Government were collaborating in the water development works project to rehabilitate the dam, in funding and technical support through a joint technical committee.
- v. Concurs with the stakeholder submissions that a public private partnership approach may be considered following extensive public participation, to circumvent the funding challenges that have overwhelmed previous rehabilitation efforts.
- vi. Notes that the main challenge in the rehabilitation of Matinga Dam was the huge budgetary allocations required for such a project.
- vii. Notes the undertaking of the Cabinet Secretary for the Ministry of Water, Sanitation, and Irrigation to rehabilitate the Matinga Dam through the Tana Athi Water Works Development Agency.

#### PART SIX

#### 6. COMMITTEE RECOMMENDATIONS

Pursuant to the provisions of Standing Order 227, the Committee recommends that-

The Committee also recommends that—

- i. The Cabinet Secretary, Ministry of Water, Sanitation, and Irrigation initiates audit of all colonial dams across the country and conducts feasibility studies on those that can be rehabilitated and maintained to ensure access to water;
- ii. The Ministry of Water, Sanitation and Irrigation to submit to the National Assembly Departmental Committee on Blue Economy and Irrigation, the budget estimates for the project and any potential donor funding options on the project or public private partnerships proposals for consideration within three months;
- The Tanathi Water Works Development Agency to submit to the National Assembly Departmental Committee on Blue Economy and Irrigation the feasibility studies such as engineering studies and surveys and detailed technical designs, for the rehabilitation of Matinga Dam within two months;
- iv. Both the National and County Governments should source for funding for the project through budgetary allocation and donor funding from various donors such as the World Bank and Water Sector Trust Fund (WSTF) and ensure accountability systems are set up in the project; and
- v. The Ministry of Water, Sanitation, and Irrigation to submit a report on the rehabilitation of the Matinga Dam upon completion of the project.

#### CONSIDERATION OF PUBLIC PETITION REGARDING DESILTATION OF MATINGA DAM IN KITUI WEST CONSTITUENCY

#### Meeting with the Petitioner, the Hon. Edith Nyenze, MP

The Petitioner made submissions on the petition before the Committee as follows:

- i. That the residents of Kitui West Constituency; Kauwi, Mutonguni, Matinyani, Kithumula/Kwa Muthonga Wards have been facing difficulties in provision of water for their livestock and household.
- ii. That for over 42 years, the residents have suffered lack of water for domestic and livestock due to siltation of Matinga Dam which is about 154 acres with capacity of one billion cubic meters of water.
- iii. The community dam has a title deed with marked boundaries and free from permanent human encroachment.
- iv. Currently the residents get fresh water from Masinga Dam which is in Machakos County but it would be more convenient for them to get water from Matinga Dam in Kitui.

- v. That the dam is a potentially productive water catchment and ecosystem supporting a human population in excess of 180,000 people and livestock.
- vi. That the residents through a group called Desiltation of Matinga Dam Lobby Group (DIMALG) have persistently sought assistance from government and NGOs for desiltation of the dam in vain.
- vii. Desiltation of the dam will realize greater benefits including utilization of sand by local community, afforestation exercise around the dam, supply of water for irrigation, other income generating activities such as tourist attraction, water sports etc.
- viii. Desiltation can take the Private Public Partnership (PPP) approach to ensure efficiency and sustainability.
- ix. That the Committee intervenes to ensure the desiltation of Matinga Dam in Kitu West Constituency by the National Government.

#### **Committees'** Concerns

#### County government's role in water management

The Committee inquired on whether the desiltation of the dam is a county government function and whether the magnitude of the desiltation could only be done by the national government. The Petitioner indicated that assistance from county government has not been possible because the project requires a lot of resources which can only be provided by the national government.

#### MIN./PPETC/2023/178: CONSIDERATION OF PUBLIC PETITION REGARDING THE AMENDMENT OF THE CONSTITUTION TO PROVIDE FOR THE OFFICE OF THE PRIME MINISTER, DEPUTY PRIME MINISTER, AND THE LEADER OF OPPOSITION

#### Meeting with the Leader of the Minority Party, the Hon. James Opiyo Wandayi, CBS.

The Leader of the Minority Party, Hon. James Opiyo Wandayi, CBS submitted as follows:

- i. With regards to the Petitioner's proposal of creation of the Offices of Prime Minister, Deputy Prime Minister, and Leader of Official Opposition to cure what he termed the curse of winner-takes-it all, there was no clarity as to how the creation of the three offices will cure the problem.
- ii. The Minority side was of the view that a parliamentary system as proposed in the Bomas Draft, Naivasha Draft and Building Bridges Initiative (BBI) was best for Kenya because of the unique cultural, social, and political orientation as a nascent democracy instead of a pure presidential or a hybrid system.
- iii. Therefore, in the parliamentary system, a Prime Minister as the head of government would be the leader of party of coalition of parties that form government as a result of the numbers of seats of Parliament in the election. Consequently, the Leader of Opposition

would lead opposition in Parliament by providing alternative viewpoints with a shadow Cabinet.

- iv. That contrary to the proposal in the Petition, the Offices of Prime Minister and Deputy Prime Minister were not necessary with a President who is the Head of State and Head of Government in place. Likewise, in the current presidential system, there was no place for the Office of the Leader of Opposition.
- v. That even if the creation of the said offices was necessitated by our unique challenges, consensus building and need for a hybrid system especially Leader of Opposition, it will have do be done correctly as provided for in the Constitution on matters that can only be amended through a referendum.
- vi. That an amendment with far reaching ramification as the creation of the said offices would have to be taken to the people in a referendum and any other route would be akin to amending the Constitution through the backdoor which the Minority side will not be party to.

#### **Committee Concerns**

#### Creation of the offices through amendment of Articles 130 and 132

The Committee sought the views of the Leader of Minority on amendment of Articles 130 and 132 to create the said offices. The Leader of Minority Party indicated that the amendment of such magnitude would still require a referendum.

#### Official Opposition Leader taking up the position of the Leader of Minority Party

The Committee sought the opinion of the Leader of Minority regarding the Office of the Official Opposition taking up the position of the Leader of Minority. The Leader of Minority stated that if the people in a referendum agree that the runners up in the presidential elections become the Opposition Leader, then that is what is expected in a parliamentary system. Therefore, that was a justification for not having the Leader of Opposition in a presidential system.

#### Why such proposals keep on coming

The Committee sought the opinion of the Leader as to why the proposal and idea for a parliamentary system kept on resurfacing in parliament. The Leader stated that it was a concern that there could be a possibility of mischief in the process of amending the Constitution to establish the said offices. That it was clear that such amendments related to the functions of Parliament either directly or indirectly hence required a referendum.

#### Ways of selecting the Leader of Opposition

The Committee sought the opinion of the Leader regarding the proposed manner of establishing the office of the Leader of Opposition. The Leader indicated that while it was premature to think about that now, there could be various methods including the proposal of the runners up in a credible presidential election becoming the office bearers or nomination by the second largest party or coalition of parties.

#### Where the Leader of Opposition will be domiciled

The Committee sought the opinion of the Leader of Minority on where the Leader of Opposition would be domiciled. The Leader stated that the Leader of Opposition should sit in Parliament, but a choice will be made as to whether it's the National Assembly or Senate.

# Consideration of a Public Petition Regarding Ward Based Solution as a long-term remedy to perennial water shortage in Kenya

The CS appeared before the Committee and submitted as follows—

#### Introduction

The CS indicated that with regards to the Petition, domestic water access was at 71% across the country while sanitation coverage was at 32% in the urban and 22% in rural areas. However, some areas faced the challenge of climate change leading to lack of natural water sources. That the proposal by the Petitioner was a little bit complicated as the reticulation of water from storage sources was a responsibility of the county governments. Further, many areas did not have systems in place such as piping.

#### The role of the Ministry in water provision

That the Ministry had undertaken various programs and projects in partnership with different stakeholders to ensure every citizen access safe water. The Ministry often conducted detailed feasibility studies of a project to determine water source availability, economic feasibility and use of appropriate technology. The need analysis undertaken is based on the area to be served and the population expected to benefit. The solutions adopted must address the problem for the particular locality. The ministry concurred with the Petitioner that in some cases ground water offered solution to water challenges.

#### The efforts by the Ministry in water provision

That the Ministry was undertaking measures to ensure ground water development projects including-

- a) *Water for schools:* The National Water Harvesting and Groundwater Exploitation Program and Water for Schools Program targeted provision of water in schools and surrounding communities countrywide. In the last two years, the project had enabled drilling of 81 boreholes for small irrigation schemes and service about 35,000 people.
- b) *Kenya Ground Water Mapping Program*: The Ministry had signed a memorandum of understanding with the Kenya National Groundwater Mapping Program to cover the entire country. The program was being implemented in phases in conjunction with county governments, state corporations, development partners and academia among other stakeholders. Currently, the project had covered Southern Turkana and Marsabit County and was in the process of undertaking groundwater mapping of Athi and Tana River Basins.
- c) *The Horn of Africa Groundwater for Resilience Project:* The project was seeking interventions in aquifer systems within regional and trans-boundary implications in ASAL areas. The project was targeting the rehabilitation of 400 rural water schemes and drilling borehole where necessary. Further, it was seeking to develop the stakeholder's capacity and strengthening of enabling environment for sustainable management, access and use of groundwater.
- d) Integrated Water Resources Assessment in Nairobi Metropolis for Sustainable Use and Management of Groundwater Resources: The project was targeting integration of water resources assessment within Nairobi Metropolis and to establish the impacts of development within the area on groundwater and surface water resources.
- e) Other programs include borehole drilling by county governments, National Water Harvesting and Storage Authority, Water Works Development Agencies and Development Partners.

#### Conclusion

The CS stated that—

i. County governments need to pull up efforts in water provision through mobilization of funds, awareness creation and collaborating with community projects to reticulate water from the available sources despite the maintenance and sustainability.

ii. The development of water resources and storage of water was squarely within the mandate of the Ministry. However, the Ministry could not achieve the proposals in the Petition without the participation of county governments.

#### **Committee Concerns**

- i. On the best methods of realizing the proposal for the county governments to engage with stakeholders such as local community projects, the CS proposed that the county governments could engage and support local community water projects. Further, the counties could collaborate to maintain water projects done by various stakeholders e.g., CDF, Development Partners to avoid bureaucracies experienced at different levels of service provision.
- ii. On the question as to whether the Ministry jointly support CDF water projects by matching the allocated budget, the CS indicated that such an arrangement was possible and had worked out in other projects. However, the Members could amend the NG CDF Act to allow for administration of ward-based solutions to address perennial water challenges.
- iii. On the issue as to why the efforts done by the Ministry or other stakeholders were not getting to the villages, the CS responded that the right to clean water was entrenched and was progressively being realized. Further, the main challenges included low water levels due to climate change.
- iv. The Committee urged the CS to engage the Petitioner as he was seeking to contribute from his expertise to assist the Ministry come up with better ideas. The CS undertook to reach out to the Petitioner to discuss the proposals in the Petition.

# Consideration of a Public Petition Regarding Pollution of River Athi

The CS submitted a written submission on the subject matter and further stated that the pollution of River Athi was a concern and the Ministry was aware of the situation and were mobilizing resources to establish huge water treatment plants especially prioritizing the Tana and Athi Rivers.

### **Committee Concerns**

- i. On the status of EPZA sewer system, the CS indicated that the sewer system was old and was constructed in 1993 and needed upgrading. Further, EPZA had continued to provide water services without being controlled by Water Services Regulatory Board (WASREB). Therefore, there were discussions ongoing for EPZA to get out of water provision.
- ii. On the ramifications of the River Athi pollution on the Thwake Dam project, the CS noted that the dam had a capacity of 688 million cubic meters and was at 83% completion with final completion expected by 6<sup>th</sup> February 2024. Therefore, the Ministry was constantly monitoring activities upstream and water quality for bacteria and chemical analysis.

iii. Regarding the solutions to addressing the pollution challenges upstream, the CS stated that there were investments going on to provide total sewer correction in Nairobi and its environs. The CS further stated that Nairobi had the capacity of 192,000 cubic meters of sewer yet it produced about 400,000 cubic meters of sewer thus becoming a major source of upstream pollutants into the River Athi.

# Consideration of a Public Petition Regarding Desiltation of Matinga Dam in Kitui West Constituency

The CS submitted as follows-

- i. Matinga Dam is in Kitui West Constituency in Kitui County and was constructed in 1955. The design storage capacity of the dam is one million cubic metres and serves a population of 200,000 people in Nguutani, Mutonguni and Kauwi wards, with water for domestic and irrigation use.
- ii. The Dam was first desilted in 1972 and has been accumulating silt since then. Currently, the dam reservoir is entirely silted, and all components of the dam are in a dilapidated state and therefore cannot be utilized by the beneficiary community.
- iii. Tanathi Water Works Development Agency (TAWWDA) has been directed to undertake comprehensive engineering studies & surveys and prepare detailed technical designs for the rehabilitation of Matinga Dam.
- iv. The studies and survey conducted will be for the desilting of the dam, rehabilitation of the dam embankment, spillway and fencing of the dam reservoir area. The Agency will conclude these studies and submit them to the Ministry of Water, Sanitation, and Irrigation by 31<sup>st</sup> July 2023 for funding consideration.

#### Committee Concerns

On the status of colonial dams across the country, the CS indicated that there was need for auditing and mapping of all the colonial dams to establish their status. Further, there were about 408 such dams and the Ministry had begun working on some of them using new designs like establishing check dams to arrest the silt before it gets into the main dams. The CS also noted that despite encroachment of the lands allocated for various dams, some of them were strategically located and land was already set aside for them.

# MIN./PPETC/2023/264: CONSIDERATION OF REPORT ON PETITION REGARDING DESILTATION OF MATINGA DAM IN KITUI WEST CONSTITUENCY

The Committee considered the Petition regarding Desiltation of Matinga Dam in Kitui West Constituency. The Petitioners prayed that the National Assembly through the Public Petitions Committee—

- i. ensure that, the desiltation of Matinga Dam in Kitui West Constituency is carried out by the Ministry of Water, Sanitation, and Irrigation to provide water for the residents around the dam and its environs; and,
- ii. makes any other necessary recommendations the Committee deems fit to address the issues raised in the Petition.

The Committee made various observations key among them being that:

- i. Matinga Dam is silted and there is only one aquifer with water which rarely dries up. However, the dam is also unprotected, and residents have encroached the wetland areas to undertake farming activities.
- ii. lack of rehabilitation of the dam has been primarily due to funding challenges and the lack of stakeholder collaboration between County and National Government on the project.
- iii. desiltation of the dam would have several benefits for the residents of Kitui West Constituency including sand harvesting, afforestation of the area, supply of water for irrigation and other income generating activities.

- iv. both the National and County Governments should lobby for funding for the project through budgetary allocation and donor funding from various donors such as the World Bank and Water Sector Trust Fund (WSTF) and ensure accountability systems are set up in the project.
- v. the Ministry of Water, Sanitation and Irrigation was committed to rehabilitating Matinga Dam, but were awaiting results from various feasibility and technical review of the project to ascertain the funding required.
