**RE: ENGINEERS RULES 2019: LAYING OF THE STATUTORY INSTRUMENT BEFORE THE PARLIAMENT**

The Engineers Board of Kenya, with the approval of the Cabinet Secretary, developed the Engineers Rules pursuant to Section 58 of the Engineers Act 2011.

The Board conferred with the Committee on Delegated Legislation in accordance with Section 16 of the Statutory Instruments Act 2013 in a retreat held in Mombasa on 5<sup>th</sup> February, 2019 and a further meeting held on 28<sup>th</sup> February, 2019 at the Parliament buildings.

We revised the Engineers Rules 2019 Pursuant to the recommendations of the Committee on delegated legislation and subsequently forwarded the final rules to the Attorney General for publication.

The Engineers Rules 2019 have since been published vide Legal Notice No. 18 published on 12<sup>th</sup> April, 2019.
