GENERAL FORM OF A PUBLIC PETITION

(STANDING ORDER 223)

Petition on road on 23/5/13 and referred to the committee on transport public works

Mr. Speaker this meets the threshold for presentation to the House pursuant to S.O 225.

We, the undersigned residents of Kiharu constituency (Murang'a County) from Mbiri, Mugoiri and Murarandia wards draw the attention of the house to the following,

- 1) THAT there is a 40km- road that traverses through Mbiri, Mugoiri and Murarandia Wards passing through the following shopping centers within Kiharu Constituency:-

Gacaru, Muchungucha, Kiria, Ndutumi, Githagara, Mirichu, Kagaa, Kaganda, Gathaiti and Gatara.
- 2) THAT the road has remained untarmacked since the period of its establishment in pre-colonial era inspite its surrounding region being densely populated and agriculturally endowed in terms of, inter-alia, milk, bananas, tea and coffee farming activities.
- 3) THAT currently the road is in very poor condition and as a result economic and social activities in that region remain hindered.
- 4) THAT a second Dam to supply Nairobi with water is set to be established at the tail-end of this road (Gatara region) and that project will not be feasible if this road remains untarmacked.
- 5) THAT there is a nearby road (Marimira - Kahuti- Kandara road) that is being established on the ground which will cross the contentious road at Kagaa Shopping Center hence if both roads are tarmacked simultaneously, tax- payers monies would be saved due to economies of scale.

Parliamentary Commission with S.O 227 (1) this will be committed to the committee on Transport, public works and Housing to report within 60 days. Sd/- 23/5/13


- 6) THAT the ministries of finance, roads and public works have failed to give an indication on the date or financial year when the government intends to pave the said road.
- 7) THAT, we hereby confirm that efforts in terms of letters addressed to the relevant ministries and oral representations to the concerned parties have been made to have the matter addressed and no response has been forthcoming .
- 8) THAT, we hereby confirm that the issues in respect of which the petition is made are not pending before any court of law or constitutional or legal body.

WHEREFORE, your humble petitioner (s) prays that parliament:-

- a) Obtain an undertaking from the cabinet secretaries in charge of the ministries of finance, roads and public works that the said road would be paved next financial year.
- b) In the alternative to prayer (a) above, cause the paving of the said road to be provided for in the government budget for the coming financial year 2013/ 2014 by way of appropriating funds.








