The Motion was debated, put and lost.

The Rt. Hon. Member for Rift Valley moved a reduction of £100 in the vote for the Game Department to draw attention to the fact that the recommendation of the Kenya Government in regard to the appointment of an officer to the post of Game Warden had not been followed and that another officer from England had been appointed to the post.

The question was put and lost by 17 votes to 12.

THE RT. HON. MEMBER FOR RIFT VALLEY moved that an additional amount of £5,000 be included in Estimates for 1924 to make provision for European Instructors for the Technical Education of Natives.

The Motion was put and carried.
