

1 PREFACE

1.1 MANDATE OF THE COMMITTEE

- 1. The Committee on Parliamentary Broadcasting and Library is established under Standing Order 212D and is mandated to; -
 - (i) consider and report on all matters relating to broadcasting of the proceedings of the House;
 - (ii) advise the House on matters related to public participation;
 - (iii) make reports and recommendations to the House, including proposed legislation on matters relating to broadcasting of House proceedings;
 - (iv) recommend to and advise the House on matters related to the provision of library, publications, and research services in Parliament, including improvement of the library and research services; and
 - (v) assist Members in utilizing the facilities provided by the library and research services, including the use of information and communication technology.

2.0 BACKGROUND

- 7. The Constitution of Kenya (2010) prioritizes transparency and public access to Parliamentary proceedings and the parliamentary library. Provisions such as Article 118 ensure open business conduct and public accessibility to sittings, while Article 33 1(a) guarantees the right to seek, receive, and share information, including access to Parliamentary proceedings.
- 8. Additionally, Article 35 ensures that every Kenyan citizen has the right to access information held by the State or other individuals. These provisions, found in Chapter Four of the Constitution, uphold the Bill of Rights. Supporting the parliamentary library, legal frameworks like the Parliamentary Service Commission and Strategic Pillar III and the Parliamentary Service Act (No. 22 of 2019) further promote public information access and the utilization of technology for effective communication, dissemination, and storage of information.
- 9. The Library Department is the custodian of Parliamentary documents and plays an important role in providing information and research services to assist the legislative work of Members of Parliament (legislation, oversight, and representation) including Committees and staff.
- 10. The live broadcast of parliamentary proceedings plays a significant role in promoting transparency, accountability, and citizen engagement in the democratic process. The Broadcasting Unit within the Parliament of Kenya is responsible for capturing and disseminating these live broadcasts to the public through various channels. Its main objectives include disseminating information, demystifying the legislative process, and fostering connections between voters and elected representatives.
- 11. The Committee in execution of its mandate, deemed it necessary to undertake a study visit to the Parliament of Zambia to learn and appreciate the advances made on broadcasting of Parliamentary proceedings through television, radio stations and social media platforms. Further, the Committee aimed to understand the operations and digitization of the Parliamentary Information & Research Library.

2.1 RELEVANCE/RATIONALE OF THE STUDY VISIT

- 12. The objectives of the study visit to Parliament of Zambia were-
 - To learn about how Parliament of Zambia engages with citizens and shares information through online platforms, broadcast operations, libraries, and research services. The focus was on improving access to legislative works;
 - (ii) To gain a comprehensive understanding of the legislative document process, including the roles of the Parliamentary Library, and other institutions;
 - (iii) To explore digital initiatives, accessibility options, and preservation efforts for parliamentary documents; and

 (iv) To identify best practices to enhance access, usability, and preservation, thereby promoting research, democratic development, and public information access in Zambia.

2.2 BROADCASTING AND LIBRARY SERVICES IN PARLIAMENT OF ZAMBIA

- 13. The Zambian Parliament is the legislative body in Zambia and it is a unicameral Parliament with one hundred and sixty-seven (167) Members. The Parliamentary Information and Research Library in Zambia was established in 1953 as a small book collection to service the Legislative Council. After the dissolution of the Federation of Rhodesia and Nyasaland, Zambia was allocated the Federal Assembly Library. The library was reorganized to provide up-to-date information on all aspects of Zambian political, social, economic, and developmental areas. The collection has expanded to include diverse subject areas such as agriculture, law, economics, education, and developmental issues. The library's parliamentary papers include Debates, Bills and Acts, Statutory Instruments, Papers-laid-on the Table, Government Ministries and Departments, and Parastatal bodies reports including Budget Speeches.
- 14. The Parliament Library plays a vital role in providing Members of Parliament with the necessary resources and documents to carry out their duties effectively. With a rich history and a commitment to digitalization, the library ensures that valuable information is readily available to support decision-making.
- 15. The Library which houses parliamentary documents, is intended for use by Members of Parliament and staff. However, outside individuals may request permission to use it. Members may borrow up to four books for a period of four weeks, while senior additional two weeks. Members have priority in borrowing and other users are asked to avoid selecting current titles until Members' needs are met.
- 16. The Zambian National Assembly launched its own TV and FM radio stations in 2020 to promote transparency and accountability and to bridge the gap between Parliament and citizens. Parliament TV is available on DSTV Channel 272 and GOTV Channel 100, while Parliament Radio broadcasts parliamentary proceedings nationwide. The use of radio and television channels is an important tool to increase public participation and awareness in the legislative process, and this has encouraged public to take advantage of these additional platforms to follow parliamentary debates in the House and Committee Meetings.

3.0 MEETINGS WITH THE VARIOUS HEADS OF DEPARTMENTS IN THE PARLIAMENT OF ZAMBIA

3.1 Meeting with the Deputy Director, Department of Broadcasting

- 17. The delegation held a meeting with the Deputy Director, Department of Broadcasting who informed them that
 - The Broadcasting Department of the National Assembly of Zambia became a fullyfledged Department in January, 2022 and is responsible for the day to day public relations activities in co-ordination with the media and the national broadcaster especially on critical matters e.g during the Presidential Address and the budget making process;
 - The mandate of the Department is to protect and disseminate information in line with their Communication Strategy as contained in their Strategic Plan which seeks to ensure that there is effective service delivery and public participation;
 - The proceedings of the National Assembly of Zambia and Committee meetings are always aired live save for committee meetings as only one committee meeting is aired live and the rest are recorded. That the decision is based on the issues under consideration with specific regard to public interest matters;
 - iv) The national broadcaster ZANIS is the custodian and distributer of information through live transmission of the proceedings of the House. Additionally, the sittings of the House are streamed live on social media;
 - v) The House has collaborated with the national broadcaster to ensure proceedings of the House and committee proceedings are covered not just sporadically but systematically. Additionally, staff from the national broadcaster had been seconded to Parliament;
 - vi) The live transmission of the proceedings of Parliament had enabled the institution to earn the trust of the people and also drive the agenda of the country;
 - vii) The Parliament leverage on community radio stations to ensure wide coverage of the proceedings of the House.
 - viii) There are twenty- six (26) community radio stations with at least two per province. It had been established that the majority of people listen more to the community radio stations as compared to the national broadcaster; and
 - ix) That Parliament has a Memorandum of Understanding (MOU) with the community radio stations, which are paid on a monthly basis. The proceedings of the House are pre-recorded then transmitted in English and vernacular.

3.2 Meeting with the Second Deputy Speaker of the National Assembly of Zambia

18. The delegation held a meeting with the Second Deputy Speaker of the National Assembly who informed the delegation that—

- i) The Parliamentary Reforms and Modernisation Committee is established in accordance with Standing Order No. 202 of the 2024 National Assembly of Zambia Standing Orders;
- The Committee comprises of the Minister of Finance, the Minister of Justice, the Minister of Local Government, and six other Members appointed by the Standing Orders Committee, and the Second Deputy Speaker as the Chairperson;
- iii) The functions of the Committee include among others, examining and proposing reforms to the powers, procedures and practices, organisation and facilities of the Assembly. Further, that, from about November 2002, when the parliamentary reform programme commenced, the Committee had contributed to the achievement of the following milestones among many others:
 - a) Alignment of Parliamentary Committees to Government Ministries to enhance policy development and scrutiny, and opening up Committees to the public, which has enhanced public participation in Committee meetings;
 - b) Improving the legislative process, by referring Bills to relevant Committees for more detailed and careful consideration after First Reading, with input from stakeholders and the public; and covering the cost related to the drafting of Private Member's Bills as a way to encourage Members to initiate and introduce Private Member's Bill in the House;
 - c) Increasing the staff establishment and reorienting it to correspond to the new organization structure and work of the Institution, and conducting capacity building of staff, including job evaluation and assessment;
 - d) Provision of support services to Members and Management of the National Assembly of Zambia by establishing, the Parliamentary Budget Office (PBO) in 2012; Monitoring and Evaluation Department (M&E) in 2019; and Parliamentary Broadcasting Department in 2022.
 - e) The Committee had enhanced its Member Constituency Relations through the establishment of Constituency Offices in all the 156 Constituencies, which act as information centres for constituents, as well as centres of interaction between MPs and local stakeholders;
- iv) The National Assembly of Zambia had also established the Parliament Radio, Television and National Assembly of Zambia Facebook Page to facilitate the dissemination of information to the public about Parliament and vice versa; and
- v) The establishment of the Parliament Website was a key milestone as it provides key information on major events that take place in Parliament and relevant publications such as the Order Paper, profiles of Members of Parliament, Bills, Ministerial Statements and daily Hansards (parliamentary debates). Further, that the parliamentary website is used to transmit live and recorded programmes from Parliament Radio.

3.3 Meeting with the Director Library Services

- 19. The delegation also held a meeting with the Director of Library Services who informed the delegation as follows
 - The Library was set up to provide Members with information they need to meaningfully and effectively participate in the debate of many issues that come before the House;
 - The Library Department is responsible for the intake, processing and arrangement of the main collections of books, pamphlets, newspapers and periodicals; also for the preservation and indexing of all Parliamentary papers and of many other official publications, domestic and foreign; and for the maintenance of specialised indexing;
 - Since 2010, the Department embarked on the digitization of library resources. This collection is made available through its institutional repository (D-Space) and can be accessed by the public;
 - iv) The digital repository contains a collection of various Parliamentary documents ranging from papers laid on the table of both chambers of Parliament, Committee Reports, Standing orders, Bills, Colonial Ordinances the Hansard, various national government publications among other publications.
 - v) The Department has a repository of articles on matters of public interest and daily newspaper alerts on MPs. Additionally, the Department has come with an initiative of identifying a relevant book of the month in order to encourage MPs to read;
 - vi) Through the Zambian Parliament, the Library has been able to set up Constituency libraries in the 156 constituencies that are information centres on parliamentary issues;
 - vii) Through the Zambian Parliament, the Library is a member of the Association of Parliamentary Libraries in Eastern and Southern Africa (APLESA), which was constituted in 1995. Other members include the Parliaments of Angola, Botswana, Kenya, Lesotho, Malawi, Namibia, South Africa, Swaziland, Tanzania, Uganda, and Zimbabwe. The Association facilitates, among other things, the exchange of technical know-how among librarians in the region.
 - viii) The leadership of the National Assembly in collaboration with the Department of Library Services had established a Parliamentary Caucus on Literacy (PCL) whose purpose is to add a voice to initiatives in alleviating low literacy or even helping in improving children's literacy right through to adult education which will in turn help the nation to enhance literacy and life learning skills with the aim of eradicating poverty among the vulnerable communities;
 - ix) The overall objective of the Caucus is to provide literacy skills to citizens with little or no literacy skills with suitable training designed to meet their basic educational needs to reduce the illiteracy rate as well as maintain and develop them further.

- x) The Specific objectives of the Parliamentary Caucus on Literacy include among others the following:
 - a) Sensitize Members of Parliament on the importance of literacy in national development and policy making;
 - b) Advocate for increased funding towards literacy programmes;
 - c) Advocate for strengthening of the capacity of information centres in the Constituency Offices by mobilizing support from the cooperating partners;
 - Advocate and support increased availability of books and learning materials to vulnerable learning centres such as community schools; and
 - e) Mobilize support from cooperating partners
- xi) To achieve the foregoing specific objectives, the Caucus uses the following broad strategies:
 - a) organise open days in Constituencies for Members to encourage Communities to read and access reading materials to be mobilized from cooperating partners;
 - b) engage with the cooperating partners for both financial and material support on literacy activities;
 - c) have a literacy day at Parliament in collaboration with partners to show case literacy outreach activities; and
 - d) flag off distribution books road shows to Communities.
- xii) The expected outcomes of the PLC include increased literacy for the benefit of the general citizenry; increased participation of citizens in governance programmes through access to information and general literature; improved reading culture among the citizenry at local and national level; and enhanced collaboration between Members of Parliament and interest groups on literacy programmes at both local and national level; and
- xiii) That the specific target groups of the PLC are Members of Parliament (MPs), Youths, Women, Children, Adults, Prisoners, Rural Communities and Indigenous Language Speakers.

4.0 COMMITTEE OBSERVATIONS

20. The delegation made the following observations:

- The proceedings of the National Assembly of Zambia are always broadcast live, with the exception of committee meetings. Only one committee meeting is aired live while the others are recorded;
- ii) The live transmission of plenary proceedings and Committee meetings is made possible through a partnership between the Parliament of Zambia and ZANIS, which is similar to the collaboration in Kenya where the Parliamentary Service Commission (PSC) has partnered with the Kenya Broadcasting Corporation (KBC) to broadcast the proceedings of the House;
- iii) Similar to the Kenyan Parliament, the Parliament of Zambia has digitized its library resources through its institutional repository, D-Space, which is accessible to the public. The repository contains a collection of various Parliamentary documents ranging from papers laid on the table of both chambers of Parliament, Committee Reports, Standing orders, Bills, Colonial Ordinances the Hansard, various national government publications among other publications;
- iv) Parliament of Zambia leverages on community radio stations to ensure broader coverage of House proceedings, with twenty-six (26) radio stations, at least two per province, as the majority of people prefer community radio stations over the national broadcaster;
- v) The Parliament of Zambia has established Constituency libraries in all the one hundred and fifty-six (156) Constituencies, which act as information centres for constituents, as well as centres of interaction between MPs and local stakeholders; and
- vi) The Parliament of Zambia has established a Parliamentary Caucus on Literacy (PCL) in order to provide literacy skills to citizens with little or no literacy skills with suitable training designed to meet their basic educational needs to reduce the illiteracy rate as well as maintain and develop them further.

5.0 COMMITTEE RECOMMENDATION


21. The delegation recommends that the Parliamentary Service Commission;

- (i) Collaborates with the local vernacular radio stations in order to ensure wide coverage of House proceedings and Committee meetings so as to facilitate effective public participation;
- (ii) Establishes a Parliamentary Caucus on Literacy (PCL) to provide literacy skills to citizens with limited or no literacy, thereby increasing their participation in governance programs through improved access to information and literature, and enhancing effective representation in Parliament.; and
- (iii) Establishes information centers in all constituencies to enhance interaction between Members of Parliament and local stakeholders, thereby facilitating effective public participation.

The report outlined objectives of the study visit to the Zambian Parliament, briefs from various departmental heads, an overview of the history of the Zambian Parliament Library, details on the National Assembly's TV and FM radio stations, as well as the delegation's observations and recommendations.

After reviewing the draft report, the Committee highlighted the following lessons from the study visit;

- 1. Public participation can be enhanced through use of local radio and TV stations as these platforms can be used to inform the citizens about government activities. Often, the general public remains uninformed regarding parliamentary proceedings however, local radio and TV stations can effectively bridge this gap by disseminating relevant information in vernacular languages.
- 2. Library and Information Centers should be established in each constituency and should be open for free public access for fostering education, community engagement, and information. This initiative will not only promote education and community engagement, but also facilitate the widespread dissemination of information.
- 3. Parliament should consider having a Parliamentary Caucus on Literacy (PCL) which is key in providing literacy skills to citizens and MPs to reduce the illiteracy rate as well as maintain and develop them further.

It was resolved the secretariat to prepare a summary of the report highlighting key points and identify any shortcomings that need to be addressed in order to improve the PBU. In addition, the report to be prepared for the Committee to adopt and table in the House.
