**STATEMENT ON APPROVAL OF PAYMENT FROM THE CONTINGENCIES
FUND**

1. Article 223 (1) (a) & (b) of the Constitution of Kenya allows the National Government to spend monies that have not been appropriated by Parliament if the amount appropriated under the Appropriation Act is insufficient or a need has arisen for expenditure for a purpose for which no amount has been appropriated; or if the money has been withdrawn from the Contingencies Fund.
2. Section 22(1) of the Public Finance Management Act (PFMA), 2012 requires that after the payment from Contingencies Fund in terms of section 21, the Cabinet Secretary shall submit to Parliament a detailed report in respect of the payment setting out the information specified in section 23(2) and seek Parliament to approve the payment.
3. Pursuant to the provisions of the Constitution and the PFMA, 2012, the Cabinet Secretary has received and approved withdrawal from Contingencies Fund for an expenditure to support the flood victims under the State Department for Interior.
4. In accordance to section 23(2) of the PFMA, 2012 the following are the details of the said payment.

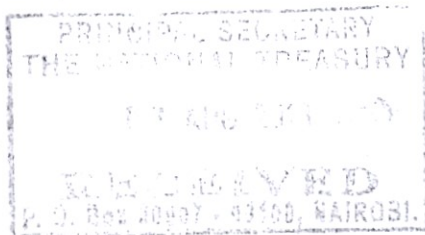
- i. **The date and amount of each payment made from the Contingencies Fund:**
The payment was made in June 2018 and the amount was **Ksh 1,050,000,000**;
- ii. **The Person to whom the payment was made:** Vote 1021 - State Department for Interior;
- iii. **The purpose for which the payment was made:** extend humanitarian support to victims of the recent flood incidences in the country;
- iv. **If the person to whom the payment was made has spent the money for that purpose, a statement to that effect:** the State Department for Interior spent the money for the indicated purpose as per the attached summary and other supporting expenditure details; and
- v. **A statement indicating how the payment conforms to section 21:** The payment was approved and withdrawn on account of supporting people affected by floods country wide. This was unforeseen disaster and was meant to support families affected by floods, families who lost loved ones across the country through floods and floods response countrywide.

5. The purpose of this Statement is to submit the details of the payment in accordance to Section 22(2) of the PFMA, 2012 and request the Parliament to approve the payment to enable the Cabinet Secretary to cause an appropriation of the money paid and the replenishment of the Contingencies Fund.






