A. Status of court cases

Since the enactment of the Kenya Constitution 2010, the National Government Constituencies Development Fund has been faced with two court cases, in quick succession. These have negatively affected the operations of the Fund. The issues and determinations in the two cases are as outlined below;

Case 1. (Petition No. 71 of 2013)

The first case was instituted by the institute of social accountability (TISA) and centre for enhancing democracy and good governance in 2013 against National Assembly, Senate, Attorney General and the then CDF Board. The petitioners sought among other things, whether the Act violated the Division of functions as between the national and County Governments. The court made the ruling on 20th February 2015 which gave the Board one year to align itself to the constitution 2010 culminating to NG-CDF Act 2015. The

Board appealed against the ruling, currently the matter is in the court of appeal and parties are in the process of filing submissions.

Case 2. (Petition No. 178 of 2016)

The petition of May 4, 2016 was instituted by Wanjiru Gikonyo and Cornelius Oduor Opuot against the National Assembly of Kenya, the Senate of the Republic of Kenya, the Honourable Attorney General, National Government Constituency Development Fund Board and Cabinet Secretary, Treasury.

Interested parties includes; the Council of Governors, Charles Agar Owino, Peter Runkin Ouma Onyango and Isabel Nyambura Waiyaki.

Generally, the petitioners argued that like its precursor, the NG-CDF Act, 2015 is unconstitutional.

The court made the following ruling on the preliminary application:

1. Debarred the Cabinet Secretary, National Treasury from releasing to the National Government Constituency Development Fund (NG-CDF) any amount exceeding Kshs. 25,000,000,000.00 during the financial year 2016/2017, pending hearing and disposal of main Petition. This was in the Court's opinion the correct amount equivalent to 2.5% due to NGCDF from the National Government's share of Revenue ;
2. Declined to declare Division of Revenue Act 2016/2017 unconstitutional; and

3. The Petition to be transmitted to the Office of the Chief Justice to constitute a bench of not less than three judges to hear and determine the Petition.

The case is coming up on 17th November 2016 for direction by the court.

The Board has decided to appeal against the Interim High court ruling restricting the Cabinet Secretary, National Treasury from disbursing to the NG-CDF an amount exceeding Ksh. 25 billion, based on advice of its advocates.

Further details on the two cases are given in Annexes to this document.

B. Status of Submission of Projects Proposals

The Board issued a circular to Constituencies on submission of project proposals for 2016/17 financial year. Key among the issues highlighted in the guideline was compliance to submit the proposals by 15th November, 2016. The following is the submission, approval of project proposals for 2016/17 financial year and status of disbursement of funds with respect to previous and current financial years.

(b) Financial Year 2015/16 Receipts

The Board received a total of Ksh 35, 213, 000,000 with respect to allocations for the 2015/16 financial year. A further Kshs. 2 billion was received on 3rd July, 2015 being part of the outstanding arrears for the 2014/15 financial year.

E. Outstanding arrears for 2011/2012, 2013/14 and 2014/15

F. Disbursement of Funds to Constituencies for 2016/2017 FY

Criteria for disbursement

For a constituency to qualify for disbursement of funds, it must meet the financial threshold set by the Board that the bank balance as attested by a Bank Statements must not exceed Kshs. 10 million. This is meant to ensure that constituencies focus on putting funds to the intended use, hence avoid wastage through huge accumulation of balances in constituency accounts.

Financial Year 2016/2017 Disbursements

Out of the Ksh 15 Billion received, the Board disbursed Kshs 2,735,344,862 to constituencies with respect to 2016/2017 allocation and Kshs 3,253,689,841.75 has been disbursed to the constituencies with respect to outstanding arrears for previous financial years. A balance of Ksh 9,010,965,296.25 is still held at the Boards CBK account.

A total of Kshs. 1,719,827,555.04 has been disbursed to 42 constituencies in respect to 2016/17 FY, each receiving Kshs. 40,948,276.60. Further a total of Kshs. 1,015,517,244.80 has been disbursed to 148 constituencies for 2016/17 FY emergency fund with each constituency receiving Kshs. 4,094,827.60 as shown below.

G. Status of disbursements for previous financial years

a) Financial Year 2015/2016 Disbursements

Kshs. 33,687,378,744 of the amount received 2015/2016 and 2016/2017 was disbursed to constituencies with respect to 2015/16 project proposals approved by the Board as summarized below:

- i. One hundred ten (110) constituencies have received full disbursement of their 2015/2016 allocation amounting to **Ksh 12,451,927,748**
- ii. One hundred fifty three (153) constituencies have received at least 90% of their 2015/2016 allocation amounting to **Ksh 17,643,898,835**
- iii. Nine (9) constituencies have received at least 75% of their 2015/2016 allocation amounting to **Ksh 873,676,540**
- iv. Seventeen (17) constituencies have received at least 50% of their 2015/2016 allocation amounting to **Ksh 947,225,621**
- v. One (1) constituency has received statutory allocation for 2015/2016 to cater for bursary amounting to **Kshs. 10,000,000**
- vi. **Ksh 1,760,650,000** has been disbursed to the Board Secretariat for financial year 2015/2016

b) Payment of arrears for previous years

Out of the total amount received in the 2015/2016 and 2016/2017 financial year, the Board has disbursed a total of Ksh 6,779,311,097.75 to constituencies with respect to outstanding arrears accumulated from 2009/2010 to 2014/2015 financial years.

H. Annex III: Court Cases Challenging NG-CDF

Since the enactment of the Kenya Constitution 2010, the National Government Constituencies Development Fund has been faced with two court cases, in quick succession. These have negatively affected the operations of the Fund. The issues and determinations in the two cases are as outlined below;

A. Case 1. (Petition No. 71 of 2013)

The first case was instituted by the institute of social accountability (TISA) and centre for enhancing democracy and good governance in 2013 against National Assembly, Senate, Attorney General and the then CDF Board.

The petition sought determination of the following issues:

- Whether the process leading to the enactment of the then CDF Act (amendments) of 2013 were unconstitutional due to non-involvement of Senate;
- Whether the Act violated the principles of public finance and division of revenue. (Did the CDF then upset the formula for equitable sharing of national revenue);
- Whether the Act violated the Division of functions as between the national and County Governments; and
- Whether the CDF Act offended the Principle of separation of powers.

The court made the ruling on 20th February 2015, as follows:

- That suspension of the order of invalidity would be appropriate in these circumstances as it will allow the legislature time to correct the defective legislation while avoiding chaos and disarray in a system that has been established for over a decade; and
- The national government was entitled to remedy the defects in the period (1yr) either in form of new legislation or other means.

In accordance with the ruling, the CDF, then repealed the CDF Act 2013, leading to NG-CDF Act 2015, which came into effect on 16th February 2016. Among the notable changes were the name of the organisation to National Government Constituencies Development Fund and also the scope of projects which have been limited to national government functions as per the constitution

B. Case 2. (Petition No. 178 of 2016)

The petition of May 4, 2016 was instituted by Wanjiru Gikonyo and Cornelius Oduor Opuot against the National Assembly of Kenya, the Senate of the Republic of Kenya, the Honourable Attorney General, National Government Constituency Development Fund Board and Cabinet Secretary, Treasury.

Interested parties includes; the Council of Governors, Charles Agar Owino, Peter Runkin Ouma Onyango and Isabel Nyambura Waiyaki.

Generally, the petitioners argued that like its precursor, the NG-CDF Act, 2015 is unconstitutional. Some of the sections cited as unconstitutional includes:

- i. S3- the objects of the Act(NGCDF Act 2015) undermine devolution;
- ii. S4- on the establishment of the Fund- undermines the principles of public finance and in turn this makes the funds allocation to the Fund for the financial year 2016/2017 under the Division of Revenue Act contrary to constitutional provisions;
- iii. S. 15(4) approval of Board Members- undermines principle of separation of powers;
- iv. S.19 removal of a Board member- undermines principle of separation of powers;
- v. S. 20 appointment of the CEO- undermines principle of separation of powers;
- vi. S. 23 approval of budget for secretariat- undermines principle of separation of powers;
- vii. S. 24 types of projects (concurrent)- undermines devolution;
- viii. S. 43 appointment of CDFC (approval at NA)- undermines the rule of rule and the principle of separation of powers; and
- ix. S. 53. Constituency oversight Committee- undermines principle of separation of powers

They also cited the following issues:-

- Failure to involve Senate and Commission on Revenue Allocation during the formulation of the NG-CDF Act 2015.

The issues that the petitioners sought the court to determine were:

1. That a declaration that the allocation of funds before vertical division between the national and the county governments contravenes Article 203 of the constitution and therefore unconstitutional.
2. That those parts of the Division of Revenue Bill/Act locating the source of funds for the NG-CDF before vertical division of revenue between the county and national governments is a violation of the constitution principles of public finances under Article 201 and 203 of the constitution and the rule of law principle under Article 10 and it is inimical to the basic structure of the constitution in regards to devolution of powers;
3. That a declaration be issued that the National Government Development Fund Act of 2015 is unconstitutional, because it offends the principles of separation of powers, division of functions and the principles of public finance;
4. That a declaration be issued that the Bill that resulted into the Act was a bill concerning county governments and hence failure to subject it for consideration by the senate was unconstitutional and renders the Act invalid;
5. That a declaration be issued that any attempt to establish a constituency provided for in Article 89(1) as a unit of development and parallel planning from the county and national executive planning and implementation of executive functions is unconstitutional because it goes against the basic structure of the Constitution;
6. That a declaration be issued that any office, organ or body purportedly established by this NGCDF Act is illegal as it is created in contravention of the Constitution;
7. That a declaration be issued that numerous provisions of the NG-CDF Act that violate the constitution cumulatively render the entire Act untenable and therefore constitutionally invalid;
8. That an order issue striking down the NGCDF Act in its entirety for being unconstitutional;
9. That an order issue permanently restraining the Cabinet Secretary, Treasury from allocating funds to the National Government Constituency Development Fund on the basis of the Division of Revenue Bill/Act, 2016;
10. That an order issue striking down those parts of the Division of Revenue Bill/Act 2016, purporting to allocate funds to the National Government Constituency Development Fund before the vertical division of revenue between the county and national governments;
11. That an order issue providing mechanisms and timeline of winding up any and all projects and activities undertaken under the Act;
12. That the Costs of, and incidental to, this Petition be awarded to the Petitioners against the Respondents; and

That the Court be please to grant such further directions or orders as may be just and appropriate.

The petitioners also made a preliminary application on their petition where they prayed for the following orders pending the hearing of the main petition:-

1. Debarment of the Cabinet Secretary from releasing 2016/2017 NG-CDF Funds allocation of Kshs. 35,000,000 on allegations of unconstitutionality of NG-CDF Act 2015, thereby halting its implementation;
2. Declaration of Unconstitutionality of Division of Revenue Act 2016/2017 in allocating Kshs. 35,000,000 to NGCDF which they argued was done before allocation of revenue to Counties;
3. Select at least three Judge bench to hear the main petition

The court made the following ruling on the preliminary application:

4. Debarred the Cabinet Secretary, National Treasury from releasing to the National Government Constituency Development Fund (NG-CDF) any amount exceeding Kshs. 25,000,000,000.00 during the financial year 2016/2017, pending hearing and disposal of main Petition. This was in the Court's opinion the correct amount equivalent to 2.5% due to NGCDF from the National Government's share of Revenue ;
5. Declined to declare Division of Revenue Act 2016/2017 unconstitutional; and
6. The Petition to be transmitted to the Office of the Chief Justice to constitute a bench of not less than three judges to hear and determine the Petition.

Currently the above orders on the preliminary application are in force and the effect is that the allocations to Constituencies for the 2016/2017 must be based on the amount allowed by the court i.e. Kshs. 25,000,000,000. The matter has also been placed before the office of the Chief Justice awaiting the constitution of a three judge bench.

The NG-CDF Board has appealed this preliminary ruling in order to address the withheld Kshs. 10,000,000,000.00 as the basis for the Court's calculation was not well elaborated in its ruling.
