- I. The Club is mandated,

  - (e) Organizing and preparing the Kenya Parliament team to the annual EAC games and advocating the interest of Kenya as a Nation in the EAC.




## SUMMARY

The East African Community inter-Parliamentary(EAC) games 2015 report entails the background of the Games, The background of the Bunge Sports Club and the previous performance of Team Kenya since the onset of the games in the year 2001 in Arusha-Tanzania.

Four partner states from the EAC, (Kenya, Uganda, Rwanda and East African Legislative Assembly (EALA) took part in the 2015 Kigali Games and participated in Football, Volleyball (men and women), Netball, Athletics (men and women), Golf and Tug of War (men and women).

Team Kenya were the **Overall Winners** after having won winner's trophy in Volleyball men, Tug of War men, Tug of War women, Athletics men and Golf. The team also secured Runners up trophy in Volleyball women and Netball, 2<sup>nd</sup> Runners up in Athletics women and fourth place in Football.

Besides being the Overall Winner, Team Kenya was also unanimously voted the **best disciplined Team** owing to the impeccable team organization displayed during the Tournament.

The report also contains the challenges and proposed solutions as well as resolutions for future activities.

# **REPORT OF THE EAST AFRICAN COMMUNITY INTER-PARLIAMENTARY GAMES TOURNAMENT HELD IN KIGALI-RWANDA IN DECEMBER 2015**

## **1.0 INTRODUCTION**

The East African Community (EAC) Inter-Parliamentary Games are a key aspect of building relations between the East African Legislative Assembly (EALA) and the Parliaments in the East African Community regions. The games play a fundamental part in enabling EALA interact with Members of the National Parliaments in the partner states as envisaged in article 49(2a) of the Treaty for the establishment of the EAC. It is a mechanism applied to enhance interaction with the citizenry of the Partner States and as a mode of sensitization to popularizing the integration process.

The establishment of the annual EAC Inter-Parliamentary Games emerged during the 4<sup>th</sup> EAC Speaker's forum held in 2009 in Arusha, which agreed to have the Inter-Parliamentary Games held on annual and rotational basis. During this meeting the Member states were requested to include the championships in their budget line. EALA has since then continued to organize the games as the Secretariat/Coordinator, working closely with the hosting National Parliament to ensure successful tournaments.

The Games which started with only one discipline of football has since evolved to include Netball, Tug of War, Athletics, Volleyball and Golf.

## **2.0 BUNGE SPORTS CLUB**

Bunge Sports Club is as old as the Parliament of Kenya. Members of Parliament realized from the outset that sports unites people in a way that little else does and its more powerful than anything else in breaking down all kinds of social and tribal barriers.



Successive Parliaments from the First to the Eleventh have continuously as per tradition established the leadership of Bunge Sports to run the affairs of the club ever since. The current Bunge Sports Club is led by the Hon. Wafula Wamunyinyi as Chairman and the two Speakers as Co-Patrons.

### 3.0 THE PREVIOUS GAMES

The Parliament of Kenya has taken part in all the Games since inception and performed as follows:

#### **4.0 2015 - KIGALI – RWANDA**

The focus of this report is on the Kigali-Rwanda Games – 2015. The Parliament of Rwanda agreed to host the Games during the post Arusha review Tournament 2014 held in Bujumbura – Burundi from 4<sup>th</sup> to 11<sup>th</sup> December, 2015. This was ratified during the Pre-Kigali 2015 preparatory meeting held in Nairobi, Kenya on 14<sup>th</sup> to 18<sup>th</sup> October, 2015 attended by representatives of all the Parliaments. This meeting set the date of the tournament to kick off from 4<sup>th</sup> to 11<sup>th</sup> December, 2015.

#### **4.1 Participants**

The 2015 EAC Inter-Parliamentary Games was attended by the following EAC Partner States Parliaments/Assemblies:

- Kenya
- Uganda
- Rwanda and
- East African Legislative Assembly (EALA)

#### **4.2 Disciplines**

The 2015 EAC Inter-Parliamentary Games included the following and Kenya took part in all of them.

- (i) Football
- (ii) Volleyball (Men and Women)
- (iii) Tug of War (Men and Women)
- (iv) Athletics (Men and Women)
- (v) Netball
- (vi) Golf

#### **4.3 The Kenya Team**

##### **4.3.1 Training and Preparations**

The preparation of the Kenyan Team, Road to Kigali started long way back in March 2015 with all the teams involved in intensive training on Tuesdays and Thursdays at the Nyayo Stadium. The training was supplemented by frequent

participation in various invitational tournaments for the players to gain match fitness and team cohesion in the various disciplines.

#### 4.3.2 Team Selection

Members of Parliament and staff were selected to the main team based on the following criteria:-

- (i) Membership to the Bunge Sports Club,
- (ii) Availability for the duration of the tournament,
- (iii) Free from any form of disease or injury,
- (iv) Physical fitness based on regular training, based on technical and tactical capability,
- (v) Slots as per the Rules and Regulations on registration,
  
- (vi) Discipline especially on the part of the staff selected to support the Members and
- (vii) Endorsement by the Technical Committee of the Bunge Sports Club.

#### 4.3.3 Kits and Uniforms

All the teams were well kitted with official uniforms and playing kits save for the Netball Team which had challenges on the sizes. The Kenyan teams were judged the smartest however it was the feeling of the Members that in future the kits be individualized with the names of the Members printed on the jerseys.

#### 4.3.4 Medical Team

The Medical Unit headed by Hon. Dr. Robert Pukose was manned by two medical personnel from the Ministry of Health and supplemented by a physiotherapist and massage therapists from the Health club. The unit managed to take care of all the medical needs of the entire contingent.

#### 4.3.5 Technical Personnel

The Kenya Parliament engaged the services of a netball and volleyball coach from the Kenya Prison Services since such expertise does not exist in Parliament. The two coaches were with the team throughout the year and were in charge in Kigali.

#### 4.3.6 Funding

The team was well funded throughout the year up to and including the Games in Kigali despite the lack of a budget line for the Games. This showed a serious commitment by the Parliament of Kenya to this Games.

### **4.4 The Tournament**

#### 4.4.1 Teams Management

The Kenyan Team was led by the Chairman of the Bunge Sports Club, Hon. Wafula Wamunyinyi,MP at the Club level but collectively by the Member of the Speaker's Panel-National Assembly Hon. Jessica Mbalu,MP together with Hon. Commissioner Lorna Mumelo and Hon. Commissioner Dr. Abdullahi Ali from the Commission.

At the team level there was a team of coordinators and captains whose main responsibilities were to organize the teams for training, matches and provision of all requirements through the Chief Coordinator and the Deputy Coordinator.

Meetings were held every evening to review the day's activities and prepare for the activities of the next day. In this way each and every member of the contingent had a role to play in the smooth management of the team. A total of nine meetings were held for the duration.

#### 4.4.2 Pre-Tournament Conference

The pre-tournament Conference was held on 4<sup>th</sup> December, 2015 in Rwanda Parliament attended by all the Team Leaders and participants. The main aim of the Conference was to offer a forum to enable Members and staff bond in a relaxed atmosphere and build harmony prior to the commencement of the Games.



Every Speaker used the occasion to reiterate that the Games was a forum to accelerate the deepening and widening of the East African Community and that after the games, unity, harmony and peaceful coexistence should be the outcome of the championships.



After the conference all the teams had a colourful procession from Rwanda Parliament to Amahoro Stadium for the games opening ceremony and kick off.

## **5.0 CHALLENGES/PROPOSED SOLUTIONS**

The team faced serious challenges leading to and during the Games in Kigali, Rwanda which affected their performance especially in Football.

### **5.1 Training and Training matches**

The turnout for the weekdays trainings was poorly attended throughout the year and this was also witnessed during training friendly matches. This affected team dynamics in team fitness, tactics and techniques. ***A mechanism should be explored to interest the Members to attend training sessions and training friendly matches consistently.***

### **5.2 Kits and uniforms**

There was a problem with the kits especially for the Netball Team due to the sizes of the players. ***This can be addressed by making acquisition early so that the uniforms are ordered as per the size***

### **5.3 Team Selection**

Despite the fact that the Team and officials were selected based on a set up criteria, there was still a scramble for positions to travel to Kigali at the last minute.

***To avoid this the criteria on selection should be upheld at all the levels of decision making to bring about some semblance of order.***

### **5.4 Technical Personnel**

The teams relied on coaches from the Kenyan Prisons Services in Netball and Volleyball due to the fact that Parliament does not have the expertise.

***Bunge Sports Club have embarked on making sure that the technically sound staff are sponsored to undertake coaching courses in various disciplines. Towards this end three staff (Ms. Florence Chemutai, Ms. Daisy Rotich and Mr. Fredrick Werimo) have been trained and are now qualified Netball Coaches.***

#### **5.5 Medical Issues**

Due to the age of the Members of Parliament participating in Sports activities, proper medical initiative must be put in place to avoid unfortunate incidences which may occur as a result of late medical intervention during trainings and competition.

***Towards this end Dr. Christine Sagini who is a staff of the parliamentary service commission should be attached to the Bunge Sports Club to be in charge of the medical unit.***

#### **5.6 Funds**

There has been a problem of funding the team every year during the EAC Inter Parliamentary Championships hampering the smooth preparation of the Team.

***Since this is an event which features prominently in the Calendar of events every year, adequate funding should be budgeted for this activity.***

#### **5.7 Staff Involvement**

There has emerged a serious interest by the members of staff in these Games despite the fact that the EAC Inter Parliamentary Games are essentially for Sitting Members of Parliament of the Members States save for a few slots reserved for a few staff in various disciplines. This has created animosity and bad blood from members of staff who are left out during selections.

***To accommodate staff in this games, the Parliament of Kenya should spearhead the formation of the EAC Sports Championship for Staff***

## **6.0 CONCLUSION**

The role of sports in social interaction cannot be overemphasized and this formed the wisdom of the Speakers of the Member States of the EAC to embrace Sports as a key aspect of sensitization and popularization of the EAC Integration.

The Championships brings together over five hundred Members of Parliament and thousands of EAC citizens together every year and the conception of the Pre-Tournament Conference first held in Kigali-Rwanda is a brilliant idea to cement the relationships and bring peace, harmony and brotherhood to the competition.

Nelson Mandela once said this about sports, ***“Sports has the power to change the world. It has the power to inspire. It has the power to unite people in a way that little else does. It speaks to the youth in a language they understand. Sports can create hope where once there was despair. It is more powerful than Governments in breaking down social barriers”***. This quote captures the spirit and true essence of the EAC Inter Parliamentary sports championships.

## **7.0 RESOLUTIONS**

### **7.1 Hosting of the EAC Championships 2017**

Kenya is due to host the EAC championships in the year 2017 but being an election year, Members may not be available, Bunge Sports Club has requested the organizers to be allowed to host the Championships this year 2016.

***Kenya Parliament is therefore requested to write formally to the organizers to express this interest.***

### **7.2 Funding**

The decision to hold the EAC Inter Parliamentary Games on an annual and rotational basis was agreed on at a high level by the EAC Speakers at the Speaker's 4<sup>th</sup> Forum held in Arusha in the year 2009. This meeting reiterated the need for the Members states to include a budget line for this activity in their budget line to ensure continuous participation by the Member States.

***Kenya Parliament should therefore have an adequate budget factored in 2016/2017 financial year for this and other activities leading to the Games and especially if Kenya will be awarded the hosting rights.***






