On Wednesday 15th August 2018, the Committee carried out the vetting exercise. The Committee was guided by the Constitution, the Public Appointments (Parliamentary Approval) Act No. 33 of 2011; Independent Policing Oversight Authority Act and the National Assembly Standing Orders.

The Committee, in compliance with the Constitutional and other legal requirements and established procedures for vetting, ensured that its approval hearing meetings were open to the public and covered by the media.

EXECUTIVE SUMMARY

This report contains the Committee's proceedings during the approval hearing following the nomination by H.E the President. of Mrs. Anne Wacheke Makori as Chairperson and Mrs. Doreen Nkatha Muthaura, Mrs. Fatuma Mohamud Mohamed, Dr. Walter Owen Owuor Ogony, Mr. Jonathan Ltipalei Lodompui, Ms. Praxedes Chepkoech Tororey, Dr. Jimmy Mutuku Mwithi,and Hon. John Muriithi Waiganjo as members of the Independent Policing Oversight Authority. The notification was communicated to the House by the Speaker on Tuesday 7th August, 2018.

The Clerk of the National Assembly requested for memoranda from the Public on suitability or otherwise of the nominees, however, by close of the deadline for submission, no memoranda had been submitted for or against the nominees.

The nominees appeared before the Committee for the approval hearings on Wednesday 15th August, 2018 and the Committee examined their suitability based on the criteria set out by the Public Appointments (Parliamentary Approval) Act, 2011.

The nominees were vetted on their academic credentials, relevant experience, knowledge of sector issues and leadership and integrity.

Based on their performance during the vetting exercise the Committee found the nominees to have a wealth of experience, professionalism, integrity, knowledge on police oversight and Public Service. The process was in compliance with the Independent Policing Oversight Authority Act and therefore the Committee recommends that the House to approves the nominations of the aforementioned persons for appointment to the Independent Policing Oversight Authority Board.

1.0 PREFACE

1.1 Establishment and mandate of the Committee

The Departmental Committee on Administration and National Security is established under *Standing Order 216* with the mandate to:

- a) investigate, inquire into, and report on all matters relating to the mandate, management, activities, administration, operations and estimates of the assigned ministries and departments;
- b) study the programme and policy objectives of Ministries and departments and the effectiveness of their implementation;
- c) study and review all the legislation referred to it;
- d) study, access and analyze the relative success of the Ministries and departments as measured by the results obtained as compared with their stated objectives;

- f) vet and report on all appointments where the Constitution or any law requires the National Assembly to approve, except those under Standing Order No.204 (Committee on appointments);

- h) make reports and recommendations to the House as often as possible, including recommendation of proposed legislation;
- i) consider reports of Commissions and Independent Offices submitted to the House pursuant to the provisions of Article 254 of the Constitution; and
- j) examine any questions raised by Members on a matter within its mandate.
- In executing its mandate, the Committee oversees the following Ministries and Departments:
 - i) The Ministry of Interior & Coordination of National Government
 - a) State Department of Interior;
 - b) State Department of Border Control, Immigration and Registration of Persons; and

- c) State Department of Correctional Services.
- ii) The National Police Service Commission;
- iii) The Independent Policing Oversight Authority; and
- iv) The Public Service Commission.
- 3. According to Schedule II of the Standing Orders, the Committee is mandated to consider the following subjects:
 - i) National Security;
 - ii) Police Services;
 - iii) Home Affairs:
 - iv) Public Administration;
 - v) Public Service;
 - vi) Prisons; and
 - vii) Immigration.

2.0 BACKGROUND

APPOINTMENTS IN COMMISSIONS AND INDEPENDENT OFFICES

Appointment of Commissions and Independent offices

Article 250(2) (b) of the Constitution provides that;

- (1) The Chairperson and each member of a commission and the holder of independent office shall be-
- (a) Identified and recommended for appointment in a manner prescribed by National legislation;
- (b) Approved by the National Assembly; and
- (c) Appointed by the President.

THE INDEPENDENT POLICING OVERSIGHT AUTHORITY

The Independent Policing Oversight Authority was established through an Act of Parliament published in November, 2011 to provide for civilian oversight over the work of the police in Kenya and in response to the country's long history of serious violations of human rights and fundamental freedoms by the then Kenya Police Force (KPF) and the Administrative Police Force (APF), which were created under the repealed Caps 84 and 85 respectively, but are now under the National Police Service – NPS Act, No. 11A of 2012.

IPOA's creation was part of the legal and policy agenda for transformation of the NPS into an efficient and accountable service, capable of providing and ensuring security for all Kenyans whilst observing the highest standards of professionalism and respect for the constitutionally guaranteed fundamental freedoms and rights for all, especially the principles set forth in Articles 238, 239 and 244 of the Constitution of Kenya.

Objectives of the Authority

Section 5 of the independent policing oversight authority Act No. 35 of 2011 provides that the objectives of the Authority shall be to—

- (a) Hold the Police accountable to the public in the performance of their functions;
- (b) Give effect to the provision of Article 244 of the Constitution that the Police shall strive for professionalism and discipline and shall promote and practice transparency and accountability; and
- (c) Ensure independent oversight of the handling of complaints by the Service.

Functions of the Authority

Pursuant to Section 6 of the Independent Policing Oversight Authority Act No. 35 of 2011 the functions of the authority shall be to-

- a) investigate any complaints related to disciplinary or criminal offences committed by any member of the Service, whether on its own motion or on receipt of a complaint, and make recommendations to the relevant authorities, including recommendations for prosecution, compensation, internal disciplinary action or any other appropriate relief, and shall make public the response received to these recommendations;
- b) receive and investigate complaints by members of the Service;
- c) monitor and investigate policing operations affecting members of the public;
- d) monitor, review and audit investigations and actions taken by the Internal Affairs Unit of the Service in response to complaints against the Police and keep a record of all such complaints regardless of where they have been first reported and what action has been taken;
- e) conduct inspections of Police premises, including detention facilities under the control of the Service;
- f) co-operate with other institutions on issues of Police oversight, including other State organs in relation to services offered by them;
- g) review the patterns of Police misconduct and the functioning of the internal disciplinary process;
- h) present any information it deems appropriate to an inquest conducted by a court of law;

- i) take all reasonable steps to facilitate access to the Authority's services for the public;
- j) subject to the Constitution and the laws related to freedom of information, publish findings of its investigations, monitoring, reviews and audits as it sees fit, including by means of the electronic or printed media;
- k) make recommendations to the Service or any State organ
- 1) report on all its functions under this Act or any written law; and
- m) Perform such other functions as may be necessary for promoting the objectives for which the Authority is established.

Procedure for appointment of the members of the Board

Section 11 (5) of the Independent Policing Oversight Authority provides that

The President shall, if he approves, within fourteen days of receipt of the names of successful applicants forwarded, select the chairperson and members of the Commission and forward the names of the persons so selected to the National Assembly for approval.

2.1 Issues for consideration in conducting the Approval hearing Public access and participation.

Article 118 (1) of the Constitution provides that; Parliament shall

- (a) Conduct its business in an open manner, and its sittings and those of its committees shall be open to the public; and
- (b) Facilitate public participation and involvement in the legislative and other business of Parliament and its committees.
- (2) Parliament may not exclude the public, or any media, from any sitting unless in exceptional circumstances the relevant Speaker has determined that there are justifiable reasons for the exclusion.

In conducting the Approval hearing, the Committee was guided by Article 73(2)(a) (b)(c) and (e) of the Constitution, and the provisions of Sections 6 (7) and 7 of the Public Appointments (Parliamentary Approval) Act No. 33 of 2011.

Article 73 (2) of the Constitution provides that:

- (2) The guiding principles of leadership and integrity include—
- (a) selection on the basis of personal integrity, competence and suitability, or election in free and fair elections;
- (b) Objectivity and impartiality in decision making, and in ensuring that decisions are not influenced by nepotism, favoritism, other improper motives or corrupt practices;
- (c) Selfless service based solely on the public interest, demonstrated by—
 - (i) Honesty in the execution of public duties; and,
 - (ii) The declaration of any personal interest that may conflict with public duties;
- (d) Accountability to the public for decisions and actions; and
- (e) Discipline and commitment in service to the people.

2.2 Notification of nomination by the appointing authority.

Pursuant to Article 250 (2) (b) of the Constitution and section 11(5) of the Independent Policing Oversight Authority Act No. 35 of 2011, His Excellency the President has nominated the following persons for appointment to the position of Chairperson and Members of the Independent Policing Oversight Authority.subject to approval by the National Assembly.

2.3 Communication and committal to committee

Pursuant to Standing Order 42(2) of the National Assembly on Tuesday 7th August 2018 the Speaker communicated a message from, H. E. the President with respect to the nomination of the aforementioned persons for appointment to the position of Chairperson and Members of the Independent Policing Oversight Authority.

The Speaker further informed the House that H.E. the President forwarded the names of the nominees for approval by the National Assembly before appointment.

In accordance with Standing Order 42(3) (c) the Speaker having read the Message from the H.E. the President referred the names of the nominees together with their curriculum vitae to the Departmental Committee on Administration and National Security to conduct approval hearings. The Speaker advised the Committee to conduct extensive public participation as provided for under Article 118 of the Constitution as well as the Public Appointments (Parliamentary Approval) Act (No.33 of 2011) and report to the House.

2.4 Notification to the public

Section 6(9) of the Public Appointments (Parliamentary Approval) Act No. 33 of 2011, provides that "any person may, prior to the approval hearing, and by written statement on oath, provide the Clerk with evidence contesting the suitability of a candidate to hold the office to which the candidate has been nominated".

The Clerk of the National Assembly on **Thursday 9th August, 2018** placed a notification in the print media informing the public of the intention of the Committee to conduct approval hearings as provided for under Article 118 (1) (a) (b) and (2) of the Constitution

and Section 6(4) of the Public Appointments (Parliamentary Approval) Act, (No.33 of 2011), which allows public participation in committee proceedings. The notification gave provision for the submission of memoranda, on the suitability or otherwise of the nominee by **Wednesday 15th August 2018**, at **5.00 pm**.

2.5 Notification to the nominees

On Thursday 9th August, 2018 the Clerk of the National Assembly, pursuant to Section 6(3) of the Public Appointments (Parliamentary Approval) Act No. 33 of 2011, notified the nominees in writing that the approval hearing was scheduled to take place on Wednesday 15th August, 2018 in Mini Chamber County Hall Parliament Buildings, at 9.60 am.

2.6 Clearance requirements

On Thursday 9th August 2018 the Clerk of the National Assembly wrote letters to-

- 1) the Ethics and Anti-Corruption Commission;
- 2) the Criminal Investigation Department;
- 3) the Kenya Revenue Authority (KRA);
- 4) the Higher Education Loans Board (HELB); and
- 5) the Office of the Registrar Political Parties.

seeking information on the nominees with respect to matters relating to integrity, status of any pending criminal record, tax compliance, any unpaid loan and whether the nominee is an official of a registered political party.

The Committee received letters from the Kenya Revenue Authority indicating that all nominees were tax compliant, and the Higher Education Loans Board stating that the Board was not owed any loans by the nominees.

The Ethics and Anti-Corruption Commission and the Directorate of Criminal Investigation confirmed that there were no outstanding issues or ongoing investigations against the nominees. The Office of the Registrar of Political Parties confirmed that the

nominees were not officials of a registered political party. The nominees also presented before the Committee their Certificates of Good Conduct.

2.7 Committee proceedings

The National Assembly having received the names of the nominees was obligated to conduct approval hearings and make determination of the nominees' suitability pursuant to the provisions of section 11 (5) of the Independent Policing Oversight Authority Act as read together with section 3 and 5 of the Public Appointments (Parliamentary Approval) Act, 2011.

The Committee held a total of two sittings to receive the notification and plan on how to conduct the approval hearings, examine and review the nominees' certificates, testimonials, consider public views and hold vetting meeting with the nominees.

2.8 Legal framework and issues for consideration in conducting the approval hearing

The Committee observed that the issues for consideration in relation to the nomination and approval exercise are as provided under section 7 of the Public Appointments (Parliamentary Approvals) Act, as follows-

- a) the procedure used to arrive at the nominee;
- b) the constitutional and statutory requirements relating to the office in question; and
- c) the suitability of the nominees for the appointment proposed having regard to whether the nominees' abilities, experience and qualities meet the needs of the body to which the nomination is being made.

(a) Procedure used to arrive at the nominee

The procedure for appointment of the Chairperson and Members of the Independent Policing Oversight Authority is outlined under the Constitution, the Independent Policing Oversight Authority Act and the Public Appointments (Parliamentary Approval) Act, 2011.

The Committee observed that Article 250(2)(a) of the Constitution, section 11(5) the Independent Policing Oversight Authority Act No. 35 of 2011 and the Public

Appointments (Parliamentary Approvals) Act, 2011 provides that nomination and appointment of the Chairperson and Members of the Independent Policing Oversight Authority is by the President after competitive recruitments.

(b) Constitutional and Statutory requirements

The Constitution, in addition, sets out requirements regarding the appointment of persons to public office which include –

(i) Leadership and Integrity

The Committee, in determining the suitability of the nominees, took into consideration the provisions on leadership and integrity as outlined under Chapter Six of the Constitution. In particular, the Committee took cognizance of the following provisions-

- i. Article 73(2) of the Constitution which provides that the guiding principles of leadership and integrity include
 - (a) selection on the basis of personal integrity, competence and suitability, or election in free and fair elections;
 - (b) objectivity and impartiality in decision making, and in ensuring that decisions are not influenced by nepotism, favoritism, other improper motives or corrupt practices;
 - (c) selfless service based solely on the public interest, demonstrated by-
 - (i) honesty in the execution of public duties; and
 - (ii)the declaration of any personal interest that may conflict with public duties;
 - (d) accountability to the public for decisions and actions; and
 - (e) discipline and commitment in service to the people.
- ii. Article 75(1) of the Constitution that requires a State Officer, whether in public or private life to behave in a manner that avoids conflict between personal interest and public official duties and Article 75(3) of the Constitution that prohibits a State Officer who has been removed from office under that Article from holding any other State Office.

- iii. Article 77(2) of the Constitution that prohibits an appointed State officer from holding office in a political party.
- iv. Article 78 of the Constitution that disqualifies persons who are not Kenyan Citizens and persons holding dual citizenship from appointment as State Officers.
- c) Suitability of the nominees for the appointment proposed having regard to whether the nominee's abilities, experience and qualities meet the needs of the body to which the nomination is being made

The Committee observed that suitability of the nominees should be evaluated holistically taking into account the nominee's academic credentials, professional training, experience, background and personal qualities as well as the performance of the nominee during the approval hearing.

2.9 Qualifications for appointment as Chairperson and Members of the Independent Policing Oversight Authority

In conducting the Approval hearing, the Committee was guided by Article 250(2)(b) Constitution, section 11(5) of the Independent Policing Oversight Authority Act No. 35 of 2011 and the provisions of Section 3 and 5 of the Public Appointments (Parliamentary Approval) Act No. 33 of 2011.

Article 250(3) of the Constitution provides that to be appointed as a member to a Commission or Independent Office, a person shall have specific qualifications required by the Constitution or national legislation. Further Article 250(4) provides that appointments to Commissions and Independent Offices shall consider the national values referred to in Article 10 and the principle that the composition of the Commissions and Offices, taken shall reflect the regional and ethnic diversity of the people of Kenya.

Article 73 of the Constitution provides that: (2) The guiding principles of leadership and integrity include— (a) selection on the basis of personal integrity, competence and

suitability, or election in free and fair elections; (b) objectivity and impartiality in decision making, and in ensuring that decisions are not influenced by nepotism, favouritism, other improper motives or corrupt practices; (c) selfless service based solely on the public interest, demonstrated by— (i) honesty in the execution of public duties; and, (ii) the declaration of any personal interest that may conflict with public duties; (d) accountability to the public for decisions and for decisions and actions; and (e) discipline and commitment in service to the people.

2.10 Submission of memoranda

At the close of business Wednesday 15th August 2018, the Office of the Clerk, had not received any memoranda contesting the suitability of the nominee.

3.0 APPROVAL HEARINGS

The Committee conducted approval hearings for the nominees to the position of Chairperson and members of the Independent Policing Oversight Authority on Wednesday 15th August, 2018. In conducting the vetting exercise, the Committee was guided by, the Constitution, the Independent Policing Oversight Authority Act No. 35 of 2011 and the Public Appointments (Parliamentary Approval) Act (No. 33 of 2011) and the National Assembly Standing Orders.

The Committee examined the nominees using the guidelines provided for in the Public Appointments (Parliamentary Approval) Act No. 33 of 2011. The Committee also followed the following criteria in vetting the nominees -

- i) Academic qualifications;
- ii) Employment record and work experience;
- iii) Professional Experience;
- iv) Integrity;
- v) Potential Conflict of Interest; and
- vi) Suitability for the position.



The nominee informed the committee that, she holds requisite academic qualification and relevant experience in terms of dispute resolution which will be necessary in resolving dispute which might arise from the members of the Police service and from the public;

The nominee further informed the committee that she intends to bring on board her working experience, values and integrity for the effective and efficient service delivery.

On how she will deal issues of sexual offences

The nominee informed the Committee that she will use her networks in FIDA Kenya and advice the public on sexual offences and other complaints.

3.8 VETTING OF DR. JIMMY MUTUKU MWITHI – NOMINEE FOR POSITION OF MEMBER, INDEPENDENT POLICING OVERSIGHT AUTHORITY

The nominee appeared before the Committee for vetting on Wednesday 15th August, 2018 and was orally interviewed by the Committee and responded to questions during vetting as follows:

The nominee informed the Committee that, besides his academic qualifications, he will use his experience in the police service and his network in the Directorate of Criminal Investigation to make the Authority's assignment success and make necessary recommendations for Police reforms.

The nominee further informed the Committee that he will come up with strategies to restore public confidence, trust and professionalism in the Police Force.

On the relationship between the Independent Policing Oversight Authority and National Police Service Commission

The nominee informed the Committee that, he will nature the relationship between Independent Policing Oversight Authority and National Police Service Commission through enhanced engagement for the effective and efficient service delivery to Kenyans.

4.0 COMMITTEE OBSERVATIONS

The Committee having considered the curriculum vitae of the nominees and having heard their oral submissions during the vetting exercise, at the sitting held on Wednesday 15th August 2018 made the following observations;

- i) THAT, the nominees had the requisite qualifications and experience pursuant to section 9(a)(b) of the Independent Policing Oversight Authority Act No. 35 of 2011 on the criteria for the appointment of Chairperson and Members of the Board;
- ii) THAT, all nominees had been cleared by the DCI, KRA on tax compliance and HELB;
- iii) THAT, the Committee did not receive any adverse information on any of the nominees from EACC, which is the constitutional body mandated to ensure compliance with and to enforce the provisions of Chapter Six of the Constitution;
- iv) THAT, none of the nominees has been convicted in a Court of Law for a criminal offence in the last three years;
- v) THAT, as stipulated in Article 75(1) of the Constitution, all the nominees indicated that they have no potential conflict of interest;
- vi) THAT, all the nominees do not hold office in any political party hence satisfy the provisions of Article 77(2) of the Constitution;
- vii) THAT, the Board's composition will comprise of four lawyers, a medical practitioner, a gender expert, a criminologist and a political scientist; and
- viii) THAT, the composition of the Board meets the Constitution principle on gender rule with four males and four females respectively.

5.0 COMMITTEE RECCOMENDATIONS

Having considered the suitability, capacity, qualifications and integrity of the nominees and pursuant to Article 250(2)(b) of the Constitution and Section 11 (5) of the Independent Policing Oversight Authority Act No. 35 of 2011 and Public Appointments (Parliamentary Approval) Act No. 33 of 2011, the Committee recommends that the National Assembly approves the nomination for appointment of the following as Chairperson and Members of the Independent Policing Oversight Authority.
