



#### **1.0 CHAIR'S FOREWORD**

The Warehouse Receipt Bill was introduced as the National Assembly Bill No. 12 of 2015 and thereafter committed to the Departmental Committee on Agriculture, Livestock and Cooperatives on Thursday 16<sup>th</sup> April 2015 for deliberation pursuant to the Standing Order.

The Committee invited and held meetings with the State Department of Agriculture-MoALF, National Cereals and Produce Board, Agriculture Fisheries and Food Authority and other key stakeholders drawn majorly from the private sector whose views are captured and contained in the body of this Report.

In considering the bill, the Committee invited comments from the public by placing advertisements in the Daily Nation and Standard newspaper on 22<sup>nd</sup> April 2015, conferring to Article 118 of the Constitution

The Committee engaged the stakeholders and deliberated on the issues in the bill, a workshop was held on Warehouse Receipt System Bill, 2015 at Safari park Hotel, Nairobi from 3<sup>rd</sup> to 4<sup>th</sup> November, 2015.

The Committee appreciate to the Office of the Speaker and the Clerk of the National Assembly for the support accorded to it to complete this report.

On behalf of the Departmental Committee on Agriculture, Livestock and Cooperatives, it is my pleasant privilege and honor to present to this House the Report of the Committee on its consideration of the Warehouse Receipt System Bill, 2015 National Assembly Bill No. 12 of 2015.

#### 2.0 EXECUTIVE SUMMARY

The object and reasons of this bill is to provide for a legal framework for regulation and development of the warehouse receipt system to cure the challenge of marketing cereal product in the country.

This report as interpreted in Clause 2 explains the meaning of Warehouse Receipt system (WRS) as a process of depositing commodities in a licensed warehouse, the issuance of a warehouse receipt reflecting the quantity and quality of the deposited commodity. The management of the transfer of receipts as a document of the tittle but it is not limited to the regulation and actors in the associated processes.

The bill elaborates the establishment of the warehouse receipt system council as body corporate its objects and function, membership, powers and funds of the council.

The bill provides for the licensing and inspection of the warehouse, the application of the warehouse and its operations within, it also emphasizes on the revocation and suspension of the license.

The bill states clearly the general inspection by the authorized officers from the council, the publication of the general inspection and examination of books and records of the licensed warehouse.

The bill pursues to provide for an act of parliament to provide for the development and regulation of a Warehouse Receipt System for agricultural commodities, the establishment of the Warehouse Receipts System Council and for connected purposes.

The Bill seeks to create a platform for establishment of a commodity exchange and widening marketing options for farmers to handle post-harvest of agricultural products.

The report concludes by stating that adoption of innovative approaches and employ technology when establishing and operating commodity exchange. Roles played by the two levels of government should be clearly spelt out in as far as regulation of WRS is concerned.

Use of modern technology platforms especially use of mobile telephony and tracking devises) should be integrated into the WRS as this will aid in the supervision of warehouses and reduce cost in the long run.

## **3.0 MANDATE OF THE COMMITTEE**

## **8.0 LIST OF RECOMMENDATIONS**

The Committee is proposing the following amendments during the Committee Stage of the Bill.

THAT the Bill be amended in

## Clause.2 -Interpretations by providing for new definitions of term

"Warehouse Receipt System" "Warehouse Receipt System" means part or the whole of the process of depositing commodities in a licensed warehouse, the issuance of a warehouse receipt reflecting the quantity and quality of the deposited commodity, the management of the transfer of the receipts as a document of title and includes but not limited to, the regulation of warehouses and actors in the associated processes.

#### Justifications

No provision on the definition of "Warehouse Receipt System had been provided and there was need to provide for clarity on the meaning of "Warehouse Receipt System"

## **Clause 3 - Establishment of the WRS Council**

#### Amend Sub -clause 3

(3) The Council shall consist of—

- (a) the Principal Secretary for the time being responsible for matters relating to agriculture or his representative;
- (b) the Principal Secretary for the time being responsible for matters relating to finance or his representative;
- (c) one person representing Council of Governors
- (d) the Director General of the Agriculture, Food and Fisheries Authority or his representative;
- (e) one person representing the financial sector;
- (f)one person representing traders and processors;
- (g) one person representing agricultural producers;
- (h) one person representing warehouse operators; and
- (i) one person representing consumers organization;



- (4) The Cabinet Secretary shall make Regulations to prescribe how the persons referred to in (3)(e) to (i) above shall be nominated.
- (5) The Cabinet Secretary shall appoint the members nominated in subsection (4) above.
- (6) The Council shall at its first sitting elect a Chairperson and Vice-Chairperson from amongst its members.
- (7) The Chairperson and Vice-Chairperson shall be of the opposite gender.
- (8) A decision of the Council shall not be invalid by reason only of a vacancy among the members thereof.

#### **Justifications**

- a) There should be stakeholder participation in constituting the WRS Council
- b) Since the Bill concerns and shall be largely be implemented in the Counties then representation of Council of Governors is crucial.
- c) Agriculture Food and Fisheries Authority should be a member of the Council since it's a regulatory institution in-charge of Food and Cereal items.
- d) Appointment of the Chairperson and Vice-Chairperson of the Council should be from amongst the nominated members.

## Amend Sub -clause 5 (c)

By deleting the clause and therefore replacing it with "gross misconduct and abuse of office in contravention of the Public Officer Ethics Act and any other relevant law."

#### Justifications

# To provide for clarity in the procedure for vacation of office by members of the Council.

#### Amend Sub -clause 5 (e)

By deleting the sub-clause and therefore replacing it with the following sub-clause

"The member becomes, by reason of unsound mind or physical infirmity, incapable of performing his duties as a member of the Council."

To provide for clarity in the procedure for vacation of office by members of the Council

To provide for registration of warehouses in line with proposed amendment in clause 4 (0)

# Clause 18 – Revocation of license and suspension of license or operations.

#### Amend Clause 18 (1)(c)

By deleting the Sub clause 1(C)

#### **Justification**

#### It is difficult to determine rationally whether an operator is incompetent and incapable.

#### **Amend Clause 18**

By introducing a sub clause (7) to read as follows

"Where a license has been suspended or revoked, the Council shall appoint an independent warehouse manager to operate the warehouse in the interim until the matter is resolved."

#### **Justifications**

This is to safeguard the commodities stored in warehouses and the interest of parties to the commodity.

#### Amend Clause 18

By introducing a sub clause (8) to read as follows

"The Cabinet Secretary in consultation with the Council shall make regulations to bring into effect the provisions of this section with regard to the management of a warehouse whose license has been suspended or revoked and commodities stored therein."

#### **Justifications**

This is to safeguard the commodities stored in warehouses and the interest of parties to the commodity.

#### Clause 20 – Warehouse Receipts Appeals Committee

#### Amend Clause 20 (1)

By replacing the word "one" appearing immediately before the words 'other members ' with the word "two".

#### **Justifications**

To broaden the membership to the Warehouse Receipts Appeals Committee for greater fairness.



# Clause 21 – Grading and weighing of agricultural Products

By replacing the word "calibrated" appearing immediately after the words 'using equipment ' with the word "certified".

#### **Justifications**

## Provide for terminology that reflects actual practice.

#### Amend Clause 21 (2)

By replacing the word "recognized competent" appearing immediately after the words 'certified by a ' with the word "mandated".

#### **Justifications**

Provide for terminology that reflects actual practice.

## Clause 23 – Publication of general inspections

Amend Clause 23 Remove the word "bonded". Replace the word "persons" with "operators."

By deleting the word 'bonded' appearing immediately after the words 'locations of the licensed'

By replacing the word "persons" appearing immediately after the words 'names of the ' with the word "operators".

#### **Justifications**

Remove anomaly in this Act does not consider warehouses as customs bonded warehouses.

#### **9.0 INTRODUCTION**

The Warehouse Receipt Bill was introduced in the National Assembly on 16<sup>th</sup> April 2015 as National Assembly Bill No. 12 of 2015, has undergone the second reading and been committed to the National Assembly Committee on Agriculture, Livestock and Cooperatives.

On 3<sup>rd</sup> and 4<sup>th</sup> November 2015, the Committee convened a meeting at Safari park Hotel, Nairobi and invited the State Department of Agriculture Ministry of Agriculture, Livestock and Fisheries (MoALF) National Cereals and Produce Board (NCPB), Agriculture Fisheries and Food Authority and other key stakeholders drawn majorly from the private sector for discussions on the Bill. The Ministry team was led by the Ag. Cabinet Secretary who also gave opening remarks. In his remarks, he underscored the importance of the Bill in creating a platform for the establishment of a commodity exchange and widening marketing options for farmers. The following specific institutions were represented during the meeting;

- (a) International Finance Corporation of World Bank(IFC)
- (b) Insurance companies
- (c) Banking and Financial Institutions
- (d) Millers
- (e) Warehouse Operators
- (f) Commodity/Cereal Traders
- (g) Farmer Associations e.g. East Africa Farmer Federation and Kenya National Federation of Farmers.
- (h) Council of Governors
- (i) East Africa Trade Hub of USAID
- (j) Capital Markets Authority
- (k) Eastern Africa Grain Council

The Chairman of the Committee led the team in detailed discussions on the Bill. Each clause was reviewed and proposed amendments considered.

As a way forward a team of drafters was tasked to make write up on the changes as agreed during the meeting. This team met on the 11<sup>th</sup> November at Jacaranda Hotel, Nairobi and constituted of technical staff and drafters from the State Department of Agriculture; East Africa Grain Council; National Cereals and Produce Board ,Agriculture, Fisheries and Food Authority and Secretariat from the Committee on Agriculture, Livestock and Fisheries.

## **10.0 Evidence/Presentations**

## 10.1 Ministry of Agriculture Livestock and Cooperative

While appearing before the Committee Mr. Ombalo Principal Policy Officer in the Ministry of Agriculture ,Livestock and Fisheries presented a consolidated presentation from all the stakeholders with exception of the Council of Governors as follows;

- 1. Constitution and membership to the WRS Council should be rationalized and provide for the following; More rational nomination process that involves stakeholder participation process and inclusion of representation from the following categories County level of government, Agriculture Fish and Food Authority and Consumer organization
- 2. Appointment of the chairperson and Vice-Chairperson from amongst the nominated members should be made in a clear manner.
- 3. The conditions and procedure for a member of the Council to vacate Office should be clearly provided.
- 4. The areas that have been identified as requiring attention for an effective WRS and Commodities exchange are as follows:
  - Financing of warehouse development and warehouse operations
  - National storage capacity, network and quality of warehouse management
  - Aggregation and community storage
  - Farmer/stakeholder awareness creation and education
  - Sustainable rural extension services model for farmers
  - Grain quality standards
  - Capacity building and training
  - Regional approach vs national commodity exchange platforms

5. The current pilot Warehouse Receipt System is operated by the NCPB, EAGC, Export trading and Lesiolo Grain handlers with maize as the main commodities are promising but are faced with the following challenges;

- Limited scale in commodity range, volumes and outreach coverage
- Lack of trust an acceptability by the a majority of small scale famers
- Absence of legal framework for credible and dependable WRS and commodity exchange
- Low awareness by the farmers on the opportunities and potential benefits of WRS and commodities exchange
- Limited involvement of financial and insurance institution

6. The proposed implementation plan and way forward are indicated below;

- Capacity building for warehouse receipts system stakeholders. This would enable stakeholders to build physical, financial and human skills capacity and training needs will be identified for WRS Authority and actors along the value chains.
- Attract investments along warehouse receipt value chain by Identifying, prioritizing and proposing incentives for areas in the WRS for attracting investments and PPPs that is establishment of private warehouses, rural commodity aggregation and storage centers, transport and logistics support to producers and traders of agricultural commodities. Facilitate collection and discussion of information on potential investors along the value chain including establishment of information portals .Participate in workshops with investors and other relevant national and county government institutions
- Operationalization of a Warehouse Receipts System including Warehouse Receipts Authority Finalize draft regulations and rules for operationalizing the WRS Legislation should consider:
  - Convening of consultative workshops on WRS Regulations and Rules with various stakeholders.
  - Incorporating stakeholders' comments received during consultations into the final Regulations and Rules


- Facilitating the Gazettement of Regulations and Rules though the State Law Office
- Convening of workshops for WRS actors and key stakeholders for awareness creation
- Finalization of Legal Framework for Warehouse Receipts System. To convene consultative engagement with parliamentary committees on agriculture National Assembly and Senate. Follow up and coordinate the finalization of the enactment of the WRS law through Parliamentary process.
- 7. The next step for follow up of the bill should be as follows:
  - Meet relevant National Assembly and Senate Committees to clarify provisions of WRS Bill subsequent to tabling in the National Assembly and the Senate.
  - Benchmarking study tour for both National Assembly and Senate Committee leadership (India) to inform debate on the Bill and Development of regulations and linkages with COMEX.
  - Convene experts' committee to develop WRS Regulations.
  - Appoint WRS Board, establish interim and substantive offices of the WRS Council and Registrar (Chief Executive Officer)
  - Undertake multiagency capacity building for WRS Stakeholders
  - Implement activities for attracting investments along Warehouse Receipts value chain.
  - Undertake impact assessment

## **10.2 Council of Governors**

While appearing before the Committee Mr. David Wanjohi represented the Council of Governors submitted that:

- a) In the establishment of the Warehouse Receipt System Council, a representative from the Council of Governors should be included, because the function touches on Agriculture which is a devolved function.
- b) The council proposed that the Warehouses be inspected and subsequently licensed by the County governments given that the constitution defines division of roles between the two levels of governments.

- c) On the revocation the license to operate a Warehouse ,the Chief Executive Officer of the Council who sits on the Council should not sit on the Appeals Committee as it is a conflict of interest. An independent body should be suited to hear and determine the appeals.
- d) Examination of books and records of licensed Warehouse be a mandatory obligation to the Chief Executive Officer to minimize the costs.

## **11.0 OBSERVATIONS**

The Committee while considering the Bill observed the following;-

- a) To ensure the successful implementation of the Warehouse Receipt System confidence of the key players among them farmers and financial institution must be guaranteed by the system.
- b) The involvement of the Government in the setting up of the governance structures and implementation of the system is crucial but must be limited to policy matters only.
- c) The private sector must be encouraged and supported through necessary subsidiary legislation to ensure their full participation in this new trading system.
- d) It was noted that including investors along warehouse Receipt system is an important issue as it will broaden the growth of warehouse system and allow widespread marketing of the grain commodity by farmers.
- e) The committee observed that the issues of the warehouse receipt system touches on the farmers and most agricultural issues have been devolved.
- f) The Committee further observed that the Bill is made of the following parts ;-



"Warehouse Receipt System" "Warehouse Receipt System" means part or the whole of the process of depositing commodities in a licensed warehouse, the issuance of a warehouse receipt reflecting the quantity and quality of the deposited commodity, the management of the transfer of the receipts as a document of title and includes but not limited to, the regulation of warehouses and actors in the associated processes.

The Council shall at its first sitting elect a Chairperson and Vice-Chairperson from amongst its members.

The Chairperson and Vice-Chairperson shall be of the opposite gender.

A decision of the Council shall not be invalid by reason only of a vacancy among the members thereof.

## Min. 080/2016 Matters Arising

## Under min. 075/2016

The Members resolved to deliberate on KMC matters exhaustively at the retreat that is planned to be held between 7<sup>th</sup> to 10<sup>th</sup> April 2016 alongside the Ministry of Agriculture, Livestock and Fisheries.

## Min. 081/2016: Adoption of the Report on Warehouse Receipt Systems Bill, 2015

The Committee adopted the report on Warehouse Receipt Systems Bill, 2015 with the recommendations and justifications contained in the report.

## Min. 082/2016: Briefing by the Parliamentary Budget Office on the Supplementary Estimates

The Parliamentary Budget Office informed the Committee of the following with regard to the 2015/2016 Supplementary Estimates;

1. The Supplementary Estimates for the State Department of Agriculture indicates total reduction from a gross of KES. 34.466 billion in the printed estimates to KES. 17.001

billion Translating to 51% reduction. The capital expenditure has been reviewed downwards from KES. 26.15 billion to KES. 10.92 billion and the recurrent expenditure reduced from KES. 8.314 billion to KES. 6.081 billion. The reduction is mainly on account of transfer of one of the programmes, namely, Irrigation and Drainage Infrastructure Programme, to the Ministry of Water and Irrigation.

- II. The overall budget for the State Department of Livestock has been reduced from KES.
  7.11 billion to KES. 6.59 billion. Recurrent expenditure increased by KES. 116 million while the development budget reduces by KES. 647 million. Capital grants to Governments Agencies have been allocated additional KES. 700 million under Development Vote of which KES. 500 million is donor funded. This is mainly for upgrading of Kenya Dairy Board which will probably address the problems facing livestock farmers in terms production and marketing of Dairy products but the overall reduction of development budget will affect on-going development projects like construction of pastoral training institutes in various regions of the Country. There is increased provision of recurrent expenditure for Veterinary Services and decease control mainly for specialized materials and supplies.
- 111. The approved estimates for State Department of Fisheries have been adjusted to a gross allocation of KES. 4.2 billion down from KES. 4.5 billion. The recurrent expenditure reduced from Kshs 1.37 billion to Kshs.1.33 billion while the Capital Expenditure reduced from KES. 3.1 billion to KES. 2.8 billion. The reductions are mainly on account of austerity measures which may have a negative impact on service delivery by the State Department. However, there is additional provision in the recurrent expenditure to cater for maintenance of Fisheries facilities like boats, fish bonds and ports which were destroyed by the ELNINO rains.
  - The budget to the Programme of Cooperative Development and Managementin the Ministry of Industrialization and Enterprise Development increased from a gross of KES. 267 million to KES. 745 million translating to 179% increase. The adjustment is towards recurrent expenditure mainly on account Coffee debt waivers as subsidies to small businesses, cooperatives and self-employed item under the office of the

Commissioner. The waiver will enable farmers access credit from financial institutions for investment in the Coffee Sector.
