FOREWARD

Pursuant to Article 132 (2) (e) of the Constitution and section 5 of the Public Appointments (Parliamentary Approval) Act No. 33 of 2011, H.E. the President, forwarded to the Clerk of the National Assembly, a notification of appointment containing the names and Curricula Vitae of four (4) Ambassador/High Commissioner nominees on 14th March, 2018. This was for consideration for approval by the National Assembly for appointment as Ambassador/High Commissioner.

On 15th March, 2018, the notification of nominations was communicated by the Speaker and thereafter referred to the Departmental Committee for vetting and reporting to the House within fourteen (14) days.

The Committee held three (3) sittings. Three nominees appeared before the Committee on 27th March, 2018 and were vetted in accordance with the provisions of the Constitution, the Public Appointments (Parliamentary Approval) Act, No. 33 of 2011 and the National Assembly Standing Orders on their suitability or otherwise for appointment as Ambassadors/High Commissioners.

One nominee, Eng. John Okuna Ogango, had notified the Clerk of the National Assembly of withdrawal from the approval process as outlined under Section 6(10) of the Public Appointments (Parliamentary Approvals) Act.

The Committee deliberated on the nominees duly filled questionnaires in accordance with Section 6 (8) of the Public Appointments (Parliamentary Approval) Act, curricula vitas, reports from relevant authorities, submissions made by the nominees including their oral submissions during the vetting at the sittings

,

held on Monday 27th March, 2018.

The Committee, in compliance with the Constitutional and other legal requirements and established procedures for vetting, ensured that its meetings were open to the public and covered by the media.

May I take this opportunity to thank all Members of the Committee for their input and valuable contributions during the deliberations and vetting exercise. I also take this opportunity on behalf of the Committee to thank the Offices of the Speaker and of the Clerk of the National Assembly for the logistical support accorded to it during the exercise. As a Committee, we also appreciate the role played by the media following its coverage of the proceedings, thus enhancing accountability, transparency and ensuring the participation of the public.

1.0 PREFACE

1.1 Establishment of the Committee

The Departmental Committee on Defence and Foreign Relations is established pursuant to Standing Order 216 (1).

1.2 Mandate of the Committee

The Committee is mandated under Standing Order 216 (4) and (5) to inter alia-

- a) investigate, inquire into, and report on all matters relating to the mandate, management, activities, administration, operations and estimates of the assigned ministries and departments;
- b) study the programme and policy objectives of ministries and departments and the effectiveness of the implementation and effectiveness of the implementation;
- c) study and review all legislation referred to it;
- d) study, assess and analyze the relative success of the ministries and departments as measured by the results obtained as compared with their stated objectives;
- e) investigate and inquire into all matters relating to the assigned ministries and departments as they may deem necessary, and as may be referred to them by the House;
- f) vet and report on all appointments where the Constitution or any law requires the National Assembly to approve, except those under Standing Order 204 (Committee on Appointments);
- g) examine treaties, agreements and conventions;
- h) make reports and recommendations to the House as often as possible, including recommendation of proposed legislation.

- i) consider reports of Commissions and independent offices submitted to the house pursuant to the provisions of Article 254 of the Constitution; and
- j) examine any questions raised by Members on a matter within its mandate.

In executing its mandate, the Committee oversights the following Ministries and Departments:

- i. Ministry of Defence;
- ii. Ministry of Foreign Affairs and International Trade;
- iii. East African Community; and
- iv. National Intelligence Service.

According to Schedule II of the Standing Orders, the Committee is mandated to consider the following subjects:

- i. Defence;
- ii. Intelligence;
- iii. Foreign Relations;
- iv. Diplomatic and Consular Services;
- v. International Boundaries including territorial waters and international Relations; and
- vi. Agreements, Treaties and Conventions.

2.0 BACKGROUND

2.1 Establishment of the Office of High Commissioners/Ambassadors

The Office of Ambassador/High Commissioner is an Office under the Ministry of Foreign Affairs and International Trade. The duties of Ambassadors and High Commissioners include -

- a) advancement and protection of Kenya's interests in host Countries and Countries of accreditation through innovative Diplomacy;
- b) promotion of Kenya's influence in international decision making;
- c) protection of Kenya's sovereignty and territorial integrity;
- d) promotion and strengthening of bilateral/multilateral co-operation/ties;
- e) promotion of sub-regional, regional and international integration and cooperation; and
- f) promotion of public Diplomacy, among other duties.

2.2 Nomination of High Commissioners and Ambassadors

Article 132(2) (e) of the Constitution confers upon the President the power to nominate, and subject to approval by the National Assembly, appoint Ambassadors and High Commissioners. It provides that -

"The President shall nominate and, with the approval of the National Assembly, appoint and may dismiss- ... (e) High Commissioners, Ambassador and Diplomatic and Consular Representatives"

2.3 Notification of nomination

In accordance with the provisions of Article 132(2) (e) of the Constitution and section 5 of the Public Appointments (Parliamentary Approvals) Act, H.E. the President vide a letter dated 14th March, 2018 under reference number OP.CAB.14.1A (Annexure 1) forwarded to the National Assembly, for

consideration and approval, the notification of nomination of the following four (4) persons nominated for appointment as Ambassadors and High Commissioners -

2.4 Committal to the Departmental Committee of the nominations

In his Communication to the House on 15th March, 2018 pursuant to Standing Order 42, the Speaker of the National Assembly informed the House that H.E. the President, by way of letter dated 14th March, 2018 had nominated Amb. Richard Titus Ekai, Eng. John Okuna Ogango, Hon. Wilfred Gisuka Machage and Hon. Mohamed Muktar Shidiye as Ambassadors/High Commissioners for approval by the House pursuant to Article 132 (2) (e) of the Constitution.

After conveying the message from H. E., the President on the nomination, the Speaker of the National Assembly pursuant to Standing Order 42 (3)(c) forwarded the names of the nominees and their curricula vitae to the Departmental Committee on Defence and Foreign Relations to conduct approval hearings.

2.5 Notification to the public

Section 6(9) of the Public Appointments (Parliamentary Approval) Act No. 33 of 2011, provides that "any person may, prior to the approval hearing, and by written statement on oath, provide the Clerk with evidence contesting the suitability of a candidate to hold the office to which the candidate has been nominated".

The Clerk of the National Assembly placed an advertisement in the print media on

Friday, 16th March, 2018 *(Annexure 2)* inviting the public to submit memoranda by way of written statements on oath (affidavits) on the suitability or otherwise of the nominees in conformity with section 6(9) of the Public Appointments (Parliamentary Approval) Act, 2011. The advertisements indicated that the submissions were to be received by Friday, 23rd March, 2018 at 5.00 pm.

Pursuant to the provisions of Article 118 of the Constitution, Section 6(4) of the Public Appointments (Parliamentary Approval) Act and Standing Order 45(3), the general public was on Friday, 16th March, 2018 *(Annexure 3)* notified in the print media by the Clerk of the National Assembly of the intention of the Departmental Committee on Defence and Foreign Relations to conduct the vetting of the nominees on Monday, 26th March, 2018.

2.6 Notification to the nominees

On 16th March, 2018, the Clerk of the National Assembly, pursuant to Section 6(3) of the Public Appointments (Parliamentary Approval) Act No. 33 of 2011, notified the nominees of the date, time, and place for holding the Approval hearings (*Annexure 4*).

2.7 Clearance requirements

On 16th March, 2018 the Clerk of the National Assembly wrote to the Ethics and Anti-Corruption Commission (EACC), Kenya Revenue Authority (KRA), the Criminal Investigation Department (DCI), the Higher Education Loans Board (HELB), and the Registrar of Political Parties (RPP) requesting for information (*Annexure 5*) with respect to the nominees on the following;

- (a) matters touching on integrity;
- (b)tax compliance;
- (c) loan repayments; and

(d)political affiliations.

2.7.1 Higher Education Loans Board

The Higher Education Loans Board had by Monday, 26th March, 2018, not responded to the request by the Clerk of the National Assembly for provision of information relating to clearance of student loans by the nominee.

2.7.2 Kenya Revenue Authority

The Kenya Revenue Authority had by Monday, 26th March, 2018, not responded to the request by the Clerk of the National Assembly for provision of information relating to tax compliance by the nominee.

2.7.3 Ethics and Anti-Corruption Commission

The Ethics and Anti-Corruption Commission vide a letter under ref. EACC dated March, 2018 (*Annexure 6*) confirmed that there were no outstanding issues or ongoing investigations against the following nominees-

- a) Eng, John Okuna Ogango;
- b) Hon. Wilfred Gisuka Machage;
- c) Hon. Mohamed Muktar Shidiye;

However, the Commission indicated that it had received allegations against **Amb**. **Richard Titus Ekai**, **CBS** in November 2016 touching on Olympic Games in Rio de Janeiro, Brazil. The Commission further indicated that the case was forwarded to DCI. However, the DCI vide letter ref. DCI/CRO/SEC/6/7/2/A/VOL.VI/44 dated 20th March, 2018 cleared the nominee.

2.7.4 The Directorate of Criminal Investigations

The Directorate of Criminal Investigations vide a letter under ref. DCI/CRO/SEC/6/7/2/A/VOL.VI/44 dated 20th March, 2018 *(Annexure 7)* confirmed that three (3) Ambassador/High Commissioner nominees applied for police clearance certificates on diverse dates and were genuinely issued with clearance certificates. However, the DCI noted that they could not give information pertaining to Eng. John Okuna Ogango since he had not done any application for a clearance certificate.

2.7.5 Registrar of Political Parties

The Office of the Registrar of Political Parties vide a letter under Ref No. RPP/ORG/34 Vol II (13) dated 20th March, 2018 *(Annexure 8)* confirmed that according to the records held by the office as at 20th March 2018, the four (4) nominees were not officials of a registered political party.

2.8 Issues for consideration in conducting the Approval hearing

The Committee observed that the issues for consideration in relation to the nomination and approval exercise are as provided under section 7 of the Public Appointments (Parliamentary Approvals) Act, as follows-

- a) the procedure used to arrive at the nominee;
- b) the constitutional and statutory requirements relating to the office in question; and
- c) the suitability of the nominee for the appointment proposed having regard to whether the nominee's abilities, experience and qualities meet the needs of the body to which the nomination is being made.

(a) Procedure used to arrive at the nominee

The procedure for appointment of Ambassadors and High Commissioners is outlined under the Constitution and the Public Appointments (Parliamentary Approval) Act, 2011.

The Committee observed that Article 132(2) (e) of the Constitution and the Public Appointments (Parliamentary Approvals) Act provides that nomination of Ambassadors and High Commissioners is a constitutional prerogative of the President as there is no further procedure prescribed in the Constitution or statute law.

(b) Constitutional and Statutory requirements

The Constitution, in addition, sets out certain requirements regarding the appointment of persons to public office which include –

(i) Leadership and Integrity

The Committee, in determining the suitability of the nominees, took into consideration the provisions on leadership and integrity as outlined under Chapter Six of the Constitution. In particular, the Committee took cognizance of the following provisions-

- i. Article 73 (2) of the Constitution which provides that the guiding principles of leadership and integrity include –
- (a) selection on the basis of personal integrity, competence and suitability, or election in free and fair elections;
- (b) objectivity and impartiality in decision making, and in ensuring that decisions are not influenced by nepotism, favoritism, other improper motives or corrupt practices;
- (c) selfless service based solely on the public interest, demonstrated by —

- (i) honesty in the execution of public duties; and
- (ii) the declaration of any personal interest that may conflict with public duties;
- (d) accountability to the public for decisions and actions; and
- (e) discipline and commitment in service to the people.
- ii. Article 75(1) of the Constitution that requires a State Officer, whether in public or private life to behave in a manner that avoids conflict between personal interest and public official duties and Article 75(3) of the Constitution that prohibits a State Officer who has been removed from office under that Article from holding any other State Office.
- iii. Article 77(1) of the Constitution that prohibits a full time State Officer from participating in any other gainful employment.
- iv. Article 77(2) of the Constitution that prohibits an appointed State officer from holding office in a political party.
- v. Article 78 of the Constitution that disqualifies persons who are not Kenyan Citizens and persons holding dual citizenship from appointment as State Officers.

c) Suitability of the nominee for the appointment proposed having regard to whether the nominee's abilities, experience and qualities meet the needs of the body to which the nomination is being made

The Committee observed that suitability of the nominee should be evaluated holistically taking into account the nominee's academic credentials,

professional training, experience, background and personal qualities as well as the performance of the nominee during the approval hearing.

The Committee's observations and resolutions as per the specific nominees are contained in the respective parts relating to those nominees in this report.

2.8 Memoranda from members of the public

Section 6(9) of the Public Appointments (Parliamentary Approvals) Act, provides that any person may, prior to the approval hearing, and by written statement on oath, provide the Clerk with evidence contesting the suitability of a candidate to hold office to which the candidate has been nominated.

The Clerk of the National Assembly placed an advertisement in the print media on Friday 16th March, 2018 inviting the public to submit memoranda by way of written statements on oath (affidavits) on the suitability or otherwise of the nominees in conformity with section 6(9) of the Public Appointments (Parliamentary Approval) Act.

By close of business on Friday 23rd March, 2018 at 5.00 p.m., the Committee had not received any written statements on oath in respect of the suitability or otherwise of the four (4) Ambassadorial and High Commissioner nominees.

2.9 Withdrawal from the approval process

Section 6(10) of the Public Appointments (Parliamentary Approvals) Act, provides that a candidate may, at any time, by notice in writing addressed to the Clerk, withdraw from the approval process and the candidates nomination shall thereupon lapse.

Eng. John Okuna Ogango, a nominee, pursuant to Section 6(10) of the Public Appointments (Parliamentary Approvals) Act, notified the Clerk of the National Assembly of his withdrawal from the approval process vide letter dated 21st March, 2018 (*Annexure 9*)

<u>3.0</u> APPROVAL HEARINGS/ VETTING OF NOMINEES FOR APPOINTMENT TO THE POSITION OF AMBASSADORS AND HIGH COMMISSIONERS

The Departmental Committee on Defence and Foreign Relations held a sitting on Monday, 26th March, 2018 at 9:00am to deliberate on the approval hearings and the following were highlighted: -

- (a) That, by the deadline date of 23rd March, 2018 the Clerk of the National Assembly had not received any written statements on oath contesting the suitability of ALL the four (4) nominees;
- (b)That, Eng. John Okuna Ogango, a nominee, had notified the Clerk of the National Assembly of withdrawal from the approval process as outlined under Section 6(10) of the Public Appointments (Parliamentary Approvals) Act;
- (c) That, the appointing authority had not indicated the diplomatic stations that the nominees were to be posted as was the case in earlier nominations; and
- (d) That, the Clerk of the National Assembly had written to the appointing authority vide letter Ref. NA/DCS/DFE/2018 dated 21st March, 2018 (*Annexure 10*) requesting that the Committee be provided with the stations that the Ambassador/High Commissioner nominees were to be assigned.

The Committee resolved to suspend the approval hearings until Tuesday 27th March, 2018 to allow the appointing authority to respond to the issues raised.

On Tuesday 27th March, 2016 the Committee was in receipt of a letter ref: OP/CAB.1/40A dated 26th March, 2018 (*Annexure 11*) responding to the aforementioned letter by the Clerk with regard to missions that the ambassador/High Commissioner nominees will be assigned to. The Presidency opined that the Committee is ideally required to determine the suitability of the nominees to represent Kenya's foreign policy and to defend the national interest before the President assigns them diplomatic missions.

The Committee having taken note of the explanation from the Presidency in the aforementioned letter by the Head of Public Service, resolved to undertake the approval hearings.

In conducting the approval hearings, the Committee examined the nominees against the following criteria as set out in the Public Appointments (Parliamentary Approval) Act-

- i. Academic qualifications;
- ii. Employment record;
- iii. Professional affiliations;
- iv. Potential conflict of interest;
- v. Knowledge of the relevant subject;
- vi. Overall suitability for the position;
- vii. Integrity;
- viii. Vision and leadership; and
 - ix. Expectations and key priorities.

3.1 VETTING OF AMB. RICHARD TITUS EKAI, PHD, CBS - NOMINEE FOR POSITION OF AMBASSADOR/HIGH COMMISSIONER

Ambassador Richard Titus Ekai appeared before the Committee on Tuesday, 27th March, 2018 at 9.00am and was interviewed pursuant to the provisions of the Constitution, Public Appointments (Parliamentary Approvals) Act and the Standing Orders of the National Assembly. The nominee responded to several questions during the vetting as follows-

Citizenship, Date and Place of Birth

1. The nominee is a Kenyan Citizen with identity card (ID) number 7477635 and was born in Turkana County in 1967.

Academic and Professional Qualifications

 He holds a Bachelor of Science degree in Physics and a Master of Philosophy in physics - Solar Energy from Moi University (1991) and (1996) respectively. He is a PhD holder on Renewable Energy from University of Hannover, Germany (2000). He also holds a Master of Business Administration from Moi University (2005).

Employment records and Work Experience

- 3. His work experience is largely in the public sector. He was an Ambassador to the Kingdom of Thailand and was the Dean of the Diplomatic Corps between 2012 and 2013 during which period he coordinated engagements between the diplomatic corps and the Royal Thai Government.
- He has held public positions in the Government as Principal Secretary in various state departments - Mining, Sports Culture and Arts, Sports Development and Correctional Services.

Honours and Awards

- 5. He was awarded the following honours and awards-
 - (a) the Chief of the Order of the Burning Spear (CBS) by H.E. President Uhuru Kenyatta, Dec. 12, 2014;
 - (b) the Moran of the Order of the Burning Spear (MBS) by H.E. President Mwai Kibaki, Dec. 12, 2011; and
 - (c) the Dean of the Diplomatic Corps in Thailand, March 2012 June 2013.

Professional Association

6. He is a member of the Kenya Association for Public Administration and Management.

18. The nominee informed the Committee that Kenya's Maritime dispute with Somalia will be guided by Kenya's foreign policy and position of the Ministry of Foreign Affairs from time to time.




