#### **FORWARD**

This is the annual report of the National Assembly for the Second Session, covering the period from February 11, 2014 to December 18, 2014. The report seeks to provide the highlights of the business conducted in the National Assembly during the stipulated Session.

The National Assembly upon resuming on February 11, 2014 began with the scrutiny of the Budget Policy Statement, Supplementary Estimates for 2013/2014, the Division of Revenue Bill, 2014, and Budget Estimates for the 2014/2015 financial year, all being budget-related Bills with set timelines to be adhered to. An amendment made to the Standing Orders in December 2013 ensued that Bills introduced during a session do not lapse in the next Session. The House considered seventy seven (77) Bills at various stages with twenty two (22) Bills having been carried over from the last Session. In addition, several private Members bills were introduced touching on various matters, ranging from health care to procurement, financial matters, and education issues, among others.

This Session also heralded the formation of the first-ever Mediation Committees comprising of Members from both Houses to discuss and present a compromise version of the County Governments (Amendment) Bill, 2013, whose motion was lost at the Second Reading, and the Division of Revenue Bill, 2014, where the National Assembly rejected the Senate amendments to the Bill. This continues to highlight the need for both Houses to engage in dialogue and consensus-building to ensure smooth passage of laws being considered by both Houses.

The introduction of request for Statements in place of Questions, and management of Statements responses to statements remained a challenge. However, the House in a bid to actualize Article 153 of the Constitution amended the National Assembly Standing Orders twice within the year to allow Cabinet Secretaries to appear before the House. Implementation of this process is still ongoing.

Progress has been made on some of the challenges experienced last year. For instance, approval of Statutory Instruments was resolved through a considered ruling by the Speaker. In addition, more capacity has been availed to the Directorates and the Assembly at large through the recent recruitment of new staff by the Parliamentary Service Commission. This will greatly assist in handling the expanded House Membership. It is noted that the Commission is in the process of constructing an office block in the area around Continental House, a second office block and car park behind the Restaurant to provide sufficient parking, office accommodation and meeting rooms for Members and staff.

It is my hope that the enhanced linkages and synergy between the various Directorates and Departments that has been evident throughout the year will continue so as to ensure that the work of the National Assembly continues to flow smoothly during the Third Session.

#### 1. RESUMPTION OF THE HOUSE

The National Assembly resumed its sittings on Tuesday, 11<sup>th</sup> February, 2014 after the December recess. The National Assembly passed its Calendar of Regular Sessions with **122** sitting days while introducing periods of short recess to give Members of Parliament (MPs) some time to visit their constituencies. The longer recess periods, comprising of 25 days and above, were included to allow Members to spend more time in their various Committees scrutinizing various bills and financial documents so as to adhere to constitutional requests for public participation and statutory deadlines. The National Assembly held a total of 122 sittings including special sittings in the Second Session. The Sessional Calendar, as adopted by the

#### II. SPECIAL SITTINGS OF PARLIAMENT

House in February 2014 forms part of this report (Annex I).

The House had several Special Sittings during the Session. The first Special Sitting in the Session was a Joint Sitting of Parliament addressed by **H.E. the President** on **March 27, 2014** in keeping with Article 132(1) (b) and (c) of the Constitution. The President gave a State of the Nation address during which he tabled the following three reports:

- a) Report on all the measures taken and the progress achieved in the realization of the national values, referred to in Article 10 of the Constitution;
- b) Report on the progress made in fulfilling the International Obligations of the Republic; and
- c) Report on the Nation's security, in accordance with Article 240 (7) of the Constitution.

The first report was to provide feedback to Parliament and the citizens on the progress and achievements by the Government in fostering national values and principles of governance in the country. The report therefore includes measures taken towards this end in public institutions, and the progress made, the challenges encountered during the operationalization of this process, and recommendations on what strategies to incorporate for higher effectiveness.

The Report on International Obligations highlights the status and strength of Kenya's regional and international ties through the ratification of treaties, and accomplishments in fulfilling the ensuing obligations. The report also provides information on the specific treaties and agreements that Kenya is a signatory.

The Report on the State of National Security touches on the security situation in the country within the last one year, challenges encountered, plus strategies and measures implemented to deal with the ongoing and future security threats.

On **September 10, 2014,** the House held a Special Sitting to consider the reports of the Departmental Committee on Defence and Foreign Relations on the vetting of the nominee for appointment to the position

of Director-General of the National Intelligence Service and the nominees for appointment as Ambassadors, High Commissioners and Diplomatic Representatives.

On **October 6, 2014,** H.E. the President addressed a Special Joint Sitting of Parliament on various issues touching on the Presidency in relation to the ongoing Kenyan cases at the International Criminal Court. This was done in accordance with Article 132(1) (b) of the Constitution.

The last Special Sitting of the National Assembly was on December 18, 2014 to consider the following:-

- (a) The Report of the Select Committee on the Constituencies Development Fund on its consideration of nominees for appointment to the Constituencies Development Fund (CDF) Board;
- (b) The Third Report of the Committee on Appointments on vetting of a nominee for Cabinet Secretary; and
- (c) The Security Laws (Amendment) Bill, 2014 in Committee of the whole House.

#### III. SWEARING-IN OF MEMBERS

The initial swearing-in of the newly-elected Members was conducted in March 2013. However, the oath can be administered at different times of a parliamentary Session for various reasons. In fact, under Article 74 of the Constitution, no person shall assume or perform any functions of a State office before taking or subscribing to the oath or affirmation of office. Standing Order 3(5) also provides for Members who are sworn-in at other times besides the first sitting of a new House.

The Speaker therefore conducted swearing-in (Administration of Oath) to four (4) Members of the National Assembly between February and December 2014. These Members were sworn in afresh after the resolution of their respective election issues. They comprise of the following:


#### IV. PARLIAMENTARY BUSINESS

Standing Order 171 gives the House Business Committee the mandate to prepare the Parliamentary Calendar, monitor and oversee implementation of House business. During the Second Session, the House Business Committee held a total of twenty eight (28) sittings to schedule business before the House. The following is a highlight of what the House has considered during the period under review.

#### A. Bills

As part of its legislative mandate, seventy seven (77) Bills were introduced in the House, out of which, twelve (12) were from the Senate. Seven of the Bills originating from the National Assembly were forwarded to the Senate for consideration while two were passed after undergoing Mediation. These two were: the County Governments (Amendment) (No. 2) Bill, 2013 – Senate Bill, and the Division of Revenue Bill, 2014.

A list of Bills passed in this Session is found in **Annex II**, with a table showing the status of the different Bills below:

Of particular note was the introduction of Constitutional Bills in a bid to conform to the set timelines. However, only three Bills were submitted by the Executive very close to the constitutional deadline, making it impossible to pass all the required laws within the stipulated timeframe, given that some of the Bills were not ready, and others also required to be considered by the Senate. As such, and in accordance with Article 261 (2) of the Constitution, the National Assembly extended the period prescribed for enactment of legislations necessary to give effect to the Constitution from August 27, 2014 to May 27, 2015. These Bills include:

- (i) The Public Service (Values and Principles) Bill Article 232;
- (ii) The Persons Deprived of Liberty Bill Article 51;
- (iii) The Environmental Management and Coordination (Amendment) Bill Article 72;
- (iv) The Public Audit Bill, 2014 Article 226;
- (v) The Public Procurement and Asset Disposal Bill, 2014 Article 227; and
- (vi) The Victim Protection Bill, 2013 Article 50.

The Public Service (Values and Principles) Bill, 2014 and the Environmental Management and Coordination (Amendment) Bill, 2014 have already concluded debate in the National Assembly and forwarded to the Senate for its debate. These will be among the Bills to be given priority in the upcoming Session to ensure their passage within the new timelines set.

#### B. Motions

During the last Session, one hundred and twenty five (125) Motions were introduced in the House. Of these, 114 were Ordinary while 11 were Special Motions. Sixty one of these Motions were adopted, of which 23 were Committee reports, 27 were general motions and 11 were Special motions. Three motions were negatived or lost. They included the motion on the report of Westgate and other terror attacks; a motion seeking the establishment of a fund for men; and the appointment of MPs to various committees.

It is noted that due to the increased number of Bills submitted by individual Members in the current Session, legislative proposals were given priority on Wednesday mornings. This led to only a small number of Members' motions being considered by the end of the year. This is an area that may possibly require review, perhaps to balance better the business conducted on Wednesday mornings.

#### C. Petitions

Fifty one (51) Petitions were presented during the Session and were committed to the relevant committees. A total of 26 Petitions were presented through the Speaker as provided for by Standing Order 225(2)(b) indicating the increased awareness on the part of the public on the representative and oversight role of Parliament. On the other hand, a total of 25 Petitions were presented through Members of Parliament. Of these, nine Petitions have already been concluded.

It is noted that the number of Petitions has been on the increase as the Members preferred using this method to present issues from their constituents in the House. This phenomenon also arises from the fact that Statements have now been phased out; providing another avenue for Members to present grievances from their constituents on a variety of matters.

#### D. Statutory Instruments

The National Assembly has continued to play a key role in the processing and management of delegated legislation as provided for under PART IV of the Statutory Instruments Act, 2013. During the Second Session, the National Assembly received the following statutory instruments which were duly laid on the Table of the House:-

- i. The Public Finance Management (Uwezo Fund) Regulations, 2013;
- ii. Bilateral Air Services Agreements between Kenya and Angola, Mozambique, Canada and Kuwait;
- iii. The Constituencies Development Fund Regulations, 2014;
- iv. The National Construction Authority Regulations, 2014;
- v. The Child Welfare Society of Kenya Order, 2014;
- vi. The Kisumu National Polytechnic Order, 2014; The Eldoret National Polytechnic Order, 2014; and The Kenya Technical Trainers College Order, 2014;

- vii. The National Payment System Regulations, 2014;
- viii. The Government Financial Management (Hospital Management Services) Regulations, 2009;
- ix. The Environmental Management and Coordination (Waste Tyre Management) Regulations, 2014;
- x. The County Land Management Boards Regulations, 2014 and the National Land Commission (Review of Grants and Dispositions) Regulations, 2014;
- xi. The Value Added Tax Regulations, 2014;
- xii. The Leadership and Integrity Regulations, 2014;
- xiii. The National Social Security Fund Regulations, 2014;
- xiv. The Universities Regulations, 2014;
- xv. The Science, Technology and Innovation (Registration and Accreditation of Research Institutions) Regulations, 2014;
- xvi. The Public Finance Management (Affirmative Action Social Development Fund) Regulations, 2014; and
- xvii. The Tobacco Control Regulations, 2014.

Out of these, motions on the following statutory instruments were considered and adopted:


- (i) The Public Finance Management (Uwezo Fund) Regulations, 2013;
- (ii) Bilateral Air Services Agreements between Kenya and Angola, Mozambique, Canada and Kuwait;
- (iii) The Constituencies Development Fund Regulations, 2014; and
- (iv) The National Construction Authority Regulations, 2014.

#### E. Statements and The Re-Introduction of Questions

As the Session began, Statements were used as a means of presenting issues of concern to Members as representatives of the people. However, this mode was changed when the Procedure and House Rules Committee recommended amendments to the National Assembly Standing Orders which were passed by the House in June and August 2014. These changes paved way for the re-introduction of parliamentary questions, thus doing away with statements. By the time of the re-introduction, a total of three hundred and ten (310) statements had been processed.

The re-introduction of Questions has seen Cabinet Secretaries appearing before committees of the House every Tuesday between 10.00am and 12.30pm to respond to questions directed to their respective dockets as requested by Members. Questions continue to be a popular avenue for Members to channel matters of local and national concern from their constituents to the Executive, to hopefully receive comprehensive answers in a timely manner.

A total of 126 Questions (118 Ordinary and 8 by Private Notice as provided by Standing Order 170G) were requested by Members between September and December 2014. By the end of the Session, 29 questions had been responded to and concluded, and 89 had been dispatched to the relevant Ministries awaiting scheduling for response, while one of question by Private Notice had been responded to. The chart below shows a pictorial of this analysis.



#### F. Vetting and Approval of Appointees to Public Offices

In fulfillment of its role in accordance with the Constitution, the House vetted the following for appointment to the offices indicated:-

- i. Chairperson and Members of the Kenya National Commission on Human Rights;
- ii. Member of the National Gender and Equality Commission;
- iii. Two members to the Parliamentary Service Commission;
- iv. Fifteen Members to the National Cohesion and Integration Commission;
- v. Chairperson of the Teachers' Service Commission;
- vi. Nominee for the position of Director-General of the National Intelligence Service;
- vii. Nominees for appointment as Ambassadors, High Commissioners and Diplomatic Representatives;
- viii. Member to the Constituencies Development Fund Board; and
- ix. Nominee for appointment to the position of Cabinet Secretary for the Ministry of Interior and Coordination of National Government.

#### G. Committee Reports

Committees have continued exercising their mandate as extensions of the House. At the end of the Session, a total of seventy eight (78) reports on diverse subject matters including reports on vetting of nominees for different public positions, field visit reports, consideration of Bills and reports on


Petitions had been tabled (Annex III).

Some of the Committee reports that have been tabled include:

- i. The Report of the Committee on Regional Integration which was a consideration of the East African Community Cross Border Legal Practice Bill, 2014; the East African Community Integration (Education) Bill, 2014; and the East African Community Cooperative Societies Bill, 2014 forwarded by the East African Legislative Assembly (EALA).
- ii. The Report of the Departmental Committee on Transport, Public Works and Housing on the consideration of Bilateral Air Services Agreements between the Government of the Republic of Kenya and the Government of the Republic of Angola; Mozambique; the Government of Canada and the State of Kuwait.
- The Public Accounts Committee report on the accounts of the Auditor-General for the financial years 2008/2009 and 2009/2010.
- iv. The Report of the Select Committee on all matters relating to Khat (Miraa) which makes recommendations on how to handle the economic and social aspects of this crop in the country.
- v. The Public Investments Committee Special Report on the procurement and financing of the construction of the Standard Gauge Railway from Mombasa to Nairobi (Phase I) and Nairobi to Malaba/Kisumu (Phase II).
- vi. The Report of the Joint Committee on Energy, Communications and Information and Education, Research and Technology on the status of the San Marco Space Application Centre in Malindi, regarding the bilateral agreement between Kenya and Italy on the management of this centre.
- vii. The Report of the Public Accounts Committee on the Hire of an Aircraft for the Deputy President for a tour of Four African Nations in May, 2013.
- viii. The Report of the Departmental Committee on Health on the Devolution of Health Services, focusing on implementation challenges in the health sector, and proposed recommendations on how to handle the devolution of health services.
- ix. The Report of the Joint Committee on Budget & Appropriations and Finance, Planning & Trade on settlement of foreign court judgements against the Government of Kenya.

The National Assembly also continues to receive Sessional Papers from the various Ministries on proposed policies for implementation.

Below is a breakdown of the status of different reports as detailed in Annex III:



#### H. Communications from the Chair

The Speaker continued to guide the House on various matters through Communications from the Chair pursuant to Standing Order 40. This included issuance of considered rulings on matters arising on the floor of the House. The most notable Communications were those regarding:-

- a) The Special Sittings of Parliament;
- b) Guidance on debate relating to the President's Address;
- c) Consideration of amendments to the Value Added Tax (Amendment) Bill, 2014, and other money bills as defined by Article 114 of the Constitution;
- d) Supplementary guidance on mandate of Audit Committees vis-à-vis Departmental Committees;
- e) The conduct of Members in the Chamber:
- f) Procedure for consideration of delegated legislation; and
- g) The disclosure of contents of Committee reports before they are tabled.

The Speaker also continued to convey Messages from H.E. the President and the Senate on various matters. In the period under review, there were over eight Messages on nominees for appointment to various public offices, on refusal to assent to some Bills, and from the Senate on various Bills.

#### V. International Desks, 2014

#### A. The Inter-Parliamentary Union (IPU)

The IPU facilitates political parliamentary debate, dialogue and cooperation, assisting parliaments and parliamentarians throughout the world to fulfill their mandates. It also assists Parliaments in coping with a growing international agenda, and in contributing a Parliamentary dimension to the work of the United Nations and similar multilateral institutions.

The IPU Assembly is the principle statutory body that expresses the views of the Inter Parliamentary Union on political issues. It brings together Parliamentarians to study international problems and make recommendations for action. In 2014, the IPU held its 130th and 131st Assemblies and related meetings in Geneva, Switzerland in March and October respectively. The most significant occurrence was the appointment of two Members of the Kenyan Parliament to the Bureaux of the Committee on Democracy and Human Rights, and the Committee on United Nations Affairs in the March meeting. The role of these Bureaux, which comprise of members from different regions of the world, among other things, guide the work of the IPU Standing Committees, discuss proposals for agenda items and develop work plans for their respective Committees. There were also various seminars on topical issues that were conducted throughout the year, at which Kenya was represented.

#### B. The Commonwealth Parliamentary Association (CPA)

The Commonwealth Parliamentary Association (CPA), of which the Parliament of Kenya is a member, is an association of Parliamentarians from the Commonwealth countries. The CPA was formed to promote parliamentary democracy, and enhance governance, respect for individual rights and rule of law. It also facilitates co-operation between the Parliaments and Legislatures represented in it.

In the period under review, the 45<sup>th</sup> CPA (Africa Region) meeting was held in Arusha, Tanzania in July, 2014 while the 60<sup>th</sup> Plenary Session in Yaounde, Cameroon in October, 2014. During this 45<sup>th</sup> meeting, the Speaker of the National Assembly, the Hon. Justin Muturi, EGH, MP, was nominated as a Member of the Board of Investments of the CPA (Africa Region). There were also various seminars conducted on topical issues like human rights, parliamentary and developments issues, among others, throughout the year, at which Kenya was represented.

As part of its international obligations, in 2015, the Parliament of Kenya will be hosting two important events under the Commonwealth Parliamentary Association, that is, the inaugural Staff

Development Seminar for the Society of Clerks-at-the Table (SOCATT) for Africa Region to be held in mid-January 2015 and the Annual CPA Conference - Africa Region, scheduled to be held in mid-2015. The two events are expected not only to provide a forum for sharing parliamentary experiences amongst the participants, but also to contribute towards promoting conference tourism in line with Kenya's Vision 2030.

#### C. The African, Caribbean, Pacific- European Union Assembly (ACP-EU)

The ACP-EU Joint Parliamentary Assembly is one of the organs of joint institutions established under the ACP-EU Partnership Agreement, mostly known as the Cotonou Agreement. The Assembly was created out of a common desire to bring together the representatives of the African, Caribbean and Pacific states that have signed the Cotonou Agreement and the European Parliament.

The ACP-EU brings together more than 320 MPs from the 79 ACP Countries and Members of the European parliament, drawn from the 27 members stated of the EU, commonly referred to as MEPs. The Parliament of Kenya has been a member of the ACP-EU Joint Parliamentary Assembly (JPA) since its inception.

During the period under review, the ACP-EU held three meetings. The first was the 11<sup>th</sup> Regional Meeting (East Africa) held in Port Louis, Mauritius in February 2014; Kenya was represented by two Members of the National Assembly. The second meeting was the 35<sup>th</sup> session of the ACP Parliamentary Assembly and the 27<sup>th</sup> Session of the ACP-EU Joint Parliamentary Assembly held in Strasbourg, France in March 2014. The third meeting was the 36<sup>th</sup> session of the ACP parliamentary Assembly and the 28<sup>th</sup> Session of the ACP-EU Joint Parliamentary Assembly held in Strasbourg, France in November, 2014. Kenya was represented at the main assemblies by two Members of the National Assembly, and one Senator, and was able to have the ACP Parliamentary Assembly adopt a resolution on terrorism in Kenya at the December 2014 meeting.

#### D. The Pan-African Parliament (PAP)

The Pan-African Parliament (PAP) was established according to the Protocol to the Treaty Establishing the African Economic Community Relating to the Pan-African Parliament (PAP Protocol) as one of the 10 Organs of the African Union. It was inaugurated on 18 March 2004 in Addis Ababa and moved to its current Seat in Midrand, Johannesburg - South Africa.

In the period under review, four Members of Parliament out of the five representing Kenya were sworn in during the plenary session in March 2014; the fifth one had been sworn in last year. There were also committee meetings held during this session. The entire delegation comprises of three Members of the National Assembly, and two Members of the Senate. The National Assembly was also represented in the PAP Parliamentary Association of Secretaries General in Africa and the Conference of Speakers in August, 2014. Further, the Kenyan delegation participated in the 5<sup>th</sup> Ordinary Session of the Third Parliament of the PAP held in Midrand, South Africa in October, 2014.

#### VI. HIGHLIGHTS OF THE SESSION

The Second Session had a total of 122 sittings, and was not without some noteworthy occurrences. As has been evident, despite the set of established rules and regulations that govern and guide the operation of business in the House, changing times, political motivations, constitutional or statutory deadlines, among other factors, often affect the conduct of business in the Assembly. A few events of the year 2014 stand out as worth noting and possibly learning from:

#### 1. KEY PROCEDURAL ISSUES AND OTHER DEVELOPMENTS

#### a) Extension of timelines for Constitutional Bills

As alluded to elsewhere in the report, there are various laws that must be passed by August 27 of each year as stipulated in the Fifth Schedule of the Constitution. Ideally, these laws require to be received by end of May, 2014 at the very least, to allow for in-depth consideration by the relevant Committees and Members, and ensure adequate time for public participation before their consideration and passage. This year, six laws were required to be passed by the constitutional deadline. Of these, only one, the Victim Protection Bill, 2013, had been received on time. It was actually sponsored by a private Member, and was reviewed to ensure that it fully gave effect to Article 50. Three other bills, as mentioned earlier, were submitted on 25 July 2014 while the other two were still in draft form. This was despite numerous engagements with the relevant stakeholders to fast-track these legislative proposals.

This did not give sufficient time to the House to concretely examine them before the 27 August 2014 constitutional deadline, given that two of these had to be considered by the Senate as well. As such, the National Assembly resolved and was able to extend the timelines for passage of these bills by nine months, as provided for in Article 261 of the Constitution, after marshalling a two-third majority of Members of the Assembly. The opportunity was also taken to vote to conclude the Second Reading of the Constitution of Kenya (Amendment) (No. 2) Bill, 2013, which also required two-thirds majority to continue to the Committee Stage, being a Bill amending the Constitution.

#### b) Formation of Mediation Committees

The year also heralded the formation for the first time, of Mediation Committees between the Houses in accordance with Article 113 of the Constitution. Two such committees were formed when the two Houses had divergent views on the County Governments (No. 2) (Amendment) Bill, 2013, and the Division of Revenue Bill, 2014. The Mediation Committee versions of the Bills presented were eventually passed in both Houses.

There continues to be need for establishment of a forum for the two Houses to consult and build consensus on legislative issues and to forge good working relations, especially when dealing with laws that have to be considered by both Houses, and those that have to adhere to strict timelines, such as the Division of Revenue Bill and County Allocation of Revenue Bill.

#### c) First report of the Committee on Privileges

The Second Session marked the first time that the Committee on Privileges tabled a report on the conduct of Members. The House is yet to debate the report, which largely touched on petitions sent to the National Assembly by the public wishing to declare two seats vacant based on non-attendance of plenary sittings by the two Members, pursuant to Article 103 (1) (b) of the Constitution. The matter is yet to be canvassed in full, but this presents an opportunity for the House to fully actualize this constitutional provision for posterity, so as to clarify the process of removal of a Member based on attendance of plenary sessions.

#### d) Amendments to the Standing Orders on Statements and re-introduction of Questions

In 2014, there were two amendments to the Standing Orders, initiated by the Procedure and House Rules Committee. Both had to do with re-introduction of parliamentary Questions, in place of Statements. The first amendment introduced a methodology for the attendance of plenary sessions by Cabinet Secretaries to answer to questions, similar to what was experienced under the parliamentary system of government in the last Parliament. After a series of consultative meetings between the National Assembly and the Executive, especially touching on the constitutionality of this amendment, the Standing Orders were again amended to form the Committee on General Oversight to allow the Cabinet Secretaries to instead appear before a Committee instead of in a plenary session of the House.

This procedure however continued to raise concern, particularly with the Constitutional Implementation Commission and the Executive. As such, the Committee on General Oversight was suspended, and the Cabinet Secretaries continued to appear before Departmental Committees every Tuesday morning to answer between three to five questions. The process continues to be reviewed to ensure that Members' concerns regarding constituencies and national issues are appropriately addressed.

#### e) Suspension of Members

In the period under review, there seemed to be escalating cases of disorderly conduct and indiscipline among Members while debating on the floor. This prompted the Hon. Speaker to issue a number of communications on this matter, as well as cause some Members to withdraw from the Chamber, pursuant to Standing Order 107. As a result, during the year, nine (9) Members were sent out during the sittings. The Committee on Privileges is currently reviewing some of these cases of indiscipline, with a view to reporting back to the House.

### f) Grave disorderly conduct during consideration of the Security Laws (Amendment) Bill, 2014

On December 18, 2014, a special sitting of the Assembly was convened to consider the Security Laws (Amendment) Bill, 2014 at the Committee Stage, and also consider two Special Motions, one on a nominee to the Cabinet and the second on nominees to the CDF Board. However, the House experienced various incidents of grave disorder, at one juncture prompting the Hon. Speaker to suspend the House for thirty (30) minutes to restore order. However, the sitting still could not continue due to incidents of heckling, singing, shouting and general mayhem from Members within the Chamber, and from Senators who were standing in the Speaker's gallery. The morning sitting was adjourned earlier than scheduled to allow more consultations.

Unfortunately, the grave disorder reigned in the afternoon sitting, culminating in the Speaker having to conduct the Committee of the Whole House for passage of the said Bill. At some point, amid filibuster and divisions, Members toned down to pass one of the Special Motions. What transpired next was an unusual occurrence not seen in the Parliament of Kenya in a long time. A Member was spotted tearing apart reference materials used by his colleague in the Chamber, while another was seen pouring a liquid substance on the Deputy Speaker when presiding in the Committee of the Whole House, ostensibly, in protest. Later, another Member was seen tossing one of the Law Volumes provided for use by Members, towards the Speaker when he was chairing the Committee. The unprecedented grave disorderly conduct of the House on that day drew wide criticism and was described by one Member as the "darkest and lowest moment of the House that should never be allowed or remembered."

#### g) Handling of Subsidiary Legislation/Regulations/Statutory Instruments

The handling of these pieces of legislation was clarified through a considered ruling of the Speaker issued on March 26, 2014. This was due to the increased number of such regulations being forwarded to the National Assembly for consideration from various Ministries, in accordance with the Statutory Instruments Act, 2013 and the Standing Orders.

It was highlighted that according to the Statutory Instruments Act, 2013 and Standing Order 210:

- (i) Under section 12 of the Act, every statutory instrument tabled stands referred to the Committee on Delegated Legislation.
- (ii) The Committee only reports back to the House in the instances where it desires to annul the whole or part of the statutory instrument. Where there is no desire to annul the whole or any part of a statutory instrument, that resolution is communicated to the Clerk who then communicates to the relevant state department or the authority that published the statutory instrument.
- (iii) The Committee is obliged to scrutinize the statutory instrument in accordance with the criteria set out in the Act and upon completion of its scrutiny, there is no contemplation of any motion for approval or amendment of the statutory instrument, except for a motion of annulment where the Committee has recommended so.

The main point of this communication was to highlight that consideration of delegated legislation was radically different from consideration of Bills, and amendments would not occur the same way. The regulations approved this year, including those awaiting review are mentioned elsewhere in this report.

#### h) Consideration of Money Bills

During the year, the Speaker provided guidance to the House that any amendment relating to a Money bill should go through the Committee on Budget and Appropriations to ensure that the financial aspects were addressed in full. This also related to amendments on other Bills that had monetary implications.

#### 2. KEY ISSUES IN COMMITTEES

#### a) Rejection of changes to Committee membership

During the Session, one political party attempted to discipline its errant Members by discharging them from various Committees and replacing them with others. However, though the discharge took effect, the motion to replace the Members was lost, marking the first time such an action has happened in 2014. During the course of the year, the same party attempted to change some memberships in the Committees, but was unable to when the House rejected that motion. These cases have prompted Members to request the Procedure and House Rules Committee to review Standing Orders 173 and 176 with a view to amending them for more clarity regarding nomination to and discharge of Members from committees.

#### b) Introduction of Question Time

Arising out of the introduction of parliamentary questions and suspension of the new Committee on General Oversight, the Departmental Committees took the forefront in dealing with parliamentary Questions. Cabinet Secretaries began appearing before the Committees to answer questions falling within their mandate. This procedure will continue to be streamlined to ensure that as the processing of Questions begins in the Legislative and Procedural Services Directorate, it will continue seamlessly when handed over to the Directorate of Committee Services, including the tracking of the status of replies sought.

One emerging issue noted regarding these questions is the current backlog. So far, 126 Questions have been prepared and dispatched to the ministries. However, since Cabinet Secretaries only respond to between three and five questions at each appearance, and do not appear weekly, only twenty nine (29) questions have received a reply so far, with eighty nine (89) still awaiting scheduling. Further, of the eight (8) questions sent by private notice, only one (1) has been responded to. Another challenge that has occurred at these meetings is the absence of the questioners when their response is scheduled. As a result, the Cabinet Secretaries only table their responses or leave without transacting any business.

#### c) Vetting of nominees to various public offices

The Committees continued to be greatly involved in the vetting of nominees to various public posts, as stipulated elsewhere in the report. The House was able to consider all the reports on the vetting process, and of the fifty six (56) total nominees presented for approval, the relevant Committees approved fifty one (51) and rejected five (5) nominees.

It should be noted that for members of the National Cohesion and Integration Commission, the relevant law stipulates that the National Assembly conduct the recruitment, interviewing, and subsequent vetting of shortlisted candidates as commissioners. The law will require an amendment to ensure that the Executive handles the recruitment and interview part of the process, leaving the Assembly with only the vetting process to conduct, to ensure better separation of powers between the two branches of Government.

#### VII. DIRECTORATE BRIEFS

#### a) Directorate of Legislative and Procedural Services

The Directorate continues to play a key role in marshalling business for the National Assembly. It has continued to offer legislative and procedural advice to Members, staff and the public while offering

secretariat service to different committees including the House Business Committee, the Procedure and House Rules Committee, the Chairpersons' Panel and the Powers and Privileges Committee.

During the Session, the Directorate accomplished several achievements key among them being:-

- i. Marshalled the publication and consideration of seventy seven (77) Bills, fifty one (51) Petitions, one hundred and twenty five (125) Motions and more than one hundred and twenty six (126) Questions;
- ii. Facilitated a breakfast meeting with Cabinet Secretaries on the new Committee on General Oversight;
- iii. Conducted a meeting with the Parliamentary liaison officers in ministries to apprise them on the Committee on General Oversight;
- iv. Inducted eight newly-recruited officers;
- v. Conducted three seminars for officers in the directorate:
- vi. More than twelve (12) officers were trained/attached locally and outside the country;
- vii. Facilitated two House Leadership retreats in Mombasa;
- viii. Facilitated two workshops to consider the amendments to the Standing Orders in March & May 2014.
- Conducted training sessions for county assemblies including Nairobi, Nyeri, Nyandarua, Baringo, Makueni and West Pokot.

In the coming Session, the Directorate envisages a more vibrant approach to the activities in the National Assembly. The Directorate is in the process of formulating its service charter with a view to enhance service delivery through results-based management. The Directorate is currently organizing to host the Professional Development Seminar of the Society of Clerks-at-the-Table (SOCATT) for the Africa region of the CPA in January 2015.

#### Envisaged Activities in the Third Session

- ✓ Creation of three sections/units within the Directorate to better offer services to Members
  of Parliament, staff and the public. These are the Table Office Department, the Procedural
  Research and Journal Department, and the Procedural Committees and Inter-Parliamentary
  Affairs Department;
- ✓ Formulation of the Service Charter and an updated workplan;
- ✓ Creation and updating of various procedural manuals;
- ✓ Continuous extensive, practical training and attachments to enhance internal capacity; and
- ✓ Possible introduction of new staff to Chamber duties.

#### **b)** Hansard Department

The Hansard Department continues to ensure timely production of accurate record of the proceedings of the House. During the Session, the department undertook several activities. These include:-

- i. Production of ninety five (95) Hansard reports and one report of the Committee on General Oversight;
- ii. Shifted from the Uganda room to the Western wing of the Main Parliament buildings;
- iii. Received and inducted nine (9) newly-recruited staff at the National Youth Service Business Institute;
- iv. Held a three-day workshop to update the Hansard Guide (Production manual) in March;
- v. Organized an orientation workshop for new officers in Mombasa in October, 2014;
- Conducted training sessions for the County Assemblies of Nyeri, Nyandarua, Baringo, Makueni and Nairobi.

Officers in the department also had foreign assignments and attachments including:-

- Commonwealth Hansard Editors' association conference in Accra, Ghana;
- Pan-African Parliament:
- CPA Seminar in Dar-es-Salam in May, 2014;
- Institute of Chartered Secretaries and Reporters Training in Lagos, Nigeria in June;
- IPU Conference in Santa Cruz, Bolivia;
- Reporters Training course in the UK; and
- An internship programme at the Bureau of Parliamentary Studies and Training at Lok Sabha,
   India.

#### Envisaged Activities in the Third Session

- ✓ New officers to undergo training at the Kenya School of Government;
- ✓ Review of the Work-Plan and Service Charter;
- ✓ Source for training and attachments to enhance capacity.

#### c) Serjeant-At-Arms Department

The Serjeant-at-Arms is responsible for performing chamber and ceremonial duties, estate management, operation and liaison functions to enable the National Assembly to effectively discharge its mandate.

During the period under review, the Department made the following key achievements:-

- Re-organised the department into various units;
- ii. Prepared a proposal for the restructuring of the department and elevation to a directorate;
- iii. Successfully inducted newly recruited staff; and
- iv. Participated in the Parliament week, where it received recognition for the best stand.

#### Key Activities Undertaken

In the performance of its core role, the department undertook the following activities:-

- Enforced Speaker's rules;
- ii. Facilitated the swearing-in of newly elected Members,
- iii. Coordinated and facilitated presidential addresses;

- iv. Facilitated memorial and funeral services of Members and/or former Members;
- v. Coordinated and facilitated international functions and colloquium e.g. EALA;
- vi. Liaised with the Executive for Members' security (Bodyguards);

#### Activities for the Third Session

- ✓ Capacity building for staff;
- ✓ Holding a national colloquium for Serjeant-at-Arms;
- ✓ Acquisition of communication equipment;
- ✓ Attachment to other jurisdictions for enhanced exposure;
- ✓ Development of a training manual and curriculum in conjunction with the CPST;
- ✓ Assist in training County Assemblies.

#### d) Directorate, Speaker's Office

The Directorate has continued to work closely with all parliamentary offices to ensure the effective fulfillment of the functions of the Speaker's office. As the administrative arm of the Speaker's office, the directorate has ensured that the Speaker's office is properly facilitated to effectively and efficiently perform its duties. During the period under review, the Directorate:-

- i. Facilitated the Speaker in outreach programmes with a view to improving the image of Parliament;
- ii. Facilitated the Speaker's attendance in various conferences and seminars;
- iii. Was involved in hosting various parliamentary caucuses and diplomatic courtesies;
- iv. Coordinated and attended various Speakers' conferences including the East African Community Speakers' Conference and the PAP African speakers' conference in South Africa.

The Media Relations section within the Speaker's office has also been instrumental in highlighting the business of the directorate in the media. The department has been critical in profiling stories and activities of the Speaker's Office. This has been done through enhancing parliamentary visibility by placing important information in the local media as well as daily engaging with the editors and reporters to avert negative publicity.

#### e) Directorate of Committee Services

In 2014, Parliamentary Committees have continued to perform their functions of summoning of witnesses, vetting of nominees to state offices, facilitating presentation and analysis of evidence, conducting in-depth inquiries, undertaking inspection tours, and scrutinizing legislative proposals, among other duties.

Key achievements during the Session

- ✓ Addition of thirty five (35) new staff to bring total complement of officers in the Directorate to fifty six (56), ensuring adequate personnel for the twenty nine (29) committees;
- ✓ Total of seventy eight (78) reports tabled in the House;
- ✓ Vetting of fifty six (56) nominees to various public offices;
- ✓ Training of staff both locally and internationally to build capacity.

#### f) Directorate of Legal Services

The Directorate of Legal Services has continued to provide in-house legal services to the National Assembly in fulfilment of its mandate being the successor of the then Office of the Legal Counsel.

During the period under review, the Directorate discharged the following functions:

- (i) drafting of Members' Bills;
- (ii) preparation of Vellum copies of Bills passed by the National Assembly;
- (iii) drafting of amendments to Bills to be proposed to the House by any member of the National Assembly or any Committee of the Assembly;
- (iv) giving legal interpretation of the law and any Bill and generally giving legal advice on matters relating to legislation;
- serving as Speaker's Counsel and in this capacity act as legal counsel to the Speaker in respect of all official aspects of the Speaker's office;
- (vi) providing legal advice to the Parliamentary Service Commission and the National Assembly and its Committees;
- (vii) carrying out of legal research on assorted legal and procedural matters; and
- (viii) providing any other legal services that may be required by National Assembly, the Parliamentary Service Commission or House Committees.

Other than the usual duties, the directorate undertook the following activities:-

✓ Implementation of the New Constitution

The DLS has undertaken the following activities relating to the continuous implementation of the Constitution:

- ❖ Offering legal and technical support to the National Assembly;
- Continuous legal interpretation of the Constitution particularly on matters touching on the respective roles and jurisdiction of the two Houses of Parliament;
- Continuous engagement with the other institutions charged with the responsibility of implementing the New Constitution including the Commission for the Implementation of the Constitution, the Attorney-General Chambers and the Kenya Law Reform Commission.

#### ✓ Parliamentary Pupillage Programme

During the year under review, the directorate hosted three pupils under the Parliamentary Pupillage Programme. This Programmes offers students instructions on the proper practice of an advocate, as required for them to be admitted to the bar while affording them a firsthand experience on the legislative process.

#### VIII. TRANSITION

Towards the end of the long recess period, on Wednesday May 21, 2014, the National Assembly lost a Member due to a sudden illness. The Hon. Joseph Ngugi Nyumu, MP, was a first-time Member for Gatundu South Constituency, actively involved in the Departmental Committee on Education, Research and Technology, as well as the Constitutional Implementation Oversight Committee. He leaves behind a wife and two children.

#### IX. WHAT'S AHEAD FOR THE THIRD SESSION

The Third Session is scheduled to resume on February 10, 2015 after a recess period of 59 days. This falls right in the middle of the budget cycle. The House will therefore have the following business to conduct within the First Part of the Session:

- i. Approval processes for certain public/state office holders;
- Consideration and approval of the Supplementary Budget Estimates for the 2014/2015 financial year;
- Consideration and Approval of Pending Reports of the Public Accounts Committee, as they have implication on the sharing of national revenue between the National and County Governments;
- iv. Review and passage of the Budget Policy Statement (to be done before end of February);
- v. The Division of Revenue Bill, 2015 and the County Allocation of Revenue Bill, 2015;
- vi. The review and passage of four constitutional bills before May 27, 2015. These Bills are:
  - The Public Service (Values and Principles) Bill, 2014 Article 232;
  - The Environmental Management and Coordination (Amendment) Bill, 2014 Article 72;
  - The Public Audit Bill, 2014 Article 226; and
  - The Public Procurement and Asset Disposal Bill, 2014 Article 227.

However, given the low note on which the Second Session ended, there will be need to address the various disciplinary cases observed on 18<sup>th</sup> December 2014. In addition, there will possibly be need for consensus-building to resolve matters between the two main coalitions, to ensure more harmonious engagement as the year unfolds. This synergy will need to be built with Members of the Senate as well, to improve working relations between the two Houses of Parliament.

Parliamentary staff will have to be fast learners, quick to act and always non-partisan in the everchanging political climate to facilitate the smooth running of the Assembly and Parliament at large. It is also expected that we shall see an increase in the number of Questions, Motions and Bills, as most Members hit their stride in the third year in office, having fully grasped parliamentary procedures and practices.


