The Committee oversees the operations of the Ministry of Lands, Housing and Urban Development on the following matters: Land Policy and Physical Planning, Land Transactions, Survey and Mapping, Land Adjudication, Settlement, Land registration, Land Valuation, Administration of community and Public Land, and Land Information and Management System.

1.4 COMMITTEE GENERAL OBSERVATIONS AND RECOMMENDATIONS

Having held meetings, undertaken the inspection/fact finding visit and considered the submissions presented, the Committee made the following observations and recommendations: -

1.4.1 OBSERVATIONS

General Observations

- 1. The residents have no title deeds to the land;
- 2. The residents are constantly facing eviction threats from Kenset Holdings who claim ownership of the land as well as other wealthy land owners in the area;
- 3. The land Kwa Bulo can be categorized as private land (lease hold);
- 4. There exists absentee Landlords;
- 5. There are suspicious/fictitious agents collecting rent for land owners who abandoned their land.

Observations made In Maweni/Kisumu Ndogo and Idi Kumbi Village;

- 1. The residents have no title deeds to the land;
- 2. The private land owners in the area are willing to accept compensation from the government, for their land to be surveyed and redistributed to the residents;
- 3. Residents have been subjected to paying rent to suspicious/fictitious land owners who abandoned their land.

Observations made In Kisumu Ndogo;

There exists absentee Landlords in the area;

1.4.2 RECOMMENDATIONS

- The National Government through the Ministry of Lands, Housing and Urban Development should fund private land purchase to pave way for squatter settlement in Nyali;
- 2. The National Land Commission should establish the leases which have expired with a view to repossessing the land to pave way for squatter settlement;
- 3. The Government through the Ministry of Lands, Housing and Urban Development should conduct an audit with a view of establishing the legal owners of the various

parcels of Land in Nyali. If public, the land should be re-planned and allocated to the squatters and if private, compensate the private owners who are willing and resettle the squatters.

- 4. The National Land Commission and the County Government of Mombasa should urgently review land ownership in the area to establish ownership. Land without ownership or with expired lease ought to revert back to the Government;
- 5. The National Land Commission should publish the renewed leases for the area in question for the last 2 years.

2.0 BACKGROUND

- 2.0.1 During its sitting held on 15th October 2015, the Member for Nyali Constituency Hon. Awiti Bollo, M.P brought to the attention of the Committee land disputes in Nyali Constituency;
- 2.0.2 The Committee was informed of the following categories of land in the constituency to which he sought the intervention of the Committee with a view to assisting in resolving the land issues in the Constituency. Plot no 112/1/MN whose leases have expired:
 - a) Plot numbers 44, 45, 46, 64, 161, 106, 112, 397, 621, 622, 624, 154, 175,11224,1409/1/MN to which he is seeking assistance of the national government to fund land purchase to pave way for squatter settlement;
 - b) Plot Numbers 623,183/1/MN which has absentee landlords who continue collecting fees through lawyers; and
 - Plot no 62,427/1/MN which is government land; and the following under listed plots among others;

2.1 MEETINGS DURING THE FACT FINDING VISIT

The Committee received submissions from the County Commissioner and the resident's follows:

Submissions from the County Commissioners Office

The Committee paid a courtesy call to the Mombasa County Commissioner Mr. Nelson Marwa, who was in the company of Messrs. Peter Ng'ethe, Land Officer, Dick James Safari, Registrar of titles, Justus M. Levu, Settlement officer, Rachel M. Ndambuki, Surveyor and Nyamawi Mwajoto, surveyor. The County Commissioner informed the Committee that: -

- 2.1.1 In Nyali- Maweni, land was set aside for settlement scheme and was awaiting declaration to be established as a settlement scheme;
- 2.1.2 There were however squatters residing on private land;

Submissions from Residents In Kwa Bulo (Mkomani Ward) Nyali Constituency

Mr. Joseph Karisa- Chairman Mwatamba Swamp, Kenneth Baya-Chairman Land Freetown and Messrs.: Masika, Mama Mariam Bakari Jade-Resident Majengo Mapya, Omar Sore, Ali Abdalla bin Hemed-Resident Kwabulo, Jonah Ishmael Ambaka-Resident Gombe Village and Mati wa Matamazero-Resident Kwa Bulo made submissions before the committee. The Committee was informed as follows, that: -

- 2.1.3 Kwabulo Settlement land LR No is 379 measures 86 acres and was initially owned by Mzee Bin Ali on behalf of the Mazrui Family. He later lost the land to the government due to his failure in making income tax payment. The land was later transferred to Bulo and later reverted back to the government when Bulo could not pay the tax;
- 2.1.4 The government thereafter transferred the land to an Insurance Company-Kenya National Assurance. However in recent times, a company known as Kenset has come to claim ownership of the land, which they say they acquired from National Assurance and has been threatening to evict the squatters from the land. There are about 7600 squatters in Kwabulo.

The Committee was also informed that: -

- 2.1.5 The first settlers on the land were the indigenous coastal people who were mostly from the Mijikenda community. Later, a white settler by the name Dr. Bulo settled in the area with the indigenous people;
- 2.1.6 Later, Dr. Bulo gave the land to his grandson Andrew Bulo who later sold it to Mr. Suleiman Bin Ali a transporter in Bamburi;
- 2.1.7 In the 1980s, the land was sold to the Kenya National Assurances, there were 49 families existing on the piece of land then, who were mostly the indigenous Mijikenda people;
- 2.1.8 The indigenous people started looking for titles to the land around the year 2000;
- 2.1.9 Kenya National Assurance sold the land in 2006 to Kenset Holdings, who now claim ownership of the land. Kenset Holdings is claimed to have given a deposit of Kshs 40 Million to Kenya National Assurance to acquire the land;
- 2.1.10 The residents have been given eviction notices twice and are continuously been threatened with eviction;
- 2.1.11 Currently there are 10,000 residents in the area and apart from the eviction notices from Kenselt Holdings, other influential land owners, continuously threaten the residents with court orders;
- 2.1.12 Other Residents in Mwatamba Swamp, Mafisini Village, Majengo Mpya, Freetown and Gombe villages also continuously face eviction, from individuals who claim to own the land, despite the residents having settled on the land years ago. Gombe village for instance measures 5.32 acres and has 150 villagers. Arab settlers originally owned it. In 2005, the land was claimed by a Mr. Kimani Muthua who claims he bought for Kshs 1 Million;
- 2.1.13 The residents in Kwa Bulo are seeking the help of the committee, in having the land surveyed and sub-divided among them, as well as getting title deeds, to rid them off the constant harassment and threats of eviction;
- 2.1.14 The residents are further sought the intervention of the National Land Commission in repossessing the land and having the land surveyed and allocated to the residents.

Submissions from Residents In Maweni/Kisumu Ndogo (Kadzandani Ward) Nyali Constituency

Mr. Clement Wasike – Chairman Land Nyali Constituency and messrs: Mohammed Salim -Mnazi Moja Resident, Mr. Jimmy Dickson Gitau – Land Owner Maweni, Idi Hamis Mambo – Resident Kumbi Village, Rahel Wakio – Resident Kisumu Ndogo, Zahara Salim – Land owner Kisumu Ndogo, Alice Njoki- Resident Ziwa la Ng'ombe and Mama Dina Mwala – Resident Kisumu Ndogo made submissions before the committee. The Committee was informed as follows that: -

- 2.1.15 The land in Kisumu Ndogo Settlement is Government land and that there are 3 villages on the land that includes; Shauri Yako, Kisumu Ndogo and Nazi Moja. The squatters have been on the land for over 40 years and there are no public utilities on the land. Further, that some wealthy land owners claim ownership of the land and keep threatening the residents with eviction;
- 2.1.16 The land in Maweni is also Government Land;
- 2.1.17 The residents have been occupying the land for many years and started seeking ownership of the land some 20 years ago, whereby they have made visits to various government offices;
- 2.1.18 In 2005, a petition on the land taken to The Ministry of Land, which recommended that the land be surveyed and distributed to the residents;
- 2.1.19 In Idi Kumbi village Mr. Said Seif Bin Salim originally owned LR. No.623/1/MN measuring about 49.9 acres. There are 6,000 people in Idi Kumbi, with approximately 200 structures on the land. In 1979, the land was registered as trust land, and agents have been collecting land rates from the residents, but continuously inflate the rates;
- 2.1.20 The absentee landlord, claiming ownership of Idi Kumbi land resides in Oman;
- 2.1.21 People claiming to own the land and threatening them with eviction constantly harass the residents. The residents have therefore formed and registered a cooperative, with an aim of presenting them and their interest on Idi Kumbi land; Similarly in Ziwa Ngombe village, the residents have not been able to obtain Ownership of the land despite having lived on the land for years and going to several offices. There are about 120 families on the land;

2.2.9 Private land owners in Maweni have agreed to compensation from the government, so that the land can be re-distributed to the residents, who have already set out space for hospitals, school as well as other social amenities.

CONSIDERATION AND ADOPTION OF THE REPORT ON NYALI CONSTITUENCY LAND ISSUES

The Committee Considered and adopted the report after being proposed by the Hon. Eusilah Ngeny, M.P. and seconded by Hon. Francis Waweru Nderitu, M.P. as follows:

The Committee made the following observations:

General Observations

- 1. The residents have no title deeds to the land;
- 2. The residents are constantly facing eviction threats from Kenset Holdings who claim ownership of

- the land as well as other wealthy land owners in the area:
- 3. The land Kwa Bulo can be categorized as private land (lease hold);
- 4. There exists absentee Landlords;
- 5. There are suspicious/fictitious agents collecting rent for land owners who abandoned their land.

Observations made In Maweni/Kisumu Ndogo and Idi Kumbi Village;

- 1. The residents have no title deeds to the land:
- 2. The private land owners in the area are willing to accept compensation from the government, for their land to be surveyed and redistributed to the residents;
- 3. Residents have been subjected to paying rent to suspicious/fictitious land owners who abandoned their land.

Observations made In Kisumu Ndogo:

1. There exists absentee Landlords in the area.

The Committee made the following recommendations:

- 1. The National Government through the Ministry of Lands, Housing and Urban Development funds private land purchase to pave way for squatter settlement in Nyali;
- 2. The National Land Commission establishes the leases which have expired with a view to repossessing the land to pave way for squatter settlement;
- 3. The government through the Ministry of Lands, Housing and Urban Development should conduct an audit with a view of establishing the legal owners of the various parcels of Land in Nyali. If public, the land should be re-planned and allocated to the squatters and if private, compensate the private owners who are willing and resettle the squatters.
- 4. The National Land Commission and the County government of Mombasa should urgently review land ownership in the area to establish ownership. Land without ownership or with expired lease ought to revert back to the Government;
- 5. The National Land Commission should publish the renewed leases for the area in question for the last 2 years.

SUBMISSIONS FROM THE RESIDENTS OF MAWENI/KISUMU NDOGO KADZANDANI WARD)

Mr. Clement Wasike – Chairman Land Nyali Constituency and messrs: Mohammed Salim -Mnazi Moja Resident, Mr. Jimmy Dickson Gitau – Land Owner Maweni, Idi Hamis Mambo – Resident Kumbi Village, Rahel Wakio – Resident Kisumu Ndogo, Zahara Salim – Land owner Kisumu Ndogo, Alice Njoki- Resident Ziwa la Ng'ombe and Mama Dina Mwala – Resident Kisumu Ndogo made submissions before the committee. The Committee was informed that:-

- a. The land in Kisumu Ndogo Settlement is Government land and that there are 3 villages on the land that includes Shauri Yako, Kisumu Ndogo and Nazi Moja. The squatters have been on the land for over 40 years and there are no public utilities on the land. Further, that some wealthy land owners claim ownership of the land and keep threatening the residents with eviction;
- b. The land in Maweni is also Government Land;
- c. The residents have been occupying the land for many years and started seeking ownership of the land some 20 years ago, whereby they have made visited various government offices;
- In 2005, a petition on the land taken to The Ministry of Land, which recommended that the land be surveyed and distributed to the residents;
- e. Idi Kumbi village in the area is land with LR. No.623/1/MN measuring about 49.9 acres was originally owned by Said Seif Bin Salim. There are 6,000 people in Idi Kumbi, with approximately 200 structures on the land.
- f. In 1979, the land was registered as trust land, and agents have been collecting land rates from the residents, but continuously inflate the rates;
- g. The absentee landlord, claiming ownership of Idi Kumbi land resides in Oman;
- h. The residents are constantly harassed by people claiming to own the land and threatening them with eviction. The residents have therefore formed and registered a co-operative, with an aim of presenting them and their interest on Idi Kumbi land;
- Similarly in Ziwa Ngombe village, the residents have not been able to obtain Ownership of the land despite having lived on the land for years and going to several offices. There are about 120 families on the land;
- j. 2.2.9 Private land owners in Maweni have agreed to compensation from the government, so that the land can be re-distributed to the residents, who have already set out space for hospitals, school as well as other social amenities.

The Committee was informed that In Nyali- Maweni, land was set aside for settlement scheme and was awaiting declaration to be established as a settlement scheme and that there were squatters residing on private land in the area.

MINUTE NO. DCK/LN/2014/235 SUBMISSIONS FROM THE RESIDENTS OF KWA BULO

Mr. Joseph Karisa- Chairman Mwatamba Swamp, Kenneth Baya-Chairman Land Freetown and Messrs.: Masika, Mama Mariam Bakari Jade-Resident Majengo Mapya, Omar Sore, Ali Abdalla bin Hemed-Resident Kwabulo, Jonah Ishmael Ambaka-Resident Gombe Village and Mati wa Matamazero-Resident Kwa Bulo made submissions before the committee.

The Committee was informed that:-

- Kwabulo Settlement land LR No is 379 measures 86 acres and was initially owned by Mzee Bin Ali on behalf of the Mazrui Family. He later lost the land to the government due to his failure in making income tax payment. The land was later transferred to Bulo and then reverted back to the government when Bulo could not pay the tax;
- ii. The government thereafter transferred the land to an Insurance Company-Kenya National Assurance. However in recent times, a company known as Kenset has come to claim ownership of the land, which they say they acquired from National Assurance and has been threatening to evict the squatters from the land. There are about 7600 squatters in Kwabulo.

The Committee was also informed that:-

- iii. The first settlers on the land were the indigenous coastal people who were mostly from the Mijikenda community. Later, a white settler by the name Dr. Bulo settled in the area with the indigenous people;
- iv. Later, Dr. Bulo gave the land to his grandson Andrew Bulo who later sold it to Mr. Suleiman Bin Ali a transporter in Bamburi;
- v. In the 1980s, the land was sold to the Kenya National Assuarance, there were 49 families existing on the piece of land then, who were mostly the indigenous Mijikenda people;
- vi. The indigenous people started looking for titles to the land around the year 2000;

- vii. Kenya National Assurance sold the land in 2006 to Kenset Holdings, who now claim ownership of the land. Kenset Holdings is claimed to have given a deposit of Kshs 40 Million to Kenya National Assurance to acquire the land;
- viii. the residents have been given eviction notices twice and are continuously been threatened with eviction:
- ix. Currently there are 10,000 residents in the area and apart from the eviction notices from Kenset Holdings, other influential land owners, continuously threaten the residents with court orders;
- x. Other Residents in Mwatamba Swamp, Mafisini Village, Majengo Mpya, Freetown and Gombe villages also continuously face eviction, from individuals who claim to own the land, despite the residents having settled on the land years ago. Gombe village for instance measures 5.32 acres and has 150 villagers. It was originally owned by Arab settlers. In 2005, the land was claimed by a Mr. Kimani Muthua who claims he bought for Kshs 1 Million;
- xi. The residents in Kwa Bulo are seeking the help of the committee, in having the land surveyed and sub-divided among them, as well as getting title deeds, to rid them off the constant harassment and threats of eviction;
- xii. The residents are further sought the intervention of the National Land Commission in repossessing the land and having the land surveyed and allocated to the residents.



We're Muungano wa wanavijiji Mnazi Mmoja Village, being in community advocacy and development bring into your attention our long struggle for security of land tenure. We settled in Mnazi Mmoja since 1930s. Task force of 2007 proposed we be settled in the pieces of land but we do not know the impediments that have stalled the process since then, hence petition the national assembly (Parliament) to investigate so that obstacles can be removed to enable squatters to be settled in Gov't Land they are in.

Mnazi mmoja is found in Nyali settlement scheme along with Kisumu Ndogo and Shauri yako. The area is measuring 10.2 acres according to the report of mapping and enumeration done by Pamoja Trust and Residents; more that 940 structures, 2584 households and a total population of more than 12,000 people. Area MP Hon. Awiti Bolo is pushing but we add our voice to speed up the investigation and the report made public.

According to attached letter date 27th May,2004 Ref. prov.LA/259Vol 1/12, the district land settlement officer approved establishment of schemes in Kisauni Division whereby Nyali settlement was one of them. In regard with the proclamation(Copy attached), by ministry of land on December, 8th 2006, the Gov't of Kenya decided to settle squatters and landless in Coast Province on lands they have occupied for over 12 years and further decided to ensure that tenants will have – clear land rights. As per the Kenya constitution, Article 1(1) and (2), Article 35 (a), Article 37, Article 39 (2) and (3), Article 43 (b), (d) and (e), Article 47, Article 48 and Article 70 (1), So therefore to accelerate sustainable development in the area we forward our petition

as law abiding citizens. We are entitled right administrative to actions that are expeditious. Attached are copies of correspondence with government offices and reports that have not been implemented to benefit settle squatters as the government had suggested in 2006 Dec 8th. Enclosed are copies also of court cases on some plot numbers 1447, 1448, 1449 and 1450 of 1/Mainland North Mombasa. Note the court sought local elders to settle the matter but their resolutions cannot be traced in court files. Therefore since grabbers are threatening to evict residents, we hope you will consider our case and come to our rescue as squatters of Mombasa County to end our nightmare.

ELECTIVE POLICY

Know ye all that the Government of Kenya has decided to settle squatters and the landless on land they have occupied uninterruptedly for over 12 years or land whose owners are absented landlords in the Coast Province. The Government has further decided to ensure that tenants-at-will in the aforesaid Province have clear land rights. The Government has therefore constituted an inter-Ministerial Task Force to look into the issues regarding absentee landlords, tenants-at-will and the squatter problem within the Ten Mile Coastal Strip with a view to legally resettling squatters and the landless thereon. The parcel of Land commonly referred to as the Ten Mile Coastal Strip is as described in section 2 of the Land Titles Act (Cap.282) of the Laws of Kenya, to wit:

- 1. The former District of Malindi
- 2. Mombasa Island
- 3. Tana River District
- 4. The area within the Coast Province the boundaries whereof commencing at Mackenzie Point opposite Mombasa Fort, run thence in a northerly and then a northy-westerly direction along the coast of the mainland bordering port Tudor and up to what is known as the Jomvu Creek and along the course of the Kombeni-River as far as the limits of the ten-mile zone; thence whom the southern boundary of Macketine Block No.1 to the coast and southwards along the coast to Macketine Point the point of commencement.
- 5. The sea of land within the Coast Province the boundaries whereof, commencing at the point where the Umba river crosses the Tanzania boundary, ran thence in a straight line to Mazeras station, thence to a point at which the Kombeni River cuts the ten mile zone, thence following the southern boundary of the area defined in paragraph 4 above to Mackenzie point, thence in a straight line to Ras Mwaka Senge, thence following the coast line of the mainland south to Tanzania, thence in a westerly direction along the Tanzania boundary to the point of commencement.
- 6. The Island of Lamu.
- The Lamu Archipelago outside Lamu Island and to the remainder of the former Lamu District lying north of the boundary of Witu.
- 8 Witu.
