### **EXECUTIVE SUMMARY**

The Urban Areas and Cities (Amendment) Bill, 2017 (Senate Bills No. 4 of 2017) was read a First Time on 7<sup>th</sup> November, 2017.

Following the First Reading of the Bills, it stood committed to the Committee on Devolution and Intergovernmental Relations (in accordance with Standing Order 134) for facilitation of public participation and consideration. Consequently, the Committee, pursuant to Article 118 of the Constitution and Standing Order 134 (5), invited submissions from members of the public on the Bill via an advertisement on the Daily Nation Newspaper on Tuesday, 27<sup>th</sup> February, 2018. The Committee received both oral and written submissions on the Bill during its meetings with the members of public held on 28<sup>th</sup> February, 2018 in the Commission Board Room, First Floor, County Hall, Parliament Buildings, on 6th March 2018 in Committee Room 10, Parliament Buildings and on 8<sup>th</sup> March, 2018 in Committee Room 9, Parliament Buildings.

### **CHAPTER ONE**

### 1. INTRODUCTION

### 1.1. The Urban Areas and Cities (Amendment) Bill, 2017

The Urban Areas and Cities (Amendment) Bill, 2017 is sponsored by Sen. Kipchumba Murkomen, MP (Leader of the Majority Party in the Senate). The Bill proposes to amend the Urban Areas and Cities Act 2011, in order to review the criteria provided for classifying an area as a city, municipality, town or market centre.

The Fourth Schedule to the Constitution distributes functions as between the National and the County Governments. The task of urban planning and development is one that is shared between the national and the county governments. Paragraph 21 of Part I of the Fourth Schedule to the Constitution, tasks the national government with the function of general principles of land planning and the co-ordination of planning by the counties. Paragraph 8 of the Part II of the Fourth Schedule to the Constitution designates county planning and development as one of the functional areas of county governments. The Constitution sets out county planning and development to include- statistics, land survey and mapping, boundaries and fencing, housing, electricity and gas reticulation and energy regulation.

### OVERVIEW OF THE BILL

### 1.2. The Urban Areas and Cities (Amendment) Bill, 2017

Clause 2 of the Bill redefines city county and urban areas. Further, the definitions of neighbourhood association and resident population have been included.

Clause 4 provides that the Cabinet Secretary or the relevant county government through the Cabinet Secretary may initiate the delineation of the boundaries of urban areas or cities. Upon receipt of the request for delineation by a county government, the Cabinet Secretary may form an ad hoc committee to undertake the delineation.

In the event that the boundaries of an urban area extend in more than one county, the Bill provides that the membership of the ad hoc committee shall include representatives of the relevant counties and the proposal for delineation of the boundaries shall be handled by the Council of Governors.

Clause 5 of the Bill seeks to review the criteria for classifying an area as city to provide that the population need not be the population arising from the census. It also seeks to delete the following criteria provided in the Act for an area to become a city —

- (a) Infrastructural facilities, including but not limited to roads, street lighting, markets and fire stations and an adequate capacity for disaster management; and
- (b) A capacity for functional and effective waste disposal.

Clause 6(3) of the Bill seeks to review the criteria a for classifying an area as municipality and provide that, to be classified as a municipality, an urban area must satisfy the following criteria —

- (a) Have a resident population of at least fifty thousand residents;
- (b) Have an integrated urban area development plan in accordance with this Act and other existing laws;
- (c) Have the capacity to effectively and efficiently deliver its services to its residents and have in existence, the services provided in the First Schedule; and
- (d) Have demonstrable good system and records of prudent management.

Clause 8 of the Bill introduces a new provision for grant of an area as a market centre. The Bill provides that the County Governor may with the approval of the County Assembly confer the status of a market centre on an area that meets the required criteria. A market area which shall be governed and managed by the county government must have a resident population of at least two thousand residents and an integrated urban area development plan.

The Bill is expected to streamline the process of urban areas and cities management. The amendments to the application processes for the various urban centres and the various offices involved in urban management are aimed at quality delivery of services and ensuring a greater enhancement of devolved services to the counties.

### CHAPTER TWO

### CHAPTER THREE

### 3.0 COMMITTEE RECOMMENDATIONS

The Committee upon deliberation recommends the following amendments-

I. COMMITTEE STAGE AMENDMENTS TO THE URBAN AREAS AND CITIES (AMENDMENT) BILL, 2017 (SENATE BILLS NO 4 OF 2017)

### **CLAUSE 4**

THAT clause 4 of the Bill be amended by –

- (a) inserting the following new subsection immediately after subsection 4A(4)
  - (5) The representative from the national government drawn from the Ministry for the time being responsible for urban development appointed under subsection (3)(b)(i) shall serve as the secretary to the *ad hoc* committee.
- (b) renumbering the existing subsection (5) as subsection (6);

### **CLAUSE 5**

THAT clause 5 of the Bill be amended in sub clause (1) by –

- (a) deleting paragraph (a); and
- (b) deleting paragraph (e).

### CLAUSE 6

THAT clause 6 of the Bill be amended by -

- (a) deleting clause 6;
- (b) inserting the following new subsection immediately after subsection (3) -
  - (4) Despite subsection (3), every the headquarters of a county government shall be conferred the status of a municipality, whether or not it meets the criteria for a classification as a municipality.

### **CLAUSE 8**

THAT clause 8 of the Bill be amended by inserting the following new section immediately after section 10A —

- 10B. (1) Delineation of the boundaries of a market may be initiated by a county governor.
- (2) The county governor shall, in considering it necessary, appoint by notice in the Kenya *Gazette* an *ad hoc* committee to delineate the boundaries of a market.

- (3) The *ad hoc* committee appointed by the county governor under subsection (2) shall comprise
  - (h) a representative of the Independent Electoral and Boundaries Commission based at the county office, who shall be the chairperson;
  - (i) two representatives from the county government drawn from
    - (i) the county department for the time being responsible for urban development who shall be the secretary;
    - (ii) the county department for the time being responsible for environment;
  - (j) a representative of the national government based at the county office;
  - (k) two representatives from the following Professional Associations in the county
    - (i) Institute of Surveyors of Kenya; and
    - (ii) Kenya Institute of Planners.
- (4) Each of the relevant Professional Associations shall nominate its representative referred to under subsection (3)(d) for appointment by the county governor.
- (5) Where the boundaries of a market extend in more than one county, the membership of the *ad hoc* committee shall include representatives of the relevant counties and the proposal for delineation of the boundaries shall be handled by the Council of Governors.

### **CLAUSE 12**

**THAT** clause 12 of the Bill be amended in sub clause (2) by deleting paragraph (b) and substituting therefor the following new paragraph -

(b) three members shall be appointed by the county governor, with the approval of the county assembly;
