We, the undersigned,

Citizens of the Republic of Kenya, and residents of Murang'a County;

DRAW the attention of the Senate to the following:

- 1. That, the insurance sector in Kenya is well regulated by the Insurance Regulatory Authority (IRA), and there are specialist Medical Insurance Providers (MIP) that act as brokers, who can source various health insurance coverage plans;
- 2. That, health insurance protects the insured from high costs arising out of an illness or an accident provided they are covered on a health policy from health insurance companies;
- 3. That, counties have been providing health insurance covers for the members of staff working with the county governments;
- 4. That, procurement processes on health insurance in counties have been riddled with corruption with highest bidders winning as opposed to the lowest bidders;
- 5. That, insurance companies have been conspiring with corrupt county officials to overcharge their bids for considerations of commissions;
- 6. That, counties are losing millions of shillings as a result of inflated bids where monies paid beyond market price is shared between corrupt county officials and companies;
- 7. That, we have made the best efforts to have these matters addressed by the relevant authorities all of which have failed to give a satisfactory response; and
- 8. That, none of these issues raised in this Petition is pending in any court of Law, Constitutional or any other legal body.

WHEREFORE, your humble petitioners pray that the Senate investigates this matter and makes appropriate recommendations thereon, among them -
