Chairperson's foreword

The petition by residents of Kibwezi East Constituency regarding the relocation of Kibwezi East Sub County Headquarters was tabled before the House pursuant to Standing Order No. 225 (2) (a) by Hon. Jessica Mbalu, MP on behalf of the Petitioners.

In considering the Petition, the Committee held meetings with the Cabinet Secretary, Ministry of Interior and Coordination of National Government and Hon. Jessica Mbalu, MP. The Committee also undertook a field visit to Kibwezi East Constituency and held meetings with the Petitioners, the Kibwezi Sub County Security Intelligence Committee the residents of Machinery town and Kambu town both in Kibwezi East Constituency. The meetings were aimed at responding to the issues raised in the Petition.

The Committee is thankful to the Office of the Speaker and the Clerk of the National Assembly for the logistical and technical support accorded to it during its Sittings. The Committee is also thankful to Hon. Jessica Mbalu, MP, Kibwezi Sub County Security Intelligence Committee and residents of Machinery and Kambu towns for the submissions they made.

On behalf of the Committee, and pursuant to Standing Order, 227 it is my pleasant duty to table in the House the Report of the Departmental Committee on Administration and National Security on its consideration of a petition by residents of Kibwezi East Constituency regarding the relocation of Kibwezi East Sub County Headquarters.

EXECUTIVE SUMMARY

The purpose of this report was to consider and respond to the prayers sought by residents of Kibwezi East Constituency regarding the relocation of Kibwezi East Sub County Headquarters. The Committee found out that the prayer sought by the petitioners was justifiable given the declared government policy to align constituency and sub county boundaries. However Kibwezi East Sub County as indicated in the petition does not exist. The current Sub County in the area is known as Kibwezi that serves the entire Kibwezi East Constituency and part of Kibwezi West Constituency that includes Kibwezi town, where the Deputy County Commissioner's office is located. Residents of Kibwezi East Constituency registered concern that the location of the sub county headquarters in Kibwezi town hindered provision of National government services particularly for residents in remote parts of Kibwezi East.

The Report concludes that the Ministry of Interior and Coordination of National Government should create a new Sub-County by subdividing the current Kibwezi Sub County into Kibwezi East and Kibwezi West Sub counties. Further the boundaries of the proposed Kibwezi East Sub County should correspond to those of Kibwezi East Constituency.

1.0 PREFACE

- 1.1 On Wednesday 22nd February, 2016, a Petition was tabled before the House pursuant to Article 119 (1) of the Constitution and Standing Order No. 225 (2) (a) by the Hon. Jessica Mbalu, MP on behalf of residents of Kibwezi East Constituency regarding the relocation of Kibwezi East Sub County Headquarters;
- 1.2 The House, pursuant to Standing Order 227, referred the Petition to the Departmental Committee on Administration and National Security to consider and respond to the petitioners by way of a report to be tabled in the House;
- 1.3 The Committee received the Petition on 22nd February, 2016 and set out terms for its consideration and to report to the House within 60 days as set out in Standing Order No 227(2);

2.0 MANDATE OF THE COMMITTEE

2.1 The Departmental Committee on Administration and National Security is established pursuant to the provisions of Standing Order No. 216 (1) and (5) with the following terms of mandate:-

- (i) make reports and recommendations to the House as often as possible, including recommendation of proposed legislation;
- (ii) to investigate, inquire into, and report on all matters relating to the mandate, management, activities, administration, operations and estimates of the assigned Ministries and departments;

2.5 Observations and recommendations

2.5.1 Committee Observations

The Committee made the following observations from evidence adduced in the meetings, that:-

1. Section 15 of the National Government Coordination Act, requires that Sub counties be headed by Deputy County Commissioners, who are to be based within respective sub counties for effective service delivery.
2. Kambu and Machinery towns within Kibwezi East Constituency have sufficient government buildings and adequate office space, vacant and available for use including CDF offices under construction in Kambu which would be used to host Kibwezi East Sub County headquarters. The towns are located near the busy Nairobi/ Mombasa highway.
3. Kibwezi East Sub County as indicated in the petition does not exist. The current Sub County is known as Kibwezi that serves the entire Kibwezi East Constituency and part of Kibwezi west that includes Kibwezi town where the Deputy County Commissioner office is located. However residents of Kibwezi East Constituency registered concern that the location of the sub county headquarters in Kibwezi town hindered provision of National Government services particularly for residents in parts of Kibwezi East Constituency.

2.5.2 Committee Recommendations

In response to the prayers by the petitioners, the Committee recommends that:-

1. The Ministry of Interior and Coordination of National Government should create a new Sub-County by subdividing the current Kibwezi Sub County into Kibwezi East and Kibwezi West Sub counties. Further the boundaries of the proposed Kibwezi East Sub County should correspond to those of Kibwezi East Constituency.
2. The Ministry of Interior and Coordination of National Government should fast track the rationalization of administrative units in the Country to align them with Constituency and Ward boundaries.

3. Once the Ministry of Interior and Coordination of National Government's alignment of electoral and administrative boundaries is finalized and gazetted, the local leaders and residents could agree on the location of headquarter of Kibwezi East Constituency.

3.0 INTRODUCTION

- 3.1 The petition by residents of Kibwezi East Constituency regarding the relocation of Kibwezi East Sub County headquarters was tabled in the House pursuant to Standing Order 225 (2) (a) by the Hon. Jessica Mbalu, MP on 22nd February, 2016.
- 3.2 Pursuant to the House rules, the Petition was referred to the Committee on 22nd February, 2016 for consideration and preparation of a report within 60 days. The Committee considered the Petition pursuant to the provisions of Standing Order 227.
- 3.3 The Petitioners wished to draw to the attention of the House to the following, that:-
- (i) Administrative units in particular the sub – counties are important in the delivery of various services required by residents, including issuance of National Identification Cards and offering security services;
 - (ii) Section 15 of the National Government Coordination Act, requires that Sub counties be headed by Deputy County Commissioners, who are to be based within the sub county for effective service delivery;
 - (iii) Currently the headquarters of Kibwezi East are located in the neighbouring Kibwezi West Constituency ;
 - (iv) Residents of Kibwezi East Sub county are disadvantaged since they have to travel long distances to access services at the sub county headquarters;
 - (v) Several consultative meeting between leaders and residents of Kibwezi East Constituency have resolved that Kambu town is the most ideal location to host the sub county headquarters;
 - (vi) Kambu town has sufficient government buildings and adequate office space ,vacant and available for use including CDF offices under construction which can be used to host sub County Administration offices and office government services;
 - (vii) The Petitioners had lodged several appeals with the Ministry of Interior and Coordination of National Government regarding the matter but their efforts to resolve the matter have been futile;
 - (viii) Multiple follow ups by the residents have not received any redress to date;
 - (ix) The matter presented in the petition is not pending before any tribunal or court of law.
- 3.4 The petitioners prayed that the National Assembly through the Departmental Committee on Administration and National Security:-

- (i) Recommends the relocation of the Kibwezi East Sub County Headquarters from the current location (Kibwezi West) to Kambu town; and
- (ii) Makes any other order or direction that it may deem fit in the circumstances of the case.

4.0 EVIDENCE

4.1 Evidence from Hon. Jessica Mbalu, MP on behalf of the Petitioners

The Committee held a meeting with Hon. Jessica Mbalu, MP on behalf of the Petitioners on Thursday 10th March 2016 in the Commonwealth Parliamentary Association Room, Parliament Buildings. During the meeting Hon. Jessica Mbalu, MP, who was accompanied by one of the petitioners Mr. Peter Mangala informed the Committee that Section 15 of the National Government Coordination Act, requires that Sub counties be headed by Deputy County Commissioners, who are to be based within a sub county for effective service delivery. Currently the headquarters of Kibwezi East are located in the neighbouring Kibwezi West Constituency thus adversely affecting service delivery as residents had to travel long distances to access National Government service at Kibwezi town. The issuance of National Identity cards had been particularly affected subsequently affecting the registration of voters as a National identity card was a requirement for one to register as a voter.

The Committee was further informed that consultative meetings between leaders and residents of Kibwezi East Constituency had resolved that Kambu town was the most ideal location to host the Kibwezi East sub county headquarters. Kambu town has sufficient government buildings and adequate office space, vacant and available for use including Constituency Development Fund (CDF) offices under construction which can be used to host sub County Administration offices and other government offices. The town is located along the busy Nairobi/ Mombasa highway and was the convergence point for the four wards within Kibwezi East Constituency.

The Hon. Jessica Mbalu, MP also informed the Committee that Kibwezi East Constituency had been gazetted as Constituency number 088 with a population of 132,196 and occupying an area of 1347.7 km as indicated in table 1. The Kibwezi East Constituency office and Makueni County Government had already opened up offices at Kambu town within Kibwezi East Constituency. Hence there was no plausible justification of the National Government not to follow suit.

The Committee observed that a number of Constituencies in the County experienced similar challenges and there was need for the Ministry of Interior to address the matter to ensure that delivery of National Government services was devolved to all administrative units.

4.2 Evidence from the Cabinet Secretary, Ministry of Interior and Coordination of National Government

The Committee held a meeting with the Cabinet Secretary for Interior and Coordination of National Government in the Committee Room 2nd Floor Continental House, Parliament Building on Tuesday 15th March 2016. During the meeting the Cabinet Secretary informed the Committee that Kibwezi East and Kibwezi West Sub Counties did not exist. He further stated that the boundary review process by the Independent Electoral and Boundaries Commission split the former Kibwezi Constituency into two, Kibwezi East and Kibwezi West. Kibwezi East Constituency was within Kibwezi Sub County. Kibwezi West Constituency on the other hand straddles across Makindu, Nzau and Kibwezi Sub Counties. The Headquarters of Kibwezi Sub County is Kibwezi Market which is shared by two Constituencies, Kibwezi East and Kibwezi West.

The Committee was further informed that residents of Kibwezi East Constituency had agitated for the Headquarters to be moved to Kambu Market but this had been opposed by the residents of Kibwezi Division. Further the National Government had made significant infrastructural developments, office constructions and fencing at the current headquarters at Kibwezi Market. The National Government was also in the process of aligning electoral and administrative boundaries and once this was done, the local leaders and residents could agree on the location of the headquarters.

The Committee observed that if indeed Kibwezi Market was located in Kibwezi West Constituency then the residents of Kibwezi East Sub County had been denied access to National Government services within their Constituency. The Cabinet Secretary requested for more time to investigate the matter and forward the findings to the Committee. The Committee recommended that if the Headquarters were to be moved to Kambu Town, the process should be gradual to allow for the development of necessary infrastructure.

4.3 Evidence from the Kibwezi Sub County Security Intelligence Committee

The Committee held a meeting with Kibwezi Sub County Security Intelligence Committee. During the meeting the Deputy County Commissioner, Mr. Michael Yator, informed the Committee that Kibwezi Sub County was created in 2007. In 2010, the IEBC recommended that the Kibwezi constituency be split into two Kibwezi East and Kibwezi West. It was further recommended that each constituency should also be a Sub-County. A meeting held on 20th August 2013 resolved that Kibwezi East and Kibwezi West Sub Counties be created. This resolution however was yet to be implemented by the Ministry of Interior and Coordination of National government.

The Deputy County Commissioner stated that the current Kibwezi Sub County headquarters is located in Kibwezi Market. There are six (6) wards in Kibwezi Sub County, four (4) located in the Kibwezi East Constituency and two (2) in the Kibwezi West Constituency. The divisional offices are at Kambu and Machinery town both in Kibwezi East Constituency.

From the evidence adduced the Committee established that administrative boundaries in Kibwezi Sub County are not aligned to the Constituency boundaries. The situation had caused challenges during recruitment into disciplined services and other government agencies, as some of recruiting officers used administrative boundaries while others used the Constituency boundaries to designate recruitment centres. Recruits from the two wards in Kibwezi west Constituency that are in Kibwezi Sub County are required to travel to Makindu town to participate in the recruitment exercises which inconveniences them.

The Committee further established that Kambu town was more centrally located to host the proposed Kibwezi East Sub County .It has enough land for construction of offices, with three quarters ($\frac{3}{4}$) acres having been set aside for National Administration Offices and a Police station.

The Security Committee proposed that a new Kibwezi East sub county be established. However the current Kibwezi Sub County should be retained but renamed Kibwezi West sub County to

serve residents of Kibwezi town because relocation of the sub county headquarters from Kibwezi town would deny residents of Kibwezi town access to national government service within reasonable proximity.

4.4. Evidence from the petitioners

The Petitioners, Mr. Peter Mangala, Mr. Nicholas Maithia, Mr. Sylvester Manthi, Ms. Dorothy Nthenya, and Mr. Michael Kioko, informed the Committee that their prayer for the relocation of Kibwezi East sub-county headquarters from Kibwezi town to Kambu town was informed by the following factors:-

- i. The four wards of Kibwezi East converge at Kambu town, which also hosts the Makueni County Government sub-county offices;
- ii. The town has offices for ten (10) developed and operational county departments;
- iii. The current administrative boundaries create a disadvantage to the residents of Kibwezi East constituency as there is confusion during the Government recruitment exercise of disciplined forces;
- iv. Independent Electoral and Boundaries Commission offices are located in Kambu town;
- v. Residents of Kibwezi East who reside in remote parts of the Constituency have to cover long distances to access national government offices; and
- vi. Government tenders are advertised at the Deputy County Commissioners offices at Kibwezi Market and residents from remote parts of Kibwezi East Constituency may not be aware of their existence.

4.5. Evidence by residents Machinery town

The Committee held a Public Baraza at Machinery town on Friday 20th May 2016. During the meeting area residents proposed that Machinery town be designated the Kibwezi East Sub County headquarters. They further, stated that they would donate five (5) acres of community land for the purpose. The Committee observed that the ongoing construction of the Standard Gauge Railway and the location of a station contributed to the revival the economic growth of the town.

4.6. Evidence by residents Kambu Town

The Committee held a Public Baraza at Kambu town on Friday 20th May 2016. During the meeting area residents indicated that a meeting held 20th August 2013 in the Assistant County Commissioner Mtito Andei's office, proposed an alignment of administrative boundaries to electoral boundaries with the proposed Mtito Andei district aligned to Kibwezi East Constituency with Kambu town as the headquarters. They justified the suitability of Kambu town

by stating that it was the second highest revenue collection market in Makeni County; has a partially complete police post; government offices, a health centre with mortuary facilities, ten (10) public primary schools; seven (7) private primary schools, county council structures at the bus park; two (2) acre council land; Ngwata Technical Training Institute; street lights; two nearby universities; two (2) tarmacked roads; six (6) secondary schools; and a railway station.

They further indicated that the boundaries of the four wards in Kibwezi East Constituency converge at Kambu Market. The Committee observed that the market was centrally located to host the proposed Kibwezi East Sub-county Headquarters.

5.0 COMMITTEE OBSERVATIONS


The Committee made the following observations from evidence adduced in the meetings, that:-

1. Kambu and Machinery towns within Kibwezi East Constituency have sufficient government buildings and adequate office space, vacant and available for use including CDF offices under construction in Kambu which would be used to host Kibwezi East Sub County headquarters. The towns are located near the busy Nairobi/ Mombasa highway.
2. Kibwezi East Sub County as indicated in the petition does not exist. The current Sub County is known as Kibwezi that serves the entire Kibwezi East Constituency and part of Kibwezi west that includes Kibwezi town where the Deputy County Commissioner office is located. However residents of Kibwezi East Constituency registered concern that the location of the sub county headquarters in Kibwezi town hindered provision of National Government services particularly for residents in parts of Kibwezi East Constituency.

6.0 COMMITTEE RECOMMENDATIONS

In response to the prayers by the petitioners, the Committee recommends that:-

1. The Ministry of interior and Coordination of National Government should create a new Sub-County by subdividing the current Kibwezi Sub county into Kibwezi East and Kibwezi West Sub counties. Further the boundaries of the proposed Kibwezi East Sub County should correspond to those of Kibwezi East Constituency.
2. The Ministry of Interior and Coordination of National Government should fast track the rationalization of administrative units in the Country to align them with Constituency and Ward boundaries.
3. Once the Ministry of Interior and Coordination of National Government's alignment of electoral and administrative boundaries is finalized and gazetted, the local leaders and residents could agree on the location of headquarter for Kibwezi East Constituency.

The Vice Chairperson called the meeting to order at ten o'clock. A prayer was said.

MIN.NO. 187/ANS/2016: CONFIRMATION OF MINUTES

Confirmation of the minutes was deferred to the next sitting.

MIN.NO.188/ANS/2016: CONSIDERATION OF THE PROPOSED NATIONAL AUTHORITY FOR THE CAMPAIGN AGAINST ALCOHOL AND DRUG ABUSE (AMENDMENT) BILL, 2016

The Committee was informed that the principal object of the Bill is to amend sections 6, 13 and the Schedule to the National Authority for the Campaign Against Alcohol and Drug Abuse Act No. 14 of 2012.

Section 6 of the Act provides for the composition of the Board of the Authority (NACADA). The amendment proposes to remove the following persons from the composition of the Board

- a) deletion of paragraph (b)-Principal Secretary in the Ministry of national security;
- b) deletion of paragraph (e)-Principal Secretary in the Ministry of Education;
- c) deletion of paragraph (f)-Principal Secretary in the Ministry of children and youth affairs;
- d) reducing the persons appointed by the Cabinet Secretary from among healthcare providers, researchers, policy, legal practitioners among others, from three persons to two persons;
- e) reducing the persons nominated by the joint forum of religious organizations from two to one; and
- f) deleting paragraph (k)-one person nominated by a most representative organization working with the youth.

The amendment further proposes to insert a new subsection immediately after subsection (3)

“(3A) Persons referred to under subsection 1(b), (c) and (l) shall be ex-officio members.”

The Committee was informed that the Board as currently constituted consists of fifteen members. The overall effect of the amendment is to reduce the membership of the Board from fifteen to nine members. The report of the Presidential Taskforce on Parastatal Reforms recommended that a Board should consist of between three and nine members, therefore the amendment intended to bring the composition of the NACADA Board in line with the recommendations of the Taskforce.

The amendment further proposes to the Principal Secretary in the Ministry responsible for national security, the Principal Secretary in the Ministry of finance and the Chief Executive

Officer as ex-officio members of the Board. This means that the three will be members of the Board by virtue of the office they hold and would have no voting rights in respect of the decisions of the Board.

Committee resolution

The Committee was in agreement with the proposed reduction of the Board members from fifteen to nine. However the proposal that the Principal Secretary in the Ministry responsible for national security, the Principal Secretary in the Ministry of finance and the Chief Executive Officer be ex-officio members of the Board was rejected as the three represented critical government departments and needed to have a voting role in the Board. The Committee recommended that the three be retained in the Board as full members.

Clause 3 amends section 13 of the Act in subsections (2) and (3), by deleting the word "Chief Executive Officer" and substituting therefore the words "Vice-Chairperson". The effect of this amendment is that the Chief Executive Officer would have no role in the authentication by signature of the common seal of the Authority. Instead the authentication will be done by the Chairperson and the Vice-Chairperson.

Committee resolution

The amendment seemed to be in conflict with section 10 of the Act which provides that the Chief Executive Officer shall among others be responsible for the day to day management of the affairs of the Authority and the general administration of the Authority. Common management practice also recognized that Chief Executive Officer was the custodian of the common seal of the authority of a public entity. If the amendment was allowed to proceed it would mean that the Chairperson would have a double role as the vice Chairperson was in essence a representative of the Chairperson. The Committee therefore recommended that the amendment is deleted.

Clause 4 amends the Schedule to the Act by—

- a) reducing the number of members required to convene a special meeting of the Board from five to three-paragraph 3(4); and
- b) reducing the quorum for the conduct of the business of the Board from half of the total number of members to three members-paragraph 3(6).

Committee resolution

The Committee observed that the amendment was in line with the amendment at clause 2 which reduces the composition of the Board. With a reduction of the total number of members of the Board, it would automatically follow that the quorum required for the conduct of the business of the Board would also reduce. However the Committee recommended that the quorum be five members instead of the proposed three members.

MIN.NO. 189/ANS/2016: DELIBERATION AND ADOPTION OF THE DRAFT REPORT ON THE CONSIDERATION OF A PETITION BY RESIDENTS OF KIBWEZI EAST CONSTITUENCY REGARDING THE RELOCATION OF KIBWEZI EAST SUB COUNTY HEADQUARTERS

The Committee after consideration of the draft report on a petition by residents of Kibwezi East Constituency regarding the relocation of Kibwezi East sub county headquarters and unanimously adopted.

Committee Observations

The Committee made the following observations

1. Section 15 of the National Government Coordination Act requires that sub counties be headed by Deputy County Commissioners, who are to be based within respective sub counties for effective service delivery;
2. Kambu and Machinery towns within Kibwezi East Constituency have sufficient government buildings and adequate office space, vacant and available for use including CDF offices under construction in Kambu which would be used to host Kibwezi East Sub county headquarters. The towns are located near the busy Nairobi/Mombasa highway; and
3. Kibwezi East Sub County as indicated in the petition does not exist. The current Sub County is known as Kibwezi that serves the entire Kibwezi East Constituency and part of Kibwezi West that includes Kibwezi town where the Deputy County Commissioner office is located. However, residents of Kibwezi East Constituency registered concern that the location of the Sub County headquarters in Kibwezi town hindered provision of National Government services particularly for residents in parts of Kibwezi East Constituency.

Committee Recommendations

The Committee recommends that

1. The Ministry of Interior and Coordination of National Government should create a new sub-county by sub-dividing the current Kibwezi East and Kibwezi West sub counties. Further the boundaries of the proposed Kibwezi East Sub County should correspond to those of Kibwezi East Constituency.
2. The Ministry of Interior and Coordination of National Government should fast track the rationalization of administrative units in the country to align them with constituency and ward boundaries.

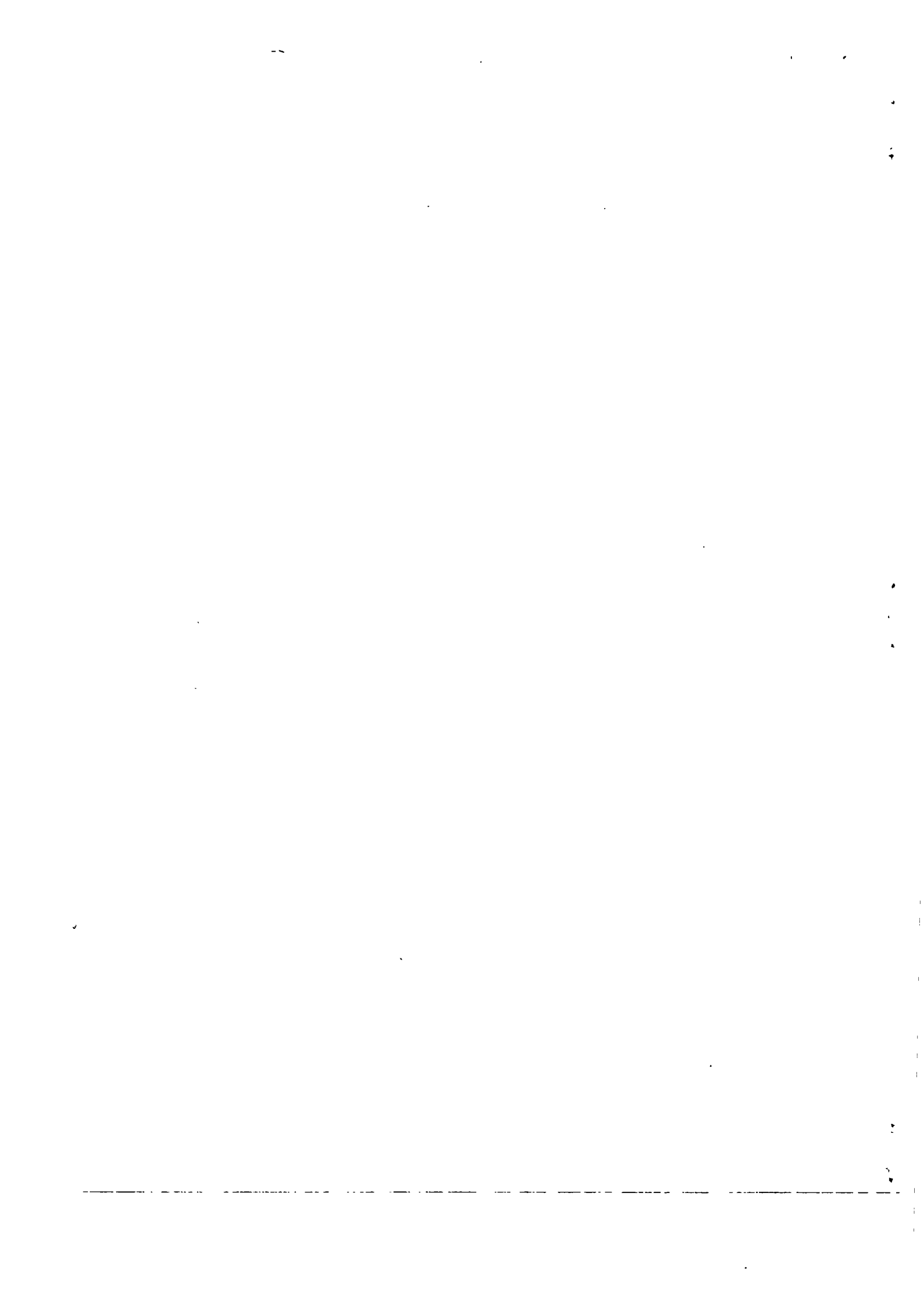

During the meeting the Committee observed that Kambu town within Kibwezi East Constituency had sufficient government buildings and adequate office space, vacant land and

available for use including CDF offices under construction in Kambu which would be used to host Kibwezi East Sub County headquarters. The town is located near the busy Nairobi/ Mombasa highway.

Committee further observed Kibwezi East Sub County as indicated in the petition does not exist. MIN.NO. 162/ANS/2016: SUBMISSION FROM THE SUB-COUNTY SECURITY INTELLIGENCE COMMITTEE, KIBWEZI COUNTY

The Deputy County Commissioner informed the Committee that Kibwezi Sub County was created in 2007. In 2010, the IEBC recommended that the Kibwezi constituency be split into two Kibwezi East and Kibwezi West. It was further recommended that each constituency should also be a Sub County. A meeting held on 20th August 2013 resolved that Kibwezi East and Kibwezi West Sub Counties be created. This resolution however was yet to be implemented by the Ministry of Interior and Coordination of National government.

The Deputy County Commissioner stated that the current Kibwezi Sub County headquarters is located in Kibwezi Market. There are six (6) wards in Kibwezi Sub County, four (4) located in the Kibwezi East Constituency and two (2) in the Kibwezi West Constituency. The divisional offices are at Kambu and Machinery town both in Kibwezi East Constituency.

The Security Committee proposed that a new Kibwezi East sub county be established. However the current Kibwezi Sub County should be retained but renamed Kibwezi West sub County to serve residents of Kibwezi town because relocation of the sub county headquarters from Kibwezi town would deny residents of Kibwezi town access to national government service within reasonable proximity.

From the evidence adduced the Committee established that administrative boundaries in Kibwezi Sub County are not aligned to the Constituency boundaries. The situation had caused challenges during recruitment into disciplined services and other government agencies, as some of recruiting officers used administrative boundaries while others used the Constituency boundaries to designate recruitment centres. Recruits from the two wards in Kibwezi west Constituency that are in Kibwezi Sub County are required to travel to Makindu town to participate in the recruitment exercises which inconveniences them.

The Committee further established that Kambu town was more centrally located to host the proposed Kibwezi East Sub County. It has enough land for construction of offices, with three quarters ($\frac{3}{4}$) acres having been set aside for National Administration Offices and a Police station.

Kambutown has set aside $\frac{3}{4}$ acres for construction of offices including the DO and police station. Machinery town has the same challenge of space to build government offices. However the issue of land can be resolved through purchase of the required land.

The Security Committee noted the need for a new Kibwezi East sub county be established. However the current Kibwezi Sub County should be retained but renamed Kibwezi West sub County to serve residents of Kibwezi town because relocation of the sub county headquarters from Kibwezi town would deny residents of Kibwezi town access to national government service within reasonable proximity.

- ii. The town has offices for ten developed and operational county departments;
- iii. The current administrative boundaries recreate a disadvantage to the residents of Kibwezi East constituency as there is confusion during the Government recruitment exercise of disciplined forces;
- iv. Independent Electoral and Boundaries Commission offices are located in Kambu town;
- v. Residents of Kibwezi East who reside in remote parts of the Constituency have to cover long distances to access national government offices for instance to acquire birth certificates as well as National Identifications;
- vi. The teachers promotions appear to be skewed towards residents of Kibwezi West constituency;
- vii. Government tender though advertised at the Deputy County Commissioners offices at Kibwezi Market, the residents from the furthest corners of Kibwezi East Constituency may not be aware of their existence.

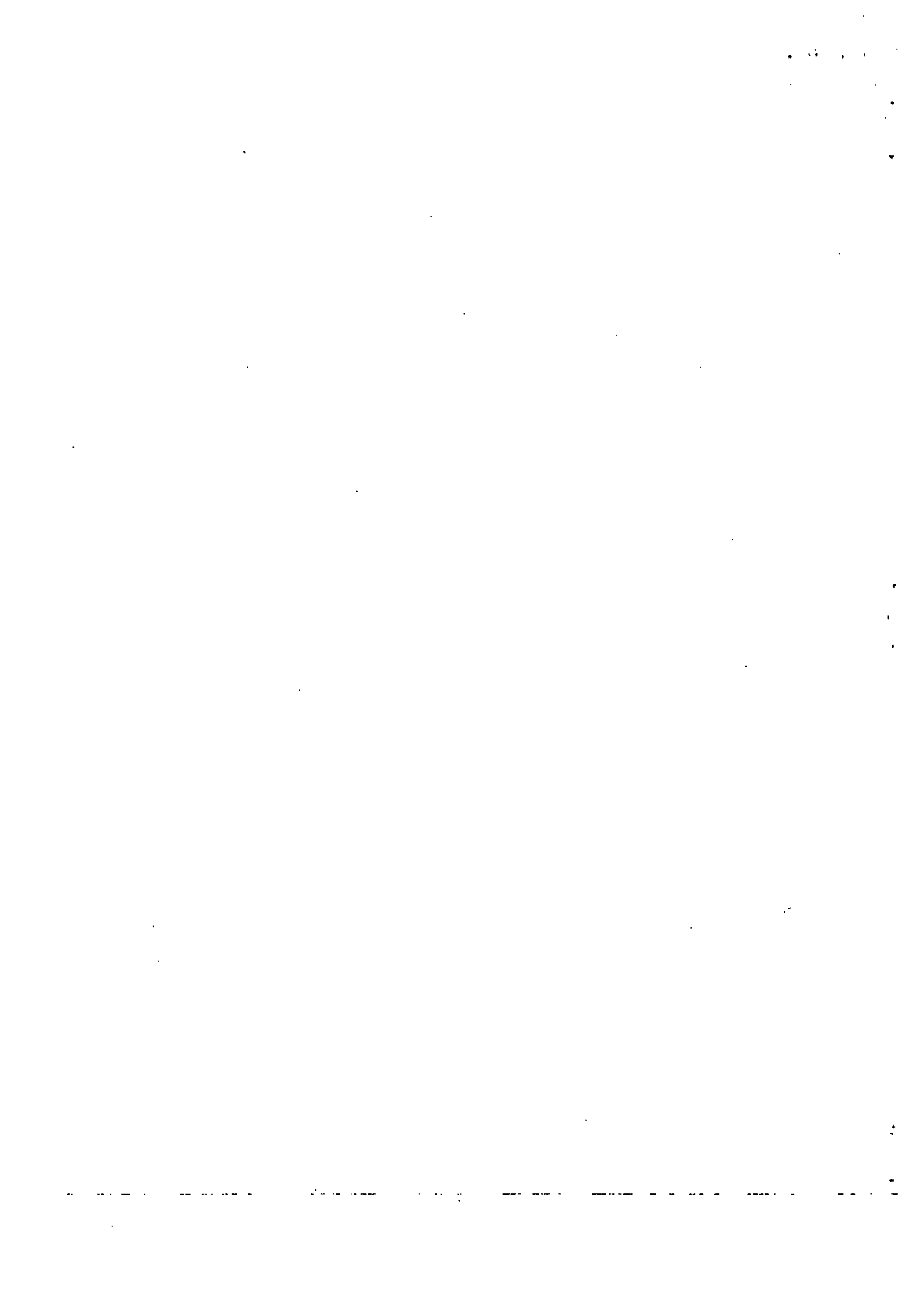

The Chairperson called the meeting to order at half past ten o'clock. A prayer was said.

MIN. NO.058 /ANS/2016: CONFIRMATION OF MINUTES

Minutes of the 1st Sitting were confirmed as a true record of the proceedings as proposed by the Hon. Zakayo K. Cheruiyot, MP and seconded by the Hon. Ahmed Abdikadir Ore, MP.

Minutes of the 2nd Sitting were confirmed as a true record of the proceedings as proposed by the Hon. Ahmed Abdikadir Ore, MP and seconded by the Hon. Akuja Protus Ewesit, MP.

Minutes of the 3rd Sitting were confirmed as a true record of the proceedings as proposed by the Hon. Zakayo K. Cheruiyot, MP and seconded by The Hon. Wanjiku Muhia, MP.

Minutes of the 5th Sitting were confirmed as a true record of the proceedings as proposed by the Hon. George Theuri, MP and seconded by the Hon. Zakayo K. Cheruiyot, MP.

MIN. NO.059 /ANS/2016: SUBMISSIONS BY THE CABINET SECRETARY ON PETITIONS

The Cabinet Secretary, Ministry of Interior and Coordination of National Government in response to petitions before the Committee, stated that:-

1. **Petition by residents of Dakabaricha Location regarding revocation of the appointment of Mr. David Mulato as the Chief of Dakabaricha Location, Saku Constituency.**

The Deputy County Commissioner, Marsabit Central Sub County chaired a panel that conducted interviews for the position of the Chief Dakabaricha Location on 26th January, 2015. The best four candidates, Mr. Omar Jillo Sage, Mr. David Mulato Ndonche, Ms. Amina Aila Ote and Mr. Yohana Hirbo Bage in that order, were all residents of the Dakabaricha Location and members of the Burji ethnic community.

Before the appointments could be finalized, the Hon. Col (Rtd) Dido Ali Rasso, MP allegedly objected to the appointment proposed Mr. Halkano Dambi for the position. However, Mr. Halkano Dambi was not among the candidates shortlisted for interview leading to appointment to the position.

Mr. Omar Jillo Sage who emerged as the best candidate during the interviews had worked as an assistant chief in Dakabaricha Sub County from 1997 to the present day. However, at one time during his employment he was suspended and charged in a court of law for the offence of incitement to violence. He was acquitted by the court and later reinstated to his current position of Assistant Chief.

In view of the past record of Mr. Omar Jillo Sage and considering the person proposed by the Hon. Col (Rtd) Dido Ali Rasso, MP had not been shortlisted for the interviews. Mr. David Mulato Ndonche, who was ranked second in the interviews, was appointed as the chief Dakabaricha Location on 20th April, 2015. Mr. David Mulato Ndonche attained C- (Minus in KCSE, though the minimum academic requirement as per the scheme of service is C+ (plus). However, the Public Service Commission granted a temporary waive on academic requirements to facilitate appointment of applicants who had a minimum of Kenya Certificate of Primary Education to the existing vacancies in the grade of Chief and Assistant Chief in Marsabit County.

The Cabinet Secretary further informed the Committee that the recruitment and selection process were well managed and appealed to the Committee to recommend that the Ministry upholds the appointment of Mr. David Mulato Ndonche to the position of Chief, Dakabaricha location. He further stated that the assertions made by Hon. Col (Rtd) Dido Ali Rasso, MP that the residents of Dakabaricha Location had serious reservations on the appointment were not accurate. Noting that the location was predominantly occupied by the Burji Community and Mr. David Mulato Ndonche is a member of the same community. He further stated that since the Chief started working in 20th July, 2016 no single incident of demonstration by locals over the appointment had been reported.

2. Kiseku Ward village managers regarding alleged compensation for services offered.

Cabinet Secretary informed the Committee that the Government was not aware of the position village managers. However, it was aware of the position of village elders. Though the Government recognized the crucial role that the village elders play, it does not facilitate them because;-

- The Ministry had no budgetary allocation for the payment of allowances;
- Most village elders were outside the employable age bracket approved by the government; and
- The size of the villages had not been standardized.

The Cabinet secretary requested Parliament to set up a fund to facilitate the operations of the village elders in recognition of the important role they play by providing an important link in the National Government service delivery.

The Committee observed that the ward administrators employed by the County governments were well remunerated and if the same was not availed to National Government administrators including the village elders the National Government risked losing this vital link in the provision of National Government services to the public. Further the village administrators were being utilized to mobilize the public and drive the agenda of the County Governments.

The Cabinet Secretary informed the Committee that the Ministry had introduced a scheme of service for the National Administration Administrators which would provide opportunities of promotion, particularly for the Chiefs and Assistant Chiefs. The Committee proposed that the facilitation of village elders to be included as a budgetary item in the Ministry's Budget for the 2016/17 Financial Year.

3. Petition by Hon. Muthomi Njuki, MP on behalf of the residents of Chuka IgambaNg'ombe Constituency on the delayed creation of a new administrative unit in Karingani location, Meru South Sub county

The Cabinet Secretary informed the Committee that the Ministry had received over 500 petitions for delineation of various administrative units across the country. The Ministry had commenced the process of rationalization and harmonization of all administrative units. The creation of administrative units would be based on recommendations from the exercise. The process would however depend, among other factors, on budgetary allocations to the Ministry.

The Hon. Muthomi Njuki, MP informed the Committee that with the development of Chuka University there was increased population growth in Karingani Location which required services yet the residents administratively report to a chief who was in a different ward. He further stated that Karingani Location has six sub locations. The Cabinet Secretary requested copies of the County Commissioners recommendations on the matter and which the Hon. Muthomi Njuki, MP agreed to provide.

The Hon. Muthomi Njuki, MP also stated that the recent public sacking of some Chiefs in Meru County had been perceived as humiliating by officers by residents. The Cabinet Secretary responded that the sacking of the Chiefs was done under his directive to serve as an example to other officers on the need to ensure the eradication of illicit brews.

4. **Petition by Hon. Jessica Mbalu, MP on behalf of residents of Kibwezi East Sub County on the relocation of the sub county's headquarters.**

The Cabinet Secretary informed the Committee that Kibwezi East and Kibwezi West Sub Counties do not exist. He further stated that the boundary review process by the Independent Electoral and Boundaries Commission split the former Kibwezi Constituency into two, Kibwezi East and Kibwezi West. Kibwezi East Constituency was within Kibwezi Sub County but Kibwezi West Constituency straddles across Makindu, Nzau and Kibwezi sub counties. The Headquarters of Kibwezi Sub County is Kibwezi Market which is shared by two Constituencies, Kibwezi East and Kibwezi West.

The Committee was further informed that residents of Kibwezi East Constituency had agitated for the Headquarters to be moved to Kambu Market but this had been opposed by the residents of Kibwezi Division. Further the National Government had made significant infrastructural developments, office constructions and fencing at the current headquarters at Kibwezi Market. The National Government was also in the process of aligning electoral and administrative boundaries and once this was done, the local leaders and residents could agree on the location of the headquarters.

The Committee observed that if indeed Kibwezi Market was located in Kibwezi West Constituency then the residents of Kibwezi East Sub County had been denied access to National Government services within their Constituency. The Cabinet Secretary requested for more time to investigate the matter and forward the findings to the Committee. The Committee recommended that if the Headquarters were to be moved to Kambu Town, the process should be gradual to allow for the development of necessary infrastructure.

MIN.NO.043/ANS/2016 - MEETING WITH HON. JESSICA MBALU MP ON APETITION BY RESIDENTS OF KIBWEZI EAST CONSTITUENCY REGARDING RELOCATION OF SUB-COUNTY HEADQUARTERS.

Hon. Jessica Mbalu, MP, accompanied by one of the petitioners, Mr. Peter Mangala, informed the Committee that the Section 15 of the National Government Coordination Act requires that Sub Counties be headed by Deputy County Commissioners, who are to be based within the sub county for effective service delivery. Currently the headquarters of Kibwezi East are located in the neighbouring Kibwezi West Constituency. Residents have to travel long distances to access National Government services in Kibwezi town. The issuance National Identity cards had been particularly affected. Subsequently affecting the registration of voters as a National identity card was a requirement for one to register as a voter.

The Committee was further informed that consultative meetings between leaders and residents of Kibwezi East Constituency had resolved that Kambu town was the most ideal location to host the Kibwezi East Sub County headquarters. Kambu town has sufficient government buildings and adequate office space, vacant and available for use including Constituency Development Fund offices under construction which can be used to host the Sub.County Administration offices and office government services. The town is located along the busy Nairobi/ Mombasa highway and is the convergence point for the four wards within the Kibwezi East Constituency.

The Committee also established that Kibwezi East Constituency had been gazetted as Constituency number 088. The Kibwezi East Constituency office and Makueni County Government had already opened up offices at Kambu town within Kibwezi East Constituency office. Hence there was no plausible justification of the National Government not to follow suit.

The petitioners drew the attention of House to the following:-

- (i) That, administration units in particular the sub-counties are important in the delivery of various services required by residents, including issuance of National Identification Cards and offering security services;
- (ii) That, Section 15 of the National Government Coordination Act, requires that sub-counties be headed by Deputy County Commissioners, who are to be based within the sub-county for effective service delivery;
- (iii) That, currently the headquarters of Kibwezi East sub-county is located in the neighboring Kibwezi West sub-county;
- (iv) That, residents of Kibwezi East sub-county are disadvantaged since they have to travel long distances to access services at the sub-county office;
- (v) That, several consultative meetings between leaders and residents of Kibwezi East Constituency have been held and resolved that Kambu Town is the most ideal location to host the sub-county headquarters;
- (vi) That, Kambu town has sufficient government buildings and adequate office space, vacant and available for use including CDF offices under construction which can be used to host sub-county administration offices and offer government services.

Committee observations

The Committee observed that a number of Sub Counties in the County experienced similar challenges and there was need for the Ministry of Interior and Coordination of National Government to address the matter to ensure that delivery of government services was devolved to all administrative units.





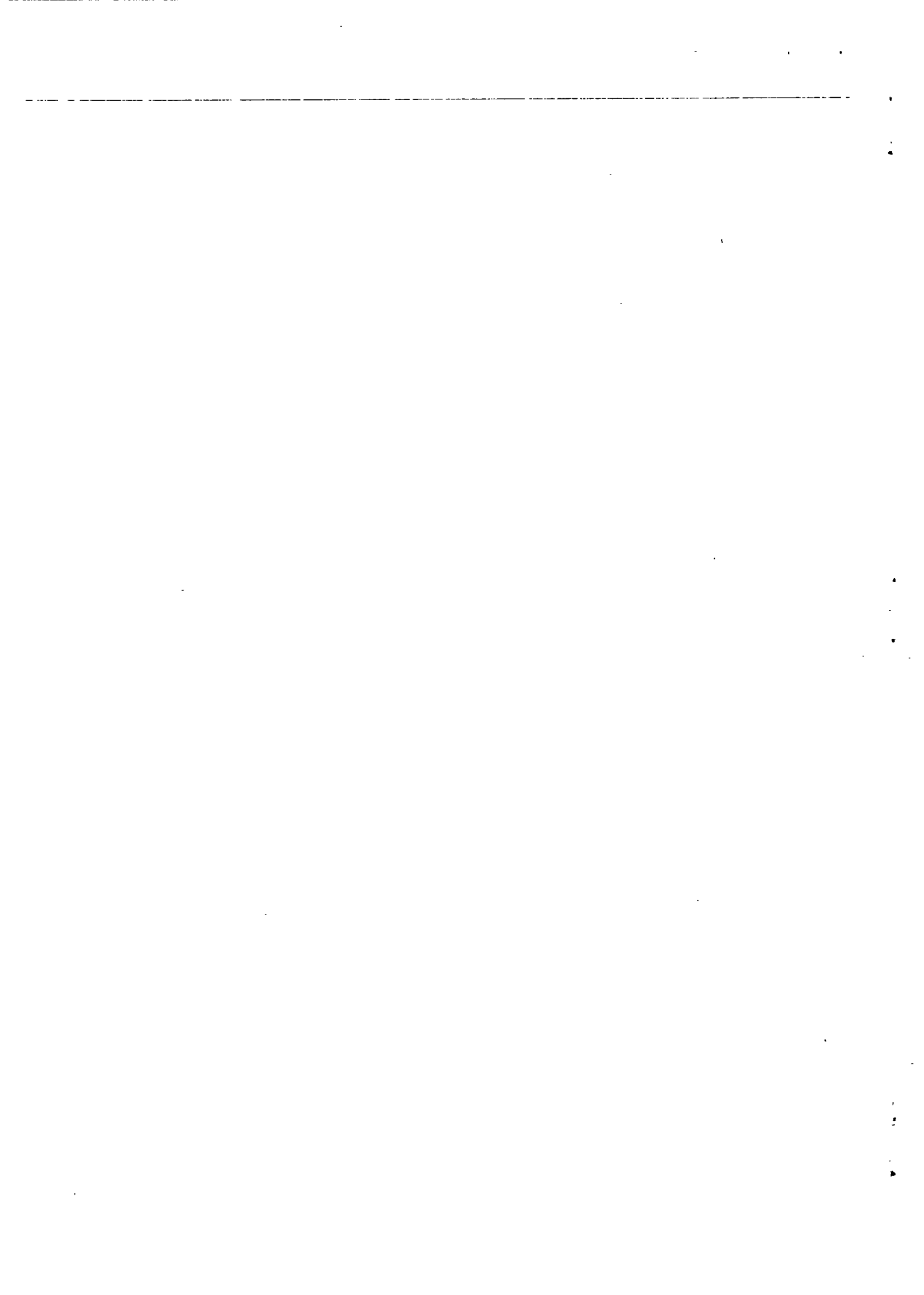

- iv. Mtito Andei

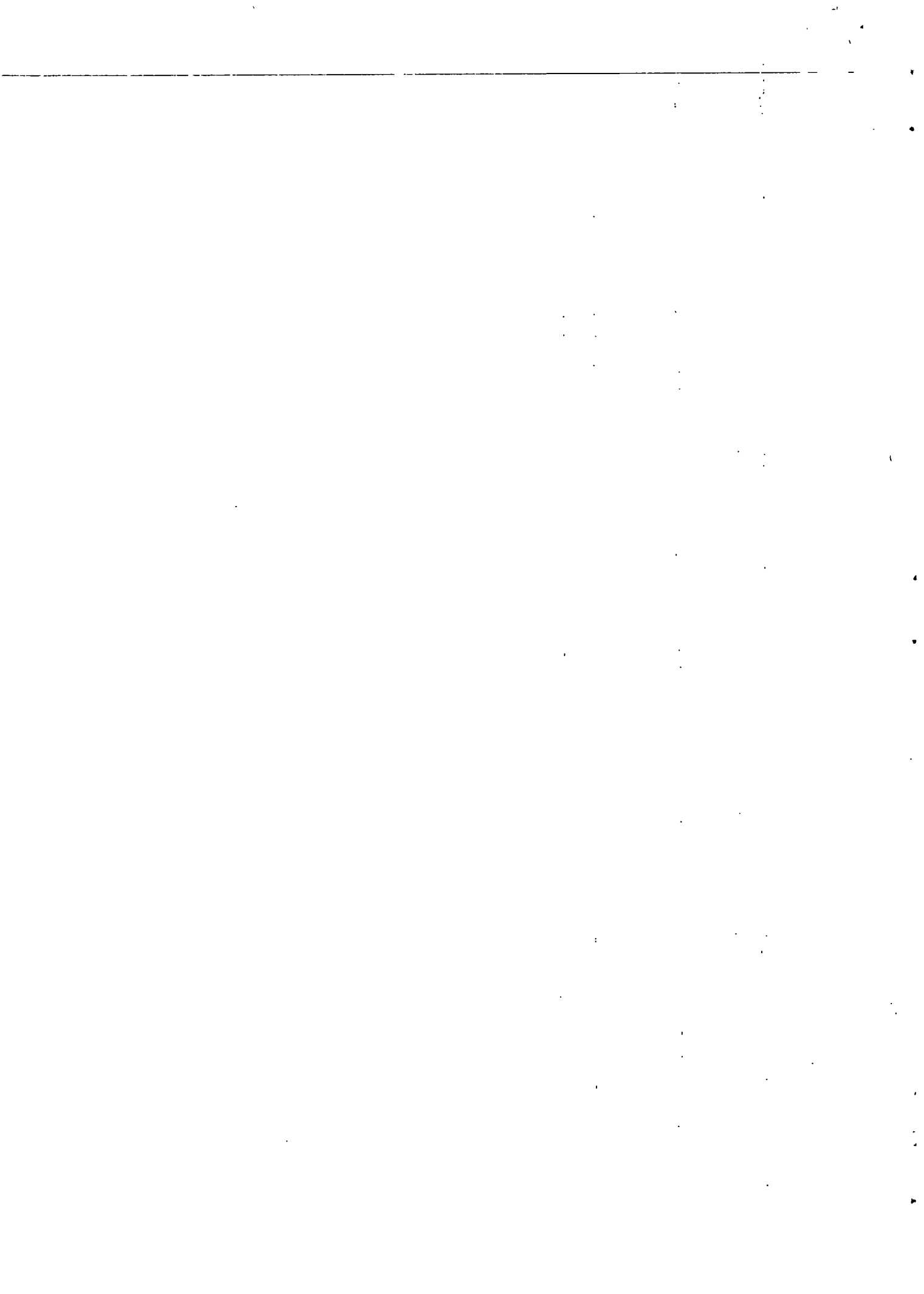

MIN 1 /DDC 1/2013: INTRODUCTORY REMARKS

The meeting started at 11.12Am with a word of prayer. On her address the chair welcomed the members to the meeting and urged members to contribute freely to the agenda of the day noting that the decisions made in the meeting will determine how the sub county will be administered. She also thanked the various locational development committees and the Sub-DDC's for their inputs to the realignment of the administrative units. She also said that Kibwezi district had six Ward where two lie in Kibwezi West Constituency and the rest in kibwezi East Constituency, hence there was need to realign the administrative units to electoral units as required by the National Government Coordination Act 2013. She noted that Districts/Sub-Counties should be aligned to constituencies while Administrative Divisions should be aligned to electoral Wards.

She read to the members, Article 89 of the Constitution of Kenya; the law that provides for delimitation of Constituency and Ward boundaries. The chair also brought to the attention of the members, Section 48 of the County Governments Act, 2012.

The MP thanked the members for availing themselves to discuss matters regarding development in the sub county. She said leaders should always take lead and have personal commitment in matters of development noting that teamwork is essential for the overall progress of the area. She also asked local leaders to support national government services and officers and avoid politicizing matters that need not be politicized that can affect development. She also asked members to make informed decisions on the deliberations of the meeting noting that decisions made in the meeting will remain for years to come. She also asked members to be sensitive to the voice of the community.

The MP also invited members to participate in the locational meetings that will be held to facilitate the development of project proposals to be funded under CDF in the financial year 2013/2014.

The speaker to the County assembly noted on the need to be mindful of the investments that had been made by the government in making decisions on the locations of the various administrative boundaries. He noted on the need to distribute administrative headquarters and sub county headquarters evenly in the various constituencies to ensure services are brought closer to the people and ensure balance in the operation of the two levels of government. He also noted that existing divisions will have to be realigned with wards and every Constituency to be a District/Sub-County.

The county executive on transport noted on the need to realign development of the national government and county government to ensure overall development. The county executive water & irrigation noted on the need to adopt a bottom up approach in deciding various development activities in the area. He also asked members to do realignment while putting into consideration the issues on security.

Members noted that Kibwezi East extends from Tsavo River to Mzima springs and there was therefore a need to create a new location named Ngulya to cover Tsavo west national park. They also noted that in 1975 the cess from the hotels in the Tsavo West national park was being levied and collected by then Eastern Province and there was thus the need for status quo to remain. Members also challenged the MP and other local leaders to follow up on the boundary dispute and ensure the boundary is officially gazetted as required. Members also noted that the county loses over 2billion per year from water that is pumped from Mzima springs and there was need for the issue to be handled correctly.

Members also recalled the contradicting views and disharmony after the creation of Makindu district & Kibwezi district and the location of the headquarters. It was also proposed that Kambu town should host the headquarter for the Sub-County Administrator whereas Machinery would house the headquarters for the administrative Kibwezi district. The selection of the location of the administrative units should be handled with care as it a premise to attract rows amongst the community members. It was agreed that there was need to have a more detailed consultative meeting of all opinion leaders in the Kibwezi east and west constituencies in order to agree on the location of the various administrative units. This was important in order to avoid the emerging misunderstandings between the residents of the constituencies.

Leaders from Kibwezi maintained that the headquarters should be at Kibwezi market since the government had invested over kshs 100million in infrastructure to house various departments. It was seen as wastage of resources to vacate all the offices that had been set up by the government. The members however agreed that the final location of the various administrative units be done after thorough consultations of all parties involved.

MIN 6 /DDC 1/2008: A. O.B

Members noted on the delays in the completion of the Umanyi Mtito Andei Pipeline thus forcing communities to either fetch water for long distances or purchase water at very exorbitant prices in some areas a 20litre water container being retailed at Kshs 40 which is far beyond the reach of the people. It was also noted that some of the pipes installed might not be of the right quality which led to spillage during the trial pumping. Members also noted that the tanks that had already been constructed at Mtito had already cracked and thus useless. This amounts to wastage of resources. Members agreed that there was need for the responsible departments to follow-up on the issue and report in the next meeting.

The chair thanked the members for their contributions and asked all members to be devoted to the development of the sub county.

The meeting ended at 14.47 with a word of prayer.



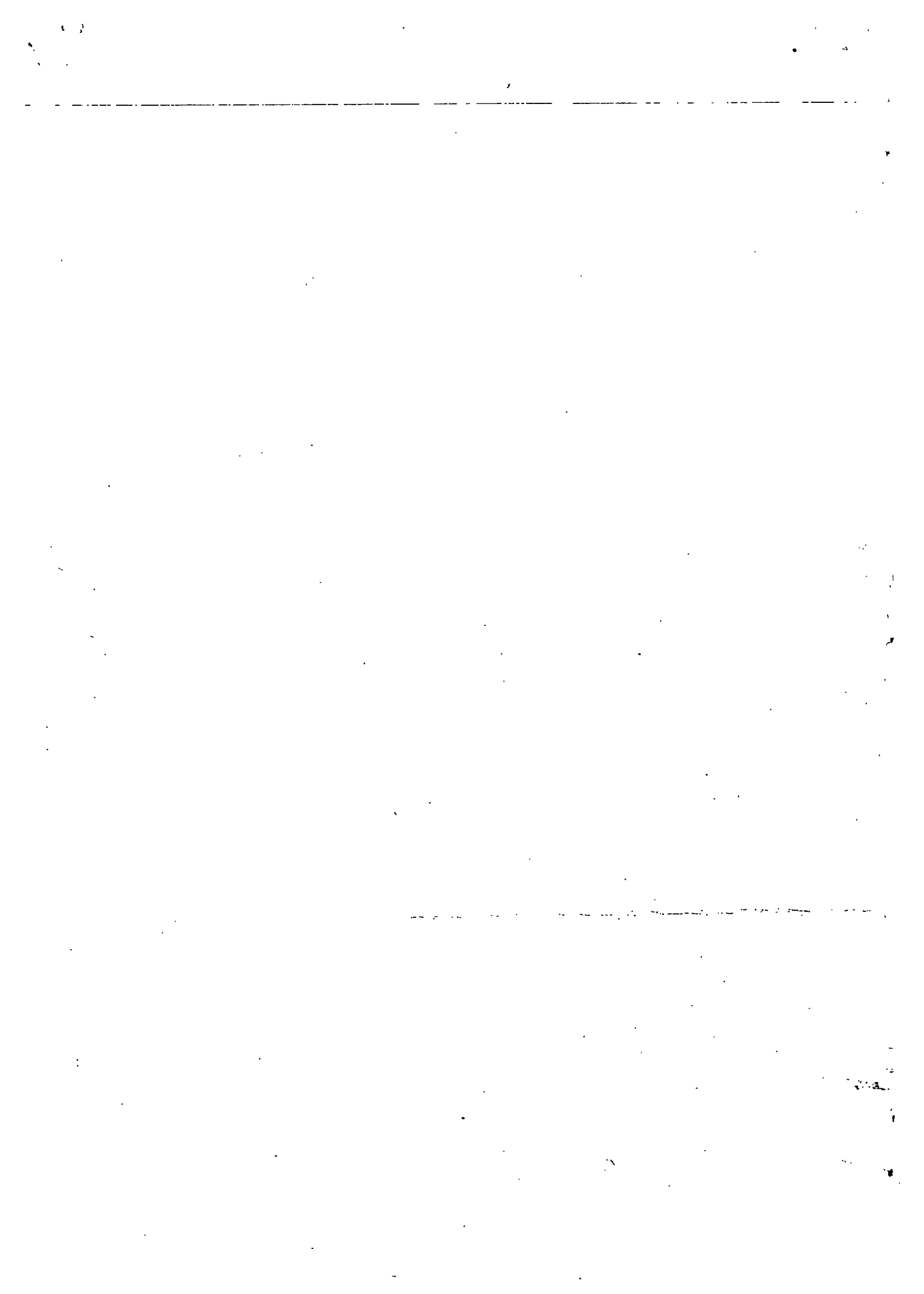
