PREFACE

Mandate and Functions of the Committee

Article 124 of the Constitution of Kenya, provides for the establishment of Committees by either House of Parliament. Committees are central to the workings, roles and functions of Parliament as set out in Article 94 and more specifically in Article 96 of the Constitution in regards to roles of the Senate.

Parliamentary committees consider policy issues, scrutinize the workings and expenditure of the national and county governments and examine proposals for legislation. The end results of these processes are reports tabled in the House for debate and adoption by plenary.

The Senate Standing Committee on Finance and Budget is established under section 8(1) of the Public Finance Management Act, 2012 and standing order 228(3) of the Standing Orders of the Senate and is mandated to -

- a) Investigate, inquire into and report on all matters relating to coordination, control and monitoring of the county budgets and to examine
 - *i)* the Budget Policy Statement presented to the Senate;
 - ii) report on the Budget allocated to Constitutional Commissions and independent offices;
 - iii) the Division of Revenue Bill, County Allocation of Revenue Bill, and cash disbursement schedule for county governments.
 - iv) to consider all matters related to resolutions and Bills for appropriations, share of national revenue amongst the counties and all matters concerning the National Budget, including public finance and monetary policies and public debt, planning and development policy; and
- b) Pursuant to Article 228 (6) of the Constitution, to examine the report of the Controller of Budget on the implementation of the budgets of county governments.

CHAIRPERSON'\$ FOREWORD

The County Governments Additional Allocations Cash Disbursement Schedule is submitted to the Senate by the National Treasury pursuant to Section 17 of the Public Financial Management Act, 2012. The purpose of the schedule is for ensuring predictable monthly transfers of funds to the respective County Revenue Fund.

The Schedule, therefore, serves as a guide and facilitates a predictable flow of funds to the county governments and thus enables counties to undertake critical functions in the delivery of services to the citizens.

The County Governments Additional Allocations Act, 2022 contains the approved additional allocations for each County as approved by Parliament and assented to on 12th December, 2022. Following this enactment, the National Treasury transmitted to the Senate the Cash Disbursement Schedule for the Financial Year 2022/23. This schedule was tabled in the Senate on 14th February, 2023.

The County Governments Additional Allocations Act as well as the disbursement Schedule has a total allocation of Kshs.163 million for the conditional grant on Supplement for the construction of county headquarters and Ksh.17.159 billion on conditional allocations financed from proceeds of loans and grants from development partners. These conditional allocations include-

- a) World Bank Credit for National Agricultural and Rural Inclusive Growth Project (NARIGP)
- b) World Bank Credit for National Agricultural Value Chain Development Project (NAVCDP)
- c) World Bank credit for Kenya Climate Smart Agriculture Project (KCSAP)
- d) World Bank credit for Water and Sanitation Development Project (WSDP).
- e) DANIDA grant for primary Healthcare in Devolved System Context (PHCDC).
- f) World Bank credit for Financing Locally-Led Climate Action, (FLLoCA) Level.
- g) Government of Sweden grant for Agriculture Sector Development Support Programme (ASDSP II).

- h) German Development Bank (KfW) to finance Drought Resilience Programme in Northern Kenya (DRPNK).
- i) World Bank credit for Emergency Locust Response Project (ELRP).
- j) World Bank credit to finance Kenya Informal Settlement Improvement Project (KISIP II).
- k) World Bank credit for Kenya Support programme (KUSP)

Upon tabling, the Cash Disbursement Schedule was committed to the Standing Committee on Finance and Budget for consideration and subsequent reporting back to the House.

The Committee considered the Cash Disbursement Schedule and observed that, cash disbursement will be made in two tranches. The first tranche will be transferred to counties by 15th March, 2023 while the second tranche will be disbursed by 15th April, 2023.

The Committee recommends that the County Governments Additional Allocation Cash Disbursement Schedule be approved as tabled in the Senate on 14th February, 2023.

Acknowledgements

The Committee acknowledges the National Treasury for their submissions of the County Governments' Additional Allocations Cash Disbursement Schedule which is a critical requirement in the execution of the county governments budget.

The Committee thanks the Offices of the Speaker and the Clerk of the Senate for the support extended to the Committee in the execution of its mandate.

I also wish to thank the Members of the Committee for their patience, sacrifice and commitment to completing the assigned task within the stipulated time.

1.0 Additional Allocations Cash Disbursement Schedule for Financial Year 2022/23

1.1 Overview

- 1. The County Governments Additional Allocations- Cash Disbursement Schedule was submitted to the Senate by the National Treasury pursuant to Section 17 of the Public Financial Management (PFM) Act, 2012. The Purpose of the schedule is to ensure a timely and predictable transfer of funds from the Consolidated Fund to the respective County Revenue Funds with regard to monies due to counties as per the County Governments Additional Allocation (No.2) Act, 2022 (CGAAA).
- 2. The CGAAA is an Act of Parliament that provides for the transfer of additional allocations from the National government's share of revenue as well as from external loans and grants from development partners to the county governments for the FY 2022/23.
- 3. Section 17 (6) and (7) of the Public Finance Management Act, 2012 authorizes the National Treasury to prepare Cash Disbursement Schedules for monies to be disbursed to county governments in consultation with the Intergovernmental Budget and Economic Council (IBEC); with the approval of the Senate and published in the Gazette.
- 4. In this regard, the National Treasury submitted the county governments' Additional Allocations- Cash Disbursement schedules for FY 2022/23, for approval by the Senate. The allocations in the schedules are in line with the allocations provided for in the County Government Additional Allocations Act, (CGAAA) 2022 as follows-
 - (i) **First Schedule** Disbursement of conditional allocations financed from the National Government share of revenue– KSh. **163 Million**
 - (ii) Second Schedule Disbursement of the Conditional Allocations financed by proceeds of loans and grants from the Development Partners KSh.17.16 Billion.
- 5. In addition, the County Governments Additional Allocations Cash Disbursement Schedule is a key Senate Resolution to operationalize the release and transfer of

approved allocations as per the annual County Governments Additional Allocation Act.

1.2 First Schedule on Additional Allocations Financed from the National Government share of the revenue for FY 2022/23

- 6. The First Schedule outlines the disbursement of the supplement funds for the construction of the County Government headquarters.
- 7. The following Four (4) counties will benefit from these funds- Isiolo, Lamu, Nyandarua, and Tana-River.
- 8. According to the disbursement schedule, the funds will be disbursed twice from the Consolidated Fund to the respective County Revenue Funds: on the 15th of March, 2023, and on the 15th of April 2023. This is based on the performance of revenue raised nationally. The National Treasury is the custodian and will be responsible for the transfer of these funds, as shown in Table 1.0



- 9. The Second schedule outlines the disbursement of conditional allocations from the development partners which is based on the financing agreements for each allocation.
- 10. The allocations will be disbursed in two phases, specifically, by 15th March 2023 and 15th April 2023.

2.0 Committee Observations

- 11. The Committee observed that
 - a) With only four months remaining to the end of the Financial Year, County Governments, through the County Assemblies, should move with speed to process Appropriation Acts, to facilitate access to the funds once disbursed.
 - b) The disbursement of conditional allocations financed from the National Government's share of revenue is subject to revenue performance. In the past, there have been delays in the release of funds to counties due to reportedly lower-than-expected revenue collection.
 - c) The National Treasury should comply with the schedule to ensure the timely disbursement of funds to the beneficiary counties without undue delay. Nonadherence will lead to unrealized benefits to the county residents, since intended programmes may stall, or lead to huge pending bills.
 - d) There is need for strengthened oversight both at national and county levels to ensure the purposes of such funds are achieved.

3.0 Committee Recommendations

- 12. The Committee recommends that
 - a) The Senate approves the County Governments Additional Allocations Cash Disbursement Schedule as tabled on 14th February 2023.
 - b) The county assemblies should expedite the processing of appropriation bills, to ensure the funds are accessed upon disbursement.
 - c) The National Treasury should adhere to the approved disbursement schedule to ensure timely implementation of the targeted projects/ programs.
