CHAIRPERSON'S FOREWORD

Pursuant to section 51(1) of the National Government Constituency Development Fund Act, 2015, the National Government Constituencies Development Board is obligated to submit a report to the National Assembly Committee detailing a summary of the project proposals received from the constituencies; indicating the approval status of such projects, summary of the status of disbursements of funds to the constituencies and the summary of the status of disbursements from the Treasury to the National Government Constituencies Development Fund Board account (NG-CDF).

In compliance with those provisions of the NG-CDF Act of 2015, the Board delivered the second Quarter Report on 6th January, 2022. Subsequently, the National Assembly Select Committee on National Government Constituency Development Fund held a meeting on 15th February, 2022 to deliberate on the Board's report.

During the meeting, members flagged out several issues that needed further explanation and clarification. These included, the arrears of four billion nine hundred seventy three million (Kshs.4.973 billion) owed to the fund by the National Treasury, delay in submission of project proposals, low rate of absorption by Constituencies occasioned by failure to submit project proposals within set timelines and failure by the National Treasury disburse the allocation of the financial year 2021/2022 to the NG-CDF Board on time.

Further, the Committee made the following recommendations that, the National Treasury should ensure the remaining twenty billion eight hundred and fifty-seven million (Kshs. 20.857 billion) for Financial Year 2021/2022 is released by February, 2022 to allow constituencies to implement and complete approved projects; the Cabinet Secretary for National Treasury and Planning should ensure the four billion nine hundred and seventy-three million (Ksh.4, 973 billion) unremitted by the Treasury owed to the National Government Constituencies Development Fund Board is provided for in the 2021/2022 Supplementary budget and the NG-CDF Board should Fast-track and approve the remaining project proposals for FY 2021/2022.

On behalf of the Committee, I take this opportunity to thank the offices of the Speaker and Clerk of the National Assembly for providing the required technical, financial, and logistical support that enabled the Committee to achieve its mandate. It is therefore my privilege to table before this House the report on report on projects proposals approvals, disbursements status and restrictions imposed on constituencies accounts for the first quarter of 2021/22 financial year.

CHAPTER ONE

1.0 PREFACE

1.1 Establishment and Mandate of the Committee

- a) To oversee the implementation of this Act and in this respect, shall after every two years submit a report to the National Assembly and where necessary, propose any amendments to this Act with respect to the quantum of funds repayable into the Fund in accordance with section 4 of the Act;
- b) To oversee the policy framework and legislative matters that may arise in relation to the Fund;
- c) To continually review the framework set out for the efficient delivery of development programmes financed through the Fund;
- d) To consider and report to the National Assembly, with recommendations, names of persons required to be approved by the National Assembly under this Act; and
- e) To carry out any other functions relevant to the work of the Fund.

2.0 INTRODUCTION

- Section 50 the National Government Constituencies Development Fund (NG-CDF) Act, 2015 as amended in 2016 establishes the National Assembly Select Committee (NASC) on the NG-CDF and its functions;
- 5. Section 51(1) of the Act stipulates that the Board shall, on a quarterly basis, submit a report to the National Assembly Select Committee detailing the following;
 - a) A summary of the project proposals received from the constituencies in the preceding quarter and indicating the approval status of such projects;
 - b) A summary of the status of disbursements of funds to the constituencies for that preceding quarter;
 - c) A summary of the status of disbursements from the Treasury to the National Account; and
 - d) Any restriction imposed on a constituency account in accordance with the Act.

Table 1.indicates a summary of disbursements to the constituencies in the financial year 2021/2022.As indicated, two hundred and seventy four constituencies received a total amount of Ksh.18.4 billion representing forty nine percent of the allocation. The remaining sixteen constituencies received a total of Ksh.0.8 billion meant for statutory items only which include emergency, bursary and administration. The board did not explain why the disparity in the disbursement of funds to the constituencies

CHAPTER FOUR

4.0 COMMITTEE OBSERVATIONS

The Committee made the following observations, that:

- The arrears of four billion nine hundred and seventy three million shillings (Ksh.4, 973, 000,000) owed to the Fund by the National Treasury is continuously causing a deficit in the Fund occasioning incomplete projects.
- 2) Continuous training or capacity building of Committee on Oversight in constituencies is critical since the implementation of the fund is also dependent on proper accountability of the Fund. And
- 3) The slow-release of funds by the National Treasury occasioned a delay in the implementation of projects.

CHAPTER FIVE

5.0 COMMITTEE RECOMMENDATIONS

The Committee recommends THAT;

- 1) The National Assembly allocates Ksh.4.973 billion in the supplementary estimates towards clearing of the arrears. And
- 2) The National Treasury releases all the monies due to the fund by 30th of April, 2022 to enable completion of projects.
