# **PREFACE**

# **Introductory remarks:**

**Mr. Speaker Sir,** the Departmental Committee on The Administration of Justice and Legal Affairs is established under Standing Order No.151. This Committee is charged with the mandate of Constitutional affairs and the administration of law and justice among others. Its factions as provided in Standing Order No.151 (4) are:

- (a) to investigate, inquire into, and report on all matters relating to the mandate, management, activities, administration, operations and estimates of the assigned Ministries and departments;
  - (b) to study the programme and policy objectives of the Ministries and departments and the effectiveness of the implementation;
  - (c) to study and review all legislation after First Reading, subject to the exemptions under Standing Order 101 A (4);
  - (d) To study, assess, and analyse the relative success of the Ministries and departments as measured by the results obtained as compared withy its objectives;
  - (e) to investigate and inquire into all matters relating to the assigned Ministries and departments as they may be deem necessary, and as may be referred to them by the House or a Minister; and
  - (f) to make reports and recommendations to the House as often as possible, including recommendations of proposed legislation.

# **Mandate of the Committee**

On April 23,2003, pursuant to the provisions of Section 6 (3) and (4) of the National Commission on Human Rights Act, 2003, the National Assembly caused the Departmental Committee on The Administration of Justice and Legal Affairs to consider applications for the positions of commissioners to the Kenya National Commission on Human Rights.

The mandate of the Committee as provided by the Act is as follows:

- (i) Consider all applications received as provided by Section 2 of the Act
- (ii) Recommend to the National Assembly twelve suitably qualified persons for nomination as Commissioners.

**Mr. Speaker Sir**, on behalf of the Members of the Departmental Committee on The Administration of Justice and Legal Affairs I wish to present to the House the Report of the Committee and the names of the twelve qualified persons for further consideration by the House.

# **Appointment of a Sub-Committee**

On receiving the applications, the Committee established a Sub-Committee consisting of the Hon. Mirugi Kariuki, M.P., the Hon.Amina Abdalla, M.P. and the Hon. Kenneth Marende, M.P.The mandate of the sub-committee was to scrutinize the applications and shortlist those who met the minimum qualifications as per the provisions of the Kenya National Commission on Human Rights Act, 2003.

# **Report Of The Sub-Committee**

**Mr. Speaker Sir**, the sub committee held three sittings during which it short-listed 126 applicants from a total of 844 applications. The Committee was unanimous on the Criteria and a system of scores which was established by the Sub-committee, where one point was accorded for any of the following:

- Academic qualifications and work experience relevant to the field of Human Rights.
- International and National advocacy in Human Rights matters.
- Trainers on human rights,
- Work with marginalized groups such as the physically challenged and pastoralists.
- Experience from working with HIV / AIDS
- Working with organizations dealing with distressed persons for example, battered women, torture victims, abused children e.t.c.

# **Report On The Interview Of The Candidates**

The Sub-Committee submitted its Report to the Committee short-listing 126 names. The Committee selected 32 names from this list and conducted interviews out of which the Committee selected 12 names to be recommended to the House. Three (3) applicants from each region were selected depending on the score awarded by the sub-Committee while six were selected from the special category. Special category i.e. gender, physically challenged and youth. The

Committee awarded scores to determine each interviewee's performance using the following criteria; presentation, human rights record, vision and knowledge on International Human Rights Instruments, with a maximum average of 20 points each.

# **Recommendation.**

The Committee recommends to the House the following 12 applicants to be considered by the House for onward transmission to H.E. the President who will appoint nine persons out of the twelve to serve as Commissioners. These are Messrs:

Mavisi Violet Khadi -WESTERN PROVINCE Philip Tirop Kitur -RIFT VALLEY PROVINCE Khelifa Khalifa -COAST PROVINCE Fatuma Ibrahim Ali -NORTH EASTERN PROVINCE -NAIROBI PROVINCE; Maina Kiai Maurice Odawo Onduru -NYANZA PROVINCE Wahu Kaara -CENTRAL PROVINCE; Godana Dovo Adhi -EASTERN PROVINCE; Catherine M. Muuma -SPECIAL (gender); Hassan Omar Hassan; -SPECIAL (youth) - SPECIAL (Disability) Lawrence M. Mute; and Wambui Kimathi. - SPECIAL (Gender)

**Mr. Speaker Sir,** the Committee further resolved to make special mention of Mr. Wallace Gichere whom it also interviewed.Mr. Gichere, a journalist of international repute and a human rights activist is now confined to a wheelchair as a result of severe injuries sustained when he was thrown from the window of his third floor flat and hit the ground with his head. He represents the face of torture. He sustained injuries on his head. The Committee was of the view that an appropriate placing by the commission at its secretariat would be most suitable in giving the commission a human face and as reminder of what this country must never again allow to happen.

# **Conclusion**

**Mr. Speaker Sir,** while deliberating on these nominations, the Committee was strictly guided by the provisions of the Act particularly Section 6 (8) which provides as follows: -

"In nominating or appointing persons as Commissioners, the National Assembly and the President shall have regard to: -

- (a) Kenya's ethnic, geographical, cultural, political, social and economic diversity;
- (b) The principle of gender equity.

**Mr. Speaker Sir,** the Committee further seeks the indulgence of the House to table its Report after the 30 days required by the Act. It is my pleasure to recommend the Report to the House for adoption.
