CHAIRPERSON'S FOREWORD

The Petition regarding negligence by the Kenya Wildlife Service (KWS) in Mtito Andei wildlife crisis was presented to the House the Hon. Speaker, on behalf of Mtito Andei Disaster Control Self-help Group on 30th June, 2021 pursuant to Standing Order 225(2)(b) of the National Assembly Standing Orders. The Petition was subsequently committed to the Departmental Committee on Environment and Natural Resources for consideration pursuant to Standing Order 227.

The Petitioners alleged that the farming activities had been affected due to crop and livestock destruction by the wildlife from the Tsavo East and Tsavo West National Parks. The residents' lives were also allegedly threatened by the wildlife as a result inflicted on them as they attempted to save their livestock from the marauding wildlife.

The Petitioners also alleged that KWS partners such as David Sheldrick Wildlife Trust, Richard Molla, Kravoss and Marcus Dunn, private conservators, were releasing wildlife into the residents' farms, consequently destroying crops and livestock. Further, there were allegations of harassment of residents by the KWS partners as they attempted to protect their property from destruction by the wildlife. The Petitioners, in addition noted that the Ministry of Tourism and Wildlife had not assisted in mitigating the human wildlife conflict, neither had it compensated the victims of the conflict.

The Petitioners had prayed that the Departmental Committee on Environment and Natural Resources, intervene to address the crisis by securing the erection of electric fence from Athi River to Mtito Andei Town, compel the KWS partners to undertake requisite corporate social responsibility through water provision in the surrounding village; securing the degazettement of the Ngai Ndethya Settlement Scheme, which is a gazetted game reserve in which people live, and securing the timely compensation of all the residents of Mtito Andei area affected by the Human Wildlife Conflict.

The Committee consequently got seized of the matters canvassed in the Petition and processed it, pursuant to Standing Order 227, through deliberative meetings with the Petitioners and the Ministry of Tourism and Wildlife with a view to responding to the prayers sought.

ISSUES FOR DETERMINATION

After an analysis of the oral and written submissions made, the Committee observed as follows:

- 1. The Mtito Andei area in Kibwezi East Constituency is under the greater Tsavo Conservancy ecosystem and has high incidences of Human-Wildlife Conflicts.
- 2. KWS had put in place a number of interventions to mitigate Human -Wildlife Conflicts in Kibwezi East Sub-County and specifically the Mtito Andei area. This included establishment of a fully-fledged Problem Animal Control (PAC) outpost at Ngiluni, ground and aerial drives of problem animals and enhancement of reporting mechanisms by the community for timely response.
- 4. On securing the erection of electric fence from Athi River to Mtito Andei Town, KWS was working with the County Government of Makueni and Conservation Partners

(Tsavo Trust) to undertake erection of a 30 km electric fence from Athi River to Mtito Andei to provide barrier between the community and wild animals especially Elephants from Tsavo East National Park. The County had provided for Kshs. 75,000,000.00 (Seventy-Five Million Shillings) to this project in the County approved budget estimates for the Financial Year 2021/22. Public and stakeholder consultation had been done and the Report on the Environmental Impact Assessment (EIA) of the fence project forwarded to NEMA for approval.

- 5. On Corporate Social Responsibility, Tsavo Trust in partnership with KWS has specifically undertaken upgrading of the Ngiluni Dispensary, established the Kamungi Conservancy in 2015 which created direct employment to 36 permanent staff and 15 casuals, trained and employed 12 Conservancy Scouts from Mtito Andei area, provided water projects and education projects amounting to Kshs. 159,978,000.00.
- 6. On the degazettement of the Ngai Ndethya Settlement Scheme, the Wildlife Conservation and Management Act, 2013 Section 37 provides for the process of variation of boundaries or revocation (de-gazettement) of a National Reserve. It was however observed that Ngai Ndethya Game Reserve is a designated protected area characterized by dryland biodiversity and provides ecosystem connectivity between Tsavo East National Park, Chyulu Hills, and Kibwezi Forest as the area remains an important wild life habitat that needs to be protected.
- 7. On timely compensation of all the residents of Mtito Andei area affected by the Human Wildlife Conflict, a total of 507 Human Wildlife Conflict Compensation Claims amounting to Kshs. 201,520,265.00 had been lodged by members of the community from Makueni County in the period 2014 2021. Out of this, 154 compensation claims had been approved and paid at a total cost of Kshs. 121,447,927.00 of which 65 claims amounting to Kshs. 44,805,820.00 emanated from Kibwezi East Sub County. Many of the lodged compensation claim cases are approved but the payments are pending release of funds by the National Treasury.
- 8. It was observed that in the month of June 2021, The National Treasury released funds totaling Kshs. 23,697,927.00 (twenty-three million six hundred ninety-seven thousand nine hundred twenty-seven shillings) on human injury, crop destruction and livestock predation that were paid within the month of July 2021 to claimants from Makueni County, out of which 33 residents of Kibwezi East sub county were paid a total of Kshs 8,427,090.00. However, the seemingly inordinate delays in compensation were as a result of inadequate funding from the National Treasury.
- 9. The area Member of Parliament, Hon. Jessica Mbalu, MP had Petitioned Parliament regarding Human Wildlife Conflicts in Kibwezi East Constituency. The Committee tabled its Report on this Petition in the House on 5th November, 2019.
- 10. Consequent to the foregoing submissions and observations, the Committee made the following recommendations:
- 11. On securing the erection of electric fence from Athi River to Mtito Andei Town; KWS jointly with the County Government of Makueni should expedite the erection of the 30

KM electric fence from Athi River to Mtito Andei Town which had already been allocated Kshs. 75 million by the County Government and other approval processes concluded.

- 12. On compelling the KWS partners to undertake requisite corporate social responsibility through among others, water provision to the surrounding villages; the KWS together with partners to continue with the corporate social responsibility activities in Mtito Andei area for a harmonious co-existence with the community.
- 13. On securing the degazettement of the Ngai Ndethya Settlement Scheme, which is a gazetted game reserve in which people live, it is observed that is a designated protected area characterized by dryland biodiversity and provides ecosystem connectivity between Tsavo East National Park, Chyulu Hills, and Kibwezi Forest as the area remains an important wild life habitat. Consequently, degazetting the area would negate the requirement of increasing the green spaces for wildlife and the conservation targets set by Convention on Biological Diversity (CBD), 1992 which Kenya is a signatory and will not be in compliance with section 37 (2) (a) of the Wildlife Conservation and Management Act 2013. Therefore, KWS should enhance human wildlife conflicts mitigation measures in the area for good co-existence.
- 14. On securing, through the Ministry of Tourism and Wildlife, timely compensation of all the residents of Mtito Andei area affected by the Human Wildlife Conflict, the Ministry of Tourism and Wildlife jointly with the National Treasury should fast track the human wildlife conflict compensation insurance scheme for efficiency in compensating the HWC victims.
- 15. The Ministry of Tourism and Wildlife to fast track implementing the recommendation of the Departmental Committee on Environment Report on the Petition Regarding Human Wildlife Conflict in Kibwezi East Constituency, which was tabled in the House on 5th November, 2019.

1.0 PREFACE

1.1 Committee Mandate

- 1. The Departmental Committee on Environment and Natural Resources is established under the National Assembly Standing Orders No. 216 (1). The functions and mandate of the Committee are also contained under the National Assembly Standing Orders, No. 216(5) as:

2.0 INTRODUCTION

- 6. The Petition regarding negligence by the Kenya Wildlife Service (KWS) in Mtito Andei wildlife crisis was presented to the House the Hon. Speaker, on behalf of Mtito Andei Disaster Control Self-help Group on 30th June, 2021 pursuant to Standing Order 225(2)(b) of the National Assembly Standing Orders. The Petition was subsequently committed to the Departmental Committee on Environment and Natural Resources for consideration pursuant to Standing Order 227.
- 7. The Petitioners alleged that the farming activities have been affected due to crop and livestock destruction by the wildlife from the Tsavo East and Tsavo West National Parks. The residents' lives were also allegedly threatened by the wildlife as a result inflicted on them as they attempted to save their livestock from the marauding wildlife.
- 8. - 11. compelling the KWS partners to undertake requisite corporate social responsibility through among others, water provision to the surrounding villages;
- 12. securing the degazettement of the Ngai Ndethya Settlement Scheme, which is a gazetted game reserve in which people live, and
- 13. securing, through the Ministry of Tourism and Wildlife, timely compensation of all the residents of Mtito Andei area affected by the Human Wildlife Conflict.
- 14. The Committee consequently got seized of the matters canvassed in the Petition and processed it, pursuant to Standing Order 227, through deliberative meetings with: the Petitioners and the Ministry of Tourism and Wildlife with a view to responding to the prayers sought.

3.0 SUBMISSIONS

11. The Committee consequently considered the matters raised in the Petition and processed it, pursuant to Standing Order 227, through deliberative meetings with: the Petitioners, the Ministry of Tourism and Wildlife to address the matters canvassed in the Petition with a view to responding to the prayers sought. The evidence adduced is recorded hereunder:

3.1 Submission by the Petitioners

- 12. Mr. Abednego Musyoki, on behalf of the Mtito Andei Community, appeared before the Committee virtually on 9th August, 2021 and briefed it that:
- 13. Mtito Andei community relied on livestock keeping and cultivation of short rain crops like maize, beans and sorghum.
- 14. Mtito Andei Division boarders the Tsavo National Park both to West and East. Every so often, animals ventured out the park causing human wildlife conflict that resulted in loss of life, injuries and property destruction.
- 15. The KWS was doing a commendable job, however, there was need to put in place extra measures to curb the human wildlife conflicts in the area.
- 16. The following were listed as KWS partners who aided the organization in wildlife conservation: David Shedrick, Richard Molla, Kravoss, Mary, and Marcus Dunn. The partners were located in Mtito Andei division, but never bothered to engage in establishing relations with the local community or any corporate social responsibility. They not only let wildlife to roam community living areas causing havoc but also translocated wildlife to the area without consulting the host community.
- 17. Losses encountered by the local community included: crops destruction by elephants, livestock attacks by hyenas, leopards, cheetahs, lions among others, serious injuries to community members, water tanks breakages due to animals seeking water.
- 18. There was delayed compensation for damage, injuries and deaths caused by the wildlife.
- 19. A permanent solution to the human wildlife conflict in the area would be erection of an electric fence in the area along Mtito Andei River to separate Ngai Ndethya Community residence from the Tsavo East National Park.
- 20. There was need to investigate the activities of KWS partners in the area who did not engage in any corporate social responsibility. They could be compelled to provide water for domestic use for residents since access to water in the area was a major challenge.
- 21. There was need to degazette the Ngai Ndethya Settlement Scheme. As much as it was alleged to be a game reserve, the local community was not involved and therefore did not recognize it as such.
- 22. The residents of Mtito Andei had elected an interim Committee that was tasked to follow up on issues of human wildlife conflict in the area. Consequently, the Committee leadership

- sent their Petition to the Clerk of the National Assembly vide a letter dated 26th March, 2021.
- 23. The Constituency and the County leadership through the Office of Kibwezi East Constituency and Makueni Senator's office, had engage the Ministry of Tourism and Wildlife on human wildlife conflict in the area.
- 24. The Ministry of Tourism and Wildlife through its letter Ref. SDW/8/15/2/VOL.VII dated 29th March, 2021 had responded to the leadership detailing the efforts by the Ministry in reducing human wildlife conflict in Mtito Andei. The Ministry had also shared details and the status of pending human wildlife conflict compensation cases with the leadership.

3.2 Submission by the Hon. Jessica Mbalu, CBS, MP, Kibwezi East Constituency

- 25. Hon. Jessica Mbalu, MP, Kibwezi East Constituency, appeared before the Committee virtually on 9th August, 2021 and briefed it that:
- 26. She had Petitioned the National Assembly in 2019 on Human Wildlife Conflicts in Kibwezi East Constituency, in which Mtito Andei lies. The Departmental Committee on Environment and Natural Resources addressed the Petition and recommended to the Ministry of Tourism and Wildlife to among others, that KWS in conjunction with the local leadership held the local community develop proposals for areas that required funding by the KWS Corporate Social Responsibility; the Ministry of Tourism and Wildlife to expedite the rehabilitation of the fence along the Tsavo West National Park bordering areas of Mtito Andei, Mangelete and Bondeni areas within the 2019/2020 financial year.
- 27. She had further followed up through the Committee the Status of implementation of the Committee's report on the Petition by Ministry of Tourism and Wildlife in which the Committee wrote to the Ministry vide its letter Ref: NA/DDC/ENR/2021(047) dated 3rd August, 2021. The Ministry had responded vide its letter Ref: SDW/1/47/1 dated 14th October, 2021 detailing the status of implementation of the Committee's recommendations on the Petition (annex 3).

3.3 Submissions by the Cabinet Secretary, Ministry of Tourism and Wildlife.

- 28. Mr. Joseph K. Boinnet, Chief Administrative Secretary, Ministry of Tourism and Wildlife appeared before the Committee on 19th August, 2021 and briefed it as follows:
- 29. Mtito Andei is in Kibwezi East Sub County of Makueni County and within the greater Tsavo Conservation Area.
- 30. Human -Wildlife Conflicts were a major threat to conservation over the years due to population growth, settlement on traditional wildlife dispersal areas or migratory routes and climatic variability with in the Country.
- 31. Mr. Abednego Musyoki on behalf of Mtito Andei Disaster Control Self-Help Group Petitioned the National Assembly to help in addressing the following:
 - a) the erection of an electric fence from Athi River to Mtito Andei town by the KWS and its partners;

- b) compelling the KWS partners to respect farm lands and undertake requisite Corporate Social Responsibility;
- c) fast tracking of compensation payments to the residents; and
- d) securing the degazettement of the Ngai Ndethya National Reserve.

32. On compensation for human-wildlife conflicts he stated that:

- a) The Wildlife Conservation and Management Act, 2013 provides for Compensation for human death, human injury, livestock predation, crop destruction and property damage cases caused by wildlife as captured in the third schedule of the Act.
- b)
- c) Section 25 of the Wildlife Conservation and Management Act, 2013 guides on the amounts, process and procedures for compensation on personal injury or death or damage to property or crops or predation caused by wildlife.
- d) The Ministry through KWS facilitates payment of compensation in strict compliance with set procedures and process. Compensation claims from Makueni County are usually deliberated upon by the County Wildlife Compensation Committee that recommends an award after which they are forwarded to the Ministry of Tourism and Wildlife for validation and payment thereof. All the Compensation claims lodged by the residents of Mtito Andei area were subjected through the same process and appropriate determination made.
- e) A total of 507 Human Wildlife Conflict Compensation Claims amounting to Ksh. 201,520,265.00 were lodged by members of the community from Makueni County in the period 2014 2021. Out of this, 154 compensation claims have been approved and paid at a total cost of Ksh. 121,447,927.00 of which 65 claims amounting to Ksh 44,805,820.00 emanate from Kibwezi East Sub County. Many of the lodged compensation claim cases are approved but the payments are pending release of funds by the National Treasury. A summary of compensation claims lodged within Makueni County as from year 2014 to year 2020 and their status has been attached as annex 4
- f) Within the month of June 2021, The National Treasury released funds totaling Ksh. 23,697,927.00 (twenty-three million six hundred ninety-seven thousand nine hundred twenty-seven shillings) on human injury, crop destruction and livestock predation that were paid within the month of July 2021 to claimants from Makueni County. 33 residents of Kibwezi East sub county were paid a total of Ksh 8,427,090.00.
- 33. On Transporting and release of Wildlife by Conservation Partners he stated that translocation of wildlife species is carried out for introduction and reintroduction of species into an area, supplementation, population control and resolution of Human-Wildlife Conflicts. KWS is the only organization mandated to undertake wildlife capture and translocation within the Country with approval of Board of Trustees and the Ministry. Translocation of wildlife species is managed through elaborate policy guidelines in respect of different wildlife species. Conservation partners such as David Sheldrick Wildlife Trust and Tsavo Trust operate under Memorandum of Understanding (MOU) with KWS. They have no mandate to introduce any wildlife with in the Tsavo Ecosystem or on adjacent community. On the contrary these partners have been very supportive to KWS in

mitigating Human- Wildlife Conflicts in the Mtito Andei area as they deploy their resources i.e., Helicopters and fixed wing aircraft to monitor and drive away straying wildlife like Elephants from the community farm lands thereby minimizing losses to the community.

- 34. On Corporate Social Responsibility he stated that:
 - a) KWS collaborates with the County Government of Makueni, National Government Agencies and Conservation Partners in the Tsavo Conservation Area to support the local communities in Kibwezi East with social projects.
 - b) A number of projects have been done through collaboration over time. Tsavo Trust in partnership with KWS has specifically undertaken upgrading of the Ngiluni Dispensary, Established the Kamungi Conservancy in 2015 which created direct employment to 36 Permanent staff and 15 Casuals, trained and employed 12 Conservancy Scouts from Mtito Andei area, provided water projects and education projects amounting to Ksh. 159,978,000.00. A copy of letter from Richard Moller the CEO of Tsavo Trust dated February 4, 2021 is attached as Annex 5).
 - c) On awareness creation and community sensitization, the KWS has been holding regular meetings with the community in collaboration with conservation partners such as the Zoological Society of London (ZSL), Tsavo Trust, and David Sheldrick Wildlife Trust (DSWT) where the communities are sensitized on Human- Elephant Conflict (HEC) and alternative livelihoods programs that are compatible with wildlife conservation like bee keeping.
- 35. On Human-Wildlife Conflict Mitigation, he stated that:
 - a) KWS had put in place a number of interventions to mitigate Human -Wildlife Conflicts in Kibwezi East Sub-County and specifically the Mtito Andei area. This includes establishment of a fully-fledged Problem Animal Control (PAC) outpost at Ngiluni, ground and aerial drives of problem animals and enhancement of reporting mechanisms by the community for timely response.
 - b) KWS was also working with the County Government of Makueni and Conservation Partners (Tsavo Trust) to undertake erection of a 30 km electric fence from Athi River to Mtito Andei to provide barrier between the community and wild animals especially Elephants from Tsavo East National Park. The County had provided for Kshs. 75,000,000.00 (Seventy-Five Million Shillings) to this project in the County approved budget estimates for the Financial Year 2021/22. Public and stakeholder consultation had been done and the Environ mental Impact Assessment (EIA) of the fence project forwarded to NEMA for approval.
- 36. On degazettement of Ngai Ndethya Game Reserve he stated that:
 - a) Ngai Ndethya Game Reserve (NNGR) was established vide gazette notice no. 9 of 1st January 1976 and boundary plan 216/32.

- b) The Reserve covers an approximate area of 21,200 Ha under the management of the Makueni County government. Following settlements in the game reserve, there had been attempts to have the Game Reserve degazetted since 1992.
- c) Ngai Ndethya Game Reserve is heavily settled by the local community with well-established public amenities including Schools, Markets, Health Centres and connected with all-weather road networks. Parts of the Game Reserve remained unsettled with pristine vegetation that supports biodiversity conservation.
- d) The community, through the Petition was seeking for the de-gazettement of the game reserve. Article 62 (1) (g) of the Constitution of Kenya 2010 defines public land as government forests other than forests to which Article 63 (2) (d) (i) applies, government game reserves, water catchment areas, national parks, government animal sanctuaries and specially protected areas.
- e) In Article 63 (2) (i) of the Constitution of Kenya 2010, community land consists of land and that is lawfully held, managed or used by specific communities as community forests, grazing areas or shrines; whereas Article 63 (2) (ii) defines community land as land lawfully held as trust land by the County Governments, but not including any public land held in trust by the County Government under Article 62 (2). In view of the above provisions of the Constitution of Kenya 2010, Ngai Ndethya Game Reserve falls under the category of public land.
- f) The Wildlife Conservation and Management Act, 2013 Section 37 provides for the process of variation of boundaries or revocation (de-gazettement) of a National Reserve. A proposal for de-gazettement of Ngai Ndethya Game Reserve must therefore be done in compliance of the process clearly defined by provision of the Law.
- g) The provision of the Section 37 of the Wildlife Conservation and Management Act, 2013 notwithstanding, Ngai Ndethya Game Reserve is a designated protected area characterized by dryland biodiversity and provides ecosystem connectivity between Tsavo East National Park, Chyulu Hills, and Kibwezi Forest. Though the Reserve is heavily settled, there are several Conservancies in the area which makes the area to remain an important wild life habitat that needs to be protected.
- h) KWS does not support the de-gazettement of the reserve because such action would negate the requirement of increasing the green spaces for wildlife and the conservation targets set by Convention on Biological Diversity (CBD), 1992 which Kenya is a signatory and will not be in compliance with section 37 (2) (a) of the Wildlife Conservation and Management Act 2013. The action will further exacerbate the Human-Wildlife conflict situation in the area.

4.0 COMMITTEE OBSERVATIONS

- 37. After an analysis of the submissions received, the Committee made the following observations:
- 38. The Mtito Andei area in Kibwezi East Constituency is under the greater Tsavo Conservancy ecosystem and has high incidences of Human-Wildlife Conflicts.
- 39. KWS had put in place a number of interventions to mitigate Human -Wildlife Conflicts in Kibwezi East Sub-County and specifically the Mtito Andei area. This includes establishment of a fully-fledged Problem Animal Control (PAC) outpost at Ngiluni, ground and aerial drives of problem animals and enhancement of reporting mechanisms by the community for timely response.
- 40. On Human Wildlife Conflict mitigation, KWS had put in place a number of interventions to mitigate Human -Wildlife Conflicts in Kibwezi East Sub-County and specifically the Mtito Andei area. The Service has established a fully-fledged Problem Animal Control (PAC) outpost at Ngiluni, ground and aerial drives of problem animals and enhancement of reporting mechanisms by the community for timely response.
- 41. On securing the erection of electric fence from Athi River to Mtito Andei Town, KWS was working with the County Government of Makueni and Conservation Partners (Tsavo Trust) to undertake erection of a 30 km electric fence from Athi River to Mtito Andei to provide barrier between the community and wild animals especially Elephants from Tsavo East National Park. The County had provided for Kshs. 75,000,000.00 (Seventy-Five Million Shillings) to this project in the County approved budget estimates for the Financial Year 2021/22. Public and stakeholder consultation had been done and the Report on the Environmental Impact Assessment (EIA) of the fence project forwarded to NEMA for approval.
- 42. On Corporate Social Responsibility, Tsavo Trust in partnership with KWS has specifically undertaken upgrading of the Ngiluni Dispensary, Established the Kamungi Conservancy in 2015 which created direct employment to 36 Permanent staff and 15 Casuals, trained and employed 12 Conservancy Scouts from Mtito Andei area, provided water projects and education projects amounting to Kshs. 159,978,000.00.
- 43. On the degazettement of the Ngai Ndethya Settlement Scheme, the Wildlife Conservation and Management Act, 2013 Section 37 provides for the process of variation of boundaries or revocation (de-gazettement) of a National Reserve. It was however observed that Ngai Ndethya Game Reserve is a designated protected area characterized by dryland biodiversity and provides ecosystem connectivity between Tsavo East National Park, Chyulu Hills, and Kibwezi Forest as the area remains an important wild life habitat that needs to be protected.
- 44. On timely compensation of all the residents of Mtito Andei area affected by the Human Wildlife Conflict, a total of 507 Human Wildlife Conflict Compensation Claims amounting to Kshs. 201,520,265.00 had been lodged by members of the community from Makueni

County in the period 2014 - 2021. Out of this, 154 compensation claims had been approved and paid at a total cost of Kshs. 121,447,927.00 of which 65 claims amounting to Kshs 44,805,820.00 emanated from Kibwezi East Sub County. Many of the lodged compensation claim cases are approved but the payments are pending release of funds by the National Treasury.

- 45. It was observed that in the month of June 2021, The National Treasury released funds totaling Kshs. 23,697,927.00 (twenty-three million six hundred ninety-seven thousand nine hundred twenty-seven shillings) on human injury, crop destruction and livestock predation that were paid within the month of July 2021 to claimants from Makueni County, out of which 33 residents of Kibwezi East sub county were paid a total of Kshs. 8,427,090.00. However, the seemingly inordinate delays in compensation were as a result of inadequate funding from the National Treasury.
- 46. The area Member of Parliament, Hon. Jessica Mbalu, MP had Petitioned Parliament regarding Human Wildlife Conflicts in Kibwezi East Constituency. The Committee tabled its Report on this Petition in the House on 5th November, 2019.

5.0 COMMITTEE RECOMMENDATIONS

- 1. Pursuant to the prayers in the Petition, submissions tabled and observations, the Committee resolves to recommend and urges that:
- 2. On securing the erection of electric fence from Athi River to Mtito Andei Town; KWS jointly with the County Government of Makueni should expedite the erection of the 30 KM electric fence from Athi River to Mtito Andei Town which has already been allocated Kshs. 75 million by the County Government and other approval processes concluded.
- 3. On compelling the KWS partners to undertake requisite corporate social responsibility through among others, water provision to the surrounding villages; the KWS together with partners to continue with the corporate social responsibility activities in Mtito Andei area for a harmonious co-existence with the community.
- 4. On securing the degazettement of the Ngai Ndethya Settlement Scheme, which is a gazetted game reserve in which people live, it is observed that is a designated protected area characterized by dryland biodiversity and provides ecosystem connectivity between Tsavo East National Park, Chyulu Hills, and Kibwezi Forest as the area remains an important wild life habitat. Consequently, degazetting the area would negate the requirement of increasing the green spaces for wildlife and the conservation targets set by Convention on Biological Diversity (CBD), 1992 which Kenya is a signatory and will not be in compliance with section 37 (2) (a) of the Wildlife Conservation and Management Act 2013. Therefore, KWS should enhance human wildlife conflicts mitigation measures in the area for good co-existence.
- 5. On securing, through the Ministry of Tourism and Wildlife, timely compensation of all the residents of Mtito Andei area affected by the Human Wildlife Conflict, the Ministry of Tourism and Wildlife jointly with the National Treasury should fast track the human wildlife conflict compensation insurance scheme for efficiency in compensating the HWC victims.
- 6. The Ministry of Tourism and Wildlife to fast track implementing the recommendation of the Departmental Committee on Environment Report on the Petition Regarding Human Wildlife Conflict in Kibwezi East Constituency, which was tabled in the House on 5th November, 2019.

SECRETARY FOR TOURISM AND WILDLIFE ON A PETITION REGARDING HUMAN WILDLIFE CONFLICTS IN MTITO ANDEI

Mr. Joseph K. Boinnet, Chief Administrative Secretary, Ministry of Tourism and Wildlife appeared before the Committee and briefed it as follows:

- 1. Mtito Andei is in Kibwezi East Sub County of Makueni County and within the greater Tsavo Conservation Area.
- 2. Human -Wildlife Conflicts have become a major threat to conservation over the years majorly due to population growth, settlement on traditional wildlife dispersal areas or migratory routes and climatic variability with in the Country.
- 3. Mr. Abednego Musyoki on behalf of Mtito Andei Disaster Control Self-Help Group petitioned the National Assembly to help in addressing the following:
 - a) the erection of an electric fence from Athi River to Mtito Andei town by the KWS and its partners,
 - b) compelling the KWS partners to respect farm lands and undertake requisite Corporate Social Responsibility,
 - c) fast tracking of compensation payments to the residents and
 - d) securing the degazettement of the Ngai Ndethya National Reserve.
- 4. On compensation for human-wildlife conflicts he stated that:
 - a) The Wildlife Conservation and Management Act, 2013 provides for Compensation for human death, human injury, livestock predation, crop destruction and property damage cases caused by wildlife as captured in the third schedule of the Act.
 - b) Section 25 of the Wildlife Conservation and Management Act, 2013 guides on the amounts, process and procedures for compensation on personal injury or death or damage to property or crops or predation caused by wildlife.
 - c) The Ministry through KWS facilitates payment of compensation in strict compliance with set procedures and process. Compensation claims from Makueni County are usually deliberated upon by the County Wildlife Compensation Committee that recommends an award after which they are forwarded to the Ministry of Tourism and Wildlife for validation and payment thereof. All the Compensation claims lodged by the residents of Mtito Andei area were subjected through the same process and appropriate determination made.
 - d) A total of 507 Human Wildlife Conflict Compensation Claims amounting to Ksh. 01,520,265.00 were lodged by members of the community from Makueni County in the period 2014 2021. Out of this, 154 compensation claims have been approved and paid at a total cost of Ksh. 121,447,927.00 of which 65 claims amounting to Ksh 44,805,820.00 emanate from Kibwezi East Sub County. Many of the lodged compensation claim cases are approved but the payments are pending release of funds by the National Treasury. (The Ministry provided a summary of compensation claims lodged within Makueni County as from year 2014 to year 2020 and their status)
 - e) Within the month of June 2021, The National Treasury released funds totaling Ksh. 23,697,927.00 (twenty-three million six hundred ninety-seven thousand nine hundred twenty-seven shillings) on human injury, crop destruction and livestock predation that were paid within the month of July 2021 to claimants from Makueni County. 33 residents

of Kibwezi East sub - county were paid a total of Ksh 8,427,090.00 (The summary schedule was provided).

- 5. On Transporting and release of Wildlife by Conservation Partners he stated that:
 - a) Translocation of wildlife species is carried out for introduction and reintroduction of species into an area, supplementation, population control and resolution of Human-Wildlife Conflicts. KWS is the only organization mandated to undertake wildlife capture and translocation within the Country with approval of Board of Trustees and the Ministry. Translocation of wildlife species is managed through elaborate policy guidelines in respect of different wildlife species. Conservation partners such as David Sheldrick Wildlife Trust and Tsavo Trust operate under MOUs with KWS. They have no mandate to introduce any wildlife with in the Tsavo Ecosystem or on adjacent community. On the contrary these partners have been very supportive to KWS in mitigating Human- Wildlife Conflicts in the Mtito Andei area as they deploy their resources i.e. Helicopters and fixed wing aircraft to monitor and drive away straying wildlife like Elephants from the community farm lands thereby minimizing losses to the community.

Tsavo Trust in partnership with KWS has specifically undertaken upgrading of the Ngiluni Dispensary, Established the Kamungi Conservancy in 2015 which created direct employment to 36 Permanent staff and 15 Casuals, trained and employed 12 Conservancy Scouts from Mtito Andei area, provided water projects and education projects amounting to Ksh. 159,978,000.00 (backed up the claims with a copy of letter from Richard Moller the CEO of Tsavo Trust dated February 4, 2021).
 - c) On awareness creation and community sensitization, the KWS has been holding regular meetings with the community in collaboration with conservation partners such as the Zoological Society of London (ZSL), Tsavo Trust, and David Sheldrick Wildlife Trust (DSWT) where the communities are sensitized on Human- Elephant Conflict (HEC) and alternative livelihoods programs that are compatible with wildlife conservation like bee keeping.

Parts of the Game Reserve remain unsettled with pristine vegetation that supports biodiversity conservation.
- d) The community through the petition is seeking for the de-gazettement of the game reserve. Article 62 (1) (g) of the Constitution of Kenya 2010 defines public land as government forests other than forests to which Article 63 (2) (d) (i) applies, government game reserves, water catchment areas, national parks, government animal sanctuaries and specially protected areas.
- e) In Article 63 (2) (i) of the Constitution of Kenya 2010, community land consists of land and that is lawfully held, managed or used by specific communities as community forests, grazing areas or shrines; whereas Article 63 (2) (ii) defines community land as land lawfully held as trust land by the County Governments, but not including any public land held in trust by the County Government under Article 62 (2). In view of the above provisions of the Constitution of Kenya 2010, Ngai Ndethya Game Reserve falls under the category of public land.
- f) The Wildlife Conservation and Management Act, 2013 Section 37 provides for the process of variation of boundaries or revocation (de-gazettement) of a National Reserve. A proposal for de-gazettement of Ngai Ndethya Game Reserve must therefore be done in compliance of the process clearly defined by provision of the Law.
- g) The above notwithstanding, Ngai Ndethya Game Reserve is a designated protected area characterized by dryland biodiversity and provides ecosystem connectivity between Tsavo East N. Park, Chyullu Hills, and Kibwezi forest. Though the Reserve is heavily settled, there are several Conservancies in the area which makes the area to remain an important wild life habitat that needs to be protected.
- h) KWS does not support the de-gazettement of the reserve because such action would negate the requirement of increasing the green spaces for wildlife and the conservation targets set by Convention on Biological Diversity (CBD), 1992 which Kenya is a signatory and will not be in compliance with section 37 (2) (a) of the Wildlife Conservation and Management Act 2013. The action will further exacerbate the Human-Wildlife conflict situation in the area.

OBSERVATIONS

Members observed that:

- 1. The information provided is general to Kibwezi East Constituency yet the petition was specific to Mtito Andei area.
- 2. The Mtito Andei area is under the greater Tsavo Conservancy ecosystem and has high incidences of Human-Wildlife Conflicts.
- 3. The National Environmental Management Authority (NEMA) had approved the erecting of a fence to curb Human-Wildlife Conflict in Mtito Andei area and the KWS was working on the logistics to put up the fence.
- 4. There was need for the KWS to act with speed to drive the elephants that were then causing havor to residents of the Mtito Andei area.
- 5. There was need for the KWS office concerned with community engagement to scale up its operations and work closely with residents of Mtito Andei area with respect to response to HWC cases and corporate social responsibility matters.
- 6. There was a major backlog of compensation for HWC cases across the country due to inadequate budgetary allocation.

RESOLUTIONS

It was resolved that the KWS should:

MIN.NO. DC/ENR/199/2021:

- 1. prepare and submit to the petitioners the compensation data, for HWC cases, that was specific to the Mtito Andei area.
- **2.** expedite the fencing of the Mtito Andei area since the NEMA had approved the erecting of a fence to curb Human-Wildlife Conflict in the area.

The Meeting was called to order at 10.17 am after which prayers were said. The Chairperson then stated that the main agenda of the day was meeting with Petitioners regarding a Petition on human wildlife conflict by Mtito Andei Community.

The Members adopted the agenda of the meeting.

CONFIRMATION OF MINUTES

Confirmation of Minutes of the previous Sitting was deferred to the next meeting.

MIN.NO. DC/ENR/185/2021:

MEETING WITH PETITIONERS REGARDING A PETITION ON HUMAN WILDLIFE CONFLICT BY MTITO ANDEI COMMUNITY.

Mr. Abednego Musyoki, on behalf of the Mtito Andei Community, appeared before the Committee and briefed it that:

- 1. Mtito Andei community relied on livestock keeping and cultivation of short rain crops like maize, beans and sorghum.
- 2. Mtito Andei Division boarders the Tsavo National Park both to West and East. Every so often, animals ventured out the park causing human wildlife conflict that resulted in loss of life, injuries and property destruction.
- 3. The KWS was doing a commendable job, however, there was need to put in place extra measures to curb the human wildlife conflicts in the area.
- 4. The following were listed as KWS partners who aided the organization in wildlife conservation: David Shedrick, Richard Molla, Kravoss, Mary, and Marcus Dunn. The partners were located in Mtito Andei division, but never bothered to engage in establishing relations with the local community or any corporate social responsibility. They not only let

- wildlife to roam community living areas causing havoc but also translocated wildlife to the area without consulting the host community.
- 5. Losses encountered by the local community included: crops destruction by elephants, livestock attacks by hyenas, leopards, cheetahs, lions among others, serious injuries to community members, water tanks breakages due to animals seeking water.
- 6. There was delayed compensation for damage, injuries and deaths caused by the wildlife.
- 7. A permanent solution to the human wildlife conflict in the area would be erection of an electric fence in the area along Mtito Andei River to separate Ngai Ndethya Community residence from the Tsavo East National Park.
- 8. There was need to investigate the activities of KWS partners in the area who did not engage in any corporate social responsibility. They could be compelled to provide water for domestic use for residents since access to water in the area is still a major challenge.
- 9. There was need to degazette the Ngai Ndethya Settlement Scheme. As much as it was alleged to be a game reserve, the local community was not involved and therefore did not recognize it as such.

OBSERVATIONS

Members observed that:

- 1. The Committee had handled a similar Petition by the Hon. Jessicah Mbalu and the Report on the subject matter had been tabled in the National Assembly.
- 2. Delays in compensation are as a result of inadequate funding from the National Treasury. The National Assembly was working towards compelling the National Treasury to allocate extra funding for compensation purposes.
- 3. There was need to monitor, control the KWS partners with regard to their intentions, translocation of animals from other regions to the Mtito Andei area without public participation. The partners include: David Shedrick, Richard Molla, Kravoss, Mary, and Marcus Dunn.
- 4. There was need for the KWS to urgently remove and reign in the elephants that were currently roaming freely in the area and causing damage to property and endangering human life.

RESOLUTION

It was resolved that the Ministry of Tourism and Wildlife be asked to shed light on the operations of the KWS partners in the Mtito Andei area. The partners include: David Shedrick, Richard Molla, Kravoss, Mary, and Marcus Dunn.

NEGLIGENCE BY THE KENYA WILDLIFE SERVICE IN MTITO ANDEI WILDLIFE CRISIS

Honourable Members, Standing Order 225(2)(b) requires the Speaker to report to the House any petition, other than those presented by a Member. Further, Article 119 of the Constitution provides for the right of any person to petition Parliament to consider any matter within its authority, including petitioning the House to enact, amend or repeal any legislation.

In this regard, Honourable Members, I wish to report to the House that my office has received a petition from a group calling itself the Mtito Andei Disaster Control Self-Help Group led by one Mr. Abednego Musyoki calling for "urgent intervention in the ongoing wildlife crisis in Mtito Andei occasioned by negligence by the Kenya Wildlife Services (KWS)."

In their petition, Honourable Members, the petitioners aver that they are farmers specializing in livestock keeping and cultivation of short-rain crops such as maize, beans, sorghum, millet and green grams which are unfortunately routinely invaded and destroyed by marauding elephants and other wild animals from Tsavo East and Tsavo West National Parks. Their livestock are also attacked and eaten by hyenas, leopards, cheetahs and lions, which also inflict serious injuries and even cause the death of residents attempting to save the livestock from the animals.

Further, Honourable Members, the petitioners assert that KWS partners such as David Sheldrick Wildlife Trust, Richard Molla, Kravoss and Marcus Dunn misuse their permits by intentionally releasing wild animals under their care into residents' farms to ensure that the wild animals access food near Mtito Andei as opposed to venturing deep into the Parks in a bid to attract tourists to Mtito Andei market centres. The petitioners claim that the said KWS partners routinely transport wild animals from other parks and dump them into Mtito Andei farms to feast on residents' harvest, and also regularly beat up area residents without cause despite the presence of local administrators. In addition, the petitioners state that no single Mtito Andei resident has ever received any compensation for farm losses, injuries and loss of lives primarily because their names are deliberately omitted from KWS compensation data.

The petitioners seek the intervention of this House in urgently addressing this ongoing crisis by securing the erection of an electric fence from Athi River to Mtito Andei Town, compelling the KWS partners to respect farmlands and to undertake requisite corporate social responsibility including provision of water to all surrounding towns and villages, securing the degazettement of the Ngai Ndethya Settlement Scheme which is gazetted as a game reserve despite having people living in it, and securing the timely compensation of all affected Mtito Andei residents.

Honourable Members, pursuant to the provisions of Standing Order 227(1), this Petition stands committed to the Departmental Committee on Environment and Natural Resources. The Committee is requested to consider the petition and report its findings to the House and to the petitioners in accordance with Standing Order 227(2).

3. Tsavo National parks:

Mtito Andei boarders the said National Park both to West and East. Every now and then very destructive and dangerous wildlife animals are trespassing from this park and bring about unmeasurable destructions to activities being done by Mtito Andei people. For example, crop and fruits damage by elephants, livestock attacks by hyenas, leopards, cheetahs, lions among others. The community has in decades of years recorded losses both in crops cultivations as well as their livestock animals. However, the community is experiencing lots of injuries and deaths from the said dangerous wildlife animals.

4. Kenya wildlife service:

This is the body that manages wildlife animals in Kenya. Mtito Andei community takes this greatest opportunity to appreciate the efforts being taken by Mtito Andei KWS officers to curb these animals from interfering with the people's activities. The community in particular recognizes Mr. Maganga together with his few colleagues who are spending sleepless nights patrolling in our areas for proper monitoring of the wildlife animals. However, the community pleads with the KWS senior warden Mtito Andei as well as the national government through the assistant county commissioner Mtito Andei division to come on board and install extra control measures.

5. David Shedrick, Richard Molla, Kravoss, Mary, Marcus Dunn:

These are KWS partners who intent to help in wildlife conservation. They are based in Mtito Andei Division along Athi river. Upon their arrival, these said KWS partners did not mind the good relationship with the community neither did they mind the corporate social responsibility of the area. The said KWS partners have 100% mistreated the community by beating the community members whom they falsely claim that they are hunting wildlife animals. They are actually being very much negligent on controlling the wildlife animals from trespassing to people's farms and homes. Their core intension is for the wildlife animals to feed on people's crops and livestock animals. We want to be very much categorical that these KWS partners are 100% liable for any loss and damage brought to community by the wildlife animals. The existing poverty within the community members is as a result of the said KWS partners who are intentionally letting the wildlife animals to regularly trespass to community's farms so that they can feed. Sadly enough, they import new wildlife animals from other national parks and dump them to the community which are becoming so canning that they have started bringing people's deaths.

6. Losses encountered by the Mtito Andei community:

The entire Mtito Andel Community has undergone a very strenuous situation as a result of wildlife animals:

- A. Crops destruction by elephants. A minimum of six acres per household in this case end up being completely destroyed.
- B. Livestock attacks by hyenas, leopards, cheetahs, lions among others have being a biggest threat to the community. The community sends sleepless nights as they watchdog their livestock animals from being attacked. Every household has lost tens of livestock animals as a result.
- C. Some members of the community have undergone serious injuries as they try to rescue their crops and livestock animals from the wildlife animals
- D. Not to forget water tanks breakages as a result of elephants looking for water to drink. Hundreds of plastic tanks have been damaged.

The poverty amongst the community members is purely brought about by wildlife animals as a result of these KWS partners

7. Delayed compensation for proper damages, people injuries and deaths

Since compensation Act on wildlife property destruction, people's injuries and deaths, we of Mtito Andei community have never received any. We undergo a lot of losses as a result of the human wildlife conflict. However, the budget for compensation is annually passed by the ministry of finance. Our biggest question is why don't we get our compensation despite the fact that we normally go through all the legal process of filling our cases? We therefore request the National Assembly as well as any other authority to question the ministry of Tourism and Wildlife on our behalf. Let the said ministry produce their list of any paid case incase you doubt our petition.

NB/It is our right to be compensated and if you don't take our request seriously we are going to protest and demonstrate against KWS.

8. Ministry of Tourism and Wildlife report.

The said ministry gave out its report on 29th March 2021 about their efforts on curbing this human wildlife conflicts. Kindly see the attachment of their report at the end of this petition. Mtito Andei Disaster Control Group is taking this highest opportunity to confirm to this able National Assembly that the ministry of tourism and wildlife gave out a false and fake report. Nothing the Kws, National Government and the said Ministry has done to curb this. As per their report they claim to have held a meeting attended by sixty people. We want them to give out their evidence of the said meeting, i.e Attendees, date and the venue. Additionally there is no where the elephants have been driven by helicopter from ngai ndethya community residence to the deep of Tsavo East National Park. The only permanent solution to the human wildlife conflict is the erection of the electric fence along Mtito Andei river to separate ngai ndethya community residence and the Tsavo east national park. We there for request this house to speed up the proposed electric fence erection from Mtito Andei town to Mtito Andei River to Athi River.

9. Misuse of an office by Mtito Andei Location Area chief Mr. Paul Luvai

Mtito Andei Disaster Control is a developmental group made up of more than five hundred members all from Mtito Andei Division. The group came into existence on 19th December, 2020 after KWS ignored their outcries to curb the ever increasing human wildlife conflicts in Mtito Andei . Its main objectives are:

- I. Curbing unusual issues among residents.
- II. To increase post primary learners in the area.
- III. Enlighten citizens on Bill of rights .
- IV. Deal with Domestic Violence.
- V. With injustice existing in public offices.
- VI. Poverty reduction.

In order to formalize its objectives, the group decided to register with the office of social development as a self help group. What shocked the group members and the community at large is that the area chief Mr Paul Luvai contact no; 0720175557 Mtito Andei Location, kibwezi sub county, in Makueni County rejected the group's great idea and refused to sign off his part. Attached is a copy of our filled form for registration where by the chief refused to sign off his part.

It is with this regards that we are writing to this house seeking for total intervention simply because the said chief has always been a very big barrier to Mtito Andei developments. We suggest that if the chief does not want to serve the people with clean heart without barriers he resigns for another person to be employed who is ready to serve Mtito Andei people. In case of any further information feel free to contact any of the members from the list of members. We are looking forward to hear your positive feedback soon.

10. Community's Appeal:

A. Electrical Installation

Mtito Andei is hereby requesting for an electric fence along Athi river all the way to Mtito Andei town. We appreciate our County Government Makueni for initiating this some months ago. Much appreciation to National Environmental Empact Assessment for their successful well done job as well as the gazettement for the said electric fence. However, the community is worried because this electric fence could be having barriers from some individuals in Mtito Andei Location. The Mentioned KWS partners are approaching the enlightened community members and lobby opposition in this electric fence installation. These KWS partners to achieve their hidden opposition in this case, have started individual three acre electric wire installation to some members of the community. In addition to these, these KWS partners are enticing community members with some case so that they may oppose the electric fence initiative by the Makueni County Government. With regards to this, the community is calling upon the county government Makueni and the National Government to use their special intelligence and deal accordingly

to any person who may be working against the electric fence installation from Athi river to Mtito Andei Town.

B. Kenya Conservancy Association.

The Mtito Andei Community is requesting for total review of the said KWS partners so that the community gets to know if they are wildlife conservancies or tourism investor and the kind of permits they have as per the conservancy. Act. Also we request the National Assembly to strictly monitor their activities because they are ever against the Kenya Conservancy Act of 2013. For example they do not mind corporate social responsibilities within Mtito Andei as they are required by our 2010 constitution. With this regards we request all able authorities to push these kws partners so that they may draw water from Athi river to Kamunyuni ,Ngiluni , Kyusani , Nthunguni ,Mbeetwani , Mavindini and Likoni as one way of minding corporate social responsibility of the community. The said areas are undergoing a lot of difficulties as they walk hundreds of kilometers to reach Athi River to fetch water for domestic use.

C. Pending compensation cases in Mtito Andei.

We request that we may be compensated damages brought about by wildlife animals. Our community has undergone a lot of damages as described in this petition. Since compensation Act none of the community members has ever been compensated despite many deaths, injuries and property destructions. Every financial year compensation budget is passed. Why don't we get compensation of the demages brought about by wildlife animals and its our right? With reference to KWS list sent to Hon Mutula Kilonzo Junior on 29th March 2021 through our request in his office, we were very shocked to find that the affected Mtito Andei people are not in the list. We hear by request the National Assembly to interrogate the ministry of Tourism and Wildlife on our behalf and get a strong answer as to why we of Mtito Andei Division are not in the list despite having many complainants who have filled their cases through KWS Mtito Andei. See the attached list of the pending compensation cases. Included are some of the damage assessment report documents where by they are not in the list.

D. DE gazettement of Ngai Ndethya settlement scheme.

All Mtito Andei people are requesting for the said Ngai Ndethya Settlement scheme to be degazetted as soon as possible. Currently it is known as a game reserve but we don't understand how it came to be a reserve with the existence of people inside it. We want to be very much clear that if we are not given Ngai Ndethya settlement scheme as a community we are going to organize for a national demonstration and this would affect the operations of the entire country. Take note of this please. No room at all to value wildlife more than human life.

Re: Community Development Support from Tsavo Trust through Kamungi Conservancy – Mtito Andei Ward.

Firstly, I wish to thank you and your team's efforts in recent weeks to halt the tensions within the communities east of Mtito Andei following the Human Wildlife Conflicts (HWC) that have taken shape with some unfortunate results.

Secondly, I would like to bring to your attention a brief summary of the very significant community development and support activities that Tsavo Trust has initiated in this area over the last 8 years. I think that you may have been misinformed of the extent of our commitment, engagement and significant funding that has flowed to the people of Ngiluni and Kamunyu villages that lie within Kamungi Conservancy, established by Tsavo Trust in 2015, to bring development to the area.

The table below shows just some of the key activities and costs involved to date that Tsavo Trust has implemented over the last 8 years in support of Kamungi Conservancy:

The above does not cover the many and varying day to day costs incurred such as vehicle running costs, staff time, arranging various participatory meetings and trainings as well as the regular support provided to local Government especially during Public Holiday celebrations.

During some of the recent meetings held in this area it was clear that those informing you were not portraying the true picture of the extent to which we have worked very hard to support this community, not just with funding but as true and meaningful neighbours (as Tsavo Trust HQ is within Kamungi Conservancy). It was also clear that the community themselves were somehow intimidated not to speak out, by someone coming from well outside the Kamungi community, which is most unfortunate given the true facts.

The Makueni County Government through the MCA, Mtito Ward and his team have been most helpful, supportive and engaged in every way as has the Kenya Wildlife Service (KWS) whom we are partners with on conservation matters. Kamungi Conservancy is one of the key Civil Society Organisations (CSO) spearheading the formation of the Makueni Local Development Organisation (LDO), a partnership between the MCG and CSO in Makueni County. Tsavo Trust has and continues to attract supporting organisations and well-wishers to this part of Makueni and I feel the table of activities above clearly reflects this positive approach.

I hope that this brief clarifies and informs you of the reality on the ground and we certainly look forward to working with you and your teams alongside Makueni County Government and other stakeholders going forward.

The setting up of the Mtito Andei to Athi River elephant exclusion fence, that Tsavo Trust, Kamungi Conservancy, County Government and other partners having been working towards over the last 4 years, I am sure will go along way to building better and stronger community relations as we tackle the serious issue of HWC east of Mtito Andei. It would be very unfair if another party was allowed to implement this project, yet we have the experience and we have done all the "leg work" to date for approvals. I trust you understand where I am coming from.

You are welcome to visit Kamungi Conservancy and Tsavo Trust at any time so that you can see for yourself the significant progress made here over recent years.
