## INTRODUCTION

The National Government Constituencies Development Fund (NG-CDF) Act, 2015 as amended in 2016 section 50 establishes the National Assembly Select Committee (NASC) on the NG-CDF whose main functions include but not limited to;

- (a) Oversee the implementation of the Act and in this respect, shall after every two years submit a report to the National Assembly and where necessary propose any amendments to this Act, in particular, with respect to the quantum of funds repayable into the Fund in accordance with section 4 of the Act;
- (b) Oversee the policy framework and legislative matters that may arise in relation to the Fund;
- (c) Continually review the framework set out for the efficient delivery of development programmes financed through the Fund;
- (d) Consider and report to the National Assembly, with recommendations, names of persons required to be approved by the National Assembly under this Act;

Section 51(1) of the Act further stipulates that the Board shall, on a quarterly basis, submit a report to the National Assembly Select Committee detailing the following;

- a) A summary of the project proposals received from the constituencies in the preceding quarter and indicating the approval status of such projects;
- (b) A summary of the status of disbursements of funds to the constituencies for that preceding quarter;
- (c) A summary of the status of disbursements from the Treasury to the National Account;
- (d) Any restriction imposed on a constituency account in accordance with the Act.

It is based on the foregoing that the NG-CDF Board is submitting its report for the third quarter of 2020/2021 Financial Year.

A. A summary of the project proposals received from the constituencies in the preceding quarter and indicating the approval status of such projects

The NG-CDF Board has to date received Project Proposals from all the two hundred and ninety (290) Constituencies with respect to 2020/2021 Financial Year. Project Proposals from two hundred and eighty nine (289) Constituencies have been deliberated on by the Board while Project Proposal from Kabete Constituency is awaiting deliberation due to late submission.

The NG-CDF Board issued a circular on submission of project proposals on 10<sup>th</sup> August 2020 guiding Constituency Committees on the process of preparation and online submission of Project Proposals for 2020/2021 Financial Year. The Constituency Committees were advised to submit their Project Proposals not later than 30<sup>th</sup> September, 2020.

B. A summary of the status of disbursements of funds to the constituencies for that preceding quarter

(i) Fund allocation and receipts for 2020/2021 Financial Year

The NG-CDF was allocated a total of Kshs.41.7148 Billion for the 2020/2021 financial year.

Section 39(2) which provides that:

*"The disbursement of funds to the constituency fund account shall be effected at the beginning of the first quarter of each financial year with an initial amount equivalent to twenty-five per centum of the annual allocation for the constituency and thereafter the constituency fund account shall be replenished in three equal instalments at the beginning of the second, third and fourth quarters of the financial year".*

Pursuant to the above section, this being the fourth quarter of the financial year, the expected receipts to date amount to Kshs.41.7148 Billion out of which Kshs.32 Billion has been received. The funds were received as follows:-

The total amount yet to be received for the financial year 2020/2021 is Kshs.9.7148 Billion and Kshs.18.69155 Billion arrears from previous financial years. The total outstanding disbursement is therefore Kshs.28.40635 Billion.

(ii) Status of disbursement of funds for 2020/2021 Financial Year to the Constituencies

Section 7 (2) of the NG-CDF Act 2015 as amended in 2016 provides that all funds allocated to a constituency shall be cumulative and shall be carried forward from one financial year to the next, including funds returned into the accounts in accordance with section 6(3) or funds which are not utilized for whatever reasons.

Section 40 of the Act further provides that the Board shall ensure that the list of projects forwarded to it by each constituency is, upon approval, funded in accordance with the Act.

During the 2020/2021 Financial Year Kshs.41.7148 was allocated to the Fund out of which a total of Kshs.32 billion has been released to the Board by the National Treasury as at 31<sup>st</sup> March 2021. The amount has been disbursed to various Constituencies as follows;

1. Kshs.14,475,900,000 disbursed to the constituencies against the 2020/2021 budgetary allocation
2. Kshs.16,414,058,783 disbursed to Constituencies with respect to balances for previous financial years.
3. An amount of Kshs.1,110,000,000 disbursed to the Board secretariat.
