1.0 PREFACE

On behalf of the Departmental Committee on Administration and National Security and pursuant to the provisions of Standing Order 199(6), it is my privilege and honour to present to the House the report of the Committee on investigations into alleged irregularities in the disbursement of funds to Civil Society Groups by the National Authority for the Campaign Against Alcohol and Drug Abuse (NACADA) in the 2013/14 Financial Year.

The investigations were necessitated by concerns raised, through the media indicating possible irregularities in the disbursement of funds to Civil Society organizations by the National Authority for the Campaign Against Alcohol and Drug Abuse (NACADA) during the 2013/14 Financial Year. The alleged irregularities included funding of non-existing or deregistered Non – Governmental Organizations, embezzlement of funds set aside for the anti-drug use campaign and irregular procurement of consultancy services for the management of NACADA's funding of civil society Organizations.

1.1 Mandate of the Committee

The Departmental Committee on Administration and National Security is established pursuant to the provisions of Standing Order No.216 with the following terms of reference:-

- (i) study and review all legislation referred to it;
- (ii) make reports and recommendations to the House as often as possible, including recommendation of proposed legislation;
- (iii) to investigate, inquire into, and report on all matters relating to the mandate, management, activities, administration, operations and estimates of the assigned Ministries and departments;
- (iv) to study the programme and policy objectives of Ministries and departments and the effectiveness of the implementation;

- (vi)to investigate and inquire into all matters relating to the assigned Ministries and departments as they may deem necessary, and as may be referred to them by the House or a Minister;

1.3 Meetings

The Committee held three meetings with the National Authority for the Campaign Against Alcohol and Drug Abuse (NACADA) Board of Directors, the Executive Director Non - Governmental Organization Coordination Board and the Director General, Public Procurement Oversight Authority.

1.4 Committee General Findings, Observations and Recommendations

Having held meetings and considered the submissions presented, the Committee observed that the procurement of consultancy services for the disbursement of funds to Civil Society Organizations by NACADA in the 2013/14 Financial Year was completely flawed. The procurement was not budgeted for nor planned. No requisition for the services was made by the procuring entity. It also contravened the Public Procurement and Disposal Act, 2005 on the following specific grounds:-

- (i) Regulation 20 (4) of the Public Procurement and Disposal Regulations 2006 that requires a head of department to submit an annual procurement plan to the accounting officer at least thirty days before the closure of each financial year was not complied with.
- (ii) No purchase requisition for the consultancy was raised by the user department, contrary to the provisions of Regulation 9 (a) and 22 of the Public Procurement and Disposal Regulations 2006.
- (iii) Although the law required firms to submit both technical and financial proposals. There were no minutes to indicate whether financial proposals were opened contrary to the requirements of Section 60 (8) and (9) of the Public Procurement and Disposal Act, 2005.
- (iv) The consultancy was procured through restricted tendering. However the choice of the method did not satisfy the requirement of section 29 (3) (a) and (b) and section 73 (2) (a), (b) and (c) of the Public Procurement and Disposal Act, 2005. The choice of the method did not also satisfy the requirements of Regulation 54 (2), (3) and (4) of the Public Procurement and Disposal Regulations, 2006 on identification of persons to be invited to participate in restricted tendering as seven firms were invited to participate in the tender instead of ten firms as provided in the Regulations 54 (3). The Committee further observed that the choice of restricted tendering was not approved by the tender committee as minutes to confirm the same were not provided. This contravened the requirements of Section 29 (3) (a) and (b) and Section 73(2)a), (b) of the Public Procurement and Disposal Act, 2005.

- (v) The evaluation criteria had stated that participating firms had to meet the minimum technical score to qualify for further evaluation but the minimum marks were not stated in the bid document. It was therefore irregular and in contravention of section 66 (2) of the Public Procurement and Disposal Act, 2005 for the tender committee to recommend M/s Price Waterhouse Coopers and M/S Ernest and Young for financial evaluation as the evaluation and comparison of the tenders was not carried out in accordance with the criteria stated in the bid document with respect to minimum qualifying marks.
- (vi) The procuring entity did use standard tender documents prescribed by Public Procurement Oversight Authority in the terms of reference signed with the firm awarded the consultancy against the provisions of section 29 (4) of the Public Procurement and Disposal Act, 2005.

The Committee also observed that the National Authority on the Campaign Against Alcohol and Drug Abuse (NACADA) violated public procurement rules in the procurement of media services from Kenya Broadcasting Corporation and other media organizations, amounting to KES. 47 million in the 2013/14 Financial Year. The services were procured without any tendering process.

The Committee recommends that the Ethics and Anti-Corruption Commission should conclude investigations into the irregular procurement of consultancy services for the disbursement of KES. 99 million to Civil Society Organizations by the National Authority for the Campaign Against Alcohol and Drug Abuse (NACADA) in the 2013/14 Financial Year and ensure that culpable officers are prosecuted.

The Ethics and Anti-Corruption Commission should also conclude investigations into the procurement of media services by the National Authority for the Campaign Against Alcohol and Drug Abuse (NACADA), amounting to KES. 47 million, without any tendering process during the 2013/14 financial year and ensure that culpable officers are prosecuted.

The Committee further National Authority for the Campaign Against Alcohol and Drug Abuse board should be dissolved and a new board be appointed to restructure the institutional framework of the organization to ensure that the board and the secretariat deliver on their respective mandates.

2.0 BACKGROUND INFORMATION

The National Authority for the Campaign against Alcohol and Drug Abuse (NACADA) is a State Corporation in the Ministry of Interior and Coordination of National Government. It is established under the National Authority for the Campaign against Alcohol and Drug Abuse Act, 2012 to coordinate a multi sectoral response to alcohol and drug abuse.

NACADA's functions are:-

- I. To carry out public education on alcohol and drug abuse directly and in collaboration with other public or private bodies and institutions;
- 2. Coordinate and facilitate public participation in the control of alcohol and drug abuse:
- 3. Coordinate and facilitate inter-agency collaboration and liaison among lead agencies responsible for alcohol and drug-demand reduction;
- 4. In collaboration with other lead agencies, facilitate and promote the monitoring and surveillance of national and international emerging trends and patterns in the production, manufacture, sale, consumption, trafficking, promotion of alcohol and drugs prone to abuse;
- 5. In collaboration with other lead agencies, provide and facilitate the development and operation of rehabilitation facilities, programmes and standards for persons suffering from substance use disorders:
- 6. Subject to any other written law to license and regulate operations of rehabilitation facilities for persons suffering from substance use disorders;
- 7. Coordinate and facilitate, in collaboration with other lead agencies and non-state actors, the formulation of national policies, laws and plans of action on control of alcohol and drug abuse and facilitate their implementation, enforcement, continuous review, monitoring and evaluation;
- 8. Develop and maintain proactive cooperation with regional and international institutions in areas relevant to achieving the Authority's objectives;

- 9. In collaboration with other public and private agencies, facilitate, conduct, promote and coordinate research and dissemination of findings on data on alcohol and drug abuse and serve as the repository of such data;
- 10. In collaboration with other lead agencies, prepare, publish and submit an alcohol and drug abuse control status report bi-annually to both Houses of Parliament through the Cabinet Secretary;
- 11. Assist and support County Governments in developing and implementing policies, laws, plans of action on control of drug abuse.

As part of the fulfillment of the mandate of carrying out public education on alcohol and drug abuse directly and in collaboration with other public or private bodies and institutions. The National Authority for the Campaign Against Alcohol and Drug Abuse (NACADA) undertook a Civil Society Organizations funding progammee, during the 2013/14 Financial Year. Under the programmee the Authority invited applications for funding for Civil Society organizations to facilitate the anti-drug use campaign. However allegations of irregularities in the disbursement of funds under the programme emerged as highlighted in the print media.

The Committee investigations into the matter were necessitated by concerns raised, through the media indicating possible irregularities in the disbursement of funds to Civil Society organizations by the National Authority for the Campaign Against Alcohol and Drug Abuse (NACADA) during the 2013/14 Financial Year. The alleged irregularities included funding of non-existing or deregistered Non – Governmental Organizations, embezzlement of funds set aside for the anti-drug use campaign and irregular procurement of consultancy services for the management of NACADA's funding of civil society Organizations

During the investigations the Committee held three meetings with the National Authority for the Campaign Against Alcohol and Drug Abuse (NACADA) Board of Directors, the Executive Director Non - Governmental Organization Coordination Board and the Director General, Public Procurement Oversight Authority. Through submissions made during the meetings the Committee drew conclusions and made several observations and recommendations to address the possible irregularities.

3.0 MEETINGS

3.1 Meeting withthe National Authority for the Campaign Against Alcohol and Drug Abuse (NACADA) Board of Directors

The Committee held a meeting with the NACADA Board of Directors on 3rd July 2015. During the meeting the board members responded to the issues raised by the Committee as follows:-

On the issue of alleged embezzlement of funds set aside for the anti-drug use campaign

The Committee was informed that the National Authority for the Campaign Against Alcohol and Drug Abuse (NACADA) formed an adhoc committee, consisting of members of the finance and audit sub – committees to investigate allegations made by the Executive Director, Non- Governmental Organizations Coordination Board indicating that NACADA had funded unregistered /deregistered organizations leading to loss of public funds. The adhoc committee held three meeting on 18th, 23rd and 29th June, 2015. During the meeting the following documents were reviewed:-

- (i) Management response to the letter from the Non- Governmental Organizations Coordination Board;
 - (ii) Legal and institutional framework for the funding for the Civil Society Organizations funding programme;
- Reports and oral presentations by Ernst and Young, the Fund Management Agency (FMA) charged with disbursing the funds;
 - (iv) The Monitoring and Evaluation framework put up by NACADA and the Fund Management Agency;
 - (v) List of funded organizations and their registration details;
 - (vi) NACADA funding instructions to the Fund Management Agency (FMA); and
 - (vii) Copies of Civil Society Organizations registration certificates, FMA 's funding instructions to the Civil Society Organizations ,RTGS confirmation from the Fund Management Agency 's Bank and the the Civil Society Organizations Bank Statements.

The Chairperson, NACADA stated that upon review of the matter the adhoc committee concluded that there was no evidence of loss of funds as monies forwarded to the Fund Management Agency (FMA) by NACADA had been disbursed and received by the Civil Society Organizations.

On alleged funding of non-existing or deregistered Non - Governmental Organizations

The Board confirmed to the Committee that all organizations funded by NACADA had provided prove of registration at the time of applying for funds. Majority of these organizations were registered as Self Help Groups/Community Based Organizations, registered by the then Ministry of Gender, Children and Social Services. Only 35 of the funded organizations were registered as Non-Governmental Organizations. The other 95 funded organizations were registered by other Government bodies as indicated in table 1.

In response to allegations made by the Non-Governmental Organizations Coordination Board, in its letter dated 9th June 2015 and addressed to the Chairperson NACADA indicating that two Non - Governmental Organizations, Coast Rural Development Organization and Community of Mercy Development Organization that had been deregistered in December, 2014 received funds from NACADA, the NACADA board of directors informed the Committee that the Authority had undertaken predisbursement assessment of all organizations approved for funding to establish their capacity to implement projects and account for the funds. This included confirmation of registration status and provision of registration details. The Committee further heard that the disbursement of funds to the two organizations was made in November, 2013 before their reported deregistration in December, 2014.

before the Board for deliberation and resolution. This decision was later rescinded by other members of the board on the grounds that it was done without following due procedure. On his part the Chairperson stated that the Chief Executive Officer was not keen on the Anti- alcohol and drug use campaign.

Documents submitted to the Committee also indicated that the Cabinet Secretary for Interior and Coordination of National Government convened a meeting on Tuesday 30th June, 2015 at Harambee House in a bid to resolve the conflict in the NACADA Board.

During the said meeting it was noted that there was clear division within the organization involving the Chairperson and the Chief Executive Officer. Further dividing the organization into two camps, one supporting the Chairperson and the other the Chief Executive Officer, The Cabinet Secretary observed that there was a clear distinction between the role of the Board and Management, with the former expected to offer leadership and policy direction and the latter was expected to implement the decisions of the board.

Procurement of Media Services from Kenya Broadcasting Corporation and Other Media Organizations in 2013/14 Financial Year

Documents submitted to the Committee indicated that NACADA had written to the Principal Secretary for Interior seeking approval forpayment of outstanding bills arising from advertisements made between 16th and 30th June 2014. The Principal Secretary declined to approve the request on the grounds that the Ministry's guidance on the matter was communicated to all officers vide circular letter reference No. OP.PA/2/27A of 14th February, 2014) which among others, drew their attention to the contents of Treasury circular(6/2014) of 13th May 2014 which directed all Accounting Officers not to enter into any new commitment between 15th and 30th June,2014 without written authority from the Principal Secretary, National Treasury.

The National Treasury vide letter Ref CONF/MOF/347/02/ (11) dated 2nd March, 2015 advised on the matter as follows:-

- (i) Section 27 of the Public Procurement and Disposal Regulations 2009, on procurement approvals states that "No procurement approval shall be made to operate retrospectively to any date earlier than the date of which it was made".
- (ii) Section 8 and 10 of the Public Procurement and Disposal Regulations on Internal Procurement Entities, stipulates and provides details on how the

On alleged irregularities in the disbursement of funds to Civil Society groups.

The Committee was informed that the NACADA Board of Directors did not find evidence of any irregularities in the disbursement of funds. A summary of the disbursement was provided as follows:-

- (i) NACADA forwarded a list of 134 organizations, which had applied for funding, to the Fund Management Agency (Ernest and Young). However the number of eligible organizations was reduced to 130 as 4 organizations did not pass capacity assessment test.
- (ii) The total cost of proposals submitted to the Fund Management Agency (MFA) was KES 118 million. As at 31st May 2015 NACADA had forwarded KES 94,911,561.50 to the Fund Management Agency (MFA). A review of documents including bank transfer certificates and acknowledgement letters from Civil Society Organizations indicated that the MFA had as at 31st May, 2015 disbursed KES 91,891,839.40 to Civil Society Organizations.
- (iii) Fund balance held by the Fund Management Agency (MFA) was KES 3,019,722.10 as at 31st May, 2015. The fund balance, held by NACADA was KES 4,088,438.50.
- (iv) The interest income earned on the disbursed funds which was managed through an interest earning account was KES 565,610.69 as at 31st May 2015. The bank charges incurred on the account amounted to KES181, 691.58.
- (v) Accrued net interest of Bank charges of KES 326,440.40 was paid to NACADA on 8th December, 2014.
- (vi) 88% of the funds disbursed had been accounted for by the Civil Society Organizations.

Conflict in the Authority for the Campaign Against Alcohol and Drug Abuse (NACADA) Board

The Chief Executive officer informed the Committee that the Chairperson had attempted to unilaterally suspend him and six other officers on 18th June, 2015 on the basis of a letter from the Board's Audit sub-committee which had not been brought

procurement function should be conducted by the procuring entities. This includes involvement of the procurement units, Tender Committees' approvals and confirmation of availability of funds for any procurement that is under consideration.

(iii) Notwithstanding the above procurement procedures there was no provision for Post-Facto authority in any procurement undertaking.

The National Treasury concluded that the matter was a case of mis -procurement as the said procurement did not meet the stipulated threshold, in the Public Procurement Process.

Observations by the Committee

During the meeting the Committee observed that:-

- (i) NACADA was under performing due to wrangles and uneasiness within the board, as witnessed in the meeting through counter accusations involving the Chairperson, Vice Chairperson and the Chief Executive Officer.
- (ii) 2.5 million Kenyans addicted to alcohol and narcotics are suffering and required rehabilitation. However there are no adequate rehabilitation centres in the Country to cater for the demand.
- (iii) The Cabinet Secretary for Interior and Coordination of National Government was yet to gazette regulations on control of alcohol quality and treatment and rehabilitation of addicts.
- (iv) NACADA violated public procurement rules in the procurement of media services from Kenya Broadcasting Corporation and other media organizations, amounting to KES. 47 million, without any tendering process in 2013/14 Financial year.

3.2 Meeting with the Executive Director Non - Governmental Organization

Coordination Board

The Committee held a meeting with the Executive Director Non - Governmental Organization Coordination Board on Thursday 30th July 2015. During the meeting the Director informed the Committee that their investigations into the disbursement of funds to Civil Society Organizations by NACADA revealed that:-

- (i) Out of the one hundred and nineteen (119) Civil Society Groups funded by NACADA, only 33 were registered by the Non –Governmental Organizations Coordination Board.
- (ii) Out of the 33 organizations registered by the Board, only 14 organizations had accurately disclosed the funds received totalling Kshs. 13,933,175.00.

 The 14 organization were as follows:-
 - Action Network for the Disabled;
 - Alliance for Education and Empowerment in Development;
 - Benevolent Institute of Development Initiatives;
 - Cheripkei Community Awareness and Education Programme;
 - Climatic and Environmental Conservation Kenya;
 - Gaplink International:
 - Green View;
 - Homa Hills Community Development Organization;
 - Kenya Network of Women with AIDS (KENWA);
 - Neem Environment Project;
 - Right Destitute Mother Child Organization;
 - Sere Africa International;
 - Strengthening Community Partnership and Empowerment; and
 - Youth Alive! Kenya.
- (iii) Two (2) organizations Coast Rural Development Organization and Community of Mercy Development Organization, which received Kshs. 745,500, had been deregistered.
- (iv) Even though, it was claimed that Kshs. 10,671,447.50 was advanced to eleven (11) organizations, records at the Board indicated that none of the organizations received any funding from NACADA. The organization were as follows:-
 - Maranatha International Counseling Foundation;
 - · Men for Gender Equality Now;
 - Solidarity for Eco-Friendly Efforts in Kenya;
 - Songa Mbele Women Organization (Move Forward);
 - Kenya Basic Support Foundation;
 - Narok District Network Forum;
 - Strategic Intervention for Poverty Alleviation in Kenya;
 - Mumoni and Kyuso Organization for Rural;
 - Sporting Chance International;
 - Maendeleo yaWanawake Organization; and
 - Young Women's Christian Association (YWCA).

(v) Six (6) organizations declared funds in excess of what was received from NACADA which points to other possible sources of funding or fraud .The six organizations are as indicated in Table 2.

(Source: documents submitted to the committee by the Non - Governmental Organization Coordination Board)

The Committee was further informed that the board was unable to establish the legal status of the 33 organizations and whether the funds allegedly advanced to them were received by the organizations or not. He added that disbursement of funds without establishing the legal status of Non-Governmental Organizations occurred because of lack of due diligence from government agencies such as NACADA.

Committee's Observations and Recommendations

The Committee observed that funding of deregistered organizations posed a threat to the security of the Country and was tantamount to misuse of taxpayers' money. The Committee requested for an updated list of deregistered Non-Governmental Organizations, those pending deregistration and those waiting registration approval. The Committee recommended that all Non-Governmental Organizations operating in the Country must be authenticated by the Non - Governmental Organization Coordination Board.

3.3 Meeting with the Director General, Public Procurement Oversight Authority

The Committee held a meeting with the Director General, Public Procurement Oversight Authority on Tuesday 25th August, 2015. The purpose of the meeting was to seek information on whether the procurement of consultancy services for the management of NACADA's funding of Civil Society Organizations in 2013/14 Financial Year followed due process. During the meeting the Director General informed the Committee that he had sought to obtain relevant documents on the matter from NACADA but was informed that the documents had been submitted to the Ethic and Anti-Corruption Authority. Attempts to obtain the documents from the latter were also not successful, although the Ethics and Anti-Corruption Authority had invited the Director General to peruse the documents in their offices. However the Director General informed the Committee that preliminaryinvestigations on the matter conducted in May, 2014 had revealed that:-

- (i) Though the disbursement of KES 99,000,000 was approved by the NACADA board of directors in March, 2013 the resultant costs for the disbursement was not budgeted nor planned as required under Section 26 (3) (a) and 26 (6) of the Public Procurement and Disposal Act,2005. In addition, Regulation 20 (4) of the Public Procurement and Disposal Regulations2006 requires that 'a head of department shall submit an annual procurement plan to the accounting officer at least thirty days before close of each financial year', however this provision was not complied with.
- (ii) There was no purchase requisition for consultancy raised by the user department contrary to the provisions of Regulation 9 (a) (i) and 22 of the Principal Regulations, 2006.

- (iii) The procuring entity did use Standard tender documents prescribed by the Public Procurement Oversight Authority in the Terms of reference signed with the firm awarded the consultancy against the provisions of Section 29 (4) of the Public Procurement and Disposal Act, 2005.
- (iv) The consultancy was procured through restricted tendering. However the choice of the method was not approved by the tender committee as minutes to confirm the same were not provided. This contravened the requirements of Section 29 (3) (a) and (b) and Section 73(2)(a) and (b) of the Act. Also only seven firms were invited to participate in the tender contrary to Regulation 54 (3) which requires a procuring entity to invite tenders from at least ten firms selected from a prequalified list. The firms invited to participate in the tender were: M/s KPMG; M/s Kenya Commercial Bank; M/s SACCO Societies Regulatory Board; M/s Price Waterhouse Coopers; M/S Ernst and Young; M/s Kenya Post Office Savings Bank; and M/s Deloitte Kenya.
- (v) Although the law required firms to submit both technical and financial proposals. There were no minutes to indicated whether financial proposals were opened contrary to the requirements of Section 60 (8) and (9) of the Public Procurement and Disposal Act, 2005.
- (vi) The evaluation of the tender was carried out by four officers and M/s Price Waterhouse was ranked Ist with a score of 97 out of 100 marks; 2nd was Ernst and Young who had scored 69 out of 100 marks; and M/s Kenya Post Office Bank was last scoring 0. However the minimum scores for one to qualify for further evaluation were not stated in the tender documents. It was therefore irregular for M/s Price Waterhouse Coopers and M/s Ernst and Young to have been recommended for further evaluation on the basis of 'best fit' as the criteria was no objective contrary to Regulation 16(7) of the Principal Regulations, 2006.
- (vii) Despite the irregularities, cited above, the Accounting Officer signed a contract with M/s Ernst and Young at Ksh 17,001,540 contrary to the provisions of Section 27 (2) of the Act which requires the Accounting Officer to adhere to the law.
- (viii) Only seven firms were invited to participate in the tender, contrary to Regulation 54 (3) which requires a procuring entity to invite tenders from at least ten firms selected from a prequalified list.

The Public Procurement Oversight Authorityconcluded that the processing of the tender did not satisfy the requirements of the procurement law and the consequent contract entered and payments made were irregular. The Committee was further informed that the Authority had recommended that the Accounting Officer take disciplinary measures on all officers involved in the procurement. Also a report on the matter was forwarded to the Ethics and Anti -Corruption Commission for action.

4.0 COMMITTEE OBSERVATIONS

From the meetings with witnesses the Committee observed that:-

- 1. The procurement of consultancy services for the disbursement of KES 99 million to Civil Society Organizations by NACADA in the 2013/14 Financial Year was completely flawed. The procurement was not budgeted for nor planned and no requisition for the services was made. It also contravened the Public Procurement and Disposal Act, 2005 on the following specific grounds:-
 - (i) Regulation 20 (4) of the Public Procurement and Disposal Regulations, 2006 that requires a head of department to submit an annual procurement plan to the accounting officer at least thirty days before the closure of each financial year was not complied with.
 - (ii) No Purchase Requisition for the consultancy was raised by the user department, contrary to the provisions of Regulation 9(a) and 22 of the Public Procurement and Disposal Regulations, 2006.
 - (iii) Although the law required firms to submit both technical and financial proposals, there were no minutes to indicate whether financial proposals were opened contrary to the requirements of Section 60 (8) and (9) of the Public Procurement and Disposal Act, 2005.
 - (iv) The consultancy was procured through restricted tendering. However the choice of the method did not satisfy the requirement of section 29 (3) (a) and (b) and section 73 (2) (a), (b) and (c) of the Public Procurement and Disposal Act, 2005. The choice of the method did not also satisfy the requirements of Regulation 54 (2) (3) and (4) of the Public Procurement and Disposal Regulations 2006 on identification of persons to be invited to participate in restricted tendering as seven firms were invited to participate in the tender instead of ten firms as provided in the Regulations 54 (3). The

Committee further observed that the choice of restricted tendering was not approved by the tender committee as minutes to confirm the same were not provided. This contravened the requirements of Section 29 (3) (a) and (b) and Section 73(2) a), (b) of the Public Procurement and Disposal Act, 2005.

- (v) The evaluation criteria had stated that participating firms had to meet the minimum technical score to qualify for further evaluation but the minimum marks were not stated in the bid document. It was therefore irregular and in contravention of section 66 (2) of the Public Procurement and Disposal Act 2005 for the tender committee to recommend M/S PriceWaterhouseCoopers and M/S Ernest and Young for financial evaluation as the evaluation and comparison of the tenders was not carried out in accordance with the criteria stated in the bid document with respect to minimum qualifying marks.
- (vi) The procuring entity did use standard tender documents prescribed by Public Procurement Oversight Authority in the terms of reference signed with the firm awarded the consultancy against the provisions of section 29 (4) of the Public Procurement and Disposal Act, 2005.
- 2. The National Authority for the Campaign Against Alcohol and Drug Abuse (NACADA) violated public procurement rules in the procurement of media services from Kenya Broadcasting Corporation and other media organizations, amounting to KES. 47 million, without any tendering process during the 2013/14 Financial Year.
 - 3. Majority of the Civil Society organizations that were funded were registered as Self Help Groups/Community Based Organizations, registered by the then Ministry of Gender, Children and Social Services. Only 35 of the funded organizations were registered as Non-Governmental Organizations. The claims made by the Executive Director, Non-Governmental Coordination Board that only 33 organizations funded by NACADA were registered by the Board did not therefore imply that the other organizations were necessarily illegal as they were registered under different categories. Evidence of the organizations' registration status that included registration certificates were submitted to the Committee.

- 4. Although Coast Rural Development Organization and Community of Mercy were deregistered by the Non-Governmental Coordination Board, the disbursement of funds to Coast Rural Development Organization was made in November, 2013 before the reported deregistration of the organization in December, 2014.
- 5. The National Authority for the Campaign against Alcohol and Drug Abuse (NACADA) was only mandated to campaign against Alcohol and Drug abuse and not to control the vice. There is need to amend the National Authority on the Campaign Against Alcohol and Drug Abuse Act 2012 to empower the Authority to control the Alcohol and Drug abuse problem.
- 6. National Authority for the Campaign Against Alcohol and Drug Abuse (NACADA) was under performing due to wrangles and uneasiness within the Board, as witnessed in the meeting through counter accusations involving the Chairperson, Vice Chairperson and the Chief Executive Officer.
- 2.5 million Kenyans were reportedly addicted to alcohol and narcotics are suffering and required rehabilitation. However there are no adequate rehabilitation centres in the Country to cater for the demand of the addicts.
- 8. The Cabinet Secretary for Interior and Coordination of National Government was yet to gazette regulations on control of alcohol quality and treatment and rehabilitation of addicts.

5.0 RECOMMENDATIONS

The Committee made the following recommendations:-

- I. The Ethics and Anti-Corruption Commission should conclude investigations into the irregular procurement of consultancy services for the disbursement of KES.99 million to Civil Society Organization by the National Authority for the Campaign Against Alcohol and Drug Abuse (NACADA) in the 2013/14 Financial Year and ensure that culpable officers are prosecuted.
- 2. The Ethics and Anti-Corruption Commission should conclude investigations into the procurement of media services by the National Authority for the Campaign Against Alcohol and Drug Abuse

- 2. The Ethics and Anti-Corruption Commission should conclude investigations into the procurement of media services by the National Authority for the Campaign Against Alcohol and Drug Abuse (NACADA), amounting to KES. 47 million, without any tendering process during the 2013/14 financial year and ensure that culpable officers are prosecuted.
- 3. The National Authority for the Campaign Against Alcohol and Drug Abuse board should be dissolved and a new Board be appointed to restructure the institutional framework of the organization to ensure that the board and the secretariat deliver on their respective mandates.

- (vi) The evaluation of the tender was carried out by four officers and M/s Price Waterhouse was ranked 1st with a score of 97 out of 100 marks; 2nd was Ernst and Young who had scored 69 out of 100 marks; and M/s Kenya Post Office Bank was last scoring 0. However the minimum scores for one to qualify for further evaluation were not stated in the tender documents. It was therefore irregular for M/s Price Waterhouse Coopers and M/s Ernst and Young to have been recommended for further evaluation on the basis of 'best fit' as the criteria was no objective contrary to Regulation 16(7) of the Principal Regulations, 2006.
- (vii) Despite the irregularities, cited above, the Accounting Officer signed a contract with M/s Ernst and Young at Ksh 17,001,540 contrary to the provisions of Section 27 (2) of the Act which requires the Accounting Officer to adhere to the Law.
- (viii) Only seven firms were invited to participate in the tender, contrary to Regulation 54 (3) which requires a procuring entity to invite tenders from at least ten firms selected from a prequalified list.

The Public Procurement Oversight Authority concluded that the processing of the tender did not satisfy the requirements of the procurement law and the consequent contract entered and payments made were irregular. The Committee was further informed that the Authority had recommended that the Accounting Officer take disciplinary measures on all officers involved in the procurement. Also a report on the matter was forwarded to the Ethics and Anti -Corruption Commission for action.

- (i) That was not economical for NACADA to pay a consultancy fee of KES 17 million to Ernst and Young for the disbursement of KES 99 million to Civil Society Organizations.
- (ii) The failure by NACADA to provide tender documents to the Public Procurement Oversight Authority on the pretext that the same had been forwarded to the Ethics and Anti Corruption Commission was not convincing as one would expect any organization to keep custody of copies of all official documents.

MIN.NO.135 /ANS/2015 - MEETING WITH NATIONAL AUTHORITY FOR THE CAMPAIGN AGAINST ALCOHOL AND DRUG ABUSE BOARD MEMBERS ON ALLEGED IRREGULARITIES IN THE DISBURSEMENT OF FUNDS SET A SIDE FOR ANTI – DRUG USE CAMPAIGN

The Chairperson stated that the National Authority For The Campaign Against Alcohol And Drug Abuse (NACADA) board had been invited to clarify allegations on embezzlement of funds set aside for the anti-drug use campaign, funding of non-existing or deregistered Non-Governmental Organizations and other irregularities in the disbursement of funds to Civil Society groups.

The Chairperson of NACADA and board Members responded to the allegations as follows:-

- (i) On allegations of embezzlement of funds set aside for the anti-drug use campaign. The Chairperson responded that the Board received a letter from the Non-Governmental Organizations Coordination Board on 9th June 2015 alleging irregularities in funding of Civil Society organizations. In the letter signed by the Executive Director Mr. Mahamed Fazul who is a former member of the NACADA Board, allegations that the Authority had funded unregistered/deregistered organizations leading to loss of funds were made. In response to the matter, the Board formed an Ad hoc committee consisting of members of the Audit and Finance Committees to investigate the matter. The Ad hoc Committee met on 18th, 23rd and 29th June 2015 and reviewed the following documents:
 - a. Management's response to the letter from NGO Coordination Bureau.
 - b. Legal and institutional framework for the CSOs funding programme.
 - c. Reports and oral presentations by the Fund Management Agency (FMA) charged with disbursing funds.
 - d. The monitoring and evaluation framework put in place by NACADA and the Fund Management Agency (FMA).
 - e. Disbursement status report by the Fund Management Agency.
 - f. List of funded organizations and their registration details.
 - g. NACADA funding instruction to the Fund Management Agency.
 - h. Copies of Civil Society Organizations registration and certificates, Fund Management Agency's funds transfer instructions to Civil Society Organizations Banks, RTGs confirmations from the Fund Management Agency's Bank and Civil Society Organizations Bank statements and confirmation of receipt of funds.

The Ad hoc Committee concluded that there was no evidence of loss of funds as monies forwarded to the Fund Management Agency by NACADA had been disbursed and received by the Civil Society Organizations whose projects are still ongoing.

(ii) Regarding alleged funding of non-existing or deregistered Non-Governmental Organizations. The Board confirmed that all funded organizations at the time of approval and assessment provided evidence of registration. Majority of these were registered as Self Help Groups/Community Based Organizations registered by the Ministry of Gender, Children and Social Services.

The Non-Governmental Organizations Coordination Board had claimed that it could not establish the registration status of 86 organizations. This is because out of the 130 organizations funded, only 35 are registered.

However the NACADA Chairperson and board Members indicated that only two funded groups were later deregistered. These were Coast Rural Development Organization deregistered in December 2014 and Community of Mercy Organization in 2010. They further reported that:-

- a. Coast Rural Development Organization had received Kshs. 343,000 and Community of Mercy Development Organization Kshs. 402,500.
- b. NACADA and the Fund Management Agency undertook pre-disbursement assessment of all approved organizations to establish their capacity to undertake the project and account for the funds. This included confirming their registration status and taking record of all registration details.
- c. From the pre-disbursement assessment and review of registration certificates, both Coastal Rural Development Organization and Community of Mercy Development Organization were registered at the time the funds were disbursed. The disbursement of funds to Coastal Rural Development Organization was made in November 2013 this was before the reported deregistration of the organization in December 2014.
- d. The two organizations acknowledged receipt of funds and had accounted for the funds disbursed to them under the programme.
- (iii) On alleged irregularities in the disbursement of funds to Civil Society groups by NACADA. The Board responded that it did not find any irregularities in the disbursement of funds. A summary of the disbursement is as follows:
 - a. NACADA forwarded to the Fund Management Agency (Ernest & Young) 134 organizations for funding. The total cost of the proposals submitted for funding was Kshs. 118 million. The number was reduced to 130 as 4 of the

organizations did not pass the capacity assessment test. The amount to be disbursed was reduced to fit within the approved budget of Kshs. 99 million.

- b. As at 31st May 2015, NACADA had forwarded Kshs. 94,911,561.50 to the Fund Management Agency.
- c. From reviewed documents including Bank transfer certificates and acknowledgement letters from the CSOs, the Fund Management Agency has at 31st May 2015 disbursed to the CSOs Kshs. 91,891,839.40.
- d. Fund balance held by the FMA was Kshs. 3,019,722.10 as at 31st May 2015. The fund balance held by NACADA is Kshs. 4,088,438.50.
- e. The interest income earned on the disbursement funds which are managed through an interest earning account was Kshs. 565,610.69 as at 31st May 2015. The bank charges incurred on the account are Kshs. 181,691.58 as at 31st May 2015 which is usually set off against the interest income earned on the account.
- f. Accrued net interest of Bank charges of Kshs. 326,440.40 was paid to NACADA on 8th December 2014. Net interest outstanding in the Fund Management Agency account is Kshs. 57,478.71 as at 31st May 2015.
- g. Of the funds disbursed, 88% of the money has been accounted for by the CSOs.

The NACADA Board concluded that there was no evidence of loss of funds in the disbursement of funds to Civil Society Organizations. The Chairperson also informed the Committee that the Authority was only mandated to campaign against Alcohol and Drug abuse and not to control the vice. He requested the Committee to consider proposing an amendment to the NACADA Act to empower the Authority to control the Alcohol and Drug abuse problem.

Committee Observations

The Committee made the following observations:-

- (i) NACADA was under performing due to wrangles and uneasiness within the board, as witnessed in the meeting through counter accusations from the Chairperson, Vice Chairperson and the Chief Executive Officer.
- (ii) 2.5 million Kenyans addicted to alcohol and narcotics are suffering and required rehabilitation. However there are no adequate rehabilitation centres in the Country to cater for the demand of the addicts.
- (iii) The Cabinet Secretary for Interior and Coordination of National Government was yet to gazette regulations on control of alcohol quality and treatment and rehabilitation of addicts.

(iv) NACADA may have violated public procurement rules in the procurement of media services from Kenya Broadcasting Corporation and other media organizations, amounting to Ksh. 47 million, without any tendering process.

Committees Resolutions

The Committee made the following resolutions:-

- (i) That the NACADA Chief Executive Officer avails the board minutes of 18th, 23rd and 29th June 2015 and any other relevant documentation that may assist the Committee in carrying out further investigations on the matter.
- (ii) To invite the Executive Director, Non-Governmental Organizations Coordination Board and the Director General Public Procurement Oversight Authority to shed light on the alleged of embezzlement of funds at the National Authority for the Campaign Against Alcohol and Drug Abuse.

The Chairperson also informed the Committee that the Authority was only mandated to campaign against Alcohol and Drug abuse and not to control the vice. He requested the Committee to consider proposing an amendment to the NACADA Act to empower the Authority to control the Alcohol and Drug abuse problem.

Committee Observations

The Committee made the following observations:-

- (i) NACADA was under performing due to wrangles and uneasiness within the board, as witnessed in the meeting through counter accusations from the Chairperson, Vice Chairperson and the Chief Executive Officer.
- (ii) 2.5 million Kenyans addicted to alcohol and narcotics are suffering and required rehabilitation. However there are no adequate rehabilitation centres in the Country to cater for the demand of the addicts.
- (iii) The Cabinet Secretary for Interior and Coordination of National Government was yet to gazette regulations on control of alcohol quality and treatment and rehabilitation of addicts.

(iv) NACADA may have violated public procurement rules in the procurement of media services from Kenya Broadcasting Corporation and other media organizations, amounting to Ksh. 47 million, without any tendering process.

Committees Resolutions

The Committee made the following resolutions:-

- (i) That the NACADA Chief Executive Officer avails the board minutes of 18th, 23rd and 29th June 2015 and any other relevant documentation that may assist the Committee in carrying out further investigations on the matter.
- (ii) To invite the Executive Director, Non-Governmental Organizations Coordination Board and the Director General Public Procurement Oversight Authority to shed light on the alleged of embezzlement of funds at the National Authority for the Campaign Against Alcohol and Drug Abuse.

REPORT OF THE NACADA BOARD OF DIRECTORS ON FUNDING TO CIVIL SOCIETY ORGANIZATIONS

Presented to the Departmental Committee on Administration and National Security on 9th
July 2015

1. INTRODUCTION

The Authority on 3rd July 2015 received a letter from the Clerk of the National Assembly reporting the resolution of the Departmental Committee on Administration and National Security to invite the NACADA Board of Directors to a meeting to deliberate on the following issues:-

- i) Allegations of embezzlement of funds set aside for the anti-drug use campaign
- ii) Alleged funding of non-existing or deregistered NGOs
- iii) Alleged irregularities in the disbursement of funds to Civil Society groups by NACADA

2. RESPONSE

The NACADA Board of Directors responds as follows:-

i) Allegations of embezzlement of funds set aside for the anti-drug use campaign

The Board has no evidence on embezzlement of funds set aside for the campaign.

However, the Chairman of the Board on 9th June 2015 received a letter from the NGO Coordination Board alleging irregularities in funding of Civil Society organizations (Appendix 1). In the letter signed by the Executive Director Mr. Mahamed Fazul who is a former member of the NACADA Board, he alleged that the Authority had funded unregistered/deregistered organizations leading to loss of funds.

On receipt of the letter during its Board meeting held on 9th June 2015, the Board formed an Adhoc Committee consisting of members of the Audit and Finance Committees of the Board to investigate the matter.

The Committee met on three occasions – 18th, 23rd and 29th June 2015. During its three meetings, the Ad Hoc Committee reviewed the following documents:-

- a) Management's Response to the letter from NGO Coordination Board
- b) Legal and institutional framework for the CSOs funding programme
- c) Reports and oral presentations by the Fund Management Agency (FMA) charged with disbursing funds Ernst & Young
- d) The Monitoring and evaluation framework put in place by NACADA and the FMA
- e) Disbursement status report by the FMA Appendix 2
- f) List of funded organizations and their registration details Appendix 3
- g) NACADA funding instruction to the FMA Appendix 4

h) Copies of CSOs registration and certificates, FMA's funds transfer instructions to CSO's Banks, RTGS confirmations from the Fund Management Agency's Bank and CSOs Bank statements and confirmation of receipt of funds – File A, B, C & D.

Upon review of the matter, the Committee concluded that so far, there is no evidence of loss of funds as monies forwarded to the FMA by NACADA had been disbursed and received by the Civil Society Organizations whose projects are still on-going.

ii) Alleged funding of non-existing or deregistered NGOs

The Board confirmed that all funded organizations at the time of approval and assessment provided evidence of registration. Majority of these were registered as Self Help Groups/Community Based Organizations registered by the Ministry of Gender, Children and Social Services.

The NGO Coordination Board had claimed that it could not establish the registration status of 86 organizations. This is because out of the 130 organizations funded, only 35 are registered by them as Non-Governmental Organizations — **Appendix 3**. The rest are registered by other Government bodies as follows:-

- CBO/Self Help -75
- Society -9
- Association/Incorporated -4
- Company -4
- Club -1
- Charitable -1
- University -1

From the NGO Coordination Board's letter of 9th June 2015, only two NGOs funded are said to be deregistered. Coast Rural Development Organization deregistered in December 2014 and Community of Mercy Organization in 2010. NACADA reports that:-

- a) The two organizations were funded under the project. Coast Rural Development Organization has received KES 343,000 and Community of Mercy Development Organization KES 402,500 (Appendix 5)
- b) NACADA and the FMA undertook pre-disbursement assessment of all approved organizations to establish their capacity to undertake the project and account for the funds. This included confirming their registration status and taking record of the registration details.
- c) From the pre-disbursement assessment and review of registration certificates, both Coastal Rural Development Organization and Community of Mercy Development Organization had been registered as Non-Governmental Organizations as per their certificates (Appendix 6)
- d) The disbursement to Coastal Rural Development Organization was made in November 2013 this was before the reported deregistration of the organization in December 2014.
- e) The two organizations in question acknowledged receipt of funds and have accounted for the funds disbursed to them under the programme (Appendix 7).

iii) Alleged irregularities in the disbursement of funds to Civil Society groups by NACADA

The Board did not find evidence of any irregularities in the disbursement of funds. A summary of the disbursement is as follows:-

a) NACADA forwarded to the Fund Management Agency (Ernest & Young) 134 organizations for funding. The total cost of the proposals submitted for funding was KES 118million. The number was reduced to 130 as 4 of the organizations did not pass the capacity assessment test. In addition, the amount to be disbursed was reduced to fit within the approved budget of KES 99million

b) As of 31st May 2015, NACADA had forwarded KES 94,911,561.50 to the FMA (Appendix 4)

c) From reviewed documents including Bank transfer certificates and acknowledgement letters from the CSOs, the FMA has as at 31st May 2015 disbursed to the CSOs 91,891,839.40 (Appendix 2)

d) Fund balance held by the FMA was KES 3,019,722.10 as at 31st May 2015. The Fund balance held by NACADA is KES 4,088,438.50

e) The interest income earned on the disbursement funds which are managed through an interest earning account was KES 565,610.69 as at 31st May 2015. The Bank charges incurred on the account are KES 181,691.58 as at 31st May 2015 which is usually set off against the interest income earned on the account

f) Accrued net interest of Bank charges of KES 326,440.40 was paid to NACADA on 8th December 2014. Net interest outstanding in the FMA account is KES 57,478.71 as at 31st May 2015

g) Of the funds disbursed, 88% of the money disbursed has been accounted for by the CSOs.

3. CONCLUSION

So far, there is no evidence of loss of funds in the disbursement of funds to Civil Society Organizations.

However, NACADA is open to an audit by an external body to ascertain loss of funds in disbursement of the funds in line with Article 229 (6) which provides that "an audit report shall confirm whether or not public money has been applied lawfully and in an effective way".

Re: CONDUCTING DUE DILIGENCE AND LOSS OF FUNDS TO NGOS BY NACADA

I write with reference to the above captioned subject matter and further to our letter to you dated March 26, 2015 and your letter dated May 27 but received at the Board in June 4, 2015.

The NGOs Co-ordination Board (hereinafter the Board) in its letter referred to hereinabove was categorical on the need for NACADA to conduct due diligence with the Board before partnering or advancing any funds to NGOs. The Board proceeded to warn NACADA of the dangers it faced by funding NGOs without verifying with the Regulator their legal and compliance status.

From NACADA's letter also referred to hereinabove, NACADA is purporting to conduct due diligence after it has advanced and lost funds to phantom organizations. In fact, from the list of NGOs NACADA has filed, the Board has ascertained that:

- Out of the one hundred and nineteen (119) organizations funded by NACADA, only 14 organizations registered by the Board have accurately disclosed the funds received totaling KES 13,933,175;
- 2. Two (2) organizations; Coast Rural Development Organization and Community of Development Organization, which received KES 745,500, had long been deregistered;
- 3. Even though from NACADA records, it is claimed that KES 10,671,447.50 was advanced to eleven (11) organizations, however the records at the Board reflect that none of them received any funding from NACADA;

4. Six (6) organizations declared funds in excess of what was received from NACADA which points to other possible sources of funding;

Other than the organizations listed hereinabove, which are 33 in number, the Board cannot establish the legal status of the remaining 86 Organizations provided by NACADA.

The NGOs Board as the Government Agency in charge of charity regulations in the country wishes to register great exception and takes umbrage in the manner with which NACADA has opted to finance or partner with illegal/unregistered organizations in total disregard to the Kenyan laws.

TAKE NOTICE THAT funding of illegal and unregistered organizations as is the case with NACADA has not only led to loss of public funds but also pose a serious threat to National security through the diversion of donor aid, potential terrorism financing and money laundering.

From the foregoing, it is our considered opinion that the funds allegedly expended by NACADA to NGOs led to careless and avoidable loss of public funds and therefore did not achieve the intended purpose as enshrined in the NACADA Act, 2010. The Board therefore demands that NACADA should with immediate effect take legal action against all officers involved in these fraudulent and/or negligent acts to avert any further loss of public funds and report to the same to the Board.

I wish to confirm the following.

- 1. Out of the one hundred and nineteen (119) organizations funded by NACADA, only 14 organizations registered by the Board have accurately disclosed the funds received totaling KES 13,933,175; (See Table A, attached)
- 2. Two (2) organizations; Coast Rural Development Organization and Community of Mercy Development Organization which received KES 745,500, had been deregistered; (See Table B, Attached)
- 3. Even though from NACADA records, it is claimed that KES 10,671,447.50 was advanced to eleven (11) organizations, however the records at the Board reflect that (9) nine of them did not receive any funding from NACADA while (2) two of them were underfunded; (See Table C, Attached)
- 4. Six (6) organizations declared funds in excess of what was received from NACADA which points to possible audit queries on the extra source of funding; (See Table D, Attached)

Other than the organizations listed hereinabove, which are 33 in number, the NGOs Coordination Board cannot establish the legal status of the remaining 86 Organizations funded by NACADA.

I hope the above information will enable NACADA make an informed decision to avert further loss of Public Funds.



v) Board's Resolutions

- The Board approved the payments subject to ratification by the National Treasury and the Parent Ministry


COMMITMENT CONTROL DURING THE CLOSURE OF FINANCIAL YEAR 2013/14

I. PURPOSE

1. The purpose of this Circular is to provide guidelines to Ministries, Departments and Agencies (MDAs) on commitment control for the remaining period of FY 2013/14.

II. BACKGROUND

2. The Government recently outlined a number of expenditure control measures which were implemented in FY 2013/14 Supplementary Estimates I across all MDAs. The measures were aimed at eliminating wasteful expenditures in Government and reprioritizing expenditures to emerging needs and capital investment. These included but not limited to:



- (i) Foreign travelling;
- (ii) Training expenses;
- (iii) Total freeze on the purchase of motor vehicles;
- (iv) Curtailing spending on purchase of furniture and fittings;
- (v) Curtailing spending on minor alterations and refurbishment of buildings; and
- (vi)Restricting unnecessary expenditures on publicity and advertising campaigns.
- 3. As we come towards the closure of the FY 2013/14, Accounting Officers should avoid last minute purchases and ensure that no new commitments are entered into. It will only be under exceptional circumstances that the National Treasury will approve the procurement of the above mentioned items. Even under such circumstances, Accounting Officers will be required to write to the Treasury to request for express authority to make such procurements.

III. SPECIFIC GUIDELINES

- 4. We have noted a common trend where Ministries/Departments/Agencies have been engaging in last-minute procurement towards the closure the financial year, just because they want to exhaust the funds allocated to them. This does reflects poor planning in the execution of the budget and often leads to delays in delivery of services and huge carry-overs of unpaid invoices which essentially are portrayed as pending bills in the new financial year.
 - 5. In order to contain the expenditures and commitments to the approved budget, and allow sufficient time for closure of the financial year, all pending tenders for this financial year must be issued by 15th May 2014. In this regard, ALL Tender Committees will remain suspended as from 16th May 30th June 2014 and no new commitments will be made during this period. For those expenditures that strictly relate to essential services which may require to be made after 15th May 2014, authority must be obtained from the National Treasury before commitments are made. Accounting Officers should note that no expenditures should be incurred without due consideration of the value for money aspect



even in cases where there is adequate budgetary provision and/or where the necessa exchanges may have been released.

IV. CONCLUSION

Accounting officers are required to ensure strict adherence to these guidelines and to bring them to the attention of all officers working under them, including Chief Executives of State Corporations and other Semi Autonomous Government Agencies (SAGAs). It is important to note that these guidelines apply to all public agencies which are funded from the Exchequer.

RE: REQUEST FOR POST-FACTO APPROVAL ON COMMITMENTS MADE BETWEEN 15TH MAY AND 30TH JUNE 2014

This is in reference to your letter Ref. No. OP.PA.2/27A dated 25th February, 2015, addressed to the CEO, NACADA and copied to us among others. We also refer to a letter by NACADA, CEO Ref. NACADA.3/1 dated 24th October, 2014 addressed to us and copied to the Cabinet Secretary, Ministry of Interior and Coordination of National Government and the Principal Secretary, State Department of Interior regarding the above subject (See copy attached).

We have noted that the Authority requested for National Treasury's post-facto authority to settle pending bills relating to procurement carried out in Financial Year 2013/14. We also note that the procurements were not carried out in accordance with the provisions of the Public Procurement and Disposal Act 2005 as well as the Regulations 2006. We further note that the Authority has adequate funds to underwrite the pending bills.

We would, however, like to advise the Authority as follows:-

- i) Section 27(2) of the Public Procurement and Disposal Regulations 2006, on procurement approvals states that "No procurement approval shall be made to operate retrospectively to any date earlier than the date on which it was made".
- Section 8 and 10 of the Public Procurement and Disposal Regulations 2006 on the Internal Organization of the Procurement Entities, stipulates and provides details on how the procurement function should be conducted by the procuring entities. This includes involvement of the Procurement Units, Tender Committees' approvals and confirmation of availability of funds for any procurement that is under consideration.
- iii) Notwithstanding the above procurement procedures, there is no provision for Post-Facto authority in any procurement undertaking.
- Printing materials such as tee-shirts, caps, fliers is prohibited by the National Treasury Circular No.17/2013 of 7th December, 2013, under austerity measures.

In light of the above, the National Treasury is not in a position to grant Post-Facto approval to pay the above Pending Bills with all the stated procurement irregularities. This is a case of mis-procurement as the said procurements did not meet the stipulated thresholds, in the Public Procurement process.

The Authority should instead ensure that action is taken against the officers who violated the public procurement procedures in accordance with the Procurement Act, 2005, Article 226(5) of the Constitution and Section 197(1)(h) of the Public Finance Management Act, 2012.

Please take the necessary action accordingly.

Re: POSSIBLE LOSS OF PUBLIC FUNDS TO NGOs BY NACADA

I write with reference to the above captioned subject matter.

The NGOs Co-ordination Board (hereinafter the Board) is established under section 3 of the NGOs Co-ordination Act, 1990 with the mandate to register, co-ordinate and regulate all charitable organizations (popularly known as NGOs) in Kenya.

On 27th May 2015 my office received a letter from NACADA (Copy Attached) requesting to know the compliance and Legal status of 119 NGOs that had been advanced 99 Million by NACADA during the FY 2013-2014 inline with the Alcoholic Drinks Control Act, 2010 to support civil society programs to carry out advocacy against Alcohol and Drug abuse.

Our preliminary investigations into the matter has revealed the following:

1. Out of the one hundred and nineteen (119) Civil Society Groups funded by NACADA, only 33 are registered by the NGOs Coordination Board.

(

- Out of the 33 organizations registered by the Board, only 14 organizations have accurately disclosed the funds received totaling KES 13,933,175; (See Table A, attached)
- 3. Two (2) organizations; Coast Rural Development Organization and Community of Mercy Development Organization, which received KES 745,500, had been deregistered; (See Table B, attached)
- 4. Even though from NACADA records, it is claimed that KES 10,671,447.50 was advanced to eleven (11) organizations, however the records at the Board reflect that none of them received any funding from NACADA; (See Table C, attached)
- 5. Six (6) organizations declared funds in excess of what was received from NACADA which points to other possible sources of funding; (See Table D, attached)

Other than the organizations listed herein above, which are 33 in number, the Board was unable establish the legal status and whether the funds allegedly advanced to them were received by the organizations or not, of the remaining 86 Organizations provided by NACADA.

The purpose of this letter therefore is to request your office to carry out urgent investigations into this matter to ascertain the extent of the problem and take necessary action to avert further possible loss of public funds.

- 3. Even though from NACADA records, it is claimed that KES 10,671,447.50 was advanced to eleven (11) organizations, however the records at the Board reflect that (9) nine of them did not receive any funding from NACADA while (2) two of them were underfunded; (See Table C, Attached)
- 4. Six (6) organizations declared funds in excess of what was received from NACADA which points to possible audit queries on the extra source of funding; (See Table D, Attached)

Other than the organizations listed hereinabove, which are 33 in number, the NGOs Coordination Board cannot establish the legal status of the remaining 86 Organizations funded by NACADA.

Re: CONDUCTING DUE DILIGENCE AND LOSS OF FUNDS TO NGOS BY NACADA

I write with reference to the above captioned subject matter and further to our letter to you dated March 26, 2015 and your letter dated May 27 but received at the Board in June 4, 2015.

The NGOs Co-ordination Board (hereinafter the Board) in its letter referred to hereinabove was categorical on the need for NACADA to conduct due diligence with the Board before partnering or advancing any funds to NGOs. The Board proceeded to warn NACADA of the dangers it faced by funding NGOs without verifying with the Regulator their legal and compliance status.

From NACADA's letter also referred to hereinabove, NACADA is purporting to conduct due diligence after it has advanced and lost funds to phantom organizations. In fact, from the list of NGOs NACADA has filed, the Board has ascertained that:

- Out of the one hundred and nineteen (119) organizations funded by NACADA, only 14 organizations registered by the Board have accurately disclosed the funds received totaling KES 13,933,175;
- 2. Two (2) organizations; Coast Rural Development Organization and Community of Mercy Development Organization, which received KES 745,500, had long been deregistered;
- 3. Even though from NACADA records, it is claimed that KES 10,671,447.50 was advanced to eleven (11) organizations, however the records at the Board reflect that none of them received any funding from NACADA;

4. Six (6) organizations declared funds in excess of what was received from NACADA which points to other possible sources of funding;

Other than the organizations listed hereinabove, which are 33 in number, the Board cannot establish the legal status of the remaining 86 Organizations provided by NACADA.

The NGOs Board as the Government Agency in charge of charity regulations in the country wishes to register great exception and takes umbrage in the manner with which NACADA has opted to finance or partner with illegal/unregistered organizations in total disregard to the Kenyan laws. **TAKE NOTICE THAT** funding of illegal and unregistered organizations as is the case with NACADA has not only led to loss of public funds but also pose a serious threat to National security through the diversion of donor aid, potential terrorism financing and money laundering.

From the foregoing, it is our considered opinion that the funds allegedly expended by NACADA to NGOs led to careless and avoidable loss of public funds and therefore did not achieve the intended purpose as enshrined in the NACADA Act, 2010. The Board therefore demands that NACADA should with immediate effect take legal action against all officers involved in these fraudulent and/or negligent acts to avert any further loss of public funds and report to the same to the Board.

I refer to the above subject matter and further to the Audit queries raised on the same by the Public Procurement Oversight Authority (PPOA) over the noncompliance of the procurement process in total disregard to the Public Procurement and Disposal Act 2005 and the various questions raised by the NGO Coordination Board regarding the legality of the NGOs funded by NACADA respectively that might have led to possible loss of public funds.

In view of the aforementioned and in compliance with Chapter 6 of the Constitution of Kenya on Leadership and Integrity, Executive order No. 6 touching on Ethics and Integrity in the Public Service, and most recently Presidential Directive requiring all public and state officers who have any integrity queries to step aside to pave way for investigations, I hereby suspend you for a period of three (3) months with immediate effect pending investigations by the NACADA Board, the NGO Coordination Board, Ethics and Anti-Corruption Commission (EACC), the Directorate of Criminal Investigations and other relevant Government agencies.



RE: OBSERVATIONS ON PROCESSING OF RESTRICTED TENDER FOR SERVICES FOR MANAGEMENT FUNDING TO CIVIL SOCIETY ORGANIZATIONS. OF NACADA'S

Please refer to your letters Ref. No. NACADA 7/20/3 and Ref. No. NACADA 7/20/14 dated 20th May, 2014. We have reviewed the documents you submitted to us regarding the above subject tender and observed the following:

1. Though the disbursement of Ksh 99,000,000 was approved by the Board of Directors in its meeting of March, 2013, the resultant costs for the disbursement was not budgeted, planned nor approved as required under Section 26 (3) (a) and 26 (6) of the Public Procurement and Disposal Act, 2005 (the Act) which provides that all procurements shall be planned and that the procuring entity shall not commence any procurement procedure until it is satisfied that sufficient funds are set aside. In addition, Regulation 20 (4) of the Public Procurement and Disposal Regulations, 2006 (the principal Regulations) requires that 'a head of department shall submit an annual procurement plan to the accounting officer at least thirty days before the close of each financial year'; this provision was not complied with.




- 2. There was no Purchase Requisition for consultancy raised by the user department contrary to the provisions of Regulation 9 (a) (i) and 22 of the Principal Regulations, 2006.
- 3. Though Terms of Reference were prepared for the consultancy, the procuring entity did not use standard tender document prescribed by PPOA against the provisions of Section 29 (4) of the Act.
- 4. The consultancy was procured through restricted tendering. However, the choice of restricted tender method did not satisfy the requirements of Section 29 (3) (a) and (b) and Section 73 (2) (a), (b) nor (c) of the Act as there are no tender committee minutes which approved the use of the method on any of the grounds. The choice of the method did not satisfy the requirements of Regulation 54 (2) (3) or (4) of the principal Regulations, 2006 on identification of the persons to be invited to participate in restricted tender as seven firms were invited to participate in tender contrary to Regulation 54 (3) which requires a procuring entity to invite tenders from at least ten persons selected from the prequalified list. The seven firms that were invited on 12/11/2012 were: M/s KPMG; M/s Kenya Commercial Bank; M/s SACCO Societies Regulatory Board; M/s Price Waterhouse Coopers; M/s Ernst & Young; M/s Kenya Post Office Savings Bank; and, M/s Deloitte Kenya.
 - 5. The procurement being an RFP required bidders to submit a Technical Proposal and Financial Proposal. The Technical Proposals were opened on 19th December, 2012 by a committee comprised of three officers in accordance with Section 60 (a) of the Act. Minutes were prepared which were signed by all members of the tender opening committee in accordance to Section 60 (8) and (9) of the Act. Three firms whose bids were opened included M/s Ernst & Young; M/s Price Waterhouse Coopers; and, M/s Kenya Post Office Savings Bank. There were no Financial Proposal opening minutes contrary to the requirements of the aforementioned Sections of the Act.
 - 6. The evaluation of the tender was carried out by four officers and an evaluation report was prepared where M/s Price Waterhouse Coopers was ranked 1st after scoring 97 out of 100 marks; 2nd was Ernst & Young who was scored 69 out of 100; and, M/s Kenya Post Office Savings Bank was last after scoring 0 marks. The evaluation criteria had stated that one was to meet the minimum technical score to qualify for further evaluation but the minimum marks were not stated in the document. It was therefore

evaluation committee to recommend M/s Price Waterhouse Coopers and M/s Ernst & Young for financial evaluation as the evaluation and comparison of the tenders was not carried out in accordance with the criteria stated in the bid document with respect to minimum qualifying marks. The statement by the evaluation committee that the two bidders were recommended for further evaluation on the basis of 'Best Fit' as indicated in Clause 4.1.2 of the bid document was misleading as this was not an objective evaluation criteria. Financial evaluation of the tender was carried out contrary to Regulation 16 (7) of the Principal Regulations, 2006.

- 7. Despite the anomalies cited above, the tender committee at its meeting held 21st January, 2013 awarded the tender to M/s Ernst & Young who scored the highest combined (technical and financial) score of 78.30 at Ksh 17,001,540 contrary to the provisions of Section 27 (3) that requires committee members to ensure that the procurement law is adhered to and Regulation 10 (2) (a) of the Principal Regulations that the tender committee has an obligation to review, verify and ascertain that whatever the committee is awarding satisfies the procurement law. It is not clear whether letters of notification of award were issued out to all the candidates who participated in the subject procurement pursuant to Section 67 (2) of the Act.
- 8. Despite the irregularities cited above, the Accounting Officer signed a contract with M/s Ernst & Young at Ksh 17,001,540 on March 2013 contrary to the provisions of Section 27 (2) of the Act which stipulates that the Accounting Officer is primarily responsible to ensure that the procurement law is adhered to.
- 9. With all the anomalies cited above, the procuring entity still went ahead and made payments on various dates such as 8/10/2013; 31/10/2013; 10/12/2013; 07/02/2014; 11/03/2014; 27/03/2014; 15/04/2014; 8/05/2014; etc. totaling to Ksh 13,900,167.35 contrary to the provisions of Section 27 (3) of the Act which states that the staff of procuring entity have obligation to ensure that the procurement law is adhered to.

Conclusion

It is our view that the processing of the subject tender did not satisfy the requirements of the procurement law and the consequent contract entered between the parties and the payments made were irregular.
