BACKGROUND

- 1. Section 12(1) of the Competition Act No.12 of 2010 creates the office of the Director General of the Competition Authority of Kenya and states:-
 - 12(1) There shall be a Director-General of the Authority who shall be appointed by the Authority with the approval of Parliament from persons having knowledge and experience in competition matters.
- 2. On 7th December, 2012, the Committee received a letter and the curriculum vitae (Annex 2) from the Permanent Secretary in the Ministry of Finance requesting parliament to approve Mr. Francis Wango'mbe Kariuki as the Director General of the Competition Authority of Kenya pursuant to the provisions of section 12(1) of the Competition Act, No. 12 of 2010. In his letter, he indicated that the recruitment exercise of the Director General was competitively done by the Board of the authority. The Best candidate (Mr. Francis Wango'mbe Kariuki) was thereafter picked for the job subject to parliamentary approval.
- 3. Section 12(1) of the Competition Authority Act, 2012 spells out the qualifications an individual should have for him/her to be eligible for appointment as the Director General of the Authority.
- 4. The tenure and terms of office of the Authority's Director General are provided in section 12(2) of the Competition Act No.12 of 2010.
 - 12(2) The Director-General shall hold office on such terms and conditions of employment as the Authority may determine in the instrument of appointment or otherwise in writing from time to time:
 - Provided that the Director —General shall hold office for a renewable term of five years, subject to a maximum of two terms.
- 5. Section 12(3) of the Competition Acf provides that the Director General shall be the Chief Executive Officer of the authority and shall be responsible for the day to day running of the authority.

CONSIDERATION OF MR. FRANCIS WANGO'MBE KARIUKI FOR APPROVAL FOR APPOINTMENT AS A DIRECTOR-GENERAL OF THE COMPETITION AUTHORITY OF KENYA

- 6. At a meeting held on 13th December, 2012, the Committee examined the nominee against the criteria set out in the Public Appointments (Parliamentary Approval) Act, 2010.
- 7. The Committee having considered the curriculum vitae of Mr. Francis Wango mbe Kariuki, and having heard his submissions during the interview, made the following observations on his nomination for appointment as the Director General of the Competition Authority:
 - i). Mr. Francis Wango'mbe Kariuki is a Kenyan citizen born on 24th July 1969 in Meru County.
 - ii). He holds a Masters degree in Economic Regulation and Competition from City University, London (2003), and a Bachelor of Arts in Economics and Business Studies from Kenyatta University (1991).
 - iii). He has a wide range of experience in business regulatory matters having worked as the Ag. Director General of the Competition Authority of Kenya from August 2011 to date; headed the monopolies and prices Commission from November 2007 to August 2011; and worked in various capacities in the Monopolies and Prices Commission from 1992 to 2007.
 - iv). He is a member of the Network Reformers- under the world Bank.
