FOREWORD

- i) Parliament acts as the watchdog of the people in governance of the Republic and plays a critical role in the affairs of the Republic. The constitutional mandate of Parliament can only be effectively and efficiently executed with the availability of adequate resources to champion Parliament's programmes and activities as outlined in the Parliamentary Service Strategic Plan.
- ii) The Constitution of Kenya establishes the Parliamentary Service Commission under section 127 with a broad mandate which includes providing services and facilities to ensure efficient and effective functioning of parliament. The commission under section 127 (6C) of the constitution is responsible for preparing annual estimates of expenditure of the Parliamentary Service and submitting them to the National Assembly for approval.
- iii) Consequently, the Recurrent Estimates for the fiscal year 2011/2012 (which also contains MTEF projections for Fiscal Years 2012/2013 to 2013/2014) that the Commission now presents to the House, have been arrived at in accordance with the provisions of the Constitution and the Parliamentary Service Act, 2000. The gross Recurrent estimates for financial year 2011/2012 will be Kshs.6,500,000,000.

The total Recurrent estimates for the 2011/2012- 2012/13-14 MTEF period are Kshs.28,895,676,658 which I now lay on the Table of the National Assembly and request that they be considered and approved in accordance with section 127(6C) of the constitution.

Parliament now has Development vote (D29) for its capital expenditures. The Development Estimates for the fiscal year 2011/2012 (which also contains MTEF projections for Fiscal Years 2012/2013 to 2013/2014) that the Commission now presents to the House, have been arrived at in accordance with the provisions of the Constitution and the Parliamentary Service Act, 2000. The net Development estimates for Financial year 2011/2012 will be Kshs.2,420,000,000.

The total Development Estimates for 2011/2012- 2012/13-14 MTEF period are Kshs.9,132,500,000 which I now lay on the Table of the National Assembly and request that they be considered and approved.

I would therefore like to present and commend the estimates of the National Assembly for the Fiscal Year 2011/2012, as agreed upon by the Commission in accordance with the relevant section of the enabling law.



FOREWORD

- Parliament acts as the watchdog of the people in governance of the Republic and plays a critical role in the affairs of the Republic. The constitutional mandate of Parliament can only be effectively and efficiently executed with the availability of adequate resources to champion Parliament's programmes and activities as outlined in the Parliamentary Service Strategic Plan.
- ii) The Constitution of Kenya establishes the Parliamentary Service Commission under section 127 with a broad mandate which includes providing services and facilities to ensure efficient and effective functioning of parliament. The commission under section 127 (6C) of the constitution is responsible for preparing annual estimates of expenditure of the Parliamentary Service and submitting them to the National Assembly for approval.
- iii) Consequently, the Recurrent Estimates for the fiscal year 2011/2012 (which also contains MTEF projections for Fiscal Years 2012/2013 to 2013/2014) that the Commission now presents to the House, have been arrived at in accordance with the provisions of the Constitution and the Parliamentary Service Act, 2000. The gross Recurrent estimates for financial year 2011/2012 will be Kshs.6,500,000,000.

The total Recurrent estimates for the 2011/2012- 2012/13-14 MTEF period are Kshs.28,895,676,658 which I now lay on the Table of the National Assembly and request that they be considered and approved in accordance with section 127(6C) of the constitution.

iv) Parliament now has Development vote (D29) for its capital expenditures. The **Development Estimates** for the fiscal year 2011/2012 (which also contains MTEF projections for Fiscal Years 2012/2013 to 2013/2014) that the Commission now presents to the House, have been arrived at in accordance with the provisions of the Constitution and the Parliamentary Service Act, 2000. The net Development estimates for Financial year 2011/2012 will be Kshs.2,420,000,000.
