HIGHLIGHTS OF THE FIRST PART OF THE SECOND SESSION-

I. RESUMPTION OF THE HOUSE

The National Assembly resumed its sittings on Tuesday, February 11, 2014 after the December recess and got down to serious legislative agenda. This included consideration of crucial Bills that included the Supplementary Estimates, 2014, and the Division of Revenue Bill, 2014, review and adoption of the Budget Policy Statement, and other Bills which had not been concluded in the last Session.

The National Assembly also passed its Calendar of Regular Sessions, introducing periods of short recess to give Members of Parliament (MPs) some time to visit their constituents. The longer recess periods, comprising of 25 days and above, will allow Members to spend more time in their various Committees scrutinizing various bills or financial documents so as to adhere to different constitutional and statutory deadlines. This is already shaping up to be a busy year, with the heavy workload spread out over a period of 131 sitting days in this Session, as compared to 108 sitting days in the First Session. The Sessional Calendar, as adopted by the House, forms part of this report (Annex I).

II. SPECIAL SITTING OF PARLIAMENT

This was the second joint sitting of the Houses of Parliament since the official opening of the Eleventh Parliament in March 2013. On March 27, 2014 and in keeping with Article 132(1) (b) and (c) of the Constitution, H.E. the President addressed a special sitting of Parliament, and gave a State of the Nation address during which he tabled three reports as follows:

- a) Report on all the measures taken and the progress achieved in the realization of the national values, referred to in Article 10 of the Constitution:
- b) Report on the progress made in fulfilling the International Obligations of the Republic; and
- c) Report on the Nation's security, in accordance with Article 240(7) of the Constitution.

The first report was to provide feedback to Parliament, and the citizens on the progress and achievements by the Government in fostering national values and principles of governance in the country. The report therefore includes measures taken towards this end in public institutions, and the progress made, the challenges encountered during the operationalization of this process, and recommendations on what strategies to incorporate for higher effectiveness.

The Report on International Obligations highlights the status and strength of Kenya's regional and international ties through the ratification of treaties, and accomplishments in fulfilling the ensuing obligations. The report also provides information on the specific treaties and agreements that Kenya is a part of at present.

The Report on the State of National Security touches on the security situation in the country within the last one year, challenges encountered, plus strategies and measures implemented to deal with the ongoing and future security threats.

The Members were able to discuss content of the first report during debate on the President's speech, while the other two reports will be prioritized for debate by the House during the second part of the second Session.

III. PARLIAMENTARY BUSINESS

Standing Order 171 gives the House Business Committee the mandate to prepare the Parliamentary Calendar, monitor and oversee implementation of House Business, as well as programme business in the House, among the functions. In the first part of this Second Session, the House Business Committee held a total of ten (10) sittings to schedule the business before the House. The following is a highlight of what the House has considered during this period under review.

A. BILLS


As part of its legislative mandate, the House has considered a total of forty five Bills which are at different stages before the House as detailed in **Annex II.**

Of particular interest is the Marriage Bill, 2013, the National Police Service (Amendment) Bill, 2013, and the National Flag, Emblems and Names (Amendment) Bill, 2013 (National Assembly Bill), which elicited a lot of public participation and heated debate in the House.


Below is a snapshot of the stages of the various Bills:

In addition, the figure below shows a representation of the origin of the various Bills that have come before the House for deliberation:





As is evident, the Members of the National Assembly are exercising their constitutional mandate fully by introducing a number of legislative proposals in the House, with these being equivalent to Bills originating from the Executive.

So far, in this part of the Session, the President has only refused to assent to two Bills as passed by the National Assembly, that is, the Insurance (Amendment) Bill, 2013, and the National Flag, Emblems and Names (Amendment) Bill, 2013. As stipulated in Article 115 of the Constitution and provisions of Standing Order 154, the President's reservations on the Bills have been referred back to the National Assembly with accompanying memoranda for further consideration. The Insurance (Amendment) Bill, 2013 has since been assented to.

In the previous Session, the Standing Orders were amended to ensure that all Bills began in the last Session do not lapse in the next Session. As such, pursuant to Standing Order 141, priority will be given to Bills began in the last Session (2013) to ensure that they are concluded with expeditiously as the life of bills was only extended by one Session.

B. MOTIONS

During the period under review, a total of fifty six (56) Motions have been submitted to the House, of which twenty two (22) motions were from individual Members, as detailed in **Annex III.**


However, an increased number of Bills submitted by individual Members in the current Session has led to these legislative proposals being given priority on Wednesday mornings. As such, no individual Members' motions have been debated and concluded. More innovative means of slotting the motions for debate may need to be considered, perhaps either setting aside another time for disposal of Members' motions, or alternating more frequently with debate on Bills.

During the period under review, only one motion was negatived, that is, the one on the Report of the Joint Sittings of the Departmental Committees on Administration & National Security and Defence & Foreign Relations on the Inquiry into the Terrorist Attacks at the Westgate Mall, and other Terror Attacks in Mandera and Kilifi. A few other motions were deferred or withdrawn for further consultations and deliberations at a later date.

C. PETITIONS

During the period under review, a total of eight (8) Petitions were presented and are pending before relevant parliamentary committees. The number of petitions is increasing as the Members feel more comfortable in using this form of presenting issues from their constituents or other Kenyans in the House.


D. STATEMENTS

A total of two hundred and nineteen (219) statements have been processed out of which one hundred and thirty (130) have been requested, thirty two (32) concluded, fifty nine (59) approved and awaiting placement on the Order Paper, and the remainder awaiting approval. This has occurred within ten weeks of sittings, whereas almost double this number of statements was requested in the entire last Session.

The number of statements requested by Members to the Leader of the Majority Party and the various Chairpersons has continued to rise weekly. The Procedure and House Rules Committee is currently in the process of considering options on how to better manage this process to

ensure Members do not remain frustrated when unable to seek answers or receive responses to matters arising in their local areas or even nationally.

E. VETTING AND APPROVAL OF APPOINTEES TO PUBLIC OFFICES

In accordance with the Constitution, the House vetted the following for appointment to the offices indicated:-

- i. Chairperson and Members of the Kenya National Commission on Human Rights;
- ii. Member of the National Gender and Equality Commission;
- iii. Two non-members to the Parliamentary Service Commission.

The House approved the nominees in concurrence with the different Committees, with only one rejection of a nominee to the National Gender and Equality Commission.

F. COMMITTEE REPORTS

During the period under review, Committees have continued to exercise their mandates. So far, a total of twenty seven (27) reports on diverse subject matters have been tabled. Reports relating to matters other than bills are eighteen (18) as detailed in **Annex IV**.

Some of the Committee reports that have been considered and adopted, include:

i. The Report of the Committee on Regional Integration which was a consideration of the East African Community Cross Border Legal Practice Bill, 2014; the East African Community Integration (Education) Bill, 2014; and the East African Community Cooperative Societies Bill, 2014 forwarded by the East African Legislative Assembly (EALA).

Standing Orders 212 and 251 stipulate that the Committee on Regional Integration in the National Assembly will review and report on Bills or other records of relevant debates received from EALA. The National Assembly therefore received communication from EALA on the three Bills for consideration, and adopted the Committee's report with its subsequent recommendations on improving these bills. The effect of adopting this report will allow for these Bills to be amended as they will eventually be effected throughout the East African Community member states.

ii. The Report of the Departmental Committee on Transport, Public Works and Housing on the consideration of Bilateral Air Services Agreements between the Government of the Republic of Kenya and the Government of the Republic of Angola; Mozambique; the Government of Canada and the State of Kuwait.

This report was adopted pursuant to Section 8 of the Treaty Making and Ratification Act, 2012, and in essence allows for air services agreements between the Kenyan Government and those of the State of Kuwait, and the Governments of Canada, Angola, and Mozambique. These treaties enable scheduled air carriers to operate between territories, allow facilitation of trade between States, create cooperation arrangements between States' competition authorities thus facilitating alliances between Kenyan and other State carriers, and create market access between Kenya and other States.

iii. The Public Accounts Committee report on the accounts of the Auditor-General for the financial years 2008/2009 and 2009/2010.

Pursuant to Article 203(3) of the Constitution, these accounts, as approved by the National Assembly, are supposed to form the basis for figures in the Division of Revenue Bill each year. As such, it is crucial for this report to be concluded each year to enable the Government to use accurate information in its forecasting and budgeting.

Other Committee reports that have been tabled in the House but not discussed include:

- i. The Report of the Select Committee on all matters relating to Khat (*Miraa*) which makes recommendations on how to handle the economic and social aspects of this crop in the country.
- ii. The Public Investments Committee Special Report on the procurement and financing of the construction of the Standard Gauge Railway from Mombasa to Nairobi (Phase I) and Nairobi to Malaba/Kisumu (Phase II). The Departmental Committee on Transport, Public Works and Housing had also prepared a report arising out of a statement requested by a Member on the same matter.
- iii. The Report of the Joint Committee on Energy, Communications and Information and Education, Research and Technology on the status of the San Marco Space Application Centre in Malindi, regarding the bilateral agreement between Kenya and Italy on the management of this centre.
- iv. The Report of the Departmental Committee on Health on the Devolution of Health Services, focusing on implementation challenges in the health sector, and proposed recommendations on how to handle the devolution of health services.
- v. The Report of the Public Accounts Committee on the Hire of an Aircraft for the Deputy President for a tour of Four African Nations in May, 2013 (The "Hustler's Jet" Inquiry).
- vi. The Report of the Joint Committee on Budget & Appropriations and Finance, Planning & Trade on settlement of foreign court judgements against the Government of Kenya.

The National Assembly also continues to receive Sessional Papers from the various Ministries on proposed policies for implementation. These are usually tabled and referred to the relevant committees, but the House is yet 10 | Page

to debate and adopt the different Sessional Papers. For the period under review, only one Sessional Paper on National Values and Principles of Covernance has been tabled and is awaiting debate.

G. COMMUNICATIONS FROM THE CHAIR

The Speaker continued to guide the House on various matters through Communications from the Chair pursuant to Standing Order 40. This included issuance of considered rulings on matters arising on the floor of the House. So far the Speaker has issued thirteen (13) communications on various topical issues ranging from procedural matters to the operations and mandates of Committees. The most notable Communications were those regarding:-

- a) The special sitting of Parliament;
- b) Guidance on debate relating to the President's Address;
- c) Consideration of amendments to the Value Added Tax (Amendment) Bill, 2014, and other money bills as defined by Article 114 of the Constitution:
- d) Supplementary guidance on mandate of Audit Committees vis-à-vis Departmental Committees;
- e) Procedure for consideration of delegated legislation; and
- f) Nominees to various state offices, among others.

H. DEPLOYMENT OF KENYA DEFENCE FORCES TO SOUTH SUDAN

Pursuant to Article 240(8)(a) of the Constitution and Section 18 of the Kenya Defence Forces Act (No. 25 of 2012), the Secretary of the National Security Council wrote to Parliament seeking approval for the deployment of troops. The National Assembly approved the deployment of the Kenya Defence Forces in South Sudan for purposes of regional peace support operations.

This was similar to a motion adopted in December 2013 during the First Session, with the difference being that this deployment was international.

It is anticipated that such approvals, as contemplated by the Constitution, will become more regular with the continued interaction of Parliament and

the Executive. This will also involve the expanded role of the Legislature in the ratification of treaties or international agreements.

IV. INTERNATIONAL DESKS, 2014

A. The Inter-Parliamentary Union (IPU)

The IPU facilitates political parliamentary debate, dialogue and cooperation, assisting parliaments and parliamentarians throughout the world to fulfill their mandates. It also assists Parliaments in coping with a growing international agenda, and in contributing a Parliamentary dimension to the work of the United Nations and similar multilateral institutions.

The IPU Assembly is the principle statutory body that expresses the views of the Inter Parliamentary Union on political issues. It brings together problems and study international Parliamentarians to recommendations for action. In March 2014, the IPU held its 130th Assembly and related meetings in Geneva, Switzerland. The most significant occurrence was the appointment of two Members of the Kenyan Parliament to the Bureaux of the Committee on Democracy and Human Rights, and the Committee on United Nations Affairs. The role of these Bureaux, which comprise of members from different regions of the world, among other things, guide the work of the IPU Standing Committees, discuss proposals for agenda items and develop work plans for their respective Committees.

B. The Commonwealth Parliamentary Association (CPA)

The Commonwealth Parliamentary Association (CPA), of which the Parliament of Kenya is a member, is an association of Parliamentarians from the Commonwealth countries. The CPA was formed to promote parliamentary democracy, and enhance governance, respect for individual rights and rule of law. It also facilitates co-operation between the Parliaments and Legislatures represented in it.

In the first part of the Second Session, the CPA only held two seminars. The first one was in March 2014 in Seychelles on the Role of Parliamentarians in the Protection of Human Rights, which was attended by two Members. The



second one, the 25th Commonwealth Parliamentary Seminar, was held in May 2014 in Dar-es-Salaam, Tanzania, and was attended by one Member.

C. The African, Caribbean, Pacific - European Union Assembly (ACP-EU)

The ACP-EU Joint Parliamentary Assembly is one of the organs of joint institutions established under the ACP-EU Partnership Agreement, mostly known as the Cotonou Agreement. The Assembly was created out of a common desire to bring together the representatives of the African, Caribbean and Pacific states that have signed the Cotonou Agreement and the European Parliament.

The ACP-EU brings together more than 320 MPs from the 79 ACP Countries and Members of the European parliament, drawn from the 27 members stated of the EU, commonly referred to as MEPs. The Parliament of Kenya has been a member of the ACP-EU Joint Parliamentary Assembly (JPA) since its inception.

In the period under review, the ACP-EU held two meetings. The first was the 11th Regional Meeting (East Africa) held in Port Louis, Mauritius in February 2014; Kenya was represented by two Members of the National Assembly. The second meeting was the 35th session of the ACP parliamentary Assembly and the 27th Session of the ACP-EU Joint Parliamentary Assembly held in Strasbourg, France in March 2014; Kenya was represented by three Members of Parliament at these sessions.

D. The Pan-African Parliament (PAP)

The Pan-African Parliament (PAP) was established according to the Protocol to the Treaty Establishing the African Economic Community Relating to the Pan-African Parliament (PAP Protocol) as one of the 10 Organs of the African Union. It was inaugurated on 18 March 2004 in Addis Ababa and moved to its current Seat in Midrand, Johannesburg - South Africa.

In the period under review, four Members of Parliament out of the five representing Kenya were sworn in during the plenary session in March 2014; the fifth one had been sworn in last year. There were also committee meetings held during this session. The entire delegation comprises of three Members of the National Assembly, and two Members of the Senate.

V. EMERGING ISSUES

a) Handling of Subsidiary Legislation/Regulations/Statutory Instruments

The handling of these pieces of legislation was clarified through a considered ruling of the Speaker issued on March 26, 2014. This was due to the increased number of such regulations being forwarded to the National Assembly for consideration from various Ministries, in accordance with the Statutory Instruments Act, 2013 and the Standing Orders.

It was highlighted that according to the Statutory Instruments Act, 2013 and Standing Order 210:

- (i) Under section 12 of the Act, every statutory instrument tabled stands referred to the Committee on Delegated Legislation.
- (ii) It is presumed that the House, in delegating the power to make statutory instruments, has already signified its approval of that statutory instrument.
- (iii) As such, The Committee therefore only reports back to the House in the instances where it is desired to annul the whole or part of the statutory instrument. Where there is no desire to annul the whole or any part of a statutory instrument, that resolution is communicated to the Clerk who then communicates to the relevant state department or the authority that published the statutory instrument.
- (iv) The Committee is then obliged to scrutinize the statutory instrument in accordance with the criteria set out in the Act and upon completion of its scrutiny, there is no contemplation of any motion for approval or amendment of the statutory instrument, except for a motion of annulment where the Committee has recommended so.

The National Assembly has received eight pieces of delegated legislation for consideration in this part of the Session. Only one, the Public Finance

Management (Uwezo Fund) Regulations, 2013, has been approved so far.

b) Continuing challenges on the removal of Question Time

This has continued to be an area of concern, despite the guidelines issued by the Speaker on the form and content of Statements requested under Standing Order 44(2)(c). The number of requests continued to rise weekly, with many still pending for request on the floor. This has caused the Members a lot of frustration, especially when the response also takes a while to be issued by the relevant Chairs.

c) Formation of the first Mediation Committee of both Houses

In an unprecedented move, the motion on the County Governments (Amendment) Bill, 2013, was lost at the Second Reading in the National Assembly. The Bill was establishing a County Development Committee comprised of the political leadership of each county. Since this Bill had originated from the Senate, provisions of Standing Order 149 applied. A Mediation Committee was formed, which comprised of three Members drawn from each House. The Committee reviewed the contentious clauses of the Bill, and drafted a proposed compromise version of the Bill for fresh consideration by both Houses. The Committee's report, with the draft bill, was tabled in the National Assembly, but is yet to be debated. This matter will be prioritized upon the resumption of the House.

VI. WHAT'S AHEAD FOR THE NEXT PART OF THE SECOND SESSION

The second part of the Second Session will resume on June 3, 2014 after a recess period of 33 days. The House will be faced with a heavy workload which comprises of the following:

i. Consideration and approval of the Budget Estimates for the 2014/2015 financial year by the second week of June, and passage of the Appropriations Bill, 2014 before the end of June;

ii. The review and passage of eight constitutional bills before August 28, 2014. These Bills are on:

- a) Consumer Protection (Article 46).
- b) Fair Hearing (Article 50).
- c) Fair Administrative Action (Article 47).
- d) Legislation regarding environment (Article 72).
- e) Procurement of public goods and services (Article 227).
- f) Right of persons detained or held in custody (Article 51).
- g) Values and principles of public service (Article 232).

Review of other important bills like:

- a) The Mediation Committee's version of the County Governments (Amendment) Bill, 2013;
- b) The Retirement Benefits (Deputy President & Designated State Officers) Bill, 2013:
- c) The Victim Protection Bill, 2013;
- d) The Mining Bill, 2014; and
- e) The Companies Bill, 2014, among others.

VII. TRANSITION

Towards the end of the long recess period, on Wednesday May 21, 2014, the National Assembly lost a Member due to a sudden illness. The Hon. Joseph Ngugi Nyumu, was a first-time Member for Gatundu South Constituency, actively involved in the Departmental Committee on Education, Research and Technology, as well as the Constitutional Implementation Oversight Committee. He leaves behind a wife and two children.




