

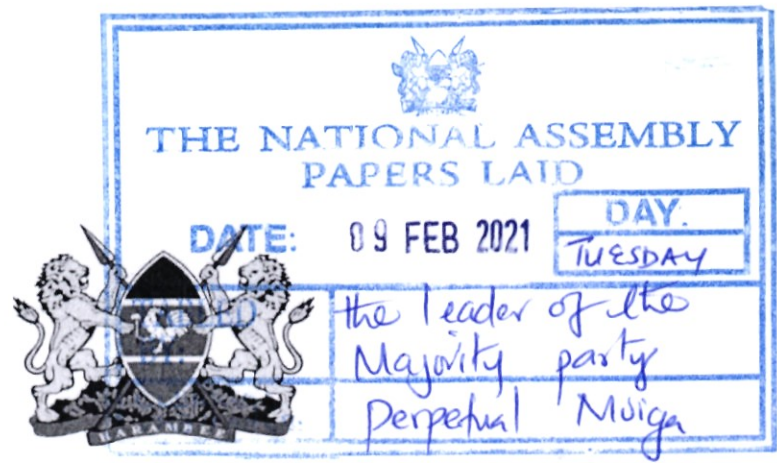

**1. Purpose of the Statutory Instrument**

The purpose of the instrument is to provide the Regulatory Fees and Charges applicable for the operations of Unmanned Aircraft Systems (UAS) in the country. It prescribes the amounts chargeable prior to importation and registration of a UAS, certification of operators and training institutions as well as licensing of UAS Pilots.

## **2. Legislative Context**

The Civil Aviation (Unmanned Aircraft Systems) Regulations 2020 were promulgated on 30<sup>th</sup> March, 2020. Consequently, KCAA has held deliberations with the stakeholders and proposes the applicable fees and charges applicable for provision of services to the general public.

The Civil Aviation Act, 2013 Section 8(1) and Section 35 provides that KCAA may determine, set out and levy rates, charges, dues or fees for any services performed by the Authority, or for use by any person of the facilities provided by the Authority or for the grant, renewal or validation of a licence, permit or certificate.

## **3. Policy Background**

The Civil Aviation Act “provides for control, regulation and orderly development of civil aviation in Kenya”. The Act establishes the Kenya Civil Aviation Authority (KCAA) whose object and purpose is to economically and efficiently plan, develop and manage civil aviation.

UAS are a new component of the global aviation system. Kenya is working towards integrating UAS into its civil aviation regulatory framework. It is Kenya’s policy to promote and facilitate civil aviation activities involving UAS by ensuring there exists a balance between facilitating growth of the UAS industry and recovery by the Authority of the resources it has invested to facilitate the operation and use of UAS in Kenya.

## **4. Consultation Outcome**

Due to the challenges posed by the pandemic and to be compliant with the directives in place dissuading from the holding of public gatherings, the Authority did not hold a meeting to discuss the charges, instead, KCAA advertised and invited for stakeholders to give their input through online platform.

The advertisement as well as a sample of the comments and input received from some stakeholders is attached as **Annex 1**.

The proposed Regulatory Fees and Charges before the stakeholder’s comments and input is attached as **Annex 2**.

The cross cutting proposal from the industry was a request for reduction of the proposed charges.

The Final Regulatory Fees and Charges after the stakeholder's comments and input is attached as **Annex 3**.

## **5. Impact**

KCAA will upon acceding of the Civil Aviation (Regulatory Fees and Charges for Unmanned Aircraft Systems) Regulations, 2020 publish the fees and charges in an Aeronautical Information Circular providing for a period of thirty (30) days before the fees and charges can be applicable. This will afford the general public an opportunity to familiarize themselves with the fees and charges relating to UAS and UAS operation in Kenya.

The fees and charges are expected to have a positive effect on the Authority as a new revenue stream will be created that will enable KCAA enhance its regulatory oversight mandate on UAS operations in Kenya.

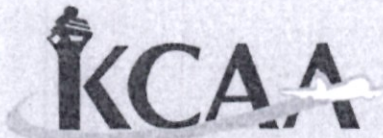
## **6. Monitoring and review**

KCAA shall closely monitor the effects of the UAS fees and charges to ensure that the same are facilitatory and not prohibitive to the growth of the UAS industry in Kenya. During implementation some of the identified areas and events that may warrant review include:

- a) Receipt of request/information from stakeholders regarding the application and/or implementation of the regulation that may enhance safe and secure UAS operations;
- b) Significant change in the size and complexity of the UAS operations in Kenya;
- c) Change in technology that may warrant review of the UAS fees and charges;
- d) Review for purposes of enhancing efficiency of the UAS safety oversight system.

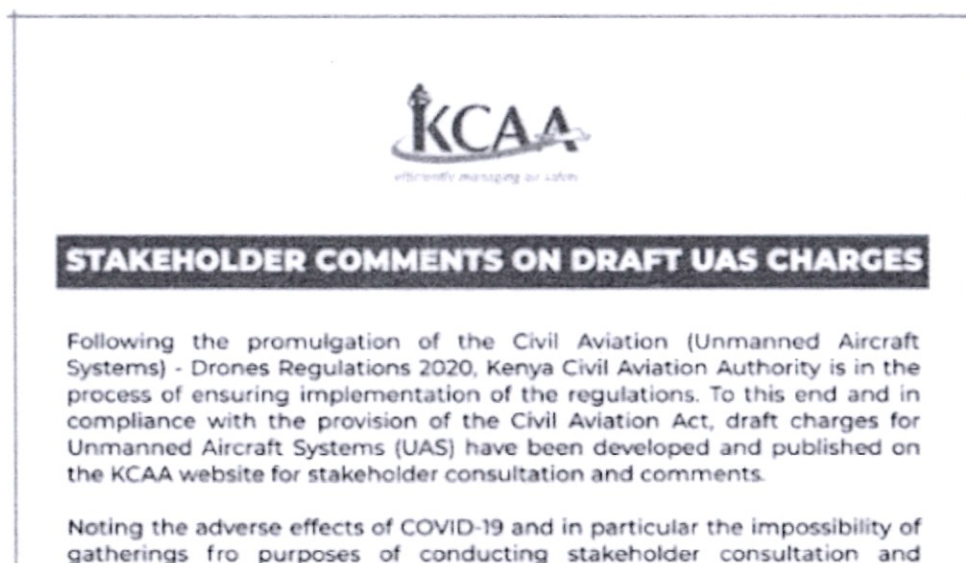

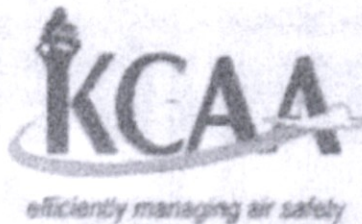
