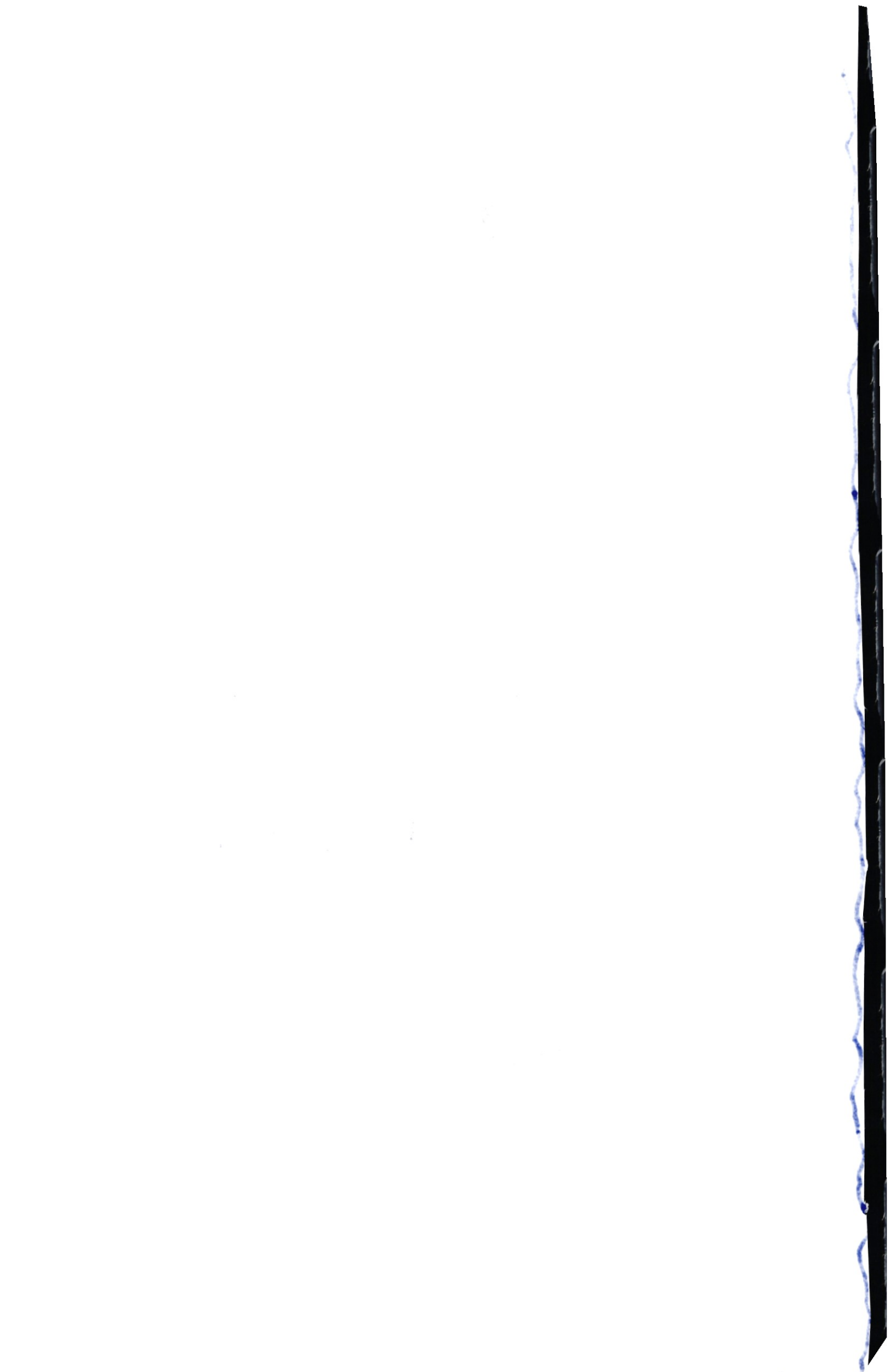

(AMENDMENT) ACT**

**AN ACT of Parliament to amend the Constituencies Development
Fund Act, 2013**

ENACTED by the Parliament of Kenya, as follows—

1. This Act may be cited as the Constituency Development Fund (Amendment) Act, 2013.

Short title

2. The Constituency Development Act (in this Act referred to as “the principal Act” is amended in section 4 by deleting subsection (2) and substituting therefor the following new subsection-

(2) All monies allocated under this Act shall be considered as funds allocated to constituencies pursuant to Article 206 (2) (c) of the Constitution to be administered according to section 5.

3. Section 20 of the principal Act is amended-

section 20 of No
30 of 2013

(a) by deleting subsection (1) and substituting therefor the following new subsection-

(1) The budget ceiling for each constituency shall be—

(a) three quarters of the amount specified in section 4(1) divided equally among all constituencies; and

(b) an amount equal to a quarter of the amount specified in section 4 (1) divided by the national poverty index multiplied by the constituency poverty index.

(b) by deleting the word “joint” appearing in subsection (2);

No. *Constituencies Development Fund (Amendment) Act* 2013

(c) by inserting a new subsection immediately after subsection (3) as follows-

(4) This section shall be deemed to have come into operation beginning with the allocation for the 2013/2014 financial year

Amendment of section 24 of No 30 of 2013

4. Section 24 of the principal Act is amended-

(a) in subsection (2) by deleting the words "and shall serve as the secretary to the Constituency Development Fund Committee" appearing in paragraph (f);

(b) in subsection (3) by inserting the words "and another person to be secretary" immediately after the words "chairperson" appearing in paragraph (d).

(c) in subsection (17) by deleting the words "not exceeding five in number" appearing in the subsection.

Amendment of section 28 of No. 30 of 2013.

5. Section 28 of the principal Act is amended by deleting the words "ten" appearing in subsection (1) and substituting therefor the word "eighteen".

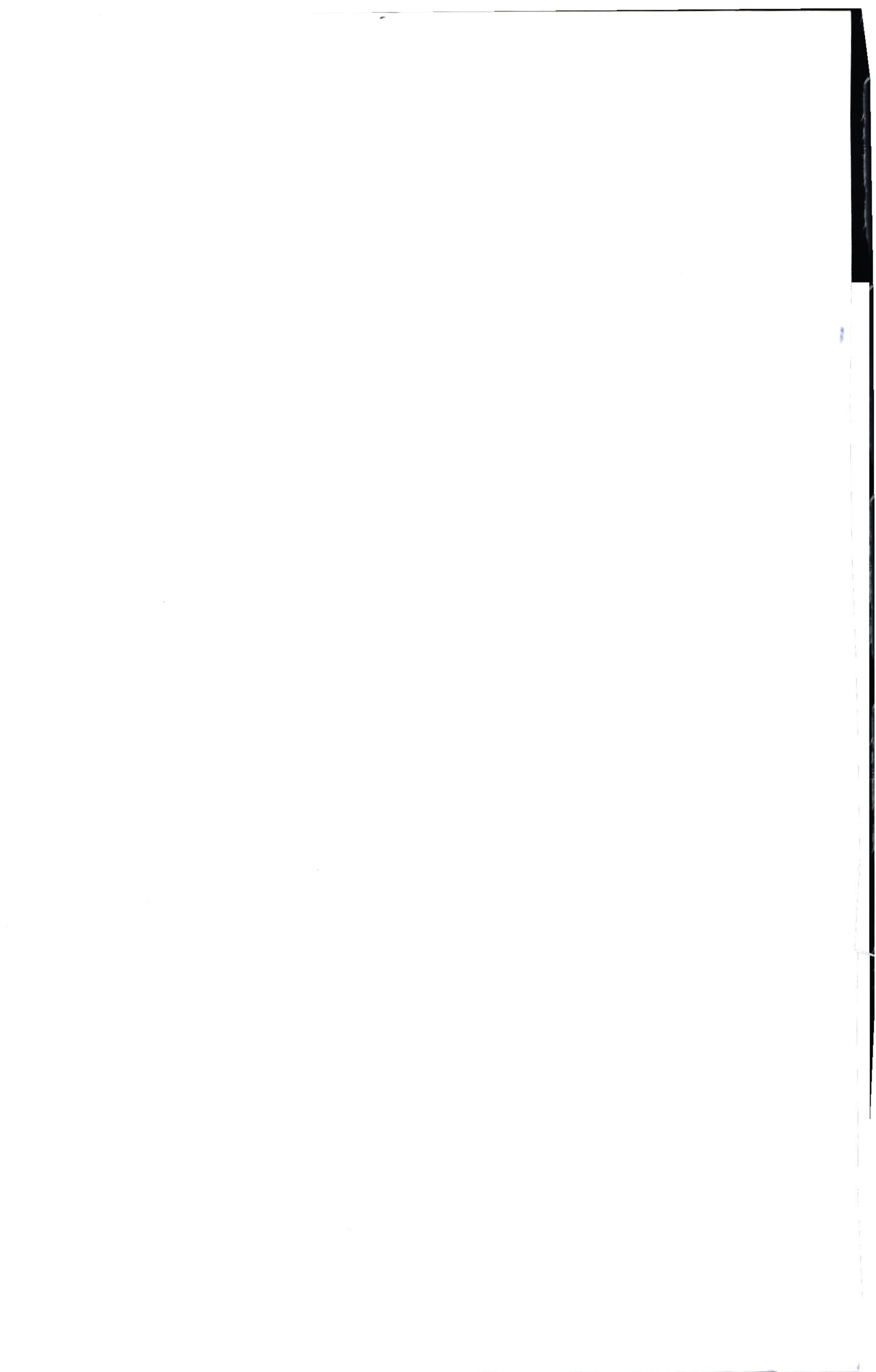


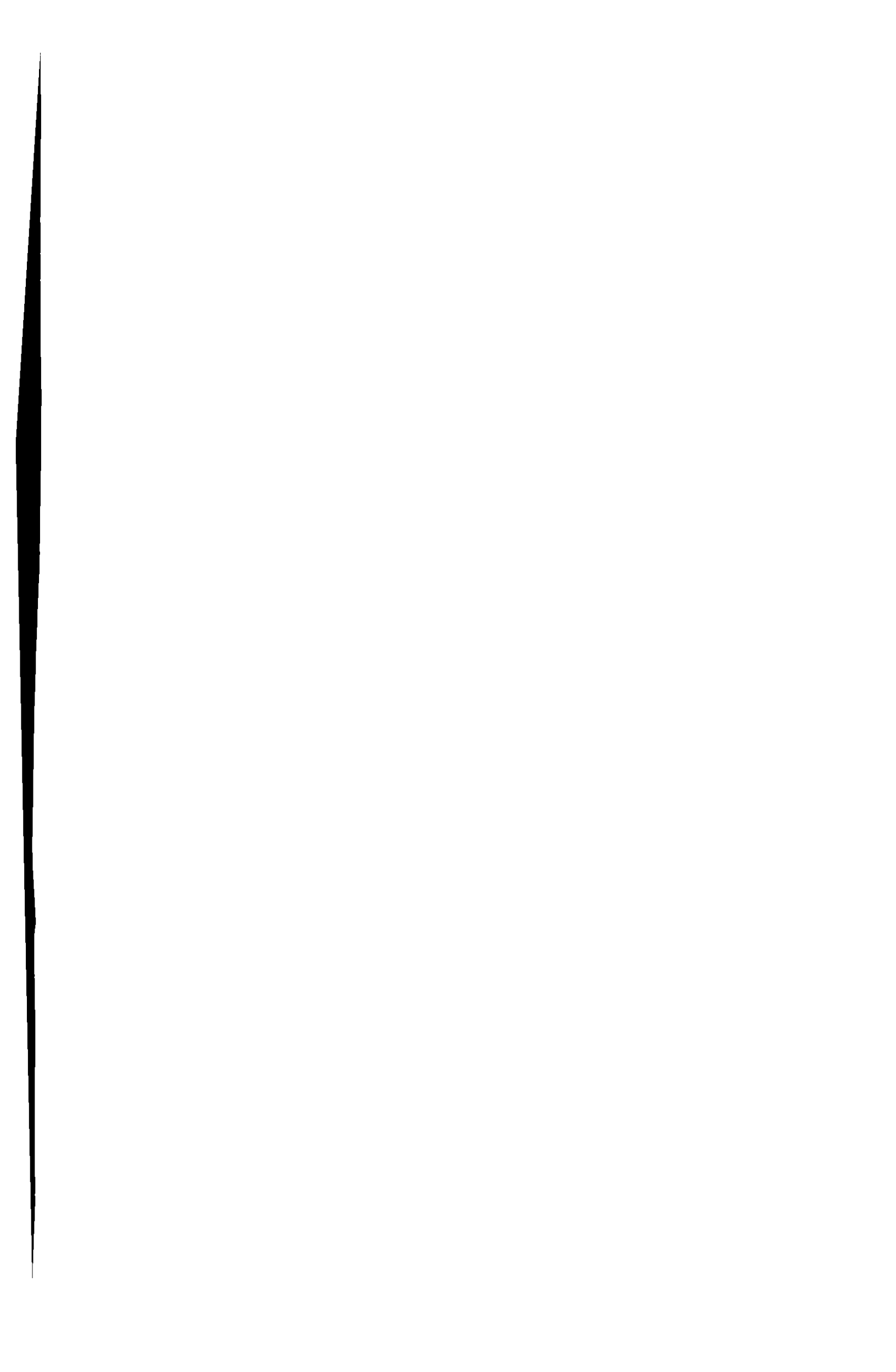
