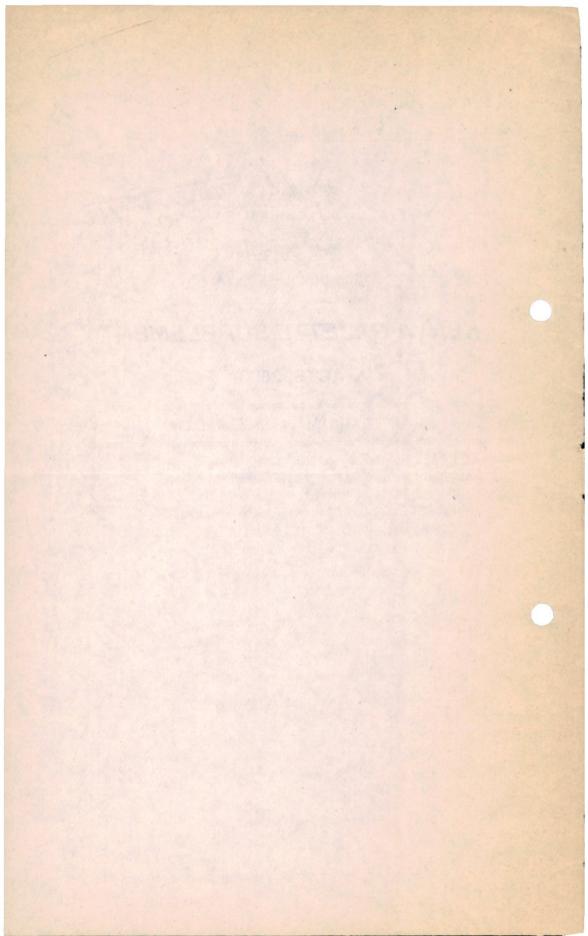

#### THE APPROPRIATION ACT, 2003

No. 7 of 2003

Date of Assent: 10th December, 2003

Date of Commencement: 10th December, 2003

An Act of Parliament to authorize the issue of a sum of money out of the Consolidated Fund and its application towards the service of the year ending on the 30th June, 2004 and to appropriate that sum and a sum voted on the account by the National Assembly for certain public services and purposes

ENACTED by the Parliament of Kenya, as follows:-

1. This Act may be cited as the Appropriation Act, 2003.

Short title.

2. (1) The Treasury may issue out of the Consolidated Fund and apply towards the supply granted for the service of the year ending on the 30th June, 2004, the sum of Kenya Shillings two hundred and eighteen billion, four hundred and thirteen million, thirty-five thousand, eight hundred and thirty, and that sum shall be deemed to have been appropriated as from the 1st July, 2003, for the services and purposes specified in the Schedule.

Issue of KSh. 218,413,035,830 out of the Consolidated Fund for the services of the year ending on the 30th June, 2004 and appropriation of money granted.

- (2) The sum granted out of the Consolidated Fund by subsection (1) includes the sum of Kenya Shillings the hundred and nine billion, two hundred and six illion, five hundred and seventeen thousand, nine hundred and fifteen voted on account by the National Assembly on the 24th June, 2003, in accordance with section 101 of the Constitution of Kenya.
- 3. In addition to the moneys granted by section 2, there may be applied, for the several services and purposes specified in the Schedule, the sums specified in relation thereto in the last column of that Schedule, out of any money directed to be applied as Appropriations in Aid in accordance with section 11 (iii) of the Exchequer and Audit Act.
