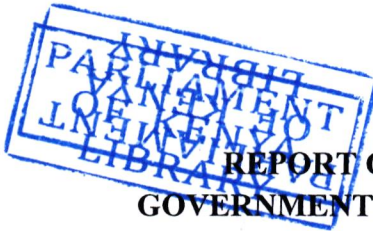

CHAIRPERSONS FOREWORD

Pursuant to Section 50 of the NG-CDF Act of 2015, the Committee is mandated to oversee the policy framework and legislative matters that may arise in relation to the Fund and continually review the framework set out for the efficient delivery of development programmes financed through the Fund.

In view of the above, the Committee resolved to consider the matter of Ksh.4.976 billion arrears that is owed to the Fund by the National Treasury, with a view of deliberating on the reasons as to why the said arrears have been occasioned and determine the modalities of ensuring that the said arrears have been remitted by the National Treasury.

The Committee in its sitting held on 26th May 2021, established a sub committee comprising of the following seven members with a view to expedite on the resolution of the said matter:

The Sub-Committee established that the arrears of Ksh.4.973 billion refers to monies owed to the Fund by the National Treasury from Financial Years 2011/2012,2013/2014 and 2014/2015 non-remittance of the said funds has occasioned delays in completing projects in constituencies, hence denying citizens the enjoyment of the goods and services accruing from the planned projects.

From the analysis that was submitted by the NG-CDF Board on the arrears of Ksh.4.973 billion, it's evident that in Financial year 2011/2012 there is a balance of Ksh.541,750,000,while Financial Year 2013/2014 arrears is Kshs.2,128,500,000 and the arrears for Financial Year 2014/2015 is Kshs. 2,302,946,750 totaling Ksh. **4,973,196,750**.

That, non-remittance of the said funds has negatively impacted implementation of projects in some constituencies such as Mandera West Constituency which has a balance of Ksh. Ksh.72, 133,983 in the Financial Year 2013/2014.

In its deliberations it was established that the said arrears do not require auditing since these funds have not been released by the National Treasury but it has resulted to under financing of planned programmes and projects at the Board Secretariat and in constituencies.

The Committee adopted the findings of the subcommittee as contained in this report that the Committee recommends the National Treasury provides for the Kshs **4,973,196,750** in the next supplementary budget to allow for completion of the planned projects in the affected constituencies.

1.0 PREFACE

1.1 ESTABLISHMENT OF THE COMMITTEE

1. The Select Committee on National Government Constituency Development Fund is established in accordance with the provisions of section 50 of the National Government Constituency Development Fund Act, 2015 and its functions include:
 - a) To oversee the implementation of this Act and in this respect, shall after every two years submit a report to the National Assembly and where necessary, propose any amendments to this Act with respect to the quantum of funds repayable into the Fund in accordance with section 4 of the Act;
 - b) To oversee the policy framework and legislative matters that may arise in relation to the Fund;
 - c) To continually review the framework set out for the efficient delivery of development programmes financed through the Fund;
 - d) To consider and report to the National Assembly, with recommendations, names of persons required to be approved by the National Assembly under this Act; and
 - e) To carry out any other functions relevant to the work of the Fund.

2.0 INTRODUCTION

4. The National Government Constituencies Development Fund (NG-CDF) is established under Section 4 of the NG-CDF Act 2015 as amended in 2016, with an objective of addressing poverty and regional development imbalances by dedicating a minimum of 2.5% of the National Government share of annual revenue as divided by the annual Division of Revenue Act enacted pursuant to Article 218 of the Constitution. The funds are geared towards community driven development projects in every constituency identified and implemented at grassroots level.
5. The Fund is managed by the NG-CDF Board, which is a Body Corporate established pursuant to Sections 14, 15 and 16 of Act. At the constituency level, the day to day management of the Fund is vested on the National Government Constituency Development Fund Committees that are in place in each of the 290 constituencies countrywide.
6. Section 34(1) of the NGCDF Act of 2015 on Basis for budget ceiling for Constituencies provides as follows: The budget ceiling for each constituency shall be the amount specified in section 4(1) divided equally among all constituencies subject to the provisions of section 8(1) and 23(1).
7. Where section 8 (1) of the NGCDF Act provides that a portion of the Fund, equivalent to five per centum (Emergency Reserve) remains unallocated and be available for emergencies that may occur within the Constituency.
8. Additionally, section 7(2) of the NGCDF Act states that: All funds allocated to a constituency shall be cumulative and shall be carried forward from one financial year to the next, including funds returned into the accounts in accordance with section 6(3) or funds which are not utilized for whatever reasons.

Section 6(3) of the NGCDF Act provides as follows: If for any reason a particular project is cancelled or discontinued during the financial year, funds allocated for such a project shall be returned to the Fund and credited to the account of the constituency from which the funds were withdrawn.

9. Section 23(1) of the NGCDF Act on Finances of the Board states that: *“The expenditure for running the Board and related purposes shall be set aside at the beginning of the financial year and not more than five per centum of the total allocation to the Fund in the*

financial year may be used for this purpose, the annual budget of which shall be approved by the Cabinet Secretary with the concurrence of the National Assembly Committee”.

10. Based on the above provisions and confirmation of the approved budgetary provision for the Fund, the Board after setting aside amounts for running the Board allocates the balance of the funds to the Constituencies in equal share.

11. The monies are then released to the Constituencies and the Board Secretariat as received from the National Treasury. In some financial years, the actual receipts have been less than the budgeted amounts resulting to under financing of planned programmes and projects at the Board Secretariat and the Constituencies. Specifically, in the financial years 2011/12, 2013/14 and 2014/15 the difference between the approved budget and actual receipts totalled Kshs. 4.97675 billion which has not been provided for in subsequent budgets.

3.0 ALLOCATION AND RECEIPTS FOR THE FINANCIAL YEARS 2011/2012 TO DATE

12. The Fund’s allocation and receipts relating to financial Years 2011/2012 to date is as tabulated below.

13. In the financial year 2019/2020 an amount totalling Kshs 41.714 billion was allocated but only, Kshs 13.7148 billion was received. This was however provided for in the financial year 2020/2021 and the monies duly received.

4.1 Financial Year 2011/2012

15. The National Government Constituencies Development Fund (NGCDF) was allocated a total of **Kshs 22.978 billion** for the 2011/12 financial year. From the allocation, Kshs 17.515 was normal allocation for 2011/12 financial year; Kshs. 3.663 billion was allocation toward conditional grant while Kshs 1.8 billion was allocation towards previous year's arrears.

16. The Board received a total of Kshs 22,436,250,000 as tabulated below:

- ii. Fifty six (56) constituencies received partial allocation amounting to **Kshs 4,118,352,553** resulting to a balance of **Kshs 487,350,000** (See Annex 1);
- iii. Two hundred nine(209) constituencies received full conditional grant allocation amounting to **Kshs 3,645,557,113;**
- iv. One(1) constituency received partial conditional grant allocation of **Kshs 17,042,857** leaving a balance of Kshs 400,000(See Annex 1);
- v. **Kshs 525,450,000** was disbursed to the Board secretariat; and
- vi. **Kshs 1,746,000,000** was disbursed to constituencies towards previous financial years arrears

19. The Funds were disbursed to the Constituencies and the Board Secretariat as follows:

- i. Two hundred thirty (230) constituencies received full allocation amounting to Kshs 16,595,516,610;
- ii. Seventy (70) constituencies received partial allocation amounting to Kshs 3,249,883,390 leaving a balance of Kshs 2,128,500,000 (See Annex II); and
- iii. Kshs 1,088,100,000 was disbursed to the Board secretariat

20. The Fund was allocated a total of **Kshs.33.213 billion** for the 2014/2015 financial year out of which Kshs 30.91005325 billion was received as follows:

21. The Funds were disbursed to the Constituencies and the Board Secretariat as follows:

- i. One hundred eighty (180) constituencies received full allocation amounting to Kshs 19,381,032,448;
- ii. One hundred ten (110) constituencies received partial allocation amounting to Kshs 9,880,520,802 leaving a balance of Kshs 2,302,946,750. (See Annex III); and
- iii. Kshs 1,648,500,000 was disbursed to the Board secretariat.

22. The Sub- Committee established that, the National Treasury affirmed in a letter dated 1st December, 2020 that, the arrears of ksh. 4.973196750 was not remitted to the NGCDF Board due to revenue under performance.

5.0 COMMITTEE OBSERVATIONS

23. The Committee made the following observations:

- 1) That, the National Treasury did not adhere to Section 4 of the NG-CDF Act of 2015 as amended in 2016, that states a minimum of 2.5% of the National Government share of annual revenue shall be allocated to the NG-CDF, as divided by the annual Division of Revenue Act enacted pursuant to Article 218, with an objective of addressing poverty and regional development imbalances.
- 2) That, non-remittance of the said funds has negatively impacted implementation of projects in some constituencies such as Manderu West Constituency which has a balance of Ksh. Ksh.72, 133,983 in the Financial Year 2013/2014.
- 3) The Sub- Committee established that, the National Treasury affirmed in a letter dated 1st December, 2020 that, the arrears of ksh. 4.973196750 was not remitted to the NGCDF Board due to revenue under performance. *(see annex iv)*
- 4) That, in the Financial Year 2011/12:
 - i. One hundred fifty four (154) constituencies received full allocation amounting to **Kshs 12,383,847,477**.
 - ii. Fifty-six (56) constituencies received partial allocation amounting to **Kshs 4,118,352,553** resulting to a balance of **Kshs 487,350,000** (See Annex 1)
 - iii. Two hundred nine (209) constituencies received full conditional grant allocation amounting to **Kshs 3,645,557,113**.
 - iv. One(1) constituency received partial conditional grant allocation of **Kshs 17,042,857** leaving a balance of **Kshs 400,000**(See Annex 1)
 - v. **Kshs 525,450,000** was disbursed to the Board secretariat.
 - vi. **Kshs 1,746,000,000** was disbursed to constituencies towards previous financial year's arrears.
- 5) That, in the Financial Year 2013/14:
 - a. Two hundred thirty (230) constituencies received full allocation amounting to **Kshs 16,595,516,610**

b. Seventy (70) constituencies received partial allocation amounting to **Kshs 3,249,883,390** leaving a balance of **Kshs 2,128,500,000**

c. **Kshs 1,088,100,000** was disbursed to the Board secretariat

6) That, in the Financial Year 2014/2015:

i. One hundred eighty (180) constituencies received full allocation amounting to **Kshs 19,381,032,448.**

ii. One hundred ten (110) constituencies received partial allocation amounting to **Kshs 9,880,520,802** leaving a balance of **Kshs 2,302,946,750.**

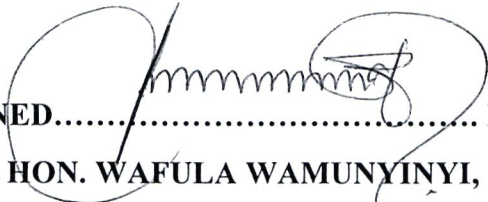

6.0 COMMITTEE RECOMMENDATIONS

24. Arising from its observations the Committee made the following recommendations, THAT:


1) The National Treasury should adhere to Section 4 of the NG-CDF Act of 2015 as amended in 2016, by ensuring that the 2.5% of the National Shareable Revenue has been remitted to NG-CDF within the specified Financial Year.

2) The National Treasury should provide the Kshs 4,973,196,750 being arrears from financial years of 2011/2012, 2013/2014 and 2014/2015 in the next supplementary budget estimates of Financial Year 2021/2022, to allow for completion of the planned projects in the affected constituencies.

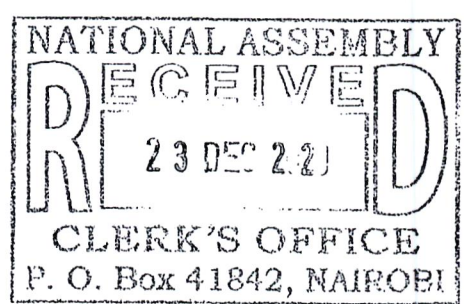

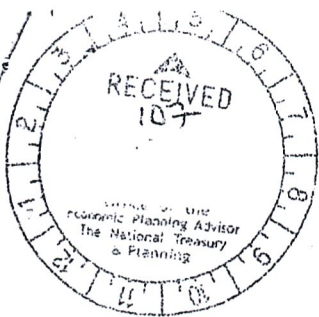

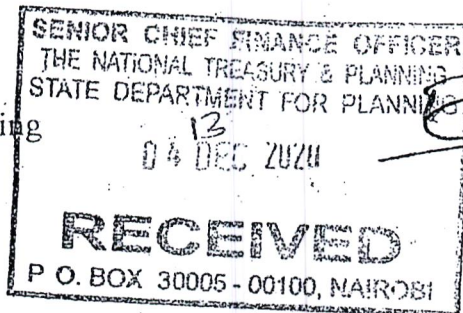

Reference is made to your Letter Ref: No. TNTP/SDP/3/41(51) dated 6th November, 2020 on the above subject matter.

The National Treasury has reviewed your request for additional funding of Kshs.18,691,550,000 to cater for arrears of previous years. We note that the arrears were occasioned by lack of exchequer due to revenue underperformance. Kindly note in accordance to Section 45 of PFMA 2012 an appropriated expenditure lapses at the closure of the financial year. Consequently, the amount being requested is not available unless the same is introduced through the FY 2020/21 Supplementary Estimates. However, the FY 2020/21 Budget Estimates has been formulated under tight fiscal framework with limited scope for additional funding coupled with the effects of Covid-19 pandemic on the economy. In this regard, the National Treasury is in the process of budget rationalization to try and ease out expenditure pressure on the exchequer.

In view of the foregoing, the National Treasury is not in a position to provide additional funding at the moment.

The report on disbursement of arrears owed to the National Government constituencies Development Fund board by the National Treasury was considered and adopted after it was proposed and seconded as the true deliberations of the Committee by Hon. Joshua Mwalyo, M.P and Hon. Benjamin Gathiru Mwangi M.P respectively with the following observations and recommendations.

COMMITTEE OBSERVATIONS:

- 1) It was noted that the National Treasury did not adhere to Section 4 of the NG-CDF Act of 2015 as amended in 2016, that states a minimum of 2.5% of the National Government share of annual revenue shall be allocated to the NG-CDF, as divided by the annual Division of Revenue Act enacted pursuant to Article 218, with an objective of addressing poverty and regional development imbalances.
- 2) That, non-remittance of the said funds has negatively impacted implementation of projects in some constituencies such as Mandera West Constituency which has a balance of Ksh. Ksh.72, 133,983 in the Financial Year 2013/2014.
- 3) That the analysis of Financial Year 2011/12 is as follows:

- b. Fifty-six (56) constituencies received partial allocation amounting to Kshs 4,118,352,553 resulting to a balance of Kshs 487,350,000 (See Annex 1)
- c. Two hundred nine (209) constituencies received full conditional grant allocation amounting to Kshs 3,645,557,113.
- d. One(1) constituency received partial conditional grant allocation of Kshs 17,042,857 leaving a balance of Kshs 400,000(See Annex 1)
- e. Kshs 525,450,000 was disbursed to the Board secretariat.
- f. Kshs 1,746,000,000 was disbursed to constituencies towards previous financial year's arrears.

4) Analysis of Financial Year 2013/14 is as follow:

- a. Two hundred thirty (230) constituencies received full allocation amounting to Kshs 16,595,516,610
- b. Seventy (70) constituencies received partial allocation amounting to Kshs 3,249,883,390 leaving a balance of Kshs 2,128,500,000

- o Kshs 1,648,500,000 was disbursed to the Board secretariat.

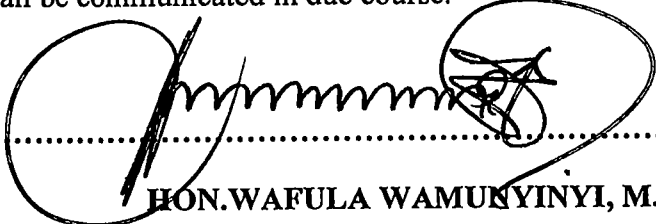
COMMITTEE RECOMMENDATIONS
