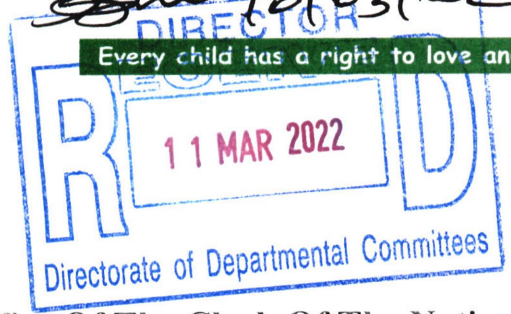

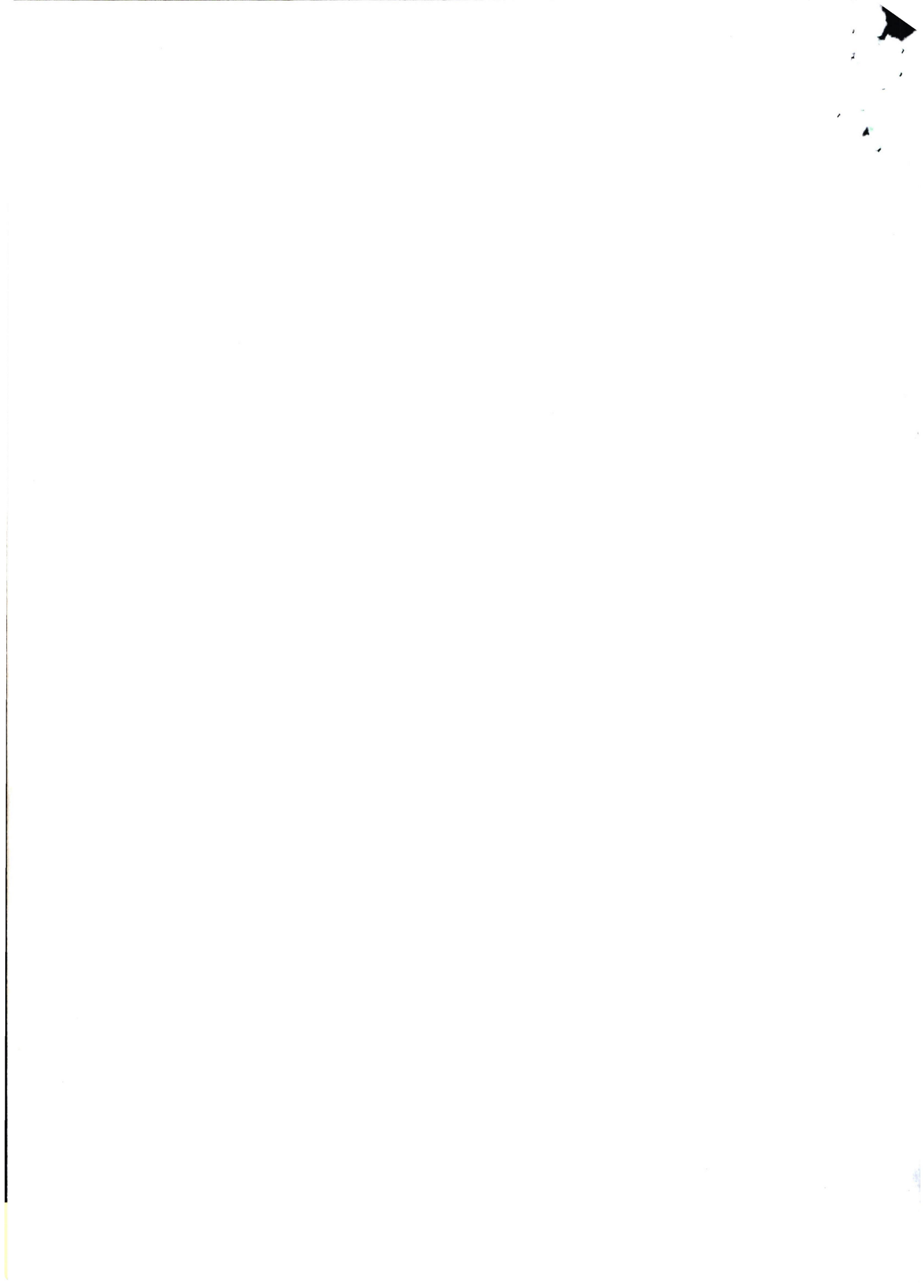

BACKGROUND

Kenyan's to Kenyan's Peace Initiative was founded as a non-governmental organization and was registered in 2006. Thereafter in 2007 it was registered as an adoption society. It was founded with a purpose of improving the welfare of orphaned, abandoned, vulnerable and destitute children through alleviation of their status and facilitating their integral development.

Vision

To be the best adoption society in Kenya

Mission

To broaden access to adoption for eligible adoptive parents and children in Kenya and abroad to ensure that every eligible adoptive child grows up in a family set up and that all adoptions are processed in adherence to local and international laws.

Strategic Goals

- To increase local adoptions by 10% annually
- To increase local partnerships by 10% annually
- To promote the image of the organization to reflect aspirations of the stakeholders and core values
- To enhance community/CCI participation in the adoption process

In our endeavor to be the best adoption society in Kenya, KKPI fraternity shares the following core values:

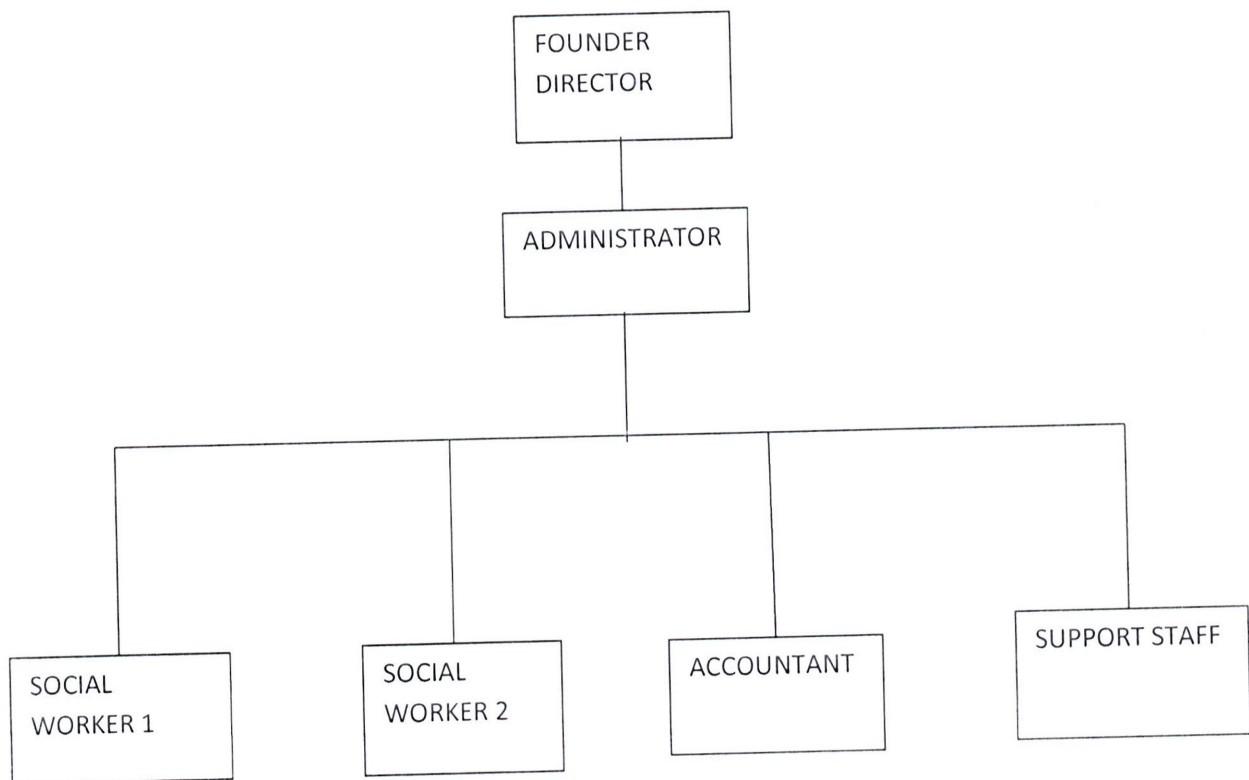
Integrity, transparency, accountability, impartiality, confidentiality, diligence, team spirit, loyalty, and care for children dictated by our values.

ORGANISATIONAL STRUCTURE



The **Founder Director** oversees the operations of KKPI adoption Society.

The Society is headed by an **Administrator** who is in charge of the day to day running of its affairs.

The other member of staff is a **Social Worker** who is involved in ensuring that the main functions of the organization are implemented and adhere to the set goals and expectations.

Case Committee

Its members convened for the first time in January 2008. Since then they have met every last Wednesday of the month to vet and approve prospective adoptive parents and also declare children free for adoption. These members have also been quite resourceful to the organization due to their varied experiences in their fields of expertise.



Awareness Creation

This was conducted through various churches, media and other organized groups during the year 2017. It was aimed at sensitizing congregations and participants on supporting adoptive parents and encouraging those who intended to adopt.

Networking

KKPI in conjunction with other Adoption Societies and child related stakeholders organized a celebration in November to mark the Adoption Month. It was a way to create public awareness on adoption.

Networking has proved to be the best mechanism in helping the Society identify clients interested in adopting and babies who can be put up for adoption. During this period, KKPI maintained a positive and effective working relationship with CCI's and other stakeholders.

Networking has helped KKPI build a client base; understand the problems that relate to adoption, and helped the Society design suitable solutions to these problems.
