1.0 PREFACE

Mr. Speaker Sir,

The Committee on Delegated Legislation is established under Standing Order 197 to, among other functions;

- i) ensure that statutory instruments are laid before the House as may be provided under any written law and scrutinize such instruments to ensure that they are consistent with parent statutes;
- ii) Unless otherwise provided for either expressly or by implication under any written law ,all subsidiary legislation shall be tabled before the House upon publication in the Kenya Gazette; and
- iii) The Committee may recommend that the House resolves that any particular subsidiary legislation be annulled.

The Standing Order also requires that all subsidiary legislation be tabled before the House upon publication in the Kenya Gazette.

Mr. Speaker Sir

The matter before the committee relates to the scrutiny for the approval by the House of the following draft regulations that were laid on the Table of the House on Thursday 30th August, 2012:-

1. The Draft Elections Regulations 2012;

- 2. The Draft Elections (Kenya Citizens Residing Outside Kenya) (Registration and Voting) Regulations 2012;
- 3. The Draft Elections (Registration of Voters) Regulations 2012; and
- 4. The Draft Elections (Voter Education) Regulations 2012.

Following the tabling of the above Draft Elections Regulations on the Table of the House by the Hon. Minister for Justice and Constitutional Affairs, the Chair directed as follows:-

".....I direct that the Committee that adjourned its sitting this morning continues with their meeting tomorrow, complete their report and the Leader of Government Business assures the House that this matter will be on the Order Paper on Tuesday in order to beat the statutory deadlines regarding the approval of these rules"

Committee Sittings

Upon the tabling of the above Regulations, the Committee on Delegated Legislation resolved to incorporate the Departmental Committee on Justice and Legal Affairs and the Constitutional Implementation and Oversight Committee in order to have more input on the Regulations.

Subsequent thereto, the Joint Committee held a total of five (5) sittings. The joint Committee noted with the concern the apathy displayed by the IEBC in adhering to deadlines and the low sense of responsibility to such an important issue. During a Speakers Kamukunji held on 30th August, 2012, it was agreed given the short period within which the regulations were tabled, it was impossible for Parliament to approve them before the stipulated deadline of 4th September, 2012. The House therefore passed the Elections (Amendment) Bill, 2012 which amended Section 103(4) of the Elections Act to provide for the approval by the House of the Draft Electoral Regulations foue months to the date of the next General Elections.

Mr. Speaker Sir, during its sitting of 18th September, 2012, the joint Committee agreed that owing to the urgency of the voter registration exercise, it will be prudent to fast tract the approval of the Draft Elections (Registration of Voters) Regulations, 2012 as we 3 | P a g e

await the scrutiny of the other sets of the Regulations. Due to the urgency of the matter, the Committee on Delegated Legislations reviewed the Draft Elections (Registration of Voters) Regulations, 2012.

During the review of the Draft Elections (Registration of Voters) Regulations, 2012, and upon the review of the Draft Elections (Kenya Citizens Residing Outside Kenya) (Registration and Voting) Regulations 2012, it come to the attention of the Committee apart from the subject matter involved, both regulation were similar since they covered the issue of registration of Kenyans as voters. The Committee therefore resolved to incorporate and harmonize the provisions of the Draft Elections (Kenya Citizens Residing Outside Kenya) (Registration and Voting) Regulations 2012 into the Draft Elections (Registration of Voters) Regulations, 2012. The end result will be that the Parliament will not need to approve Draft Elections (Kenya Citizens Residing Outside Kenya) (Registration and Voting) Regulations 2012 and the Committee therefore requests the Hon. Minister for Justice and Constitutional Affairs to withdraw the same.

2.0 BACKGROUND

- 1. The Independent Electoral and Boundaries Commission (IEBC) is established under Article 88 of the Constitution of Kenya. The Commission comprises of the Chairperson and eight other members appointed in accordance with Article 250 (4) of the Constitution and the provisions of the Independent Electoral and Boundaries Commission.
- 2. Article 88 (4) of the Constitution provides that:-

"The Commission is responsible for conducting and supervising referenda and elections to any elective body or office established by the Constitution and any other elections as prescribed by an Act of Parliament and ,in particular for :-

- a) The continuous registration of citizens as voters
- b) The regular revision of the voters' roll
- c)
- d) the regulation of the process by which parties nominate candidates for elections;
- e) the settlement of electoral disputes, including disputes relating to or arising from nominations but excluding election petitions and disputes subsequent to the declaration of election results;
- f) the registration of candidates for election;
- g) voter education;
- h) the facilitation of the observation, monitoring and evaluation of elections;
- *i)*
- 3. Article 88 (5) of the Constitution provides that:-

"The Commission shall exercise its powers and perform its functions in accordance with this Constitution and National legislation".

4. Section 109 (1) of the Elections Act (Act 24 of 2011) provides that:-

"The Commission may make regulations generally for the better carrying out of the purposes and provisions of this Act, and in particular, but without prejudice to the generality of the foregoing, may make regulations to—:-

- 5. Further, Section 109 (3) of the Elections Act (Act 24 of 2011) provides that:"The power to make regulations shall be exercised only after a draft of the proposed regulations has been approved by the National Assembly, at least six months preceding a general election.
- 6. In exercise of the above power to make regulations, the Commission has developed the Draft Elections (Registration of Voters) Regulations 2012 (hereafter referred to as the Draft Elections Regulations

- 7. The Draft Elections (Registration of Voters) Regulations 2012 covers inter alia.
 - a. Designation of registration centers within Kenya;
 - b. Appointment of registration officers and assistant registration officers;
 - c. Preparation of the principal register of voters and matters connected herewith;
 - d. Registration of voters and matters connected herewith;
 - e. Mechanism for handling claims arising from the registration exercise;
 - f. Inspection of the register
 - g. Preparation of new register etc

4.0 COMMITTEE'S PROPOSED AMENDEMENTS TO THE ELECTIONS (REGISTRATION OF VOTERS) REGULATIONS, 2012:

NOTICE is given that, Hon. Amina Abdalla, the Chair Person of the Committee on Delegated Legislation, intends to move the following amendments to Draft Elections (Registration of Voters) Regulations 2012 —

REGULATION 2

THAT, regulation 2 be amended by inserting the following definitions in the proper alphabetical order.

"Commission" means the Independent Electoral and Boundaries Commission established by the Constitution;

"foreign representative of Kenya" means a public officer serving in Kenyan foreign mission abroad;

REGULATION 6

THAT, regulation 6 be amended by inserting the words "polling stations, ward and" immediately after the word "his or her".

REGULATION 7

THAT, regulation 7 be amended-

- (a) in the marginal notes by deleting the words "Registrations areas" and substituting therefor the words "Registration areas and Registration centers".
- (b) In sub-regulation 7(c) by inserting the words "vessels or vessels" immediately after the words "vehicle or vehicles".
- (c) In sub-regulation 7(d) by inserting the words "and publicise through electronic and print media of national circulation and other easily accessible medium" immediately after the words "Gazette".

 - (3A) The Commission may use facilities of Kenyan foreign missions abroad, free of charge, for the purposes of voter registration or polling, as the case may be;
 - (4A) The Commission shall, in respect of each registration area appoint a registration officer to be responsible for the compilation of a register for the respective area;

THAT, regulation 12 be amended in sub-regulation clause (4) by inserting a new paragraph (d) as follows-

(d) by having in place an electronic register which may be accessed on a website, via mobile phone and such other electronic media as the Commission may determine.

REGULATION 17

THAT, regulation 17 be amended by inserting the following proviso"Provided that such claim shall not be made ninety days to a date of a general election or referendum and sixty days before a by-election"

REGULATION 27

THAT, regulation 27 in sub-regulation (2) be amended by inserting the words "and through other easily accessible medium." immediately after the word "nationwide circulation".

REGULATION 28

THAT, regulation 28 in sub-regulation (1) be amended by deleting the words "26" and substituting therefor the words "27" immediately after the word "regulation"

REGULATION 29

THAT, regulation 29 be amended by deleting paragraph (b)

REGULATION 30

THAT, regulation 30 be amended by deleting sub-regulation (4)

Eligibility to vote

36A. A Kenya citizen residing outside Kenya shall apply for registration as a voter upon production of a valid Kenyan Passport or National Identification Card.

Registration personnel

37A. for the purpose of registration of Kenyan citizen residing outside Kenya as voters, the Commission may use the services of foreign representatives of Kenyan who shall not be either the Ambassador, Deputy Ambassador, the High Commissioner or the Deputy High Commissioner.

Type of elections

38A. A Kenya citizen residing outside Kenya shall only participate in a presidential election or a referendum.

Members reviewed both the Draft Elections (Registration of Voters) Regulations, 2012, and upon the review of the Draft Elections (Kenya Citizens Residing Outside Kenya) (Registration and Voting) Regulations 2012, and ADOPTED to the following amendments to Draft Elections (Registration of Voters) Regulations, 2012.

REGULATION 2

THAT, regulation 2 be amended by inserting the following definitions in the proper alphabetical order.

"Commission" means the Independent Electoral and Boundaries Commission established by the Constitution;

"foreign representative of Kenya" means a public officer serving in Kenyan foreign mission abroad;

REGULATION 6

THAT, regulation 6 be amended by inserting the words "polling stations, ward and" immediately after the word "his or her".

REGULATION 7

THAT, regulation 7 be amended-

- (a) in the marginal notes by deleting the words "Registrations areas" and substituting therefor the words "Registration areas and Registration centers".
- (b) In sub-regulation 7(c) by inserting the words "vessels or vessels" immediately after the words "vehicle or vehicles".
- (c) In sub-regulation 7(d) by inserting the words "and publicise through electronic and print media of national circulation and other easily accessible medium" immediately after the words "Gazette".
- (d) In sub-regulation 7 (d)(iii) by inserting the words "vessels or vessels" immediately after the words "vehicle or vehicles".
- (e) by inserting a new paragraphs (dd) (ee) and (ff) immediately after paragraph (c) as follows-
