Mr. Speaker

I rise to issue a statement on the proposed budget ceiling for each constituency for the 2018/2019 financial year.

Mr. Speaker,

During the Financial Year 2018/2019 the National Treasury allocated Kshs. 35,758,596,000.00 to the National Government Constituencies Development Fund.

The NG-CDF Board secretariat has computed the proposed budget ceiling for each constituency and NG-CDF Board for the 2018/2019 financial year as follows:-

- i. The total allocation Kshs. 35,758,596,000.00
- ii. Allocation to NG-CDF Board Kshs. 1,547,929,800.00

 (The Board allocation is 4.3% of the total amount, which is the approved budget for the Board. This is subject to Section 23(1) which requires that not more than five percent of the total allocation to the fund in the financial year may be used for purpose of running the Board)
 - iii. Total allocation to constituencies 34,210,666,200.00
 - iv. Emergency reservation Kshs.1,787,929,800.00

(This is subject to section8 (1) which provides that a portion of the fund equivalent to five percent (referred to as "Emergency Reserve") shall remain unallocated and shall be available for emergences)

- v. Equal constituencies share Kshs. 32,422,736,400.00 Therefore, the proposed allocation per constituency is as follows
 - a. Equal share $\frac{32,422,736,400.00}{290} = Kshs. 111,802,539.31$ per constituency
 - b. Emergency reserve $\frac{1,787,929,800.00}{290} = Kshs. 6,165,275.17$ per constituency

The proposed allocation per constituency for the 2018/2019 financial year is therefore computed as follows;

Equal share Kshs. 111,802,539.31

Emergency Kshs. 6,165,275.17

Kshs. 117,967,814.48

Each Constituency is therefore expected get a total of *Kshs*. 117, 967, 814. 48 Mr. Speaker,

In line with the provisions of section 36(6) of the Act, the management is to establish the total A.I.A per constituency in the 2017/2018 financial year and factor he amount as an additional allocation to the relevant constituency. Detailed tabulation of the budget ceiling to constituencies and the ministry allocation to the Fund is annexed herewith.



The Select Committee on NGCDF has written to invite the National Treasury CS to provide an update on the 2018/19 funds allocation and outstanding arrears of the FY2017/2018.

From our review we wish to comment as follows

- The National Government Constituency Development Fund is established by Section 4 of the National Government Constituencies Development Fund (NG-CDF) Act, 2015;
- 2. The Fund is administered by the NGCDF Board;
- Section 4 of the Act provides that the Fund consists of an amount not less than 2.5% of all the national government's share of revenue as divided by the annual Division of Revenue Act enacted pursuant to Article 218 of the Constitution;
- 4. The monies appropriated to the Fund in any Financial Year shall not be less than the amount appropriated to the Fund in the preceding financial year unless as otherwise allowed by the Act;
- The Office of the Clerk of the National assembly has indicated that, there are arrears amounting to Kshs 4.976 billion owed to Constituencies due to non-remittance of Funds by the National Treasury to the Board;

Based on the 2.5 % of the National Government's Share the summary of the allocation and actual disbursement to NG-CDF is as shown below:

The shortfall in disbursement was occasioned by reduction in actual collection of revenues. For example, in the FY 2014/15 projected revenue was Kshs 1.1805 trillion while actual collection was Kshs 1.1064 trillion which reflects an underperformance of 6.3 %.

7. Review of a schedule tabled before the committee by the State Department of Devolution shows the arrears of Kshs 4.9 billion for the three years as shown in the table below.
