Nairobi County Football Association is a registered body by the sports registrar under sports act article 46.2.b with registration certificate no 240 (attached below). We thank your office for giving us opportunity to air our grievances against Football Kenya Federation in the last parliament which impacted the removal of its members.

We earlier wrote(as copied to you) seeking appointment with the committee through county football associations forum(find the attached letter below) on regards to the actions of the cabinet secretary for sports, culture and heritage Hon Ababu Namwamba to football matters which has resulted to many unfold issues we need to table before the committee. Please approve our appointment request since it is a matter of urgency.

Chapter 4 of the Kenyan constitution, article 21.3 states that "All State organs and all public officers have the duty to address the needs of vulnerable groups within society, including women, older members of society, persons with disabilities, children, youth, members of minority or marginalised communities, and members of particular ethnic, religious or cultural communities." and we hereby seek appointment we express ourselves before the committee. We earlier met with the CS, deliberated on the same and shared our comprehensive report

Ms. Mwang Ms. Mwang Lovelly dea which he declined to implement as per the agreement. We wrote a letter cautioning him on risking contempt of court (attached below) but no farther action taken by him. We hereby request to treat this letter as a matter of urgency.

We have seeked a meeting with the principal secretary for sports, culture and heritage Hon Jonathan Mueke twice but all has gone futile, however we shared the comprehensive report too to his seceratriat.

# RE: ESSAY FOR THE SURMON OF HON. ABABU NAMWAMBA FOR VIOLATION OF THE CONSTITUTION AND OATH OF OFFICE.

I hope this finds you well. In the reference above, County Football Associations are registered bodies under sports act article 46.2.b hence mandated to run football activities in the county level. We hereby state as follows:

- 1. That Football Kenya Federation is registered under article 47 of the sports act with certificate no 45.
- 2. That Football Kenya Federation failed to comply with the sports act provisions.
- 3. That the sports registrar through directions of the cabinet secretary conducted inspection of Football Kenya Federation in accordance with article 52 of the sports act
- 4. That the findings of the inspection report was submitted to the sports registrar madam Rose Wasike on 5th November 2021 by the inspection committee led by Mr. Mike Kimoko Esq in accordance with article 53 of the sports act
- That on 11th November 2021, the former Cabinet Secretary for Sports, culture and heritage Amb(Dr) Amina Mohammed removed the national executive committee of Football Kenya Federation from office in accordance with article 54.1.b of the sports act
- 6. That the Cabinet Secretary gazetted the carctaker committee on 11th November 2021 in a gazette notice 12374 in accordance with article 54 of the sports act.
- 7. That the caretaker committee was mandated to:
- (i) Monduct all the affairs of Football Kenya Federation in accordance with its constitution.
- (ii) Ensure that Football Federation of Kenya is in compliance with the Sports Act (2013)
- (iii) Coordinate and ensure smooth running of FKF's operations including team preparations of all local and international sporting events
- (iv) Coordinate elections of FKF in accordance to the Sports Act (2013) and the Sports Registrar's regulations
- (v) Hand over Football Kenya Federation to the newly elected officials after successful election.
- That Football Kenya Federation, Nick Mwendwa and Barry Otieno through a petition dated 8th November 2021 moved to high court to challenge the removal of the FKF NEC from office by the cabinet secretary.
- 9. That high court ruling no E473 of 2021 by Lady justice H. I Ong'udi confirmed the removal of FKF NEC on 10th of May 2022 and ordered FKF to be served with inspection report.
- 10. That the provisions of page 18 and 19 of the inspect report have not yet been met, resulting to the removal of FKF NEC. These includes:
- a) Misappropriation of funds advanced to FKF by the Government, FIFA, CAF, Multichoice, Odibet, Afcon, Safaricom among others
- b) Non submission of Annual Audit Reports to the Sports Registrar
- c) Non adherence to Sports Act and any other relevant law;
- d) Refusal to amend the FKF Constitution in line with the Constitution of Kenya 2010, the Sports Act, Sports Registrar Regulations and any other relevant law:

e) Un-procedural hiring and sacking of coaches;

Resistance to register County Sports Associations and sticking to nonregistered regional organizations

g) Illegal elevation of sub - county football organizations into county sports/branch associations through written instructions instead of registering them through the office of the Sports Registrar

as required under section 47 of the Sports Act;

h) Refusal to release the 47 application forms picked from the Sports Registrar's Office on behalf of the 47 County Football Associations and refusal to return the same 47 registration forms to the Sports Registrar's office to enable registration of Football County Sports Associations as required under section 47 of the Sports Act as read together with Paragraph 4 of the Sports Registrar Regulations;

i) Holding of illegal elections at the county and national level using non registered County Sports Associations and Sports Clubs, non-cleared/certified candidates who didn't meet the requirements of Chapter Six of the Constitution of Kenya 2010 as required under paragraph 20(2)(f) of the Sports Registrar Regulations, non-submission of election returns for County

Sports Associations among others;

Objection to registration of FKF county and national officials illegally elected in 2019 and 2020 respectively;

k) Irregular appointment of Board/Council Members

1) Non – Disclosure of Grants from Confederation of African Football (CAF);

m) Refusal to recognize and admit as members/affiliates County Sports Associations and Sports Clubs registered by the Sports Registrar under the Sports Act

n) Disparity in rewarding male and female teams/clubs

11. That the Cabinet Secretary extended the appointment of the committees in gazette notices no 7005 of 17th June 2022 and 9772 of 15th August 2022.

12. That upon swearing in, the cabinet secretary for sports, culture and heritage Hon. Ababu Namwamba reinstated FKF NEC without a gazette notice which is against article 153.1 of the Kenyan constitution.

13. That county football associations through Baringo County Football Association treasurer Mr. Samson Cherop and 27 others filed a case at Sports Disputes Tribunal(SDT no E038) challenging the legality of FKF NEC.

14. That SDT through the chair Mr. John Ohaga ruled that FKF NEC was operating illegally and ordered the cabinet secretary to constitute a committee to stand in for FKF NEC awaiting elections.

15. That CS Hon. Ababu Namwamba has defiled both high court ruling no E473 of 2021 and SDT ruling no E036, E038 and E039.

16. That the CS Hon Ababu Namwamba has contravened article 152. 6 of the Kenyan constitution

17. That the Cabinet Secretary to appear before the sports committee for not implementing the actions taken by his precedessor or revoke them through gazette notices. The appearance is in accordance with 153.3 of the Kenyan constitution.

18. That the Cabinet Secretary Hon. Ababu Namwamba has violated article 153.4.a hence there is need to provide a comprehensive report on matters of football in accordance with article 153.4.b

19. That county football associations issued him with a comprehensive report on the same and a notice of a letter of sueing him.

20. That county football association are ready to appear before the committee and evident the above accusations including the comprehensive report submitted to the cabinet secretary on 9th January 2023.

## RE: VIOLATION OF THE CONSTITUTION OF KENYA AND OUTH OF OFFICE

On 27th Thursday of October 2022, you were sworn in to defend the constitution of Kenya. In the football matters, you have completely violated it by not adhering to it in many circumstances. We hereby demand you to act upon the following heating matters in the football circle with emergency;

#### 1. Either

- Gazette the reinstatement of Football Kenya Federation national executive i. committee
- ii. Revoke the appointments of the caretaker/transition committees
- iii. Revoke the inspection report for it to be null and void Article 153.1 of the Kenyan constitution provides that "A decision by the Cabinet shall be in writing" and no written document from you to confirm the reinstatement of the FKF NEC.
  - 2. Or
- Honor the court rulings i.e high Court ruling no E473 of 2021 and Sports Disputes Tribunal 36,38 and 39 which confirmed the removal of Football Kenya Federation officials.
- Football Kenya Federation General meeting held on 11th June 2022 at ii. kasarani which confirmed the removal of the national executive committee and also upheld the decision of the court of arbitration for sports (CAS) of 10th June 2022 that Mr. Barry Otieno is not authorized to transact anything on behalf of FKF.
- Implement the sports act fully in football as it is in other sports federations and act by your words (we have Tweets and clips confirming the same).
  - 3. Deal with the issue of match fixing in Kenyan football with urgency, using the Director of public prosecution office and that of Ethics and Anti-corruption commission for justice to prevail.
  - 4. Use the legal, legible and certified bodies registered by government to run football activities in the county level for under 19 bottom up tournament. If
  - 5. there will be need to form a national committee, then let it come from compliant individuals who will be held accountable under the sports act which you initiated.

b) Write to the senate and parliament sports committee to appear before then for

violation of the Kenyan constitution

c) Write to the president and parliament on the essence of your removal from office on the ground of gross violation of the provisions of the Kenyan Constitution and defiling court rulings in accordance with article 152.5,6&7 of the Kenyan constitution.
