Mr. Speaker Sir,

On the 9th August, 2011 you informed the House that H.E the President had after consultation with the Rt. Hon. Prime Minister nominated the following persons to be considered for appointment to the Judges and Magistrates Vetting Board in the stated capacities, pursuant to the provisions of Section 9(7) of the Vetting of Judges and Magistrates Act, 2011:-

- i). Mr. Sharad Sadashiv Rao Chairperson (Lawyer)
- ii). Mr. Justus Maithya Munyithya Member (Lawyer)
- iii). Ms. Roseline Odhiambo Odede Member (Lawyer)
- iv). Prof. Ngotho Wa Kariuki Member (Non-lawyer)
- v). Ms. Meuledi Mabruki Iseme Member (Non-lawyer)
- vi). Mr. Abdirashid Abdullahi Member (Non-lawyer)

You then directed that the names and Curriculum Vitae (CVs) of the nominees be referred to the Constitutional Implementation Oversight Committee (CIOC) for consideration prior to approval by the House and that the CIOC tables its report on or before Wednesday, 17th August, 2011.

As directed, the Committee took up the matter and put up paid advertisements in the dailies inviting members of the public to submit written memoranda on the suitability or otherwise of the nominees for appointment to the Judges and Magistrates Vetting Board . The Committee received nine (9) written memoranda

all in support of some nominees. The Committee also held a meeting with the nominees where they made submissions on why they should be appointed to serve in the Judges and Magistrates Vetting Board. In total the Committee held three (3) sittings to deliberate on the suitability of the nominees for appointment to serve in the Vetting Board.

BACKGROUND

- 1. Section 23(1) of the Sixth Schedule to the Constitution states that:-
 - 23.(1) Within one year after the effective date, Parliament shall enact legislation, which shall operate despite Article 160, 167 and 168, establishing mechanisms and procedures for vetting, within a timeframe to be determined in the legislation, the suitability of all judges and magistrates who were in office on the effective date to continue to serve in accordance with the values and principles set out in Articles 10 and 159.
- 2. Parliament enacted the Vetting of Judges and Magistrates Act, 2011 which commenced on 22nd March, 2011. The Act was later amended and commenced on 19th May, 2011.
- 3. The Judges and Magistrates Vetting Board is established in Section 6 of the Vetting of Judges and Magistrates Act, 2011.
- 4. Section 7 of the Vetting of Judges and Magistrates Act, 2011, Act states that:-The Board shall consist of nine members comprising a chairperson, a deputy chairperson and seven other members of whom-
 - (a) Six shall be citizens of Kenya appointed in accordance with Section 9(1) to (12) and of whom, three shall be lawyers; and
 - (b) Three shall be non-citizens of Kenya appointed in accordance with Section 9(13).
- 5. The President in consultation with the Prime Minister pursuant to section 9(2) of the Vetting of Judges and Magistrates Act, 2011 as amended by the Vetting of Judges and Magistrates (Amendment) Act 2011 declared the vacancies in the office of chairman and members of the Judges and Magistrates Vetting Board and invited qualified applicants through Gazette Notice No. 5367.
- 6. Seventeen (17) applicants applied for the position of Chairperson while one hundred and twenty five (125) applied for position of member. The Public Service Commission (PSC) then conducted interviews to select suitable candidates for the positions and forwarded the names to H.E the President and Rt. Hon. Prime Minister for nomination.
- 7. On 3rd August, 2011, H.E the President, through a letter by the Permanent Secretary, Secretary to the Cabinet and Head of Public Service forwarded the names of the following persons to be considered for appointment to the respective positions:-

- i). Mr. Sharad Sadashiv Rao Chairperson (Lawyer)
- ii). Mr. Justus Maithya Munyithya Member (Lawyer)
- iii). Ms. Roseline Odhiambo Odede Member (Lawyer)
- iv). Prof. Ngotho Wa Kariuki Member (Non-lawyer)
- v). Ms. Meuledi Mabruki Iseme Member (Non-lawyer)
- vi). Mr. Abdirashid Abdullahi Member (Non-lawyer)
- 8. Upon receipt of the names of the nominees, the National Assembly is required under Section 9(8) to consider all the nominations received within 14 days.
- 9. On 9th August, 2011, the Honorable Speaker in a Communication to the House referred the names of the six nominees to the Constitutional Implementation Oversight Committee for vetting and directed the Committee to submit its recommendations on the nominees to the House by Wednesday, 17th August, 2011.
- 10. Further on 18th August, 2011 the Permanent Secretary, Secretary to the Cabinet and Head of Public Service by a letter to the Clerk of the National Assembly, informed that H.E the President in consultation with the Rt. Hon. Prime Minister had appointed Sir Stephen Sedley, former Lord Justice of Appeal, England and Wales, Chief Justice Georgina Wood of Ghana and Hon. Ms Louise Otis, retired Judge of Quebec Court, Canada as distinguished non-citizens from the Commonwealth for approval by Parliament pursuant to Section 9(13) of the Vetting of Judges and Magistrates Act, 2011.
- 11. On the same day, the Honorable Speaker in a Communication to the House referred the names of the three non-citizens of Kenya nominees to the Constitutional Implementation Oversight Committee for vetting and directed the Committee to submit its recommendations on all the nominees to the House by Tuesday, 23rd August, 2011.

CONSIDERATION OF THE NOMINEES BY THE COMMITTEE

- 12. At a meeting held on 15th August, 2011, the Committee examined the Candidates against the criteria set out in the Second Schedule to the Commission on the Implementation of the Constitution Act, 2010 (Criteria for vetting/approval of nominees for appointment to public office by the National Assembly). That criterion requires nominees to disclose information on their personal and professional life including their political affiliations, tax compliance and potential conflict of interests and other things.
 - 13. On 22nd August, 2011, the committee met to consider the names of the non-Citizens forwarded to the committee for consideration.
- 14. Section 8 of the Judges and Magistrates Act, 2011 sets out the qualifications for appointment to the Judges and Magistrates Vetting Board. The qualifications are:-
 - 8. (I) A person shall be qualified for appointment as a member if such person-
 - (a) holds a degree from a university recognized in Kenya;
 - (b) has at least fifteen years' distinguished post- qualification experience in their field of study: and
 - (c) satisfies the requirements of Chapter Six of the Constitution.
 - (2) A person shall not be qualified for appointment as the chairperson or deputy chairperson unless such person has at least twenty years' or an aggregate of twenty years' experience as a judge of a superior court, a distinguished legal academic, a judicial officer or other relevant legal practice in the public or the private sector in Kenya.

Nomination of Mr. Sharad Sadashiv Rao as Chairperson of the Judges and Magistrates Vetting Board

- 15. The Committee having considered the curriculum vitae of Mr. Sharad Sadashiv Rao, and having heard his submissions during the interview, made the following observations on his nomination for appointment as Chairman of the Judges and Magistrates Vetting Board:
 - i. That Mr. Sharad Rao is a Kenyan citizen born on 13th October, 1935 and holds a Barrister at Law, Lincoln's Inn, London and was called to the Bar on 16th June, 1659. He was enrolled as an advocate of the High Court of Kenya on 1st July, 1960. He has been at the bar for over 50 years;
 - ii. He is currently in private practice in Kenya;

- iii. He has served as Assistant Deputy Public Prosecutor, Deputy Public Prosecutor and briefly as Acting Attorney General and several International Legal and sports panels among them the Commonwealth Games Federation as Hon. Legal Adviser and on Disputes resolution Panel for FIFA World Cup 2010;
- iv. During his long career in legal practice, he has never been cited for any professional misconduct or misbehavior before the Advocates Disciplinary Committee.
- v. He has fully complied with his tax obligations to the State and has never been dismissed from office or adversely mentioned in any investigatory report of Parliament or any Commission of Inquiry;
- vi. He is a life member of a political party (KANU);
- vii. He was charged in 1984 in his capacity as a non-executive director of Elys Chemical Ltd under the Food Drugs and Chemical Substances Act together with three others. However he was never served as he was out of the country. Thereafter his case as a non-executive Director was withdrawn while the case for the three others proceeded and were all acquitted.
- viii. The Committee found the nominee qualified.

Nomination of Mr. Justus Maithya Munyithya as Member of the Judges and Magistrates Vetting Board

- 16. The Committee having considered the curriculum vitae of Mr. Justus Maithya Munyithya, and having heard his submissions during the interview, made the following observations on his nomination for appointment as member of the Judges and Magistrates Vetting Board:
 - i. That Mr. Justus Maithya Munyithya is a Kenyan citizen born on 23rd September, 1968 and holds a Bachelor of Law, (LLB),from University of Nairobi and a Diploma Legal Practice (Studies) from Kenya School of Law. He was enrolled as an advocate of the High Court on 11th January, 1996. He has been at the bar for over 15years.
 - ii. He is a practicing advocate of the High Court and currently serving as managing partner Kioko, Munyithya, Ngugi and Company Advocates. He also serves as a volunteer Legal Officer Ilishe Trust dealing with Human Rights Awareness Campaigns, Public interest Litigation, Civic Education, Child rights and Advocacy.

- iii. He is a practicing Certified Public Secretary and has work experience as a untrained teacher, in motor vehicles, debt collection, commercial litigation and banking matters.
- iv. He has been awarded several certificates among them HSC on 12th December, 2010 by H.E for distinguished service as Chairman National Adoption Committee.
- v. He has fully complied with his tax obligations to the State and has never been dismissed from office or adversely mentioned in any investigatory report of Parliament or any Commission of Inquiry.
- vi. He is not a member of any political party.
- vii. He has never been charged in a court of law for any offence
- viii. The Committee found the nominee qualified.

Nomination of Ms. Roseline Odhiambo Odede as Member of the Judges and Magistrates Vetting Board

- 17. The Committee having considered the curriculum vitae of Ms. Roseline Odhiambo Odede, and having heard her submissions during the interview, made the following observations on her nomination for appointment as member of the Judges and Magistrates Vetting Board:
 - i. That Ms. Roseline Odhiambo Odede is a Kenyan citizen born on 29th March, 1967 and holds a Masters in Law degree (LLM) from the University of Witwatersrand, Johannesburg, a Bachelor of Law, (LLB), from University of Nairobi and a Diploma in Law from Kenya School of Law. She was enrolled as an advocate of the High Court on 18th October, 1990. She has been at the bar for over 20 years.
 - ii. She currently serves in a private practice firm named Roseline and Odede Company Advocates.
 - iii. She has served as a part-time lecturer at Moi University Eldoret, School of Business Studies.
 - iv. She is a member of the Council of the Law Society of Kenya, Council of Commonwealth Lawyers Associations and the East African Lawyers Association.
 - v. She has received awards from the East Africa Law Society for distinguished legal practice and service and from FIDA Kenya for pro-bono work.

- vi. She has fully complied with her tax obligations to the State and has never been dismissed from office or adversely mentioned in any investigatory report of Parliament or any Commission of Inquiry.
- vii. She is not a member of any political party.
- viii. She has never been charged in a court of law for any offence.
 - ix. The Committee found the nominee qualified.

Nomination of Prof. Ngotho Wa Kariuki as Member of the Judges and Magistrates Vetting Board

- 18. The Committee having considered the curriculum vitae of Prof. Ngotho War Kariuki, and having heard his submissions during the interview, made the following observations on his nomination for appointment as member of the Judges and Magistrates Vetting Board:
 - i. That Prof. Ngotho wa Kariuki is a Kenyan citizen born on 3rd June, 1949 and holds a Master of Business Administration (Finance and Accounting) and Bachelor of Commerce (Accounting) both from the University of Nairobi. He also has a certificate in Job evaluation from Ernest and Young, Zimbabwe.
 - ii. He has served as a Professor in several Countries in Sub-Sahara Africa in Accounting, Auditing and Fraud Investigation, Finance and Taxation. During his career he worked in East Africa, Zimbabwe, South Africa and Cameroon as a lecturer, Professor and Consultant.
 - iii. His last assignment was with Commonwealth Fund for Technical Cooperation (CFTC), London as an Advisor and expert second to Republic of Cameroon.
 - iv. He has fully complied with his tax obligations to the State and has never been dismissed from office or adversely mentioned in any investigatory report of Parliament or any Commission of Inquiry.
 - v. He was Secretary, KANU Kangema sub-branch and contested for Kangema Parliamentary seat in 1974, 1983 and 1992 (Ford-K).
- vi. He formed SDP Party in 1994. However, currently he is not a member of any political party.
- vii. He was charged on several counts of sedition (among others- Anyona 4) in 1990 and convicted on all charges and jailed for 47 years (running concurrently for 7 years). The conviction was quashed on appeal and he was released in 1992.
- viii. The Committee found the nominee qualified.

Nomination of Ms. Meuledi Mabruki Iseme as Member of the Judges and Magistrates Vetting Board

- 19. The Committee having considered the curriculum vitae of Ms. Meleudi Mabruki Iseme, and having heard her submissions during the interview, made the following observations on her nomination for appointment as member of the Judges and Magistrates Vetting Board:
 - i. That Ms. Meuledi Iseme is a Kenyan citizen born on 17th November 1956 and holds a Masters in Business Administration (Finance Major) and a Bachelor of commerce (Accounting Option) Degrees University of Nairobi respectively.
 - ii. She has twenty four years distinguished post-qualification experience.
 - iii. She has worked as a Deputy Managing Director and Financial Management Accountant, both in the Quasi and Central Government Organizations namely; Kenya Seed Company Ltd, Industrial Development Bank Ltd, Ministry of Lands and Settlement and Ministry of Transport and Communication respectively.
 - iv. She has fully complied with her tax obligations to the State and has never been dismissed from office or adversely mentioned in any investigatory report of Parliament or any Commission of Inquiry.
 - v. She is not a member of any professional body.
- vi. She is not a member of any political party.
- vii. She has never been charged in a court of law for any offence.
- viii. The Committee found the nominee qualified.

Nomination of Mr. Abdirashid Abdullahi as Member of the Judges and Magistrates Vetting Board

- 20. The Committee having considered the curriculum vitae of Abdirashid Abdullahi, and having heard his submissions during the interview, made the following observations on his nomination for appointment as member of the Judges and Magistrates Vetting Board:
 - i. That Mr. Abdirashid Abdullahi is a Kenyan citizen born on 15th January, 1964 and holds a Master of Arts in History from Rhodes University, a Master in Conflict Resolution from George Mason University and a bachelor of Education from Kenyatta University.

- ii. He has worked as a member of the Committee of Experts (CoE) that successfully drafted and delivered our country's new Constitution which is currently being implemented. He was involved in the drafting of the Chapter on Leadership and Integrity.
- iii. He is a team player and an expert in conflict analysis and resolution both at the corporate as well as at the interpersonal, community and state level.
- iv. He has fully complied with his tax obligations to the State and has never been dismissed from office or adversely mentioned in any investigatory report of Parliament or any Commission of Inquiry.
- v. He is not a member of any professional body.
- vi. He is not a member of any political party.
- vii. He has never been charged in a court of law for any offence.
- viii. The Committee found the nominee qualified.

Nomination of Sir Stephen Sedley as Member of the Judges and Magistrates Vetting Board

- 21. The Committee having considered the curriculum vitae of Sir Stephen Sedley made the following observations on his nomination for appointment as member of the Judges and Magistrates Vetting Board:
 - i. That Sir Stephen Sedley a British citizen born on 9th October 1939 and he is a graduate of Cambridge. He was called to the Bar (Inner Temple) in 1964.
 - ii. He has practiced at the bar of England and Whales for 28 years, specializing in Public law and discrimination law, before he was appointed a Judge of the High Court in 1992, serving in the Queen's Bench Division.
 - iii. He was a judge of the Court of Appeal of England and Wales from 1999 to March, 2011 where he retired.
- iv. He was involved in many high-profile cases and inquiries, from the death of Blair Peach and the Carl Bridgewater murder trial to the contempt hearing against Kenneth Baker, then Home Secretary.
- v. He is regarded as one of the most Left-wing of current judges. Sir Stephen is a strong supporter of human rights, and spent his 28 years at the Bar working principally in the fields of civil liberties and discrimination law.
- vi. In 2000, he was elected president of the British Institute of Human Rights and has sat on the Judicial Committee of the Privy Council of and as a Judge adhoc of the European Court of Human Rights.
- vii. He is currently an Associate adviser to the Cloisters on various legal issues that range from employment, discrimination and equality, personal injury, clinical negligence, commercial law to regulatory and public law. He has

- taught as a tutor at the Communist University of London, in the 1970s a nine-day summer school organised by the Communist Party.
- viii. He has provoked considerable debate about the role of government in collecting and keeping DNA samples. At present criminal suspects detained by the police in the UK automatically are given cheek swabs and their DNA kept, in perpetuity, by the government. This has created the situation where different races are differently represented in the United Kingdom National DNA Database. On the grounds that this situation is indefensible, Lord Justice Sedley argued for a blanket DNA collection policy, including collecting samples from all visitors to the UK.

ix. He has been awarded honorary doctorates by eight universities and is an honorary Professor of Law at Warwick and Cardiff Universities.

- x. He writes in the legal periodicals and He has written about two dozen articles for the London Review of Books. A collection of his essays, Ashes and Sparks, were published by Cambridge University Press in 2011.
- xi. The committee found the nominee qualified.

Nomination of Lady Justice Georgina Wood as Member of the Judges and Magistrates Vetting Board

- 22. The Committee having considered the curriculum vitae of Her Ladyship Justice Georgina Wood made the following observations on her nomination for appointment as member of the Judges and Magistrates Vetting Board:
 - i. That Lady Justice Mrs. Georgina Wood is a Ghanaian citizen born on 8th June 1947 and holds a Bachelor of Law Degree from the University of Ghana, Legon in 1970. She also attended the Ghana Law School after which she was called to the bar. She has also done the Post-Graduate Officers Training Course at the Ghana Police College.
 - ii. She worked with the Ghana Police Service as a deputy superintendent and public prosecutor for three years. She was later appointed to the Bench as a Magistrate of the District Court in 1973 and rose through the Circuit and High Courts to become the presiding Judge of the Appeal Court in 1991.
- iii. She was appointed to the Supreme Court by President John Kufuor on 12th November 2002, an appointment she had earlier declined.
- iv. She was nominated for the position of Chief Justice of Ghana in May 2007 and on 1st June 2007, the Parliament of Ghana approved her nomination as the new Chief Justice of Ghana by consensus which made her the first woman in the history of Ghana to head the Judiciary and also made her the highest ranked female in Ghana's political history.

- v. Between 2003 and 2007, she served as a justice of the Supreme Court of Gambia when in session.
- vi. She is also a dedicated advocate of Alternative Dispute Resolution (ADR), having received extensive training from the USA, and a distance learning modular program from the World Bank.
- vii. She was a member of the task force which designed the Ghana Courtconnected ADR program and was the Chairperson of the working committee which drafted the manuals on Court connected ADR and pretrials in the Commercial Court of Ghana. She also chaired the committee responsible for mainstreaming ADR in the courts in Ghana.
- viii. She has also lectured extensively in ADR (theory and practice) at the Judicial Training Institute, training key personnel including judges, lawyers and civil society organizations. She taught Civil Procedure and ADR in the Judicial Service Career Magistrates Programme, and was an external examiner in advocacy and ethics, Ghana School of Law for more than 10 years.
- ix. She has also co-authored the practice manual on the Gambian ADR court-connected programme and has also been a Judicial educator in ADR for the Bench, the Bar and court officials in the Gambia.
- x. She was awarded Ghana's highest National Award; the Order of the Star of Ghana for meritorious public service and an LLD (Honoris Causa) from the University of Ghana. She has also received an award from the Faculty of Law, University of Ghana for outstanding Judicial Career.
- xi. She was appointed a member of the special team of the International Bar Association (IBA) and International Legal Assistance Consortium (ILAC) to Kenya at the invitation of the Kenya Law Society on Judicial Reforms in September 2010.
- xii. She is a choir leader at the Ringway Gospel Centre Assemblies of God Church, Accra and the Chairperson of the Alternative Dispute Resolution in Ghana.
- xiii. The committee found the nominee qualified.

Nomination of Hon. Louise Otis as Member of the Judges and Magistrates Vetting Board

- 23. The Committee having considered the curriculum vitae of Hon. Louise Otis made the following observations on her nomination for appointment as member of the Judges and Magistrates Vetting Board:
 - i. Hon. Louise Otis is a graduate of Laval University and was called to the Quebec Bar in 1975.

- ii. In 1990, she was appointed as a Judge to the Quebec Superior Court. Between 1993 and 2009, she was a Judge at the Quebec Court of Appeal, participating in over 3000 judgements. Prior to 1990, she practiced law for fifteen years, specializing in Public Law, Labour Law and Administrative Law
- iii. From 1983 onwards, she specialized in public, labour and constitutional law, pleading cases before the courts of first instance, Quebec Court of Appeal, and the Supreme Court of Canada.
- iv. She taught Civil Procedure at the Laval University Faculty of Law in Quebec City (1984-1987). She also lectured in Civil Procedure, Criminal Law, Administrative Law and Labour Law at the Quebec Bar School (1978-1988).
- v. She is a member of the International Academy of Mediators (Fellow), International Commission of Jurists, Canadian Section (ICJ), Canadian Conference of Judicial Mediation and International Conference on Mediation for Justice (ICMJ).
- vi. She was a member of the Professional Training Committee of the Quebec Bar where she initiated and participated actively in developing a course entitled *The Drafting of Legal Texts* at Quebec Bar School (1984-1987). She was also involved in several professional activities directly related to the practice of law. From 1981 to 1985, she was a member of the Quebec Justice Advisory Council, advising the Quebec Minister of Justice on all matters relating to the administration of justice, particularly with regards to legislative reforms.
- vii. She is an active mediator in commercial and civil matters and also Deputy Judge for the Administrative Tribunal of the Organisation for Economic Cooperation and Development (OECD).
- viii. In 1997, while a Judge at the Quebec Court of Appeal, she developed one of the world's first judicial mediation systems, and later helped establish mediation programs in Canada and abroad. She has mediated hundreds of cases in commercial and civil law. She created and dispensed intensive mediation training courses in different countries including France, Belgium, Russia, Brazil, Mali and Australia.
- ix. She regularly participates in international governance and justice reform missions. Louise has created a system of transitional justice for countries affected by armed conflicts and/or environmental disasters.
- x. She was appointed by the then United Nations Secretary General, Kofi Annan in 2006, to a 5-member group of international experts charged with redesigning the UN's internal justice system, including the creation of a mediation system.
- xi. She has lectured on Alternative Dispute Resolution at: The Council of Europe, The Harvard Fellows, Harvard University Weatherhead Center for International Affairs, The European Conference of Judges, The International Academy of Mediators, The American Bar Association, Section

- of dispute resolution, the Masters' Forum of Mediators at Pepperdine University, California, The Australian Centre for Peace and Conflict Studies, The Brazilian Judicial Institutions and various national courts and tribunals.
- xiv. She has been involved in the reform of the justice system in different countries namely Haiti, Mali, China and Russia.
- xv. The committee found the nominee qualified.

The Rt Hon Lord Justice Stephen Sedley

Sir Stephen Sedley is a Lord Justice of Appeal for England and Wales and President of the British Institute of Human Rights. Born on 9 October 1939, Sir Stephen studied at the University of Cambridge. He was called to the Bar (Inner Temple) in 1964. He was involved in many high-profile cases and inquiries, from the death of Blair Peach and the Carl Bridgewater murder case to the contempt hearing against Kenneth Baker, then Home Secretary.

In 1983 he became a <u>QC</u> and in 1992 he was appointed a <u>High Court judge</u>, serving in the <u>Queen's Bench Division</u>. In 1999 he was appointed to the <u>Court of Appeal</u>. He writes on legal topics for The London Review of Books.

Below is a Resume on Sir Stephen Sedley:

The Rt. Hon. Sir Stephen Sedley practised at the Bar of England and Wales for 28 years, specialising in public law and discrimination law, before being appointed a judge of the High Court in 1992. He became a Lord Justice of Appeal in 1999, and has sat on the Judicial Committee of the Privy Council and as a judge adhoc of the European Court of Human Rights. He retired from the bench in March 2011.

He has been awarded honorary doctorates by eight British universities, is an honorary professor of law at Warwick and Cardiff Universities and has since 2000 been president of the British Institute of Human Rights. He writes in legal periodicals and for the London Review of Books. A collection of his essays, Ashes and Sparks, was published by Cambridge University Press in 2011.

He is currently an Associate adviser to Cloisters on various legal issues that range from employment, discrimination & equality, personal injury, clinical negligence, commercial law to regulatory & public law.

Chief Justice Georgina Wood

Her Ladyship Justice Georgina Wood Chief Justice, Supreme Court, Ghana

Lady Justice Mrs. Georgina Theodora Wood has had a distinguished career on the Bench spanning over thirty-five years.

She is the Chief Justice of the Republic of Ghana, having been appointed in June of 2007, the first woman in Ghana to be elevated to this high office, constitutionally the fourth position after the President, Vice President and the Speaker of Parliament.

Justice Georgina Wood was educated at the University of Ghana, Legon and the Ghana School of Law and served for three years in the Police Service as a Public Prosecutor.

She was appointed to the Bench as a Magistrate of the District Court in 1973 and rose through the hierarchy of the court system culminating in her appointment to the highest judicial office in Ghana.

Between 2003 and 2007, she served as a justice of the Supreme Court of Gambia when in session. She is also a dedicated advocate of Alternative Dispute Resolution (ADR), having received extensive training from the USA, and a distance learning modular program from the World Bank. She was a member of the task force which designed the Ghana Court-connected ADR program and was the Chairperson of the working committee which drafted the manuals on Court connected ADR and pre-trials in the Commercial Court of Ghana. She also chaired the committee responsible for mainstreaming ADR in the courts in Ghana.

She has also lectured extensively in ADR (theory and practice) at the Judicial Training Institute, training key personnel including judges, lawyers and civil society organizations. She taught Civil Procedure and ADR in the Judicial Service Career Magistrates Programme, and was an external examiner in advocacy and ethics, Ghana School of Law for more than 10 years.

Justice Wood also co-authored the practice manual on the Gambian ADR court- connected programme and has also been a Judicial educator in ADR for the Bench, the Bar and court officials in the Gambia.

In 2007, she received Ghana's highest National Award, the Order of the Star of Ghana for meritorious public service and in August 2008 was given an LLD (Honoris Causa) from the University of Ghana. She has also received an award from the Faculty of Law, University of Ghana for outstanding Judicial Career.

In April of 2008, Her Ladyship Georgina Theodora Wood was invited by Fordham Law School in New York, where she delivered a paper on the topic The Dynamic of Law and Development in Ghana; The case for Judicial Reform in an Emergent Democracy. She was the keynote speaker for the 16th Commonwealth Law Conference (CLC2009) in Hong Kong, where she spoke on the topic Democracy, Good Governance and the role of the Legal Profession: The case of Ghana in April 2009.

In September last year, Chief Justice Wood was appointed a member of the special team of the International Bar Association (IBA) and International Legal Assistance Consortium (ILAC) to Kenya at the invitation of the Kenya Law Society on Judicial Reforms.

Louise Otis works as a civil and commercial mediator and arbitrator at the Canadian and international levels. She is a Distinguished Fellow of the Internal Academy of Mediators.

In 2008, Louise Otis was appointed Deputy Judge for the Administrative Tribunal of the Organisation for Economic Co-operation and Development (OECD).

Since 2009, she is a Guest researcher at the International Studies Center of the University of Montreal (<u>CERIUM</u>) specialised in Peace operations and international conflicts resolution.

In September 2010, Louise Otis joined the Faculty of Law at McGill University as a Senior Boulton Fellow.

In October 2010, Louise Otis was appointed as President of the Tribunal of Appeal at the International Organization of the Francophonie.

Louise Otis regularly participates in international governance and justice reform missions. Louise has created a system of transitional justice for countries affected by armed conflicts and/or environmental disasters.

Louise Otis worked as a lawyer between 1975 and 1990. In 1990, she was appointed as a Judge to the Quebec Superior Court. Between 1993 and 2009, she was a Judge at the Quebec Court of Appeal, participating in over 3000 judgements. The Quebec Court of Appeal has general appellate jurisdiction over all courts in Quebec and also performs a judicial review function in relation to all administrative tribunals. It is one of the two largest appellate courts in Canada, and hears matters governed by both civil law and common law principles.

LEGAL CAREER PROFILE

Louise Otis is a graduate of Laval University and was called to the Quebec Bar in 1975. Prior to 1990, Louise Otis practiced law for fifteen years, specializing in Public Law, Labour Law and Administrative Law.

Female

From 1983 onwards, she specialized in public, labour and constitutional law, pleading cases before the courts of first instance, Quebec Court of Appeal, and the Supreme Court of Canada.

In the course of her career, Louise Otis taught Civil Procedure at the Laval University Faculty of Law in Quebec City (1984-1987). She also lectured in Civil Procedure, Criminal Law, Administrative Law and Labour Law at the Quebec Bar School (1978-1988).

She was a member of the Professional Training Committee of the Quebec Bar where she initiated and participated actively in developing a course entitled *The Drafting of Legal Texts* at Quebec Bar School (1984-1987).

She was also involved in several professional activities directly related to the practice of law. From 1981 to 1985, she was a member of the Quebec Justice Advisory Council, advising the Quebec Minister of Justice on all matters relating to the administration of justice, particularly with regards to legislative reforms. She was also a member of the Board of Directors of SOQUEM (Société québécoise d'exploitation minière) (1985-1987).

In 1997, Louise Otis instituted one of the world's first programs of integrated judicial mediation. In Quebec, all the courts and tribunals have since developed a judicial mediation program, integrated to the traditional system of justice. This program offers citizens the chance to meet with a judge in a mediation session in order to seek a final resolution to their commercial, civil, administrative, or family disputes. Since 2004, a program of facilitation in criminal matters has also been launched at the Quebec Court of Appeal.

Since 1997, Louise Otis has conducted over 500 mediation sessions in commercial and civil law.

Throughout her career, Louise Otis has acted as a member of the jury in several moot court competitions. Since 2005, she has been a member of the Award Committee of the Bora Laskin Award established to recognize outstanding contributions to Labour Law.

Since 2005, she is a member of the Board of Directors of Equitas –International Centre for Human Rights Education.

Since 2007, she is a fellow of the International Academy of Mediators.

Since January 2009, she is on the Advisory Board of the Chaire de droit et gouvernance de la Santé of the University of Sherbrooke.

In March 2009, Louise Otis founded the Canadian Conference for Judicial Mediation intended to encourage the emergence, establishment and the advancement of judicial mediation in Canada.

Since October 2009, she is president of the *International Conference on Mediation for Justice*(ICMJ), a newly created international institution committed to advancing mediation among the judiciary around the world.

In September 2010, Louise Otis participated, as a consultant, in a mission on Transitional Justice in Haiti in order to implement a system of Front line Justice in the refugee camps. The project is conducted by Lawyers with no borders and the Canadian Department of Foreign Affairs and International Trade (DFAIT

In July 2010, Louise Otis offered an intensive training course on *Dispute Resolution Mediation Skills for Judges from around the Globe* at Pepperdine University School of Law in Malibu, California. This unique Mediation skills training program for judges was a result of a partnership between the Conference for International Mediation for Justice (CIMJ) and the Straus Institute at Pepperdine University School of Law (Straus).

In June 2010, Louise Otis was invited as a guest lecturer at the International Studies Center of the University of Montreal (CERIUM). She lectured on: Setting the Political Stage for Deployment: Mediation Efforts in Perspective. This summer lecture provided an overview of international mediation and its connections to peace operations.

In March 2010, as a legal expert, Louise Otis accompanied Her Excellency, The High Honourable Michaëlle Jean during a State visit in Senegal, Congo, Rwanda and Cape Verde. During these visits, the governor general has built on existing international relationships and strengthened ties across a broad range of sectors of Canadian life.

In October 2010 and May 2009, she was invited by The Honourable Rob Hulls, Attorney General of the State of Victoria, *Australia*, to deliver a series of twelve Conferences and training courses on Commercial and civil mediation to members of the Judiciary and the Bar.

In September 2009, Louise Otis participated in an assessment mission on prisoners' detention in *Haiti*. The goal of the mission was to conduct a pilot project on release from custody according to the Haitian Law. This assessment mission was monitored by the Canadian Department of Foreign Affairs and International Trade (DFAIT) and Lawyers without Borders, Canada.

In June 2009, she was invited by DFAIT to join a 25-person panel of experts on International mediation, and to participate in a Mediation Policy Forum on the resolution of international conflicts.

In May 2009, she lectured on Commercial mediation at the University of New Zealand's Faculty of Law and at the High Court of Auckland.

In February 2009, Justices from Appellate Courts of *Brazil* attended a specialized judicial mediation training course at McGill University in Montreal. The training was organized and directed by Louise Otis and the University of Sherbrooke.

In February 2008, Louise Otis carried out an information and training mission at the request of the Consulate in Sao Paulo and in Rio de Janeiro to present the model of Quebec judicial mediation. This mission resulted in an agreement to offer a training coursein judicial mediation to justices from Federal and Appellate Courts of *Brazil*.

In November 2006, Louise Otis, in collaboration with a representative from the Netherlands, prepared a report intended to establish the scope of intervention of Canada and the Netherlands as part of the Canadian Support Project to implement the Ten-Year Justice Development Program in *Mali* (PACMO-PRODEJ).

In January 2006, Louise Otis was appointed as an expert in alternative dispute resolution, by the *United Nations* Secretary-General Kofi Annan for a period of 6 months from February 1 to July 31, 2006. She was part of a 5-member panel of independent international experts in charge of redesigning the United Nations system of administration of Justice, including the creation of a mediation system. On April 2007, Secretary-General Ban Ki-Moon and a resolution of the General Assembly of the United Nations approved the essence of the recommendations of the Redesign Panel.

At the request of the Canadian Government, Louise Otis served as an expert consultant in the development of an interim cooperation framework for the reform of justice in *Haiti* (2004-2005). She also participated in the drafting of the judicial reform plan currently implemented by *International Organisation of La Francophonie (OIF)* on behalf of *Canada* and the *European Union*. In April 2007, she was mandated by OIF to implement a frontline justice plan in Haiti, a transitional justice programme designed to meet the immediate legal needs of the people of Haiti.

In 2005, Louise Otis was invited to Australia to present the Quebec system of criminal mediation and facilitation to the Ministers of Justice of Australian States as well as the Federal Minister of Justice. In September 2008, Rob Hulls, Deputy Premier of the

State of Victoria, came to Montreal for a training program with Louise Otis for the implementation of the first judicial mediation program in civil matters in Australia.

In October 2005, Louise Otis served as an expert consultant on case management in the Canada-China Judicial Linkages Project (National Judicial Institute and CIDA).

In May 2005, at the request of the *Council of Europe*, Louise Otis prepared and facilitated a 5-day seminar on negotiation and mediation to the representatives of 19 European countries.

In March 2004, at the request of the Commissioner for Federal Judicial Affairs, Louise Otis gave lectures on commercial mediation at the Supreme Arbitration Court of the Russian Federation in *Russia*.

In 2000, at the request of the Canadian Ambassador to Mali and of the Canadian International Development Agency (CIDA), Louise Otis and Jacques Frémont, Dean of the Faculty of Law at the University of Montreal, co-chaired a Canadian Mission to set priorities for the development of justice in *Mali* and produced a report and recommendations aimed at guiding judicial reform (July-December 2000).

TRAINING AND PROGRAM DESIGN

Drawing on her extensive experience as a mediator, Louise Otis designed an elaborate training program in mediation for judges, jurists and non-jurists. The program pursues many objectives, namely:

- to understand the nature and development of conflicts
- to understand the role of the judge-mediator, the mediator, and the negotiator
- to acquire the knowledge and skills of a negotiator
- to develop an understanding of the dynamics of negotiation and possible intervention strategies
- to acquire the skills for moving past an impasse in negotiations
- to understand the ethical rules that govern the judge-mediator, the mediator and the negotiator (ethics and immunity)
- to master the process of negotiation
- to design a system of mediation

Louise Otis has directed intensive training sessions for jurists and non-jurists from Canada, France, Belgium, Morocco, Mali, Rwanda, Uganda, Switzerland, Australia, Russia, Serbia, Norway, Denmark, Finland, Ukraine, Romania, Brazil, Argentina and CARICOM member states.

On April 22 and 23, 2003, Louise Otis offered an intensive training program in judicial mediation in Antwerp to magistrates of Belgium from the Courts of Appeal of Brussels, Antwerp, Mons, and Liège, from the Courts of First Instance and Specialized Jurisdictions and from the Court of Appeal of Grenoble, France.

In March 2004, at the initiative of Justices Louise Otis and Michel Proulx, the Court of Appeal of Quebec, the Superior Court of Quebec and the Court of Quebec adopted a common judicial policy establishing a pilot program in criminal mediation for "Pre-trial management conferences and facilitation conferences in criminal matters". Louise Otis has designed the first training program in collaboration with the University of Sherbrooke.

CITATIONS

On June 17, 2000, Louise Otis received a *Doctorate "honoris causa*" from the University of Sherbrooke in recognition for her work in implementing the first appellate level judicial mediation program in North America.

In 2002, she received the "Distinguished Service Award" from The Straus Institute for Dispute Resolution (Pepperdine University School of Law) for her contribution to the development and advancement of judicial methods of conflict resolution.

On October 28, 2003, Louise Otis received the title of Officer of the "Ordre National du Québec" in recognition for conceiving and implementing one of the first appellate level judicial mediation programs in the world.

In November 2008, CNMAC (Canadian National Mediation Advocacy Competition) created Louise Otis Award for Excellence in ADR in order to recognize the excellence of a law school in Alternative Dispute Resolution education.
