Mr. Speaker, Sir,

One of the functions of the Committee according to Standing Order 216(5), includes ***vetting and reporting on all appointments where the constitution and any other law requires the National Assembly to approve.***

The Committee oversees the Ministry of Health and state corporations in the Ministry of Health including, but not limited to, National Hospital Insurance Fund, Kenyatta National Hospital, Moi Teaching and Referral Hospital, Pharmacy and Poisons Board and Kenya Medical Supplies Authority.

The Committee is also guided by the Fourth Schedule to the Constitution of Kenya, 2010 which contains the distribution of duties between the National & County Governments. The Health Committee is thus charged with 2 functions:
- National Referral Hospitals & Health policy.

Mr. Speaker,

Article 155(1) of the Constitution provides that there is established the Office of the Principal Secretary, which is an office in the public service. The Principal Secretary shall be nominated and, with the approval of the National Assembly, appointed by the President.

Mr. Speaker, Sir,

Following the President's appointment of Principal Secretary Nominees in pursuance of Article 155 of the Constitution of Kenya and your Communication to that effect on 11th June, 2013, the Committee held four Sittings during which the nominee appeared and was vetted in accordance with the Public Appointments (Parliamentary Approval) Act No. 33 of 2011. The Committee also made reference to the Constitution and the Standing Orders.

Mr. Speaker,

May I take this opportunity to thank all Members of the Committee for their input and valuable contributions during the deliberations and vetting of the nominee.

On behalf of the Committee, I wish to thank the Offices of the Speaker and the Clerk of the National Assembly for the logistical support accorded to it during the vetting exercise. The Committee is also grateful to the media for their coverage of the proceedings of the Committee, thus enhancing accountability and transparency of the vetting exercise.

On behalf of the Members of the Departmental Committee on Health and pursuant to the provisions of Standing Order No. 199, it is my pleasure and duty to present to the House, the Committee's Report on the vetting of Prof. Fred Segor, Principal Secretary Nominee for the Ministry of Health.

1.0 BACKGROUND OF THE VETTING PROCESS

1.1 Establishment of the Office of Principal Secretary

Article 155 of the Constitution provides that;

- (1) There is established the office of Principal Secretary, which is an office in the public service.
- (2) Each State department shall be under the administration of a Principal Secretary.
- (3) The President shall—
 - (a) nominate a person for appointment as Principal Secretary from among persons recommended by the Public Service Commission; and
 - (b) With the approval of the National Assembly, appoint Principal Secretaries.

1.2 Message from H.E. the President

Article 155(3)(a) confers upon the President the power to nominate, and subject to approval by the National Assembly, appoint Principal Secretaries. In exercise of these powers, H.E. the President, wrote to the Speaker of the National Assembly on 10th June, 2013 a letter communicating his decision to nominate 26 persons for appointment as Principal Secretaries, subject to parliamentary approval.

In exercise of Standing Order 42 (1) the Speaker conveyed the message from H.E. the President to the House that Prof. Fred Segor, amongst other persons, had been nominated to serve as Principal Secretary in the Ministry of Health.

After conveying the message from the President on the nomination, the Speaker of the National Assembly forwarded the name of the nominee and his curriculum vitae to the Committee on Health to conduct approval hearings.

1.3 Approval Process

In conducting the Approval hearings, the Committee was guided by Article 73 (2) (a) (b) (c) and (e) of the Constitution, and the provisions of Section 7 of the Public Appointments (Parliamentary Approval) Act No. 33 of 2011.

Article 73 of the Constitution provides that:

(2) The guiding principles of leadership and integrity include—

- a) selection on the basis of personal integrity, competence and suitability, or election in free and fair elections;
- b) objectivity and impartiality in decision making, and in ensuring that decisions are not influenced by nepotism, favouritism, other improper motives or corrupt practices;
- c) selfless service based solely on the public interest, demonstrated by—
 - i. honesty in the execution of public duties; and,
 - ii. the declaration of any personal interest that may conflict with public duties;
 - iii. accountability to the public for decisions and actions; and
- (e) discipline and commitment in service to the people.

The Committee also made reference to correspondence from the Public Service Commission to H.E. the President communicating its decision on recommended persons for appointment. *(Refer to letters Ref. PSC.SEC.93/71 Vol III, dated 10th May, 2013, PSC.SEC.93/37/(39) dated 24th May, 2013 and Ref. PSC.SEC.93 dated 31st May, 2013 in Appendix II of the Report)*

1.4 Notification to the nominee

On 12th June, 2013, the Clerk of the National Assembly, pursuant to Section 6(3) of the Public Appointments (Parliamentary Approval) Act No. 33 of 2011, notified the nominee of the time and place for holding the Approval hearing.

1.5 Notification to the public

Section 6(9) of the Public Appointments (Parliamentary Approval) Act No. 33 of 2011, provides that *“any person may, prior to the approval hearing, and by*

written statement on oath, provide the Clerk with evidence contesting the suitability of a candidate to hold the office to which the candidate has been nominated”.

On 12th June, 2013, the Committee, through the Clerk, placed notifications in the print media informing the general public of the intention of the National Assembly to conduct an Approval hearing, pursuant to Article 118 (1)(a)(b) and (2) of the Constitution, Standing Order 198 (1) and Section 6(4) of the Public Appointments (Parliamentary Approval) Act, 2011, which allow public participation in Committee proceedings.

The Clerk also gave notification to the public to submit memoranda to his office, on the suitability or otherwise of the nominees, by Tuesday, 18th June, 2013, at 5.00pm.

1.6 Clearance requirements

On 12th June, 2013, the Clerk of the National Assembly wrote to the Ethics and Anti-Corruption Commission seeking information on the integrity of the nominees. Two other letters were written to the Kenya Revenue Authority (KRA), and the Higher Education Loans Board (HELB) respectively, requesting for information on whether the nominees were tax compliant and whether they owed any loans to the Board. The nominees were also required to present their Certificates of Good Conduct.

The Committee subsequently received letters from the Kenya Revenue Authority, indicating that the nominee was tax compliant, and the Higher Education Loans Board, stating that the Board was not owed any loans by the nominees. The Ethics and Anti-Corruption Commission also confirmed that it had not received any adverse report or opened investigations against the nominee. The nominee also presented before the Committee his Certificate of Good Conduct.

1.7 Committee meetings

The Committee commenced the vetting process on Monday, 17th June, 2013. A total of four sittings were held. The Committee's first business was to formulate questions on the vetting in line and in addition to the Public Appointments (Parliamentary Approval) Act No.33 2011, and examine Memoranda received.

By Tuesday, 18th June, 2013, the Committee had not received any memoranda from the public.

1.8 The Vetting Process

On Wednesday, 19th June, 2013, the Committee held a session with the Principal Secretary nominee, Prof. Segor. In conducting the vetting exercise, the Committee was guided by, among other documents, the Constitution, the Public Appointments (Parliamentary Approval) Act No. 33 of 2011 and the National Assembly Standing Orders.

2.0 VETTING OF PROF. SEGOR, NOMINEE FOR APPOINTMENT TO THE POSITION OF PRINCIPAL SECRETARY IN THE MINISTRY OF HEALTH

Prof. Segor appeared before the Committee on Wednesday, 19th June, 2013, at 2.30 pm.

The Committee examined the nominee using the guidelines provided for in the Public Appointments (Parliamentary Approval) Act No. 33 of 2011. The Committee also followed the following criteria in vetting the nominee: -

- i. Academic qualifications
- ii. Employment record
- iii. Professional affiliations
- iv. Potential conflict of interest
- v. Knowledge of the relevant subject
- vi. Overall suitability for the position
- vii. Tax compliance
- viii. Integrity

2.1 Personal, Academic & Professional Background

Prof. Segor was born on 1st December, 1966 in Kabargoge Village, Baringo County.

He is an accomplished research scientist in the field of Chemistry. He holds a Doctor of Philosophy degree in Chemistry from the University of Nairobi and is currently an Associate Professor and Head of Chemistry and Biochemistry Department in the University of Eldoret (formerly Chepkoilel Campus of Moi University).

He has received several honors and awards in academia including PhD Scholarship in University of Nairobi and Research Fellowship in Germany, both sponsored by German Academic Exchange Service (DAAD).

2.2 Response to Questions raised by the Committee

Suitability for the Position

When asked to comment on his suitability for the position, the nominee pledged to utilize his academic background in research in biochemistry and also leadership and managerial experience attained as Head of Department and Dean to improve service delivery in the Ministry of Health.

His short term goals in the Ministry include putting in place measures to reduce if not eliminate corruption in the Ministry and equipping public hospitals with modern equipment.

On political interference, he stated that he is independent-minded and that he will as much as possible avoid political interference in the performance of his duties as a public officer.

Distribution of Government Functions between National and County Governments

In response to the whether he understands the distribution of functions between the National Government and the County Governments, the nominee stated that he fully understands the role of each government as spelt out in Fourth Schedule to the Constitution of Kenya. He noted that the National government is mainly charged with policy making, training & quality control.

He added that consultations with major stakeholders will go a long way solving teething problems that may arise in the implementation of the Constitution.

Challenges facing the Health Sector

When asked to state some of the challenges facing the health sector, the nominee mentioned inadequate staffing in health facilities, poor remuneration

of health workers, poor infrastructure, and low bed capacity amongst others. Most of these challenges require an increase in budgetary allocation to the Ministry of Health. He pledged to work closely with Treasury, Cabinet Secretary in the Ministry of Health and the Parliamentary Committee on Health to find long lasting solutions to the problems affecting the sector.

Medical Research and Alternative Medicine

As an accomplished researcher with a wealth of research-based knowledge, he regretted that it is unfortunate that in the past, the role of research has not been fully appreciated in formulation of policies in the Ministry. He pledged to use his position to link research and policy formulation in the ministry.

On alternative medicine, he stated that he supports the contribution made by alternative medical practitioners in as long as these practitioners subscribe to the ethics set by the Ministry and allow further tests to be conducted on their medicines to establish their viability.

Fight Against Corruption

On the question of corruption, the nominee stated that he believes in good practice and that he will lead from the front in stamping out the vice. He will also work closely with government agencies like the Ethics and Anti-Corruption Commission and law enforcement agencies like the Kenya Police Service to deal firmly with the culprits.

He also fully supports embracing technology to minimize corruption through automation of services in government departments and parastatals like Kenyatta National Hospital (KNH), Moi Teaching & Referral Hospital (MTRH), National Hospital Insurance Fund (NHIF) and Kenya Medical Supplies Authority (KEMSA) with the aim of sealing corruption loopholes.

Improvement of Staff Welfare in Ministry of Health

When asked how he will improve staff welfare and morale in the Ministry, he acknowledged that low staff morale has a negative effect on output at work. Some of the measures he intends to introduce to address low staff morale and welfare include creating a good working environment with adequate and competitive salaries, avail adequate working equipment, put in place a good pension scheme and training and promotion policy.

Dealing with Counterfeit Drugs in the Market

In addressing the issue of counterfeit drugs in the Kenyan market, the nominee stated that he intends to enforce professionalism in the Pharmacy and Poisons Board and heighten surveillance to ensure counterfeit drugs do not find their way into the market. Further, the Ministry will work with law enforcement agencies to take appropriate action on the culprits found handling counterfeit drugs.

Taking Health Services Closer to the Citizens as per WHO Guidelines

In addressing the issue of bringing health services closer to the people as per the World Health Organization guidelines, the nominee stated that one of the ways of doing so is by fast-tracking registration of donor-funded facilities like those funded by CDF. This will also be followed up by equipping and deploying health personnel to fully operationalize them.

He commended Members of Parliament for their role in assisting the Ministry take services closer to the people by improving infrastructure especially in the health sector.

Funding of HIV/AIDS Programmes

Funding of health programmes such as immunization and treatment and management of HIV/AIDS especially in purchasing of ARVs is heavily donor-dependent. The donors may soon withdraw their funding thereby creating a

major crisis in the health sector unless measures are put in place early enough to mitigate this.

When asked to comment on this issue, the nominee stated that the Government of Kenya should gradually allocate funds in its annual budget for the treatment and management of HIV/AIDS and health programmes such as immunization. This will avert a humanitarian crisis should donor-funding be abruptly withdrawn.

The nominee also pledged to increase funding to scale up prenatal screening with the aim of reducing Mother-to-Child Transmission of HIV/AIDS. This will greatly reduce the number of children born with HIV.

Addressing Terminal Illnesses

When asked about how he will address the rising cases of terminal illnesses e.g cancer and diabetes, the nominee stated that he intends to ensure that cancer centres in KNH and MTRH are fully equipped to be able to rehabilitate and treat cancer patients at an affordable cost.

He will also put in place adequate measures to be able to detect early stages of these terminal illnesses and treat them before they are fully blown. The Ministry will also roll out health education to educate the public on lifestyle change and embrace preventive health measures.

Absentee Doctors

On the issue of government doctors running private clinics at the expense of their national duty, he pointed out that it is morally wrong for the doctors to abscond duty yet they are paid a non-practicing allowance. Doctors found culpable will be disciplined accordingly.

Ban on "Miraa" / "Khat"

When asked to comment on whether 'miraa' or 'khat' should be classified as a drug and therefore banned, he responded that further tests studies ought to be undertaken before a policy issue on the same is issued.

Provision of Free Maternity Health Care

The nominee expressed full support for free maternity health care as promised by the Jubilee Government. He stated that the programme is a noble initiative despite facing teething problems in its initial stages of roll-out.

Commitment to Dialogue

Last but not least, he is committed to working closely with the National Treasury, Parliamentary Budget and Health Committees and other stakeholders to ensure the smooth running of the Ministry especially on budget issues including honoring of the Collective Bargaining Agreement with the doctors and other health workers.

2.3 Committee Observations, Findings & Conclusion

The Committee observed that he is academically qualified and is an accomplished researcher in biochemistry. In fact, he has received several awards and honors in recognition of his exemplary work in the field of science.

He has never been charged in a Court of Law, has no potential conflict of interest, and has fully complied with his tax obligations. The nominee was also given a clean bill of health by the Ethics and Anti-Corruption Commission on integrity.

In addition, he has never been dismissed from office for contravention of the provisions of Article 75 of the Constitution which deals with conduct of state officers that are adversely mentioned in any investigatory report of Parliament or any Commission of Inquiry.

He also displayed keen interest and knowledge in the health sector despite being a non-medic and is willing to adapt fast to his new appointment. He also displayed humility during the vetting process.

Last but not least, he expressed willingness to work closely with stakeholders in the health sector, including Parliament, especially on policy and budgetary issues.

The Committee also observed that the nominee applied for the position of Principal Secretary as advertised by the Public Service Commission in the print media and the Commission's website on 8th February, 2013 and 11th April, 2013. He, however, was not in the earlier list of sixty-six (66) persons recommended for appointment as Principal Secretaries in the letter to H.E. the President dated 10th May, 2013.

Following further consultations between the Office of the President and the Public Service Commission, another list of nineteen (19) persons suitable for consideration for appointment to the position of Principal Secretary was sent to the President vide letters Ref PSC/SEC. 93/37/ (39) dated, 24th May, 2013 and Ref. PSC.SEC.93 dated 31st May, 2013. The list of nineteen (19) persons contained in the two letters was drawn from the list of 155 shortlisted candidates and from the full list of applicants for the same position. Prof. Segor's name was contained in the list attached to the letters dated 24th May, 2013 and 31st May, 2013 and the list of all applicants (2,088) for the position of Principal Secretary. He therefore met the requirement of Article 155 of the Constitution of Kenya.

In conclusion, the Committee found the nominee suitable for appointment as Principal Secretary, Ministry of Health.

3.0 RECOMMENDATION OF THE COMMITTEE

Having considered the suitability, capacity and integrity of the nominee, and pursuant to Article 155(3)(b) of the Constitution and Section 8 (2) of the Schedule to the Public Appointments (Parliamentary Approval) Act No. 33 of 2011, the Committee recommends that this House approves the nomination and subsequent appointment by H.E. the President, of Prof. Fred H. K. Segor, as Principal Secretary, Ministry of Health.

The Chairperson called the meeting to order at half past two o'clock. The meeting started with a word of prayer by Hon. Dr. Robert Pukose, MP. Introductions were thereafter conducted.

MIN.NO. 43/2013

VETTING OF THE PRINCIPAL SECRETARY
NOMINEE FOR HEALTH - PROF. FRED
SEGOR

Prof. Segor appeared before the Committee on Wednesday, 19th June, 2013, at 2.30 pm.

The Committee examined the nominee using the guidelines provided for in the Public Appointments (Parliamentary Approval) Act No. 33 of 2011. The Committee also followed the following criteria in vetting the nominee: -

- ix. Academic qualifications
- x. Employment record
- xi. Professional affiliations
- xii. Potential conflict of interest
- xiii. Knowledge of the relevant subject
- xiv. Overall suitability for the position
- xv. Tax compliance
- xvi. Integrity

Personal, Academic & Professional Background

Prof. Segor was born on 1st December, 1966 in Kabargoge Village, Baringo County.

He is an accomplished research scientist in the field of Chemistry. He holds a Doctor of Philosophy degree in Chemistry from the University of Nairobi and is currently an Associate Professor and Head of Chemistry and Biochemistry Department in the University of Eldoret (formerly Chepkoilel Campus of Moi University).

He has received several honors and awards in academia including PhD Scholarship in University of Nairobi and Research Fellowship in Germany, both sponsored by German Academic Exchange Service (DAAD).

Response to Questions raised by the Committee

i. Suitability for the Position

When asked to comment on his suitability for the position, the nominee pledged to utilize his academic background in research in biochemistry and also leadership and managerial experience attained as Head of Department and Dean to improve service delivery in the Ministry of Health.

His short term goals in the Ministry include putting in place measures to reduce if not eliminate corruption in the Ministry and equipping public hospitals with modern equipment.

On political interference, he stated that he is independent-minded and that he will as much as possible avoid political interference in the performance of his duties as a public officer.

ii. Distribution of Government Functions between National and County Governments

In response to the whether he understands the distribution of functions between the National Government and the County Governments, the nominee stated that he fully understands the role of each government as spelt out in Fourth Schedule to the Constitution of Kenya. He noted that the National government is mainly charged with policy making, training & quality control. He added that consultations with major stakeholders will go a long way solving teething problems that may arise in the implementation of the Constitution.

iii. Challenges facing the Health Sector

When asked to state some of the challenges facing the health sector, the nominee mentioned inadequate staffing in health facilities, poor remuneration of health workers, poor infrastructure, and low bed capacity amongst others. Most of these challenges require an increase in budgetary allocation to the Ministry of Health. He pledged to work closely with Treasury, Cabinet Secretary in the Ministry of Health and the Parliamentary Committee on Health to find long lasting solutions to the problems affecting the sector.

iv. Medical Research and Alternative Medicine

As an accomplished researcher with a wealth of research-based knowledge, he regretted that it is unfortunate that in the past, the role of research has not been fully appreciated in formulation of policies in the Ministry. He pledged to use his position to link research and policy formulation in the ministry.

On alternative medicine, he stated that he supports the contribution made by alternative medical practitioners in as long as these practitioners subscribe to the ethics set by the Ministry and allow further tests to be conducted on their medicines to establish their viability.

v. Fight Against Corruption

On the question of corruption, the nominee stated that he believes in good practice and that he will lead from the front in stamping out the vice. He will also work closely with government agencies like the Ethics and Anti-Corruption Commission and law enforcement agencies like the Kenya Police Service to deal firmly with the culprits.

He also fully supports embracing technology to minimize corruption through automation of services in government departments and parastatals like Kenyatta National Hospital (KNH), Moi Teaching & Referral Hospital (MTRH),

National Hospital Insurance Fund (NHIF) and Kenya Medical Supplies Authority (KEMSA) with the aim of sealing corruption loopholes.

vi. Improvement of Staff Welfare in Ministry of Health

When asked how he will improve staff welfare and morale in the Ministry, he acknowledged that low staff morale has a negative effect on output at work. Some of the measures he intends to introduce to address low staff morale and welfare include creating a good working environment with adequate and competitive salaries, avail adequate working equipment, put in place a good pension scheme and training and promotion policy.

vii. Dealing with Counterfeit Drugs in the Market

In addressing the issue of counterfeit drugs in the Kenyan market, the nominee stated that he intends to enforce professionalism in the Pharmacy and Poisons Board and heighten surveillance to ensure counterfeit drugs do not find their way into the market. Further, the Ministry will work with law enforcement agencies to take appropriate action on the culprits found handling counterfeit drugs.

viii. Taking Health Services Closer to the Citizens as per WHO Guidelines

In addressing the issue of bringing health services closer to the people as per the World Health Organization guidelines, the nominee stated that one of the ways of doing so is by fast-tracking registration of donor-funded facilities like those funded by CDF. This will also be followed up by equipping and deploying health personnel to fully operationalize them.

He commended Members of Parliament for their role in assisting the Ministry take services closer to the people by improving infrastructure especially in the health sector.

ix. Funding of HIV/AIDS Programmes

Funding of health programmes such as immunization and treatment and management of HIV/AIDS especially in purchasing of ARVs is heavily donor-dependent. The donors may soon withdraw their funding thereby creating a major crisis in the health sector unless measures are put in place early enough to mitigate this.

When asked to comment on this issue, the nominee stated that the Government of Kenya should gradually allocate funds in its annual budget for the treatment and management of HIV/AIDS and health programmes such as immunization. This will avert a humanitarian crisis should donor-funding be abruptly withdrawn.

The nominee also pledged to increase funding to scale up prenatal screening with the aim of reducing Mother-to-Child Transmission of HIV/AIDS. This will greatly reduce the number of children born with HIV.

x. Addressing Terminal Illnesses

When asked about how he will address the rising cases of terminal illnesses e.g cancer and diabetes, the nominee stated that he intends to ensure that cancer centres in KNH and MTRH are fully equipped to be able to rehabilitate and treat cancer patients at an affordable cost.

He will also put in place adequate measures to be able to detect early stages of these terminal illnesses and treat them before they are fully blown. The Ministry will also roll out health education to educate the public on lifestyle change and embrace preventive health measures.

xi. Absentee Doctors

On the issue of government doctors running private clinics at the expense of their national duty, he pointed out that it is morally wrong for the doctors to

abscond duty yet they are paid a non-practicing allowance. Doctors found culpable will be disciplined accordingly.

xii. Ban on "Miraa" / "Khat"

When asked to comment on whether 'miraa' or 'khat' should be classified as a drug and therefore banned, he responded that further tests studies ought to be undertaken before a policy issue on the same is issued.

xiii. Provision of Free Maternity Health Care

The nominee expressed full support for free maternity health care as promised by the Jubilee Government. He stated that the programme is a noble initiative despite facing teething problems in its initial stages of roll-out.

xiv. Commitment to Dialogue

Last but not least, he is committed to working closely with the National Treasury, Parliamentary Budget and Health Committees and other stakeholders to ensure the smooth running of the Ministry especially on budget issues including honoring of the Collective Bargaining Agreement with the doctors and other health workers.

Committee Observations, Findings & Conclusion

The Committee observed that he is academically qualified and is an accomplished researcher in biochemistry. In fact, he has received several awards and honors in recognition of his exemplary work in the field of science.

He has never been charged in a Court of Law, has no potential conflict of interest, and has fully complied with his tax obligations. The nominee was also given a clean bill of health by the Ethics and Anti-Corruption Commission on integrity.

In addition, he has never been dismissed from office for contravention of the provisions of Article 75 of the Constitution which deals with conduct of state

officers that are adversely mentioned in any investigatory report of Parliament or any Commission of Inquiry.

He also displayed keen interest and knowledge in the health sector despite being a non-medic and is willing to adapt fast to his new appointment. He also displayed humility during the vetting process.

Last but not least, he expressed willingness to work closely with stakeholders in the health sector, including Parliament, especially on policy and budgetary issues.

In conclusion, the Committee found the nominee suitable for appointment as Principal Secretary, Ministry of Health and therefore recommends his appointment.

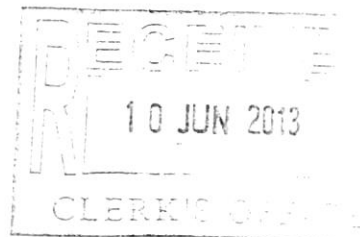

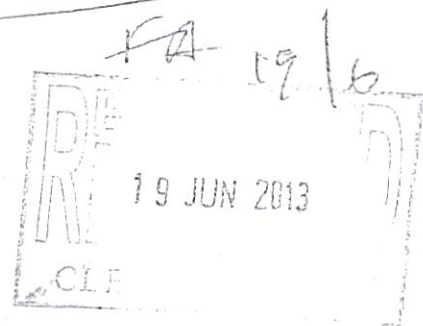


